Governor Newsom Continues to Roll Back COVID-19 Executive Orders

Governor's Press Office

Continuing California's progress in responsibly winding down executive orders implemented in response to the pandemic, Governor Gavin Newsom today took action to lift additional COVID-19 related executive order provisions, while maintaining California's nation-leading testing and vaccination programs and protecting hospital capacity – key components of the state's SMARTER Plan to guide California's response to the pandemic.

"As California navigates the evolving pandemic, the state remains laser-focused on keeping Californians safe while advancing our ongoing recovery," said Governor Newsom. "We're continuing to deploy proven strategies and programs that allow us to swiftly and effectively respond to changing pandemic conditions, take on equity gaps, and keep us moving forward."

The Governor's action today immediately terminates five provisions related to Cal/OSHA's COVID-19 Emergency Temporary Standards, following updated workplace safety rules that took effect last month. Fifteen additional provisions are set to expire on June 30, after which only 5 percent of the COVID-19 related executive order provisions issued throughout the pandemic will remain in place.

Important measures still in effect to bolster the state's COVID response and recovery efforts include provisions that support:

COVID Testing – Providing flexibility to support the state's testing program, which under the SMARTER Plan will continue being able to process at least 500,000

tests per day. For example, through executive action the Governor has waived a provision that would require a health care professional to review each test result before it was released electronically to patients, and expanded scopes of practice for pharmacists and pharmacy technicians to conduct COVID tests.

Vaccinations and Boosters – Ensuring flexibility to advance the state’s vaccination and booster programs, which under the SMARTER Plan will continue being able to distribute at least 200,000 doses per day. This includes waiving licensing requirements temporarily to enable pharmacists and pharmacy technicians to administer COVID vaccines and waiving requirements so that the state can offer mobile vaccine clinics.

Protecting Hospital Capacity and Vulnerable Populations – Provisions to protect both capacity in our health care delivery system and vulnerable populations, particularly during COVID surges. This includes provisions allowing health care workers from out of state to provide services in California and enabling the Department of Developmental Services to provide remote

and expanded nonresidential services for more clients.

Infant Formula Price Gouging Protections – Provisions that provide consumer protections against price gouging on infant formula in response to the ongoing supply chain challenges caused by the pandemic and the closure of a manufacturing facility that further impacted supply. To help improve access for parents and caretakers, sellers are generally prohibited from selling formula for a price that is more than 10 percent greater than the price they charged on February 17.

Since the onset of the pandemic, California has led the nation’s fight against COVID-19 with meaningful public health efforts that have administered more than 76 million COVID-19 vaccines, contributed to California’s maintaining one of the lowest death rates among large states and made the state a national leader in preventing school closures. Building on lessons learned, and the state’s ongoing commitment to equity, Governor Newsom earlier this year unveiled the SMARTER Plan, which outlines the state’s strategic approach to managing the next phase of the pandemic with core pillars and preparedness metrics based on proven strategies used to successfully slow the spread of the virus and protect Californians.

Meal Periods and Rest Breaks: Understanding California Employers' Expanding Obligations and Exposure

Naranjo ruling creates new employer obligations and additional potential exposure for non-compliance with respect to meal periods and rest breaks in two key respects.

First, under California Labor Code 226.7, if an employer fails to provide an employee with a compliant meal period or rest break, the employer must pay the employee one additional hour of pay at the employee's regular rate of compensation[1] for each workday that the meal or rest period was not provided. In Naranjo, the California Supreme Court held that employers must record such premium payments (related to missed, late or short meal or break times) on non-exempt employees' wage statements corresponding with the pay period(s) in which such premium payments are triggered. In reversing a prior Court of Appeal decision, the Supreme Court held that the premiums are not only meant to provide compensation for missed meal periods or rest breaks, but are also intended to provide compensation for work the employees perform during a meal period or rest break. The

California Supreme Court affirmed the Court of Appeal's holding that unpaid meal period and rest break premium payments accrue pre-judgment interest at the rate of seven percent per year.

Second, the Naranjo decision held that employers must pay meal period and rest break premium payments within the statutory deadline for all wages due to employees upon separation of employment. This means California employers will now be liable for waiting time penalties under Labor Code Section 203 if they do not pay the required premium payments in the employees' final wages, which are due at the time of termination, or within 72 hours of a resignation.[2]

Naranjo increases potential liability for meal period and rest break violations. The greatest exposure for employers is likely to be in cases where employees bring Private Attorneys' General Act (PAGA) claims. This is because PAGA allows plaintiffs to

“stack” penalties under various Labor Code provisions. On the class action front, employers can still rely on prior case law, such as the Brinker Restaurant Corp. v. Superior Court[3] decision, to argue that employers are only required to provide non-exempt employees with an opportunity to take meal periods (and are not required to ensure that employees actually stop work and take a meal period). However, given that Naranjo opens up additional avenues for potential liability, arguments traditionally used in class action defense may carry less weight in the future.

What Should Employers Do Now?

Since Naranjo held that violations related to meal periods and rest breaks can form the basis for wage statement penalty claims, the decision provides a strong incentive for employers to re-examine wage statements and work with counsel to fix wage statement related inaccuracies.

Employers are also advised to consult employment counsel to identify appropriate training and compliance measures to limit meal and rest break related liability. Such measures include periodic training managers and non-exempt employees regarding meal period and rest break policies, streamlined systems to track the timing and duration of employees' meal periods and rest breaks, systems that identify missed, short or late meal periods and rest breaks, and measures for payment of meal and/or rest premiums.

Since Naranjo implicates premium payments for meal periods and rest breaks, employers are also encouraged to re-assess the impact of bonuses on meal period and rest break premium payments.[4]

Finally, although Naranjo deals with premium payments associated with non-compliance meal periods and rest breaks, it calls into focus related issues, such as whether non-exempt employees are rounding meal period time entries, which is not permissible under existing California law. California employers should therefore consult with counsel to review and refine such policies and practices.[5]

- Having a casual attitude about safety rules leads to danger.

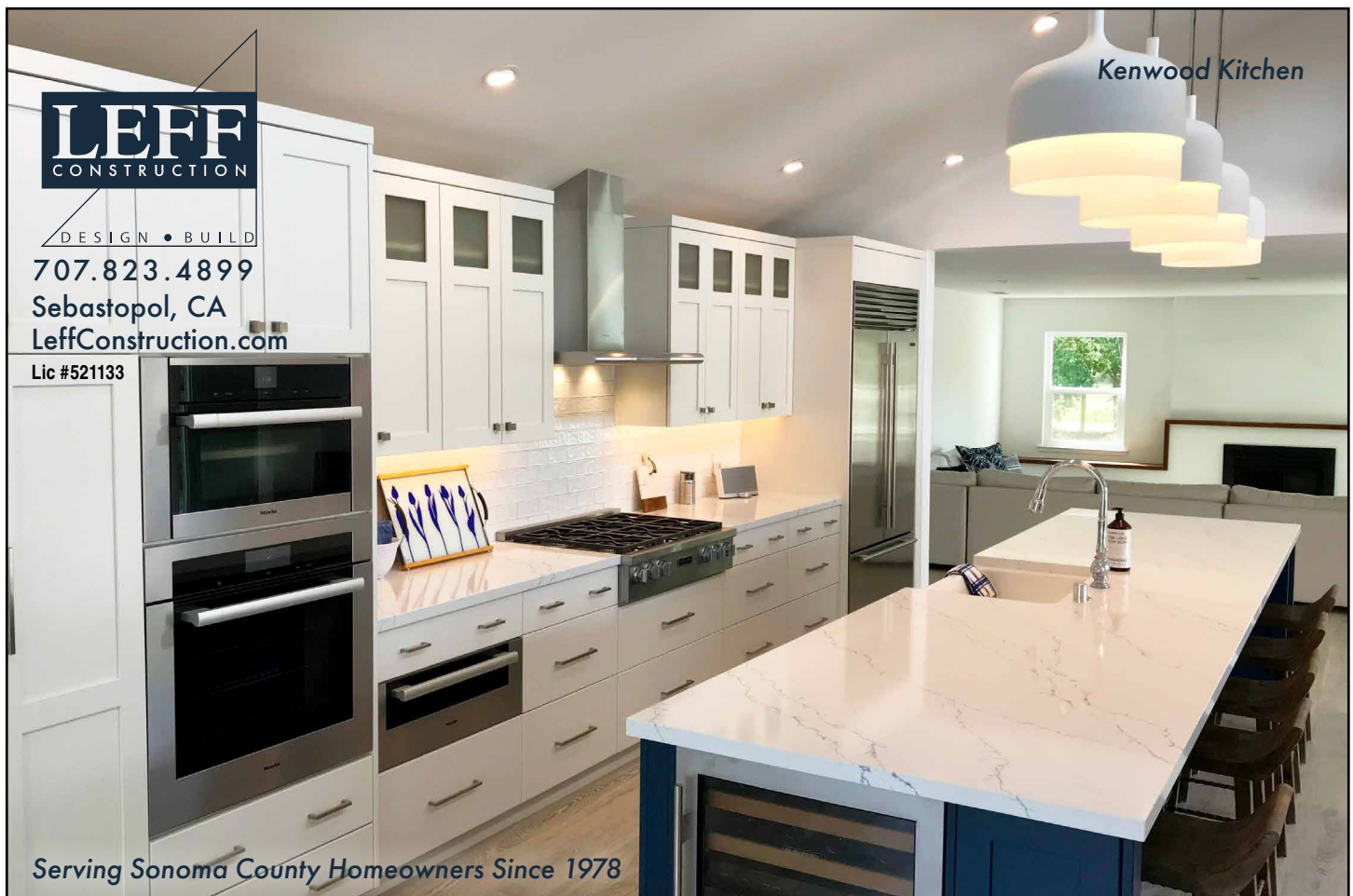
SHORTCUTS:

better instructions and should never try to do a task without knowing exactly how to do things correctly.

- New employee training is a must to prevent accidents.
- Assuming that everyone knows how to do his or her job correctly can lead to an accident.

POOR HOUSEKEEPING:

- A well maintained work area sets a standard for all.
- Poor housekeeping creates all types of hazards and sets the stage for accidents.
- Good housekeeping encourages pride and a safe environment.

MENTAL DISTRACTIONS:

- Doing a task safely requires mental attention.
- Distractions create hazards and can pull focus away from tasks at hand.

PRE-PLANNING:

- Thinking through a process to complete a task can take away hazards.
- Plan your work and then work your plan.

CONCLUSION:

- Make workplace safety a core value, a shared concern.
- Take proactive ownership of welfare and safety for all.
- Learn what can cause harm to whom, when and how. Near misses or no-injury accidents, as well as injuries, must be investigated.
- Identify hazards, assess risks and develop controls.
- Report ALL accidents to your supervisor.

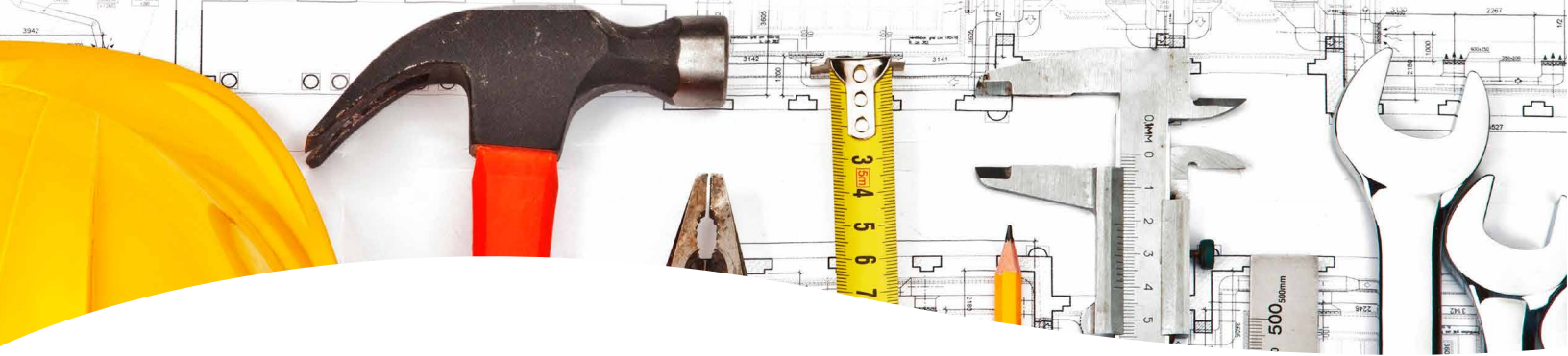

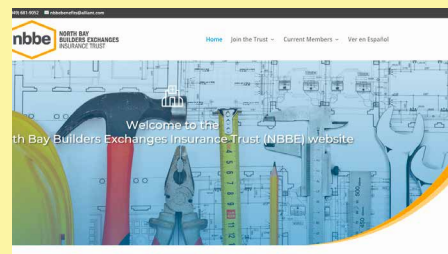

Capitol Connection Q&A for Contractors

Sometimes you can qualify for all work and no play! A contractor discovers that one Bond that you can't release until there's another, and while most regulations are black and white, isn't there always an 'exception' to a rule?...

Q: I sold my Contracting business which I am the Qualifier for. The purchase agreement states I will remain the Qualifying Individual until the buyer can take over the license or hire a qualified individual to replace me. With my ownership falling below 20%, I know I must now Inactivate my personal license while still acting as the Responsible Managing Officer (RMO) for the company I just sold. With less than 20% ownership, does that also mean I am required to work for the Company 32 hours a week? If so, I may be encouraging the buyer to speed up the process of replacing me!

A: As long as you remain an Officer (RMO) on the license and regardless of ownership, you are not required to work a certain amount of hours per week.

Q: We recently purchased another entity, and I am now maintaining their licenses in addition to the ones I was already in charge of. To make my life easier, I would like to get new Bonds in place for the new entity under the same surety company we use for our other licenses. What is the process for releasing the Bonds on record so that I can provide new Bonds from our Surety Company?

A: The first step would be to obtain the new Bonds. The CSLB will not "release" Bonds on file, however when you submit another, the CSLB puts the newest one on file and replaces the old one.

Q: We frequently do affordable housing work. We often are requested by private developers who are the owners of the project. It is known that favorable credit is given to Joint Ventures where one of the entities is a Small Business Enterprise. We are looking at a bid proposal that we'd like to bid on with another licensed SB Contractor, and in my

short experience with license law, I seem to remember that you cannot bid on work without a license. However, the Joint Venture creation is dependent on whether we are awarded the project. I'm wondering if there's an exception for Joint Ventures? Are we permitted to bid with the intention of obtaining a license if we are awarded the job?

A: There is an exception. B&P Code Section 7029.1 states two licensed Contractors may jointly bid for the performance of work prior to obtaining a license, however they cannot jointly enter a contract without first obtaining a Joint Venture Contractors license.
