## Everybody has an opinion: SCOTUS Shuts down OSHA's COVID-19 mandate

Supreme Court rules that OSHA overreached with its COVID Emergency Temporary Standard.

As we've reported elsewhere, the US Supreme Court has blocked the Occupational Safety and Health Organization (OSHA) Emergency Temporary Standard (ETS) that would have required workers at private companies with more than 100 employees to receive COVID-19 vaccinations or take weekly tests for the virus. That mandate, SCOTUS said in a 6-3 ruling, oversteps OSHA's authority as a workplace safety agency. However, SCOTUS ruled 5-4 to allow a similar mandate limited to healthcare workers to remain in effect.

In a statement, President Joe Biden said, "[The] decision by the Supreme Court to uphold the requirement for healthcare workers will save lives: the lives of patients who seek care in medical facilities, as well as the lives of doctors, nurses, and others who work there. It will cover 10.4 million health care workers at 76,000 medical facilities. We will enforce it."

"At the same time, I am disappointed that the Supreme Court has chosen to block common-sense life-saving requirements for employees at large businesses that

were grounded squarely in both science and the law. This emergency standard allowed employers to require vaccinations or to permit workers to refuse to be vaccinated, so long as they were tested once a week and wore a mask at work: a very modest burden."

"As a result of the Court's decision, it is now up to States and individual employers to determine whether to make their workplaces as safe as possible for employees, and whether their businesses will be safe for consumers during this pandemic by requiring employees to take the simple and effective step of getting vaccinated. The Court has ruled that my administration cannot use the authority granted to it by Congress to require this measure, but that does not stop me from using my voice as President to advocate for employers to do the right thing to protect Americans' health and economy. I call on business leaders to immediately join those who have already stepped up—including one third of Fortune 100 companies—and institute vaccination requirements to protect their workers, customers, and communities."

Naturally, rulings affecting most of the working population of the U.S. have resulted in numerous reactions to the ruling from various stakeholders, trade associations and other organizations. Here's a small sampling of the reactions to the rulings.

• Marty Walsh, Secretary of Labor, US Department of Labor:

*"I am disappointed in the court's decision, which is a major setback to the health and safety of workers across the country. OSHA stands by the Vaccination and Testing Emergency Temporary Standard as the best way to protect*

*the nation's workforce from a deadly virus that is infecting more than 750,000 Americans each day and has taken the lives of nearly a million Americans.... We urge all employers to require workers to get vaccinated or tested weekly to most effectively fight this deadly virus in the workplace. Employers are responsible for the safety of their workers on the job, and OSHA has comprehensive COVID-19 guidance to help them uphold their obligation. Regardless of the ultimate outcome of these proceedings, OSHA will do everything in its existing authority to hold businesses accountable for protecting workers, including under the Covid-19 National Emphasis Program and General Duty Clause."*

• Lorraine Martin, president and CEO, National Safety Council (NSC):

*"COVID-19 continues to devastate the American people, and employers must play a role in fighting this deadly virus. Despite the Court's ruling, we call on employers*

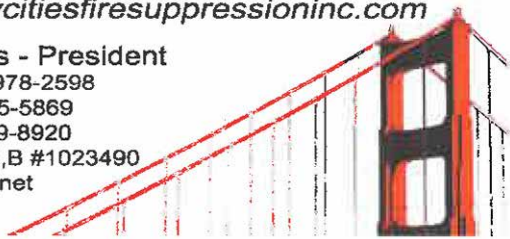

*everywhere to take responsibility for the safety of their workers by implementing a requirement for vaccination or testing, and exhausting any and all proven safety countermeasures such as masking, frequent handwashing, improved ventilation systems, and regularly disinfecting work surfaces.”*

• Jay Timmons, president and CEO of National Association of Manufacturers (NAM):

*“[The Supreme Court]’s ruling does not change the fact that getting vaccinated is the best defense against COVID-19 and central to our ability to keep businesses and schools open and prevent our hospitals from being overwhelmed.... We call on all Americans to make the choice to get vaccinated, get boosted when eligible and wear the appropriate mask in public places—so that we can save lives, protect our economy and get through this latest wave of infection.”*

• Eric Hoplin, CEO, National Association of Wholesale Distributors (NAW):

*“We commend the Supreme Court’s decision to stay President Biden’s vaccine mandate. While we share the goal this mandate hopes to achieve, the reality is that this broad government overreach will have dramatic impacts on the economy, as tens of thousands of Americans quit their jobs rather than submit to the edict of government. Moreover, imposing testing requirements during a nationwide shortage of COVID-19 tests leaves businesses open to massive fines from the government. *Court. A deeply flawed opinion ignores law and precedent that clearly states OSHA's authority to protect workers from dangerous conditions. It's good to know that workers in federally-funded health care facilities will still have protections from COVID-19, but we cannot leave other workers defenseless against a deadly virus. OSHA can and should still require employers to meet their legal and moral obligation to provide a workplace safe from known hazards, which certainly includes infectious diseases like COVID-19."*

• Robert Weissman, president, Public Citizen:

*"The [Supreme Court] got things tragically wrong in concluding that OSHA's approach to regulating COVID-19 risk at work was not plainly within the scope of its statutory authority. OSHA's emergency authority is tailored exactly for circumstances like this. The direct result of this decision will be thousands of needless deaths and preventable*

*illnesses. Beyond the immediate effects of today's decision, it is important to note that the court acknowledged OSHA's broad authority to regulate occupational hazards, including workplace-specific risks related to COVID-19."*

• Ryan Bangert, senior counsel, Alliance Defending Freedom:

*"The Supreme Court correctly concluded that the federal administrative state has no authority to treat unvaccinated employees like workplace hazards and to compel employers to carry out the government's unlawful national vaccine mandate. The Biden administration's mandate would have a profoundly negative effect on those employers and the 80 million American workers who are affected, and that is why the Supreme Court was right to immediately halt its enforcement."*

# Are electric trucks ready for California's real world of work? It depends on the task

*By Jeff Quackenbush, The North Bay Business Journal*

Electric trucks big and small are key to automakers' and California's goals to cut emissions of climate concern from transportation, which contributes nearly one-third.

But are these vehicles up to the job? That all depends on what job they're doing.

Electric, hybrid and alternative-fuel passenger cars have been integrated into government and business fleets for well over a decade, but now major and startup automakers are rolling out all-electric versions of the light-, medium- and heavy-duty trucks commonly in use in North Bay vineyards, construction sites and production yards. And the manufacturers want to know if they're ready for hire.

One of the latest such trials is a widely publicized partnership Ford Motor Company launched on Jan. 26 with viticultural trade group Sonoma County Winegrowers. Three members – Bevill Vineyard Management, Vino Farms and Dutton Ranch – will be trying out the Michigan automaker's soon-to-be-released E-Transit vans and F-150 Lightning Pro pickups, along with charging stations and fleet-management software co-developed with Salesforce.

Those growers are the first Ford is working with to try out the pickups, and reservations for deliveries when available have been capped at 200,000, a spokesperson said. The electric vans are set to arrive at the Sonoma County pilot farms in May, with the test pickups set to arrive thereafter.

For Healdsburg wine grape grower Duff Bevill, the estimated mileage per charge of the F-150 Lightning Pro electric pickups and of the E-Transit cargo van would work for the tasks commonly undertaken by his conventional vehicles.

The pickup's standard battery has an estimated 230-mile range, going up to 300 with a larger battery. The van is expected to have a 126-mile range, according to a Ford spokesperson. However, a Car & Driver review of the pro-oriented pickup said its range could drop to 100-200 miles when towing a significant load.

That doesn't bother Bevill.

The company buys gasoline and diesel in bulk for the roughly three dozen trucks in the company fleet, which are a mix of half-ton pickups up to class 8 big rigs. The conventional half-ton pickups in the fleet have a range of 300-350 miles on a tank, and common tasks the vehicles are involved with are carrying hundreds of pounds of bagged fertilizer or packages of plastic vine ties from the supplier to a vineyard site.

The diesel big rigs handle the heavy-load tasks of hauling harvesters, tractors and other equipment as well as ferrying up to 22 tons of grapes from vine to winery crushpad.

And he's rarely seen a queue for refueling at the farm shop because pickups are coming back in during the day with dry tanks.

*"None of them I think will need recharging during the day," Bevill said of the electric pickups. "My foreman who meets crews at the job site may need to recharge once a week, and the guys using (the pickup) more frequently might charge two times a week."*

That limited use would allow the 240-volt level 2 charger Ford is installing as part of the pilot program enough to serve two pickups on overnight charges. The level 2 charger can replenish the pickup battery in about 12 hours, while a DC fast charger can do so in six to eight hours, according to Ford.

The Lightning Pro pickups also can act like a generator to power tools, and they are set to have an onboard scale to factor loads into range estimates and consumption statistics, a Ford spokesperson said.

Bevill is working on getting the pilot E-Transit, which is built on the F-250 chassis, configured as a passenger van instead of for cargo. The company currently uses conventional vans and a bus to ferry farmworkers from its dormitory to the fields.

The company has a fleet rotation schedule for the pickups of 200,000-240,000 miles, selling off vehicles before they need major items, namely a new engine. That results in three or four pickups being added annually, so Bevill is considering making one or two of the additions all-electric.

That calculus could be more appealing when comparing the sticker prices, he said. The Lightning Pro with a

standard battery lists for just under \$40,000, and \$49,000 with the larger module, with as much as \$10,000 off via federal and state tax credits. A conventional F-150 can list for \$45,000 and requires recurring maintenance costs such as oil changes.

Because Bevill's Healdsburg farm has a photovoltaic array that has consistently been generating more net power than consumed over its 10-year life, he is not concerned about a hit to his electrical system by installing a number of new chargers.

### Moon shot needed for electric big rigs?

While such agricultural uses of electric pickups and solar-offset charging appears within reach now, some operators of large trucks are concerned that the Golden State's bold plan to mostly decarbonize passenger and commercial vehicles by 2045 is being compared with the late President John F. Kennedy's moon challenge in late 1962:

*"We choose to go to the moon in this decade and do the other things, not because they are easy, but because they are hard, because that goal will serve to organize and measure the best of our energies and skills, because that challenge is one that we are willing to accept, one we are unwilling to postpone, and one which we intend to win, and the others, too."*

The state's largest trucking trade group is concerned that it could be facing another moon-shot-like deadline to reach a place where the technology to get there is still emerging. A decade and a half ago, state air regulators

called for emissions from large diesel engines to meet higher standards, but the engines for each more stringent tier of emissions hadn't yet been produced. And as a result, deadlines to meet those standards repeatedly were pushed back, and the changes called for retiring some vehicles from company fleets well ahead of their planned lifecycle.

*"If the truck and bus (diesel) rule was about going to the moon, we're now being asked to go outside the solar system,"* said Chris Shimoda, senior vice president of government affairs for the California Trucking Association. *"The vehicle technology needed to get there and massive buildout of charging infrastructure, with hundreds if not thousands of stations on a grid that quite frankly is not able to handle it."*

Last year, the California Air Resources Board finalized the advanced clean trucks rule, which calls for 70% of medium- and heavy-duty trucks in the state to move to hybrid or electric by 2035, and now the agency is set to finalize a draft this spring for the advanced clean fleets rule, which would expand such requirements to trucking companies.

What's challenging for the trucking industry is that medium- and heavy-duty trucks vary widely in uses and performance demands. For example, a class 5 truck like a panel van commonly used by courier and delivery services in a 100-mile radius of a hub where the vehicles return could be feasibly transitioned to electrics and eight- to 10-hour charging times over the next decade, according to Shimoda.

The problem comes with class 8 big rigs with large batteries and long, irregular routes. The fastest DC chargers today take four hours to charge these vehicles, and six to eight hours with smaller chargers.


*"A trucker can't afford to sit at a charging station for four hours,"* Shimoda said.

And then the scale of the chargers comes into play, even if they are paired with battery storage to round off the peak demand to the grid.

He pointed to this comparison: Chargers for passenger vehicles can be 25 to 50 kilowatts, so pairing several together at a station may call for a battery capable of discharging at 100 kilowatts or more. Chargers for larger trucks commonly start at 150 kilowatts then go up to 250 and 350 kilowatts or as much as 1 megawatt for fast chargers to fill up in 30-60 minutes. So if 10 250-kilowatt chargers were in a station, the accompanying battery would have to put out 2.5 megawatts.

*"I tell people that of the 400,000 class 8 semis in California if you plug in 10% of them – 40,000 – into megawatt chargers, that would equal the total state's (average) energy demand of 40 megawatts,"* Shimoda said. *"We're having a problem keeping the lights on with (public safety power shut-offs) and calls this past summer to save energy to keep the lights on."*

## How construction can attract today's workers and fill gaps in a growing industry

**Recruiting a new generation of construction workers requires a new approach.  
Here are insights to help you recruit today's more diverse workforce.**

Several years ago, the construction industry was faced with a looming concern: the overwhelming number of workers set to retire over the next decade. A study conducted in 2019 determined that 41% of the construction workforce at the time was expected to retire by 2031. This concern has shifted from a future thought to today's reality, as a large portion of retirement-aged workers have begun to leave their jobs.

Simultaneously, the industry is expected to continue to grow in 2022 and beyond, especially following the passing of the Infrastructure Investment and Jobs Act. Many new construction jobs are predicted to come from this new legislation as the country updates roads, bridges, and other vital infrastructure, leaving construction stakeholders

scrambling to figure out how to fill the positions that this growing industry demands.

### Recruiting a New Generation

Targeting the younger generations, especially Millennials and Generation Z, for recruitment is a potential solution. However, recruiting this younger population is not as simple as it may seem.

Millennials and Generation Z are the most ethnically diverse generations in US history and have grown up in the age of the internet and connectivity. They do not communicate in the same way as Generation X and Baby Boomers – those most often in hiring positions at large

general contracting firms. Methods that have worked for potential employee pipelines in the past are less effective at engaging young people and showing them the merits of a career in construction.

So how can your company adapt? Unfortunately, there is no cookie-cutter, plug-and-play strategy that will automatically churn out new recruits for you. It takes time, investment and internal changes. Consider the following to effectively recruit a younger, more diverse audience:

### **Is your culture conducive to minority success?**

With minorities making up most of the potential labor pool, it is crucial that construction companies invest in building a culture that can help them flourish. This goes beyond hiring a more diverse population to fill job openings. You need to create a framework within your culture that is healthy and ready to welcome diverse talent.

By performing internal company assessments, conducting team training and ensuring continuity of values from the top down, you can help foster a space that appeals to this younger demographic. Creating an inclusive culture demands involvement and commitment at every level of your company.

construction programs with a strong potential pool of workers. As a team, you should be thinking through what your construction company's presence at these institutions should involve and how to develop a relationship with the institutions' leaders. Establishing a relationship with the dean of the program for example could develop a key pipeline for you.

Having a presence in schools does not require only in-person engagements. A hybrid approach including in-person workshops and virtual speaking engagements could be a very effective strategy.

### How do you provide value with community involvement?

Presence in the community is good; but providing value in your interactions will help progress relationships and build up your pipeline. At schools, is there an opportunity for you to help update their curriculum in construction-related subjects so that students are learning applicable skills? Or maybe you can volunteer to lead a workshop during the school day to harness the curiosity of young minds.

You should also seek out community organizations that are involved with young people, especially if they are engaged with young Hispanic, black and female populations. Offer to speak on career opportunities or

provide hands-on experiences with these organizations. Since Millennials and Generation Z are more diverse than past generations, finding ways to meet these groups where they are and provide value to them can help you build relationships with potential candidates for future hiring.

### How can you engage the community through construction projects?


The most visible part of every construction company is worksites. Worksites provide ample opportunity to interact with people in a physical setting that showcases potential career opportunities.

Consider hosting site visits, virtual walkthroughs and work-based learning opportunities. Giving young people hands-on applications of skills can open their mind to the real potential that a career in construction could have. Think about how you can create exposure for your company while educating potential workers at your project sites.

### Do you have formal internship, mentorship and new hire programs?

You simply cannot fix a problem if you do not understand what caused it. For that reason, you should have metrics set

up to test the effectiveness of your internship, mentorship and new hire programs. This will allow you to evaluate the structures in place, the reach of your programs and your standard operating procedures. If the goal is to attract and retain young talent, then how you introduce the construction industry to them is important.

An easy way to analyze your practices is setting up a process for feedback. This will help you align leadership strategies with employee opinions. It also shows that you value the voice of everyone on your team, which is important to younger hires who want to know that they are not just a cog in the machine, but a valued member of the team.

# How COVID-19 is impacting construction workers

**Now, more than ever, construction workers need mental health support.**

*By Nicole Stempak*

Construction workers already struggles with addiction, overdose and suicide. Now, data shows how workers' mental health have fared during the COVID-19 pandemic.

The Center for Construction Research and Training (CPWR) took a deep dive into feelings of anxiety and/or depression in the January 2022 edition of its Data Bulletin.

Anxiety and depression have worsened during the pandemic, based on data from the National Health Interview Survey (NHIS) from 2011 to 2018 and 2020, which focused on self-reported symptoms, patterns and changes during the pandemic.

Researchers compared prevalence of anxiety and/or depression across worker demographics, socioeconomic status and certain health indicators. They noted that because of survey methodology changes in 2020 and fewer respondents during the pandemic.

## **Still, the findings are concerning:**

In 2020, 14.3% of NHIS respondents reported they had feelings of anxiety and 5.9% had feelings depression.

Between 2019 and 2020, 42.9% of workers reported feeling more anxious and/or depressed, including 37.3% who felt more anxious and 18.4% who felt more depressed.

Prevalence of anxiety and/or depression was highest in workers who were ages 18-34 years old (17.9%) compared with other age groups.

Anxiety/depression was also more common among certain categories of respondents: females (23.6%), non-Hispanics (18.1%) and those living in the Midwest or West (more than 19%).

Those who reported good, fair or poor general health were more likely to report anxiety and/or depression than those with excellent or very good health (18.6% versus 13.4%).

More than a third (36.3%) of respondents considered themselves not in very good or excellent health, and 27.8% were uninsured.

Nearly one in five (19.2%) of workers who drank heavily throughout the past year reported anxiety and/or depression compared to those who didn't (15.1%).

Workers who used prescription opioids in the past year were more likely to report anxiety and/or depression compared to those who didn't (38.8% versus 13.6%).

In 2020, 7.9% of survey respondents reported they lived below the poverty threshold. Prevalence of anxiety and/or depression was slightly higher in workers with a family income below the poverty threshold (18.4%) versus those at or above poverty (15.1%). However, anxiety and/or depression was lower in blue-collar workers (13.2%) versus white-collar jobs (21.4%).

## Capitol Connection Q&A for Contractors

Getting your contractor license doesn't end when you get a number. For some just qualifying can be the issue that holds them up in getting started, for others staying ahead of the paperwork and important dates in keeping the license stops them in their tracks! As I always advise clients keep your paperwork and address up to date and avoid problems ...

**Q:** I am looking into obtaining my own Contractor's license. I'm reading that I will be required to take a "Law" exam in addition to the trade exam. I'm not at all worried about the trade exam, I have been doing construction work most of my adult life, but the law exam has me a little worried! Is it one of those things that just sounds scarier than it actually is?

**A:** Well, I'll start by saying that I'm not a Contractor and have never taken the exam myself. BUT I have certainly assisted hundreds of contractors obtain their licenses, and

if you ask the test takers which exam is "harder" between the Trade or the Law, more often it's the Trade exam. The Law exam is testing your knowledge of Contractor business related matters such as contracts, finances, licensing requirements, job safety, etc. If you don't feel comfortable with the business side, it would just take a little bit of studying and you should be just fine.

**Q:** I sent my renewal in weeks ago and it shows on the Internet that my license has expired. Can I still legally work and pull permits?

**A:** NO, if your license is expired, you technically are not able to contract. Once the CSLB processes your application, it will show as "Active" and in good standing.

**Q:** My license is set to expire, and I can't find my renewal. I called the CSLB to order another one and they told me that they send them out by regular mail. I'm concerned that with the mailing time and processing time once I send it back, it will show Expired for a period of time. Anything you can do to help?

**A:** First of all, we can pick up one up for you in person if you authorize us to do so with a Power of Attorney. We can then email to you for signature and you can send it back to us with the State fee and we can deliver it for you. Secondly, I would recommend that just in case they don't process it in time, you request that the CSLB retroactively renew your license to the expiration date. They typically

do this anyway, as long as the renewal was submitted in a timely fashion, but at least you would have something on file making this request.

The organization also points out that there are obstacles to self-care which are:

- Lack of confidence in one's ability to make a change
- Depression
- Having more than one health concern If you want to boost your confidence, or if you struggle with a mental health disorder, seek support of family and friends, or talk to a qualified mental health provider
