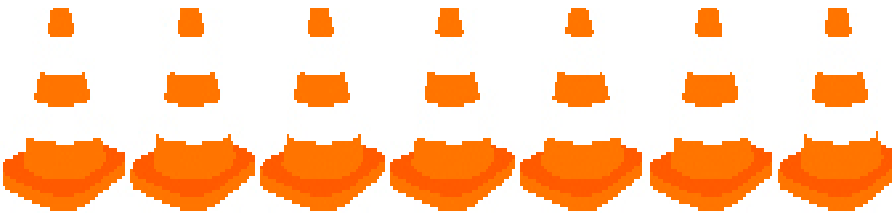

## **Residential contractors see a rebound on the horizon**

The building market should achieve stability in the months ahead despite the ongoing volatility of mortgage rates and construction costs, said Dietz. That should then lead to a rebound back to higher home construction levels later in 2023 and the beginning of 2024, he added.

The average 30-year fixed rate mortgage peaked at 7.08% in October, according to Freddie Mac. That has since declined to approximately 6.1% at the start of February. About 80% of builders said lower rates have positively impacted business, according to a HomeSphere and BTIG report on the residential market.

"Conditions continue to be sluggish overall," said Carl Reichardt, analyst with BTIG, a San Francisco-based financial services firm. "But we believe the environment is improving heading into the spring selling season."

Still, the 10-year Treasury rate has moved up more than 30 basis points during the past two weeks, indicating an increase for mortgage rates lies ahead, according to the NAHB report.

Nevertheless, while still below the breakeven line of 50, all three components of the HMI posted gains for the second consecutive month. Current sales conditions in February jumped six points to 46, while sales expectations rose 11 points to 48 and traffic from prospective buyers increased six points to 29.

"The nation continues to face a sizable housing shortage that can only be closed by building more affordable, attainable housing," said Alicia Huey, NAHB chairman. "However, the two monthly gains for the HMI at the start of 2023 match the cautious optimism noted by the large number of builders at the recent International Builders' Show in Las Vegas, who reported a better start to the year than expected last fall."

### **Other noteworthy data in the NAHB report show:**

- 31% of builders reduced home prices in February, down from 35% in December and 36% in November.
- The average price drop in February hit 6%, down from 8% in December and tied with 6% in November.
- 57% of sellers offered some kind of incentive in February, down from 62% in December and 59% in November.

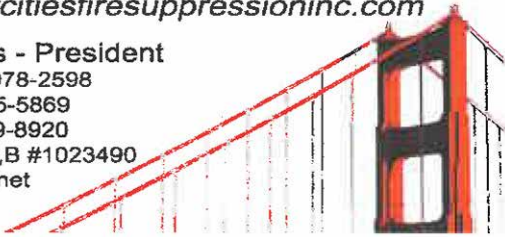

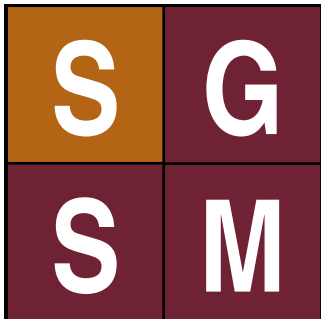

## **Leap Solutions - HR Corner**

### **Creating a Drama-Free Culture at Work**

We've all experienced, and perhaps even contributed, to workplace drama. You know what I mean, gossip, rumors, complaints, emotional outbursts about perceived wrongs, purposely excluding others for petty reasons, and the list goes on. No matter how drama manifests, it is destructive, and leaders must take a no-tolerance stance on drama in the workplace.

Being in the drama zone is not uncommon. It can stem from our brain's chemical response to perceived danger. Fear and anger rise, we get defensive, and we double down on being right. At this point, we're firmly in the drama zone. As leaders, we must check our egos before we attempt to engage others. People who are prone to emotional drama are also super-sensitive to ego and emotions in their leaders and peers. Countering drama with more emotion is not productive.

To this end, knowing when we're in the drama zone is the first step to shifting ourselves and our teams into the drama-free zone. This shift is the move from defensive to curious, from wanting to be right to wanting to learn, and from fighting for the survival of the individual ego to relating from a place of security and trust. This shift first requires a degree of emotional intelligence, realizing what we're feeling (angry and/or scared), and then taking a moment to pause before reacting.

The following can help create a drama-free culture at work:

- **Model taking responsibility:** Blame, shame, and guilt all come from fear. This fear drives the victim-villain-hero triangle, which keeps leaders and teams in the drama zone. Conscious leaders and teams take responsibility, instead of placing blame. Instead of asking who's to blame, ask, "What can we learn and how can we grow from this?" This creates huge growth opportunities on a personal and organizational level.
- **Commit to drama-free living:** At any point, we can decide to be in the drama-free zone of openness, curiosity, and commitment to learning, or we can dip into the drama zone of defensiveness and a resolute commitment to being "right." Being "right" doesn't cause drama, but wanting, proving, and fighting to be "right" does. Even though conscious leaders and

their team members get defensive occasionally, they regularly interrupt this natural reaction by pausing to shift into the drama-free zone.

- **Commit to ending gossip:** Gossip is a statement about another made by someone with negative intent or a statement the speaker would be unwilling to share in the same way if that person were in the room. People gossip to gain validation, control others and outcomes, avoid conflict, get attention, feel included, and make themselves right by making others wrong. In short, people usually gossip out of fear. When leaders and teams learn to speak candidly and directly with each other, they benefit from direct feedback about issues within the organization that otherwise could derail creative energy and productive collaboration.
- **Insist on accountability for results:** Hire and reward people who accept personal accountability. Continually develop accountability through coaching and mentoring. High-performing companies formalize these coaching and mentoring programs, and apply them universally, rather than initiate them only to solve specific problems. However, if an individual loves drama and chaos and cannot embrace a drama-free work culture, it is our job as leaders to deal with them in a way that keeps our organization from being sucked into their drama.

Controlling drama and creating a drama-free culture are essential components of a positive and productive work environment. By taking responsibility rather than placing blame, committing to the drama-free zone rather than being "right," speaking to others candidly and directly rather than gossiping, assuming the best intent rather than the worst, and being personally accountable for our actions, we can help prevent and manage drama in the workplace.

## **Make Your First Impression Count**

**Whether over the phone or in person, how you and your employees greet customers can have a significant effect on business.**

You've heard the saying, "You only have one opportunity to make a first impression." While it may be a cliché, it is true. A positive first impression is an important start to building a relationship with your customers. Whether the interaction is over the phone or in-person, the initial impression can set the tone for the entire customer experience.

### First impressions delivered by phone

Your greeting is a simple step, but it is too often overlooked. It is your first opportunity to make a positive impact on the customer. Consider these two phone interactions:

#### **Example 1**

Inside sales coordinator: "ABC Rentals, how can I help you?"

Customer: "I need to rent a backhoe for a week."

Inside sales coordinator: "OK, what size backhoe?"

#### **Example 2**

Inside sales coordinator: "Thank you for calling ABC Rentals, this is Barry. How can I help you?"

Customer: "I need to rent a backhoe for a week."

Inside sales coordinator: "Great, I will be happy to help you with that. May I get your name please?"

The differences might seem slight, but are actually significant. The personalization in the second example takes almost no additional time, but it can leave a significant impact on your customer. Use a greeting that will make a difference and set you apart from your competition, making certain your customers know they called the right place.

A phone greeting should contain the following:

- A "thank you" for calling
- Your company's name
- Your name
- An offer of assistance

If the call is transferred to you, you do not need to repeat the company name. For example, you can say, "Thank you for holding. This is Barry in rental, how may I help you?"

The tone of voice also is important when answering the phone. I am sure you've heard the saying, "It's not what you say, but how you say it." When communicating over the phone, 86 percent of the impact is in your tone, and 14 percent of the impact is based on your words.

### First impressions delivered in person

View your store as a customer would view it. What type of impression are they taking away? Even before you greet your customers they will have already developed an opinion about your business, simply based on environment. In the assessment of your physical business, consider the following:

- Appearance of your store: Is the floor clean; shelves orderly Condition of your parking lot: Is it free of trash, well landscaped and maintained?
- Signage: Is it easy to read and follow?

Do everything you can to create a welcoming and pleasant experience. Your store's appearance and curb appeal is another way to stand out from your competition. It's all part of the customer's impression.

Once your customer enters the store, they should be greeted immediately - within three seconds. If you or your employee is with another customer, the initial greeting may need to be, "I will be with you in a moment," but you should still

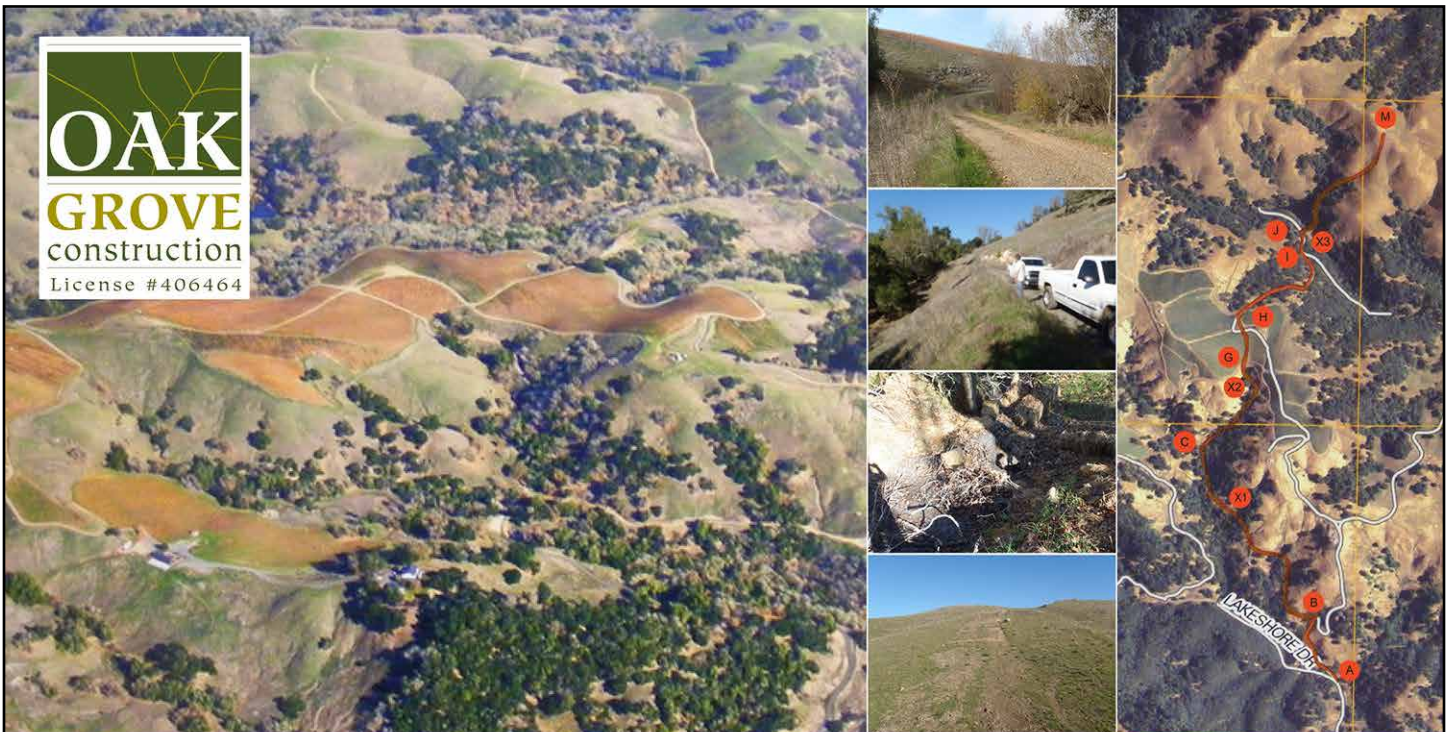
immediately acknowledge the customer and make him/her feel welcome. When you enter a store, you probably feel disappointed if you are ignored. Your customers have the same emotions. Make sure your staff immediately engages them.

When you speak with the customer, your conversation should be sincere, confident and personal. For example, "Welcome to ABC Rentals, my name is Barry. How can I help you?" That is much more effective than glancing at the customer or a simple, "How can I help you?"

In addition to a great greeting, consider the following for your staff:

- Appearance: Shirts should be tucked in, employees should wear the correct uniform, and cleanliness is a must.
- Smile: It shows the customer you are happy they are there and you are ready to help.
- Eye contact: This signals acknowledgement, connection and attention. Without eye contact, people are not encouraged to share their information.

You also may want to consider shaking the person's hand or moving from behind the counter to greet the customer. This is your chance to leave a lasting impression. When we communicate in person, 55 percent of the impact is made with body language, 38 percent with tone and seven percent with words. of impression are they taking away? Even before you greet your customers they will have already developed an opinion about your business, simply based on environment.

### Make first impressions a priority

The challenge in the rental world is that you often hire people with a technical and operational background. They are hard workers and strong contributors to your company. However, some lack the customer service and sales skills needed to deliver that positive and memorable first impression.

Here are some simple techniques to ensure a memorable and consistent impression throughout the organization:

- Script a greeting: Make certain all employees know what to say. This creates consistency. For the phone greeting, place the script next to the phone.
- Practice or role-play: Act out both the phone and in-person greeting. These practice sessions help employees learn the greeting and reinforce how important it is to your company.
- Set an example: If you are the manager, make certain your employees observe you using the right greeting and setting the right tone.
- Provide feedback: When you hear employees delivering a great greeting, let them know. Coach them if they are not following company standards.
- Measure the results: Mystery shop employees to see how they are performing. Keep looking for ways to improve.

In addition, you should talk to some of your regular customers and ask them for feedback. They may recognize areas of improvement you do not see. They'll appreciate being acknowledged as an important contributor to your business.

Your first impression may seem simple enough, but it does make a difference. It is a great way to stand out from the competition and get a relationship started on the right track. Don't leave the first impression to chance - set your team up for success.

## **OSHA to issue special visas to immigrant workers during criminal investigations**

The U.S. Department of Labor will give the Occupational Safety and Health Administration the authority to issue special visa certificates to noncitizen workers at worksites where certain criminal activities are being investigated, the federal agency said in a Feb. 13 notice.

Effective March 30, OSHA will be able to issue "U visas" and "T visas" during its workplace safety investigations if workers are victims of specific criminal activities, such as manslaughter, trafficking, extortion, felonious assault, forced labor and obstruction of justice, to allow them to assist law enforcement, DOL said. U nonimmigrant visas are granted to victims of qualifying criminal activities who have experienced physical or mental abuse, while T nonimmigrant visas are issued to victims of human trafficking.

"Workers in the U.S. need to feel empowered and able to trust OSHA and the U.S. Department of Labor enough to voice their concerns about workplace safety regardless of their immigration status and fears of retaliation," Assistant Secretary for Occupational Safety and Health Doug Parker said in the notice. "By enabling OSHA to issue U and T visa certifications, we will be empowering some of our economy's most vulnerable workers to tell us if their jobs are jeopardizing their safety and health, and that of their co-workers, and to support our enforcement efforts."

OSHA's new authority is the latest in a series of federal actions intended to protect immigrant workers.




The U.S. Department of Homeland Security


on Jan. 13 announced a policy that grants "noncitizen workers who are victims of, or witnesses to, the violation of labor rights" case-by-case protection from "threats of immigration-related retaliation from the exploitative employers," DHS said. Affected workers can request a deferral of deportation.

And in July 2022, DOL released guidelines that protect undocumented workers who file labor disputes from deportation.

The National Council for Occupational Safety and Health, a worker safety advocacy organization, said the new OSHA authority is "a step forward" for immigrant workers.

"Protecting workers who are witnesses to illegal workplace abuses not only means workers can be treated fairly, it also creates a level playing field for employers," Marcy Goldstein-Gelb, co-executive director of National COSH, said in a news release. "Companies that provide a safe workplace, use above-board hiring and recruitment practices and pay workers what they are owed should not have to compete with those who break the law to gain an unfair advantage."

## **Construction's labor gap tops 500,000**

The construction industry's outlook for labor is bleak. In order to meet demand, contractors will need to hire an estimated 546,000 workers in 2023, and that's in addition to the industry's normal pace of hiring, according to a new analysis by Associated Builders and Contractors.

In 2022, the industry averaged more than 390,000 job openings per month, the highest level on record. Construction's unemployment rate of 4.6% for 2022 was the second lowest ever, indicating there are few construction workers seeking jobs, and therefore the pool to fill demand is shallow.

ABC predicts demand for labor to increase by 3,620 new jobs for every \$1 billion in new construction spending, on top of the current, above-average job openings.


The problem with the high demand is not just the large shortage of labor, but a skill shortage, said Anirban Basu, ABC's chief economist in the release. The struggle to hire and retain workers is especially dire, as the workforce increasingly reaches retirement age. Few younger workers join the workforce, and when they do, they are less experienced and therefore less efficient.

"With nearly one in four construction workers older than 55, retirements will continue to whittle away at the construction workforce," said Basu in the release. "Many of these older construction workers are also the most productive, refining their skills over time. The number of construction laborers, the most entry-level occupational title, has accounted for nearly 4 out of every 10 new construction workers since 2012."

At the same time, Basu said, the number of workers with licensed skills have grown at a much slower pace, or, in the case of jobs like carpenters, actually declined in the last decade.

Demand and funding for megaprojects such as chip manufacturing plants, clean energy facilities and infrastructure will continue to make the problem worse — though construction is seeing money pouring into projects, it means more work to find the people to build them. And it won't get much easier.

ABC predicts that in 2024, the industry will need to hire 324,000 new workers on top of its normal pacing, and that assumes construction spending slows significantly.

## Is This the Year We Learn How to Teach Gen Z?

Whatever ideas one might have about Gen Z (those born between 1997-2012), exhaustive research done by Roberta Katz, senior researcher at Stanford University's Center for Advanced Study in the Behavior Sciences, has uncovered interesting traits that safety professionals should be aware of.

What she finds most surprising, as noted in an interview with Stanford News, is that when asked what type of communication Gen Z prefers, nearly all respondents answered that they prefer "in person."

In fact, a previous study from talent recruiting firm Bridgeworks found that 40% of Gen Zers want daily interactions with their boss and think they've done something wrong if they don't have these interactions. I would venture to guess that older generations would think something is wrong if their bosses want to talk to them that much.

This face-to-face preference might be derived from the more collaborative way Gen Z employees work, which presents an advantage for savvy safety managers, who tend to be older than their employees and are more comfortable with in-person interactions.

Katz offers this advice: "Both the older and younger colleagues can learn from the other, in each case by listening with more respect, appreciation and trust. The older colleague can learn some helpful new ways of getting a job done, while the younger colleague may learn good reasons for why things have long been done in a certain way."

We can see examples of this two-way learning process as emerging technology, such as video and augmented reality (AR), is being used by safety leaders to bridge the generation gap to enhance training efficiency. I have spoken with several employers who have found that by using these techniques, older colleagues feel appreciated that their knowledge is being codified this way, while younger colleagues appreciate the opportunity to learn through video.

Experience-based learning, as opposed to classroom learning, is the route preferred by Gen Zers. In a study conducted by Barnes and Noble College, 51% of Gen Z respondents said they learn best by working through examples. Seeing things done was the preferred learning method for 38%, while only 12% chose listening to a lecture.



## **Is This the Year We Learn How to Teach Gen Z?**

And learning on the job is important to Gen Zers as well. A study done by ECMC Group of 5,000 high school students, conducted between February 2020 and January 2022, found that students are moving away from the traditional route of waiting to work following the completion of a four-year college degree. They are often opting to complete training that requires less time or on-the-job training. And when choosing an employer, they will often opt for one that offers reimbursement for four-year degrees.

Here are some specific findings of that survey:

- Nearly one-third of teens prefer that their post-high school education lasts two years or less.
- More than half of teens are open to something other than a four-year college, and nearly half believe they can achieve success with education attained in three years or less.
- Most teens prefer learning hands-on skills either in a lab/classroom or through on-the-job experiences.
- Most teens understand the importance of gaining marketable skills and learning throughout their lifetime.

This group not only understands the necessity of lifetime learning but uses it as criterion when choosing employers, according to research from Robert Half. “Gen Z professionals are highly motivated by development and learning opportunities,” the Robert Half study concludes. The survey found that the top three reasons Gen Zers chose an employer are:

- Career development opportunities.
- A manager they can learn from.
- Professional development and training.

Technology of course is how this generation prefers to gain access to knowledge. In a survey by Kahoot, when asked what training tools they wanted at their workplace, 65% of Gen Zers said mobile apps, 48% said online learning tools, 39% said videos, and 34% preferred social media.

This generation’s emphasis on learning might prove, once and for all, how truly smart they are. And it’s good news for safety professionals looking for the best ways to their workers are actively engaged in the training process.

## Capitol Connection Q&A for Contractors

Answers are not always yes, or no. Sometimes, it depends! Let's talk stress reduction with a qualified answer for one contractor and end the drama for another...

**Q:** I am interested in selling my contracting business. If I sell, do I keep my license number, or does it go with the sale?

**A:** It depends on whether it's a stock sale or an asset sale. In a stock sale, the contractor's license goes to the buyer and the buyer just makes the appropriate changes (if necessary) to the license. With an asset sale, the buyer is required to obtain a new license. In which case, what happens with your existing license depends on the buy/sell agreement and such. You can give me a call to discuss this further if you'd like.

**Q:** You recently helped us with replacing our Qualifier after our previous Qualifier passed away unexpectedly. It was a close call so to speak, but thanks to the extension request, we were able to complete the process with no lapse in licensure. Are we permitted to now add a second qualified employee to the license just in case something similar were to occur again? We went through several weeks of being on edge worrying we would be out of work with a suspended license and prefer to not go through that stress again!

**A:** While you can only have one Qualifier per classification on a license, you are able to have your employee(s) obtain their own personal "back-up" license as a Sole Proprietor. That will allow them to go through the approval process, testing, and fingerprinting so that they can immediately jump on to the company license if you run in to another emergency situation.

**Q:** We are finding conflicting information on an issue that we hope you can help with. I have recently been hired on with a company who wants to use me as a Responsible Managing Employee or RME. I have a corporation that I'm the Responsible Managing Officer or RMO on. I've read where I can be an RMO on up

to three licenses, and also read about the requirement to dedicate at least 32 hours per week as an RME. My thought is to keep my corporation active and then at the same time be the RME for the company license because I am already working more than 32 hours per week with them. However, the company is telling me I'm going to have disassociate or inactivate my corporation license in order to become their RME. Can you clarify?

**A:** The company is correct. An RME can only be active on one license at a time. There are a few situations that allow for an RME to be on two licenses at the same time, but your particular case is not going to meet this limited exception.

Each bid shall be accompanied by cash, a cashier's or certified check, or a bidder's bond executed by a surety licensed to do business in the State of California as a surety, made payable to the District, in an amount not less than ten percent (10%) of the maximum amount of the bid. The check or bid bond shall be given as a guarantee that the bidder to whom the contract is awarded will execute the Contract Documents and will provide the required payment and performance bonds and insurance certificates within ten (10) days after the notification of the award of the contract.
4. The successful bidder shall comply with the provisions of the Labor Code pertaining to payment of the generally prevailing rate of wages and apprenticeships or other training programs. The Department of Industrial Relations has made available the general prevailing rate of per diem wages in the locality in which the work is to be performed for each craft, classification or type of worker needed to execute the contract, including employer payments for health and welfare, pension, vacation, apprenticeship and similar purposes. Copies of these prevailing rates are available to any interested party upon request and are online at <http://www.dir.ca.gov/DLSR>. The Contractor and all Subcontractors shall pay not less than the specified rates to all workers employed by them in the execution of the Contract. It is the Contractor's responsibility to determine any rate change.
5. The schedule of per diem wages is based upon a working day of eight hours. The rate for holiday and overtime work shall be at least time and one half.
6. The substitution of appropriate securities in lieu of retention amounts from progress payments in accordance with Public Contract Code §22300 is permitted.

7. Pursuant to Public Contract Code §4104, each bid shall include the name and location of the place of business of each subcontractor who shall perform work or service or fabricate or install work for the contractor in excess of one-half of one percent (1/2 of 1%) of the bid price. The bid shall describe the type of the work to be performed by each listed subcontractor.
