USGBC Releases its top 10 states for LEED, recognizing leaders committed to more sustainable and resilient buildings, cities and communities

The U.S. Green Building Council (USGBC) announced the ranking of its annual Top 10 States for LEED, with Illinois once again topping the list and demonstrating leadership in green building. Illinois certified 3.16 square feet of building space per person under LEED in 2021. LEED is the world's most widely used green building program and was created by USGBC as a leadership standard defining best practices for healthy, high-performing green buildings.

"Amidst the challenges of 2021, governments, companies and other organizations committed to taking bold actions to protect the climate, their employees and their communities," said Peter Templeton, president and CEO, USGBC. "Transitioning our buildings to be healthier and more sustainable is essential to meeting these commitments, and we're proud to recognize states where that work is well under way."

In 2021, the top 10 states, plus the District of Columbia, certified 1,105 projects and more than 247 million gross square feet under LEED. Washington, Massachusetts, Colorado and Virginia round out the top five, and Utah made an appearance on the list for the first time since 2015.

Despite Washington, D.C., not appearing in the official top 10 list because of its status as a federal territory, it consistently leads the nation in LEED-certified square footage per capita. In 2021, the nation's capital certified 29.46 square feet of space per resident across 103 green building projects.

Notable projects that were certified in 2021 include:

Hines VC Project 20 in Chicago achieved LEED Gold; Hines has over 90 million square feet that have certified, pre-certified or registered under LEED.

Union Station in Seattle received LEED Platinum certification and was the highest Platinum-level project of 2021 in Washington state.

Harvard University Science and Engineering Complex in Allston, Mass., received LEED Platinum certification and was also a regional award recipient at USGBC Live for outstanding design and long-term sustainability focus.

The Denver Water OCR campus of eight buildings achieved LEED certification at various levels: LEED Platinum (1), LEED Gold (5) and LEED Silver (2),

The Government Services Administration facility in Winchester, Va., achieved LEED Gold under LEED v4, as well as SITES v2 Silver certification and Guiding Principles Compliance, becoming the first project to certify across all three programs.

1500 Mission Residential in Los Angeles is an affordable and low-income housing project with a rooftop park and wellness features that achieved LEED Gold certification.

Glenstone II Art Museum in Potomac, Md., just outside of Washington, D.C., achieved three LEED certifications: LEED Gold for the café, Platinum for the arrival hall and Gold for the museum itself.

Porter Portland Hotel in Portland, Ore., achieved LEED Silver certification and became the first hotel in the U.S. to certify under LEED 4.1.

Outpatient Clinic and Cancer Center in Provo, Utah, achieved LEED Silver.

The City Of Las Vegas Municipal Courthouse was certified LEED Silver.

The 2021 World Green Building Trends report from Dodge Data shows that green building remains a global priority and commitment to sustainable building is strong. LEED provides a framework for designing, constructing and operating buildings that are cost-effective, reduce greenhouse gas emissions, use fewer resources and support human health. The overall growth in LEED certification reflects the increased global adoption of corporate and institutional ESG goals and reporting.

“Green building is projected to continue its rapid growth in 2022, and USGBC remains focused on supporting further market transformation and innovation,” Templeton added. *“It is particularly encouraging to see policy leadership at all levels of government promoting green building practice and performance—from the*

federal Infrastructure Investment and Jobs Act to local code enhancements. USGBC will continue to support efforts in all sectors to accelerate progress and increase accountability for creating sustainable, healthy, resilient and equitable buildings and communities.”

USGBC calculates the top 10 list based on 2020 U.S. Census data, using per capita figures to allow for a fair comparison of the level of green building taking place among states with significant differences in population and number of overall buildings. The data includes commercial and institutional green building projects certified to LEED between Jan. 1 and Dec. 31, 2021.

Featured speaker at WIC Week brings a fresh perspective on women in construction

Doreen Bartoldus can remember the first time she heard of WIC Week after joining the National Association of Women in Construction (NAWIC) in 2004. *"Someone asked if I knew about WIC Week and I was like, 'What week?' But I haven't missed one since."* WIC Week is short for Women in Construction Week, a national series of events that recognizes the roles of women in the construction industry. Bartoldus is now the Board President for NAWIC, the organization that launched WIC Week in 1998, and she will be a featured speaker this year during WIC Week events March 6-12.

Bartoldus's construction career spans four decades. She started out working for contractors while earning a civil engineering degree at night, and later added an MBA in sustainable business. But she also came

to realize that she didn't want to sit behind a desk all day. *"I grew up in a family of carpenters and masons,"* she says. *"From a young age I was playing with bricks, concrete and sand. I wanted to be outside on the job site."* Today, Bartoldus is a construction manager for Jacobs NYC, specializing in water and wastewater projects.

Those early WIC Week events made a lasting impression. *"I remember being in awe of some of the women who spoke or made presentations at WIC Week events,"* she recalls. *"They had accomplished so much against the odds of a male-dominated industry. It made me see what was possible and inspired me to continue the work I do through NAWIC."*

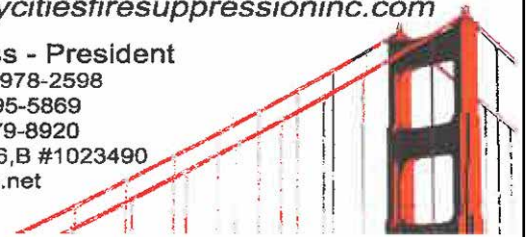

After a few years of attending WIC Week, Bartoldus began taking a leadership role in WIC Week events as part of the annual New York Build expo. She became a moderator and encouraged other NAWIC local chapters to participate. Now, as president of NAWIC, the boot is on the other foot, so to speak. She is a featured speaker and panelist for New York Build 2022, which has goal this year to have 50 percent female speakers.

Bartoldus is excited to be one of them. *“I’m really focused this year on a topic that is important to our industry and to our society—diversity, equity and inclusion. My presentation is entitled ‘Envision Equity’ and will focus on the important role of women in construction in the future, specific career paths that women can take to advance their careers, and how gender and racial diversity are critical to building a dynamic construction industry workforce.*

“The theme is meant to not only highlight the accomplishments of female architects, tradeswomen, general contractors, executives, apprentices or any woman in the industry, but also to create action plans on how to make female representation in construction the norm rather than the exception,” she added.

The construction industry is currently about 11 percent female, and attracting young women to the profession is a major goal for Bartoldus. *“We’ve seen WIC Week really getting younger women to learn more about possible careers in construction,” she says. “Over the years, WIC Week has grown to be a nationally known event. I’m proud to be a part of it.”*

About NAWIC

The National Association of Women in Construction (NAWIC) originated as Women in Construction of Fort Worth, Texas. Sixteen women working in the construction industry founded it in 1953 to create a support network for women in construction-related jobs. Today, NAWIC is still based in Fort Worth and has 118 chapters throughout the United States that provide professional development, education, networking, leadership training and public service.

Hoarding, ghost orders and pop-up warehouses: construction's new supply chain playbook

Few old-timers can remember searching harder for roofing materials, bar joists or steel pipe. Prices for essential parts like these have risen by at least 50% in a year, and delivery dates are at least as long, if not twice. To survive, some contractors have resorted to hoarding.

Contractors are jockeying to get supplies before competitors. Cash is king. Credit is rare. And price quotes expire in as few as five days.

Reverberations across the supply chain mean contractors are scrambling to have every last nail and screw they need before turning dirt. They're renting or building warehouses to stockpile supplies. They are putting in "ghost orders," creating tensions with suppliers who need to protect relationships with loyal customers.

"It's as bad as any time during COVID," said Erin Roberts, who leads Ernst & Young's global construction and engineering practice. "You've got all this demand after a brief pause shutting down the supply chain, and it's just causing havoc."

Supply shortages, worsened by surging demand, have led to the largest annual spike of input prices to construction since 1987, when data collection began.

On average, input prices for nonresidential construction surged more than 24% over the past year, according to an

analysis of the U.S. Bureau of Labor Statistics' Producer Price Index by the Associated Builders and Contractors.


"Inflation remains hot, hot, hot," said Anirban Basu, ABC's chief economist. "There is effectively no relief in sight for the nation's contractors" this year.

The Associated General Contractors of America spelled out the pain in numbers:

Construction pros are playing diplomat, struggling to manage owners' expectations as bills for materials and storage mount.

"I'd rather be looking at it, than looking for it," said Peter Tuffo, president of Boston-based Suffolk Construction's South Region, about his construction supplies. "We're at the point now where we're warehousing materials, and getting them wherever we can. If you have to move it twice, you move it twice. But you know what? That cost of moving it twice is much less than having no work to put in place for that month."

Long lead times

Chris Bailey, senior vice president of integrated solutions at XL Construction, counts the pain in months, ticking off materials in shortest supply on the West Coast.

"We recently learned that the lead time for acquiring open bar joists has pushed into 2023," said Bailey, from his headquarters in Milpitas, California. "Beyond that, lead times for a wide array of materials that were commonly known to be weeks pre-pandemic have turned into months."

His most challenging materials and lead times include:

Roofing and roof insulation (8 - 10 months)

Steel bar joists (8 - 10 months)

Metal decking (8 - 10 months)

Aluminum windows and window curtain walls
(6 - 12 months)

Precast concrete wall panels (6 - 10 months)

Structural steel (6 - 8 months)

Metal studs and cold formed metal framing
(2 - 4 months).

Roofing materials are as scarce as hen's teeth

Granger Hassmann, vice president of preconstruction at Minneapolis-based Adolfson & Peterson Construction, put it bluntly: "The entire roofing industry is just an absolute mess right now. It's ridiculous. The manufacturers aren't even providing competitive pricing. They won't give you a bid until you actually order it."

Ethylene propylene diene terpolymerany (EPDM) rubber roofing membranes, widely used on commercial buildings, are nearly impossible to find.

"Everything is becoming more difficult to source, including any products with the word 'poly' in them," said Paul Moffat, vice president of preconstruction at Detroit-based contractor Barton Malow.

Where's all the warehouse space?

Firms foraging for materials and trying to store them has led to another shortage.

"The market for warehouse space is so tight around the country, you almost have to sign a lease before or during

construction to secure it ... We've been reaching out to empty big-box retail centers to help bridge the gap," said Amy Rodbell, a broker in the Atlanta office of commercial real estate consultancy Newmark.

To survive, some contractors are building their own warehouses.

"They're erecting temporary structures on or near jobsites to house materials before they're needed. That can remove most or all of the attempted cost savings by pre-purchasing," said Jacob MacIntyre, director of the customer acceleration group at Quickbase, who focuses on the construction market.

That's flipped the construction industry's lean business model upside-down.

"Everybody realized that instead of just in time, we needed just in case," said Ernst & Young's Roberts.

'Ghost'-order busters

Jake Romano, a manager at a residential plumbing contractor outside Toronto, Canada, struggles to get everything from toilets to PVC piping.

"Some of our competitors have bought up nearly every toilet they can get their hands on. These guys have their warehouses filled to the brim," Romano said.

Manufacturers are reacting by tethering sales.

"That's the new world way of saying I can't get you everything you want," said Chris Fitzgerald, global vice president at Downers Grove, Illinois-based chemical and sealants giant Univar Solutions, which supplies some of those hard-to-get "poly" products. If a product is limited, he might only give clients 70% of last year's order.

"Manufacturers are pushing back and asking for project-specific information so they don't have a bunch of ghost orders down the line."

Further down the supply chain, mid-level suppliers are policing against "ghost orders," when contractors put out multiple bids for a single product.

The solution? Starting sooner, working longer

In response, contractors kick off the preconstruction phase of their projects as much as 18 months ahead of groundbreaking, almost a year earlier than normal.

"We're telling our owners that once we start, we can still build their job in 11 months, but we can't start it right away, because after a couple months on site, we'd have to stop and wait for steel," said A&P's Hassmann.

Now, those months are spent gathering supplies.


"You're spending the first two months ordering to get material there so it's on site, or in a bonded warehouse, or in storage bins," Hassmann said. "Wherever you can put it just to make sure you've got it and it's captured."

When the current supply chain snarls will end is anyone's guess.

ABC's Basu said, "It may seem naive given current data readings, but the expectation remains that, at some point later this year, construction materials prices will moderate."

But others caution that as one shortage lessens, another gets worse. They see little relief before the end of the year or next.

Construction faces over half-a-million-worker shortage

- Construction needs more than half a million workers above its current pace of hiring in order to meet demand in 2022, according to an analysis released Wednesday by Associated Builders and Contractors. Predictive models from ABC indicate the industry needs 650,000 additional workers.

- For every \$1 billion in additional construction spending, construction gains 3,900 jobs, ABC found. As massive infrastructure spending enters the pipeline, the industry will have a lot of hardhats to fill.

- Anirban Basu, chief economist for ABC, described the workforce shortage as the “most acute challenge” the industry faces, even in the face of sluggish spending growth.

“After accounting for inflation, construction spending has likely fallen over the past 12 months,” Basu said in a release. “As outlays from the infrastructure bill increase, construction spending will expand, exacerbating the chasm between supply and demand for labor.”

An estimated 1.2 million construction workers will leave for other industries in 2022, ABC found, but an anticipated 1.3 million will offset that departure — leaving other industries for construction. Nevertheless, the age of the workforce raises concerns, as fewer young workers join and stay on jobsites, and veterans of the industry retire.

The number of workers ages 25-54 dropped 8% over the last decade, while the number of older workers has increased proportionally.

“According to the Centers for Disease Control and Prevention, the industry’s average age of retirement is 61, and more than one in five construction workers are currently older than 55,” Basu said.

The number of entry-level laborers has increased 72.8% since 2011, Basu said, while the total number of workers has grown by less than 25%.

“The roughly 650,000 workers needed must quickly acquire specialized skills,” Basu said. “With many industries outside of construction also competing for increasingly scarce labor, the industry must take drastic steps to ensure future workforce demands are met.”

ABC CEO Michael Bellaman emphasized how construction workers will be essential to fulfill the projects associated with the \$1.2 trillion Infrastructure Investment and Jobs Act. He railed against regulations attached by the Biden administration.

Some of those regulations include President Joe Biden’s recent executive order mandating the use of project labor agreements on federally funded construction projects over \$35 million.

“More regulations and less worker freedom make it harder to fill these jobs,” Bellaman said in a statement.

Capitol Connection Q&A for Contractors

Never ‘wonder’ when you can always know by asking! Assisting contractor understanding of licensing is what we do best. How ‘two’ can become ‘one’ Qualifier is tricky, but not like pulling a rabbit out of a hat! However, ‘magic’ won’t help in saving our last ‘contractor’ but I do know how to help going forward ...

Q: I was wondering if you could help point us in the right direction. We’re trying to decide what is the best and easiest way to expand as a company. We’re not sure if it would be better to hire a Responsible Managing Employee (RME) with the desired license, or to do a Joint Venture? Our company is structured as a Corporation and the other company is a Sole Proprietor. Our Company is a “C-10” (Electrical) license holder but we are needing the “B” (General Building) license.

A: A Joint Venture is a separate license made up of two licensed entities. The reason you would do a Joint Venture is usually to do separate projects outside of the projects that each license holder is doing on their own. If you are wanting to operate as just the corporation, that’s where you would just add the desired licensed sole owner license holder to the Corporation with their classification.

Q: Do you know which application I would need to fill out to become an RME for two companies? I’m currently licensed as a RME with my Employer, but I also want to be licensed for my own business. Both are corporations. Could my employer own 20% of my company which would allow for me holding two licenses?

A: The application you would need to complete to become the Qualifying Party on a second license would be the Application for Original Contractors License Waiver. We can assist you with the completion and submittal if you’d like. And yes, one licensed entity owning at least 20% of the other licensed entity allows an individual to qualify both active licenses at the same time.

Q: I paid approximately \$250,000 to a general-contractor entity for construction services. The entity itself does not have a contractor license. One of its Officers does have a license, but it is a “Sole Ownership” or personal license. Is that sufficient for the entity – a corporation – to be considered licensed? Does that make him the “Responsible Managing Officer (RMO)” and, if so, does that mean the ‘contractor’ entity is effectively licensed, or does that just mean that the entity can apply for a license based on this Officer’s license?

A: The latter is correct. The individual license of an officer of a Corporation is not sufficient for the Company/ Corporation to be doing contracting work. The Corporation

needs to have a license in the name of the entity if that is how they are conducting business. The Company can apply for a license and use that Officer’s qualification to obtain the license, but they still need to go through the licensing process including bonding and insurance and everything.

Just FYI, the Company is not allowed to do contracting work over \$500 without a license so depending on the circumstances, California Contractors License law actually allows you to recover the full amount of what you paid that ‘contractor’ if the work was performed unlicensed. While knowledge is power, knowing where to go for the answers is half the battle. Hearing loss prevention: What you should consider

Make sure every employee is aware of the hazards of noise-induced hearing loss, so they can take steps to protect against them.

Loud noises in the workplace can lead to permanent hearing loss among workers. Banging, drilling, and other mechanical processes can produce loud noises that can damage a person's eardrum. The types of sounds, noise intensity, and duration of exposure can all contribute to hearing loss. Symptoms may take years to develop, but even brief exposure to loud noises can have a major effect on a person's life, limiting their ability to hear the world around them. Once noise-related hearing loss occurs, it is irreversible, so it's crucial to protect your hearing when on the job and off (like when attending concerts, using loud tools and equipment at home, etc.).

The Occupational Safety and Health Administration (OSHA) has set clear rules regarding noise pollution in the workplace. If these sounds pass a certain threshold, managers should implement what's known as a hearing conservation program to protect staff from permanent hearing loss.

Measuring Sound

Managers first need to understand how sound is measured in the workplace. Decibels (dB) are used to measure the intensity of sound. The higher the decibel, the louder the sound. For context, normal conversations occur at around 40 dB, while appliances like a hair dryer come in at around 70 dB. Meanwhile, a jetliner can be as loud as 140 dB.

Prolonged exposure to sound above 85 dB and any exposure to sounds above 135 dB can cause permanent hearing damage. In addition to hearing loss, these noises can cause damage to the inner ear, which can lead to

long-term ringing in the ears or tinnitus.

Complying with OSHA Guidelines: When to Implement a Hearing Conservation Program

According to current OSHA guidelines, employers must implement a hearing conservation program if noise exposure is at or above 85 decibels averaged over 8 working hours, or an 8-hour time-weighted average (TWA). This doesn't mean exposing workers to 85 dB for 8 hours straight. OSHA wants employers to average sound exposure over the 8-hour day. For example, if a worker is exposed to 100 dB of sound on and off for around two hours in an otherwise quiet workplace, they will likely still need a hearing conservation program during their shift if the average comes out to 85 dB or more.

To add up the average, employers can add up the amount of time workers are exposed to different levels of noises. For example, a worker may be exposed to 50 dB for two hours, 70 dB for two hours, 90 dB for two hours and then another two hours of 50 dB. This comes out to an average of 65 dB over an 8-hour shift.

According to OSHA, hearing conservation programs should *"strive to prevent initial occupational hearing loss, preserve and protect remaining hearing, and equip workers with the knowledge and hearing protection devices necessary to safeguard themselves."*

These programs can take many forms as long as they all work toward the same goal, which is to prevent

hearing loss. Creating a hearing conservation program all depends on the workplace in question and the source of the noise. However, most programs include the following:

- Workers should be aware of the risks of noise-induced hearing loss and other health risks that can occur due to noise exposure.
- If workers are potentially exposed to noise-induced hearing loss, they must be given a baseline audiogram within the first six months of work. Afterward, they should receive an annual audiogram performed by a certified audiologist, free of charge. They should then compare the results to those of the baseline audiogram to determine if noise exposure has caused hearing loss.
- Workers at risk of experiencing noise-induced hearing loss should be given various hearing protection options, including earplugs, earmuffs, and headphones for reducing ambient sound.
- Employers must hold a hearing protection training program every year to make sure workers who will be exposed to more than 8 hours of 85-decibel noise know how to protect themselves on the job.
- Records must be kept of employees' varying noise exposure levels.

Hearing protection equipment comes in many different shapes and sizes. Managers should provide workers with a range of options, so they can choose the right, securely-fitted equipment for the task at hand.

For example, electricians will often wear dielectric headphones to protect them from electrical hazards. This equipment is often inserted underneath or on top of other

personal protective equipment. Workers may need to use bands or inserts underneath their helmets. In other cases, these devices may be mounted on the helmet or neck.

Some teams will use earplugs when it's too hot to wear earmuffs or to supplement their hearing protection equipment. Plugs can be molded, custom molded, or unmolded. Some are corded, which may get in the way on the job. Some are disposable, while others are reusable. These devices should fit properly without making the worker uncomfortable. Managers should consider investing in custom-molded ear plugs for a better fit if their workers are continuously exposed to loud noises.

Creating a Hearing Conservation Program

Managers can use the following steps to implement a safe and effective hearing conservation program in the workplace:

1. Managers should first make a checklist of all the loud noises that occur in the workplace, including their respective decibel levels and how often they occur.
2. Once the source of the noise has been identified, the manager should look for ways to reduce the noise level. This may include using a different piece of equipment, setting up a sound barrier, running equipment during different times of the day, or moving workers away from the source of the sound. Managers may also rotate their teams to limit their exposure to high noise levels. Preventing loud noises also means using materials and machinery with care. Workers

should avoid slamming or dropping items that could put their colleagues' hearing at risk.

3. If the noise level can't be adjusted, managers should install "High Noise Area" signs around the site to alert staff.
4. They should also provide various types of hearing protection equipment to workers before they enter the high noise area.
5. Crew members should regularly inspect this equipment for damage, including cracks, tears, or poor noise control, to make sure it will work as intended in the workplace.
6. In addition to baseline testing, managers should continue monitoring and testing their workers' hearing to make sure they aren't losing their hearing over time.

Even if some workers appear to have their hearing intact, they may see a noticeable decline down the line since these symptoms may take years to develop.

Workers have a right to earn a living without worrying about losing their hearing. If managers don't comply with the latest noise pollution guidelines, workers have a right to report their employer to OSHA. Workers may also

receive compensation if their hearing is damaged in the workplace.

If managers aren't sure whether sound levels merit a hearing conservation program or they don't know how to implement such a program, they should consult with a workplace safety professional with a background in preventing hearing loss. This person can help managers identify potential hazards in the workplace while proposing a reasonable solution for limiting staff exposure to these sounds.

Preventing hearing loss is often a group effort. Everyone in the workplace should be aware of the hazards of noise-induced hearing loss, so they can take steps to protect against them. If employees have any questions about hearing protection, they should contact their employer directly for more information.

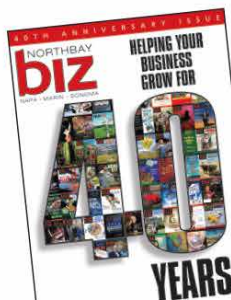
