## DIR Reminds Homekey Employers They Must Pay the Prevailing Wage on Publicly Funded Projects


The Department of Industrial Relations' (DIR) Labor Enforcement Task Force (LETf) reminds employers on public works projects, including Homekey projects, that they must pay workers the prevailing wage, according to the work performed and the location of the project.

Homekey is a publicly funded statewide initiative to provide housing for people experiencing homelessness. Employers with workers at Homekey housing job sites must comply with labor laws, including paying workers the prevailing wage, providing workers' compensation insurance, and following workplace health and safety requirements and apprenticeship standards.

Individuals with leads on labor law violations at publicly funded construction projects are invited to complete one of the following complaint forms:

- Worker Complaint form for workers on public works projects.
- Public Complaint form for others wishing to report a public works complaint.

The Labor Enforcement Task Force, under the direction of the Department of Industrial Relations, is a coalition of California State government enforcement agencies, including Cal/OSHA, Labor Commissioner's Office, and Contractors State License Board, that work together and in partnership with local agencies to combat the underground economy. In this joint effort, information and resources are shared to ensure workers are paid properly and have safe work conditions and honest, law-abiding businesses have the opportunity for healthy competition.

## **If industry safety numbers are murky, how can construction companies measure improvement?**

After months analyzing OSHA's safety data, Construction Dive's findings are discouraging: The death rate for U.S. construction workers has flatlined for at least a decade. Injury rates from the four most common hazards also haven't declined. And OSHA's program for serial offenders hasn't snagged all of the worst contractors in commercial or residential construction.

Moreover, the quality and value of OSHA data for initial violations are widely criticized by the industry, citing lag times and the frequency that citations and fines are challenged, and later reduced or erased. OSHA could not provide final figures for the total amount of citations that were resolved or paid.

### **The rate of fatal injuries in construction is virtually unchanged**

"It's no secret that when OSHA shows up it's too late to be safe," said Ron Taylor, a lawyer at Venable in Baltimore who has represented Whiting-Turner for over 30 years.

Taylor has worked for years to reduce Whiting-Turner's violations. The Baltimore, Maryland-based contractor had 80 initial violations between 2012 and 2021 and fines of \$186,119. Taylor said he trimmed those numbers to 50 violations and the company paid just \$39,705.

"All litigation has the opportunity, after initiated, to be resolved ... the vast majority settle or resolve before hearing," he said.

In response, OSHA said its "goal is to get employers to fix the hazards. Sometimes, we lower the penalty to get protections earlier ... so focusing on the fines is not always the best measure. When setting a penalty, OSHA begins with the maximum penalty, then adjusts based on a variety of factors."

OSHA said it "continues to look at ways to improve its data analysis and collection to better protect workers and ensure equity in enforcement, including making sure sufficient data and information are available for use in targeting enforcement and compliance assistance."

Nevertheless, a major challenge to improving safety is that there is no universally accepted, publicly available metric for construction that measures how safe

a company or jobsite is, which hobbles regulators trying to craft more targeted standards and programs. Bad data also make it harder for workers and project owners to sidestep contractors that run risky jobsites.

### **A look at the numbers**

Construction Dive studied the country's 30 largest general contractors by revenue including subsidiaries but excluding joint ventures. Addresses were cross-checked for accuracy. Many companies are privately held and not required to disclose such details, but almost all provided them. The results were shared with OSHA as well as with the 10 contractors with the most initial violations.

Measuring safety on sites is challenging. Construction Dive analyzed both total violations and violations per inspection over the past decade, but focused on violations per inspection in order to more fairly compare companies that had been inspected by OSHA at different rates.

Construction Dive also found issues with accuracy, consistency and upkeep in OSHA's database.



Violations per inspection was deemed the more reliable metric based on the time lag between when a violation was contested and resolved versus when it's recorded in a database.

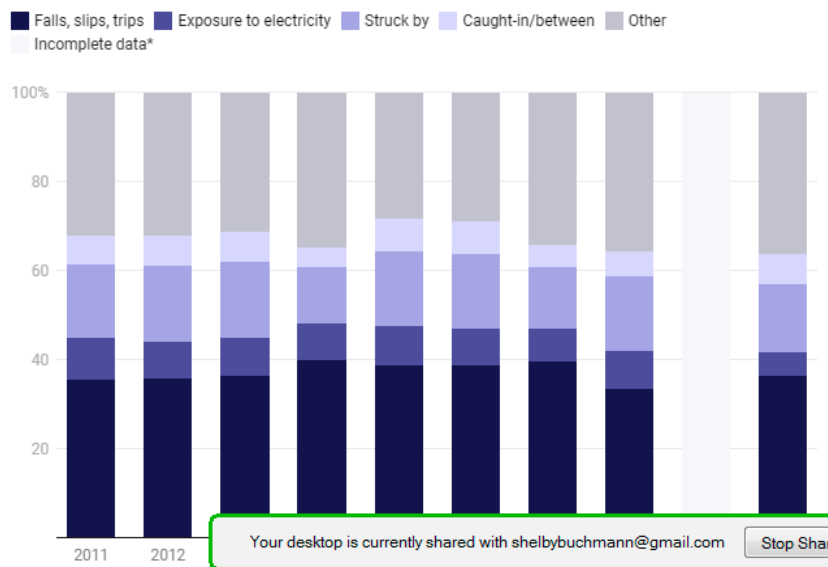
Every contractor interviewed claimed OSHA's initial violations were an unreliable safety benchmark because final violations and fines were much lower.

Moreover, initial violations do "not reflect the safety culture and climate of a project; the volume or type of work being performed; and do not reflect the ultimate resolution of citations," said Cindy DePrater, New York City-based Turner Construction's chief environmental health and safety officer. As America's largest contractor, Turner had the most OSHA inspections during the decade analyzed by Construction Dive, but one of the lowest number of citations per inspection.

The number of inspections for the country's largest contractors had no bearing on violations, demonstrating that having a high number of inspections does not necessarily correlate with having higher violation rates. Only one in three inspections ended with a citation, indicating the largest players know the rules and most have solid safety programs.

To keep workers safe, contractors rely on a mix of some type of incident tracking, preventative practices, OSHA guidelines, employee training and technology-based tools. Providence, Rhode Island-based Gilbane, for instance, sees OSHA as an important partner in its safety efforts, but also has plans that exceed OSHA regulations in many areas, according to spokesperson Lynn Rasic.

## OSHA rule change expands use of instance-by-instance citations

Under the new rule, repeat citations can be issued for incidents surrounding lockout/tagout, machine guarding, permit-required confined spaces, respiratory protection, falls, trenching and for cases with other-than-serious violations specific to recordkeeping.

OSHA's rule change is designed to crack down on employers that continue to fail to address hazards, the agency said.

"This is intended to be a targeted strategy for those employers who repeatedly choose to put profits before their employees' safety, health and wellbeing," Doug Parker, assistant secretary for OSHA, said in the announcement. "Employers who callously view injured or sickened workers simply as a cost of doing business will face more serious consequences."

The new guidance covers enforcement activity in general industry, agriculture, maritime and construction, and becomes effective 60 days from Jan. 26.

### What do commercial contractors need to know about the new rules?

Charlie Morgan, Atlanta-based labor and employment lawyer and partner at Alston & Bird, said the rule change is largely discretionary, and therefore will likely be used by OSHA to flex its muscles in severe instances, as Parker indicated.

"You're not going to see it presumably used often," Morgan said. "I can speculate that they would probably apply it where there was a fatality or multiple hospitalizations ... but also they may go after someone they sort of see as a repeat offender."

That doesn't mean that compliant builders won't be at risk of higher citations.

"While 'bad actors' may be in the agency's crosshairs, it will be incumbent on 'good actors' or those who are simply not fully engaged on the compliance front, to become compliant so as to avoid additional penalties should the agency conduct an inspection," said Ian D. Meklinsky, Princeton, New Jersey-based partner with law firm Fox Rothschild and co-chair of its labor and employment department.

Morgan said the recordkeeping aspect of the new rule could pose a potential problem. OSHA requires employers with more than 10 employees keep a record of serious work-related illnesses and injuries and maintain them for at least five years. A lack of thorough documentation could now pose a high fine, Morgan said, so contractors should ensure to document their jobsite practices well.

Nevertheless, he said he thought the new ruling could have a positive effect, even if "bad things happen to good people."

For Morgan, the rule won't change the way OSHA tackles most enforcement, but rather beefs up the tools already at its disposal.

In the meantime, Meklinsky's advice is simple: Brush up on OSHA obligations and stay compliant.

## PNEUMATIC TOOL SAFETY

Pneumatic tools can increase productivity and lessen fatigue. They are powered by compressed air and include chippers, drills, jackhammers, sanders, and many more. However, because they are so powerful, they can cause plenty of injuries if used improperly. Therefore, keep the following tips in mind to avoid injuries while using pneumatic tools.

### PREPARATION

- Read the entire instruction manual before you begin operating the tool.
- Clean and oil your tools regularly.
- Check the hoses for damage.
  - Replace a damaged hose with a new one immediately.
- Use clean, dry compressed air.
- Set the tool pressure accurately.
- Blow any air out of the line before attaching a tool.
- Consider attaching the tool to the hose with a locking device, chain, or a short wire for added protection.
  - If the hose detaches while air is going through it, the hose will violently whip around and could cause injury to people in the workplace.
- Ensure the hose doesn't present a tripping hazard.
- Post signs at a safe distance notifying bystanders that pneumatic tools are being used in the area.
- Set up screens to protect nearby workers from being struck by flying fragments.

### Wearing the right PPE can prevent many injuries associated with using pneumatic tools:

- Safety glasses/face shield
  - Protects your eyes and face from the air and flying particles.
- Boots
  - Protects your feet from falling tools or debris.
- Heavy gloves
  - Protects your hands from extreme air temperature, debris, and helps lessen vibrational damage to your hands.
- Ear protection
  - Protects your ears from the loud noises caused by the tools.

### DON'TS OF USING PNEUMATIC TOOLS

- Don't let the tools get clogged or jammed.
- Don't use any attachments that don't belong with the tool.

- Don't force a tool to accept an attachment.
- Don't exceed the tool manufacturer's recommended air pressure.
- Don't point the tool at yourself or another person.
  - Some tools, such as nail guns, should be treated with the same caution as regular guns.
  - Nozzles of pneumatic tools can fire rust particles at high velocity and cause injury.
- Don't use compressed air for cleaning unless fitted with an attachment that reduces the pressure to 30 psi.
- Don't ever use compressed air on yourself.
- Don't carry tools by the air hose.

### CONCLUSION

Pneumatic tools can make work more efficient, but can also be dangerous. Most of the dangers of using pneumatic tools can be avoided if you prepare to use them, wear the proper personal protective equipment, and remember to avoid certain dangerous practices.

## Last Minute Checklist for Electronic Reporting of OSHA Form 300A

### Forms needed to be submitted by March 2nd.

The deadline to electronically submit information from the Occupational Safety and Health Administration’s (OSHA) Form 300A for the year 2022 is fast approaching. Your establishment’s injury and illness recordkeeping forms should be complete and posted at this time, but are you aware that OSHA also requires certain establishments to submit electronically the information from Form 300A?

OSHA Form 300A is a summary of all the injuries and illnesses that took place in an establishment during the previous year. The injuries and illnesses recorded on any of the recordkeeping forms must meet the OSHA recordable criteria. OSHA Form 300A is required to be posted by February 1st of each year. In 2019, OSHA updated its recordkeeping rules to include an electronic submission of the information from form 300A for certain industries.

To help you stay compliant, I’ve compiled a quick checklist that explains what you need to submit by the March 2 deadline. If your organization has a digital environment, health and safety (EHS) solution, this information is likely easily accessible from a dashboard or custom report.

#### 1: Ensure Completion of OSHA Forms 300 and 301

OSHA provides 3 separate forms for recordkeeping of work-related injuries and illnesses:

- OSHA Form 300
- OSAH Form 300A
- OSHA Form 301

#### OSHA Form 300

OSHA Form 300 requires you to account for each injury and illness that took place in the previous year (this round is for 2022). Each injury or illness to an employee

which meets the recordable criteria will be entered as an individual line item on OSHA Form 300. The form will require information such as:

- Case Number
- Employee Name
- Description of the Case
- Classification of the Case
- Number of lost days for the employee

#### OSHA Form 301

OSHA Form 301 is an individual account of a recordable case. A separate 301 form is used for each case that meets the recording criteria. Most people refer to the 301 as a “First Report of Injury” form.

Let’s take a closer look at OSHA Form 300A since its information is necessary for establishments required to submit electronically.

#### OSHA Form 300A

The 300A form is a summary form of all the information found on OSHA Form 300. Here is how your establishment should complete the 300A Form.

#### 2. Tally Workplace Incidents and Illnesses

You’ll need to add up the following incidents from your 300 Form and record them on the 300A Form:

- Total number of cases
  - Fatalities
  - Cases with days away from work
  - Cases with job transfer or restriction
  - Other recordable cases
- Total number of days away from work/job transfer/restriction
- Total number of injury and illness types

### 3: Calculate Total Number of Hours Worked

Part of the form requires you to submit the number of hours employees worked and how many employees work at your organization.

Your HR department should be able to tell you how many employees worked at your organization in 2022.

To calculate the total number of hours worked by all employees, you can multiply the number of full-time employees by 2,000 hours (which is the commonly agreed-upon standard number of work hours for full-time employees). The graphic below can help you calculate this number as well.

### 4: Identify A Certifying Official to Sign the Form

A certifying official is someone at your organization who can attest with a signature that they examined the OSHA 300 and 300A form and believe that it's reasonably accurate.

A certifying official is typically the company's owner. If the owner is unavailable to sign the form, the certifying official can be someone in the C-suite. If that person is unavailable, the highest-ranking company official working at that organization may also sign.

### 5: Understand If You Qualify for Electronic Submission

OSHA only requires certain establishments to submit the information from the 300A Form electronically in the ITA. If your establishment meets the following criteria then it must make the electronic submission by March 2nd.

- Establishments with 250 or more employees**
- Establishments with 20-249 employees in certain high-risk industries**

OSHA updated both its login rules and submission options as of October 2022.

The login rules required you to have both an ITA account and a Login.gov account to access the application. All current and new account holders must connect their ITA account to a Login.gov account with the same email address to access the application for the 2023 collection of calendar year 2022. For more information on the new login rules, you can watch OSHA's how-to video.

Regarding submissions options, you can either manually enter the data, upload a CSV file to add multiple establishments at the same time, or transmit data electronically via an API. However, few establishments are required to electronically submit their OSHA Form 300 data. You can find out if your establishment qualifies by visiting OSHA’s ITA page.

### 6: Post OSHA Form 300A Where It’s Easily Visible

OSHA requires companies to physically print the OSHA Form 300A and post it in a public area of the business for employees to view. This can be any area that hosts regulatory posters or company updates. Break rooms or hallways are generally good places to put it – as long as it’s easily accessible and not hidden behind other printed materials.

OSHA 300 forms must be posted at an easily visible and accessible place in the organization between February 1st and April 30th.

### 7: Monitor for the Proposed Rule Change

OSHA has proposed rules which would update the criteria for which establishments would need to complete electronic reporting, however, those rules have not reached the final stages and so we must follow the current rules in effect.

## **Railroads Under New Scrutiny**

The derailment and chemical release incident in East Palestine, Ohio, may mark a new era in railroad regulation, one that shippers and other critics believe is long overdue. This time the focus not only will be fixed on rail safety, but also on the currently prevalent operations model that imposes an overwhelming emphasis on cost-cutting to boost shareholder value.

Even before the Ohio incident freight railroads were in trouble with the federal government in the form of investigations, service orders and threatened fines being pursued by the Surface Transportation Board (STB), which supervises the freight railroads' economic practices involving their customers, including service quality, and how they apply freight rates along with demurrage and other fees.

For example, at the end of last year the board adopted two rules establishing new rate reasonableness procedures which are intended to provide two streamlined approaches for shippers and railroads to resolve smaller rate disputes. It also has ordered the railroads to provide service in areas where it has deteriorated because of neglect due to cost-cutting.

The board is the successor to the old Interstate Commerce Commission and has nothing to do these days with enforcement of federal railroad safety regulations, which are the responsibility of the Federal Railroad Administration (FRA), an agency of the Department of Transportation (DOT).

Investigations of rail accidents are conducted by the National Transportation Safety Board (NTSB), an agency that is entirely separate from DOT, and which is supposed to come under the authority of Congress. Both the NTSB and STB are run by board members who are nominated by the President to set terms and are approved by the Senate. In fact, on occasion the NTSB has been highly critical of DOT safety enforcement efforts in the past.

Adding to the alphabet soup of federal agencies roused to action following the Biden administration's slow response is the Environmental Protection Agency (EPA). Supervising the clean-up efforts in East Palestine, the EPA most recently stumbled when it failed to communicate with the state governments of Texas and Michigan about shipments of contaminated water and dirt, leaving them waiting in East Palestine until the snafu could be untangled.

Perhaps to make up for their earlier silence in the immediate aftermath of the incident, the EPA and other government officials loudly proclaimed that Norfolk Southern (NS) railroad would have to pay for the clean-up—which in fact was something the railroad had already pledged to do.

The belated haste of federal officials extended to NTSB Chairman Jennifer Homendy, who declared at a Feb. 23 press conference that, "I can tell you this much: This was 100% preventable." She added, "We call things accidents. There is no accident. Every single event that we investigate is preventable. Know that the NTSB has one goal, and that is safety and ensuring that this never happens again."

### **Credibility on the Line**

Her statement was highly unusual for a head of the NTSB. Throughout its history, when investigating accidents, the board had sought to bolster its reputation for professionalism and objectivity by limiting public statements to acknowledging that an investigation was underway and a final report would be forthcoming after it was completed, which usually takes months.

## Little Hoover Commission to Study the California Environmental Quality Act

The Little Hoover Commission – America’s only permanent, independent citizens commission working to improve state government – will hold a series of hearings this spring to examine the California Environmental Quality Act (CEQA).

Since its enactment in 1970, CEQA has been California’s premier piece of environmental legislation. The law requires public agencies and decision-makers to evaluate the environmental impact of a proposed project, determine if the project will have significant impacts on environmental quality, disclose those impacts to the public, and mitigate them to the degree feasible.


However, CEQA has long been at the center of controversy and debate.

In its hearings, the Commission will examine the controversy around CEQA, evaluate CEQA’s impact on housing, land use, and other issues, and explore the present state of the CEQA process.

The first of three hearings will be held in person on Thursday, March 16, with the option for remote participation. This hearing will focus on the debate over CEQA and give the Commission the opportunity to hear different perspectives on CEQA and on CEQA’s impact and effectiveness. The second and third hearings will be held virtually on April 13 and April 27. All three hearings will be accessible from the events page on our website: [www.lhc.ca.gov/events](http://www.lhc.ca.gov/events). Additional information, including witness lists, will be released on a later date.

## More Time to File State Taxes for Californians Impacted by December and January Winter Storms

**WHAT YOU NEED TO KNOW:** California is extending the tax filing deadline for Californians impacted by December and January winter storms to October 16, 2023 – aligning with the IRS

**SACRAMENTO** – In addition to tax relief measures that Governor Gavin Newsom announced in January, California is also extending the state tax filing and payment due dates to October 16, 2023 for Californians impacted by the winter storms in December and January. This aligns California with the Biden Administration, which announced that the IRS extended various due dates until October 16, as well.

“As communities across the state continue recovering from the damage caused by the winter storms, California is working swiftly to help recovering Californians get back on their feet,” said Governor Newsom. “The state is aligning with the Biden Administration and extending the tax filing deadline in addition to the tax relief announced earlier this year.”

Last month, Governor Newsom announced tax relief for those impacted by winter storms, giving people the ability to claim a deduction for disaster loss and extending certain filing deadlines.

The following counties are eligible for this extended tax relief, per the IRS announcements here and here:

Residents and businesses in Alameda, Alpine, Amador, Butte, Calaveras, Colusa, Contra Costa, Del Norte, El Dorado, Fresno, Glenn, Humboldt, Inyo, Kings, **Lake**, Los Angeles, Madera, Marin, Mariposa, **Mendocino**, Merced, Mono, Monterey, **Napa**, Nevada, Orange, Placer, Riverside, Sacramento, San Benito, San Bernardino, San Diego, San Francisco, San Joaquin, San Luis Obispo, San Mateo, Santa Barbara, Santa Clara, Santa Cruz, Siskiyou, Solano, **Sonoma**, Stanislaus, Sutter, Tehama, Trinity, Tulare, Tuolumne, Ventura, Yolo, and Yuba counties who have been affected by severe winter storms, flooding, landslides, and mudslides are eligible for tax relief.

### TAX EXTENSION

To help alleviate some of the hardship many have endured during this trying period, the FTB has extended the filing and payment deadlines for individuals and businesses in California until October 16, 2023.

This relief applies to deadlines falling on or after January 8, 2023, and before October 16, 2023, including

the 2022 individual income tax returns due on April 18 and the quarterly estimated tax payments, typically due on January 17, 2023 and April 18, 2023. Those payments were previously extended to May 15, 2023 for those impacted by winter storms.

The IRS announced tax relief for Californians affected by these winter storms. Taxpayers affected by these storms qualify for an extension to October 16, 2023 to file individual and business tax returns and make certain tax payments. This includes:

- Individuals whose tax returns and payments are due on April 18, 2023.
- Quarterly estimated tax payments due January 17, 2023, April 18, 2023, June 15, 2023, and September 15, 2023.
- Business entities whose tax returns are normally due on March 15 and April 18.
- PTE Elective Tax payments due on June 15, 2023.

### CLAIMING DISASTER LOSSES

Taxpayers affected by a presidentially declared disaster may claim a deduction for a disaster loss. Taxpayers may claim a disaster loss when filing either an original or amended tax year 2022 tax return.

When filing their return, taxpayers should write the name of the disaster in blue or black ink at the top of their tax return to alert FTB. If filing electronically, taxpayers should follow the software instructions to enter disaster information. If a taxpayer receives a late filing or payment penalty notice related to the postponement period, they should call the number on the notice to have the penalty abated.

Additional information and instructions are available in FTB Publication 1034, 2022 Disaster Loss: How to Claim a State Tax Deduction.

Disaster victims can receive free copies of their state returns to replace those lost or damaged. To do so, they should use form FTB 3516 and write the name of the disaster in blue or black ink at the top of the request.



## Capitol Connection Q&A for Contractors

**Not just No, but #%' No! I also help a contractor on a renewal issue, discover how much trust is necessary in an LLC and am always ready for your call, emergency or not...**

**Q:** We just received our renewal for our license and I'm noticing our previous CEO is still listed on the license. He left the company over a year ago. I read that we have 90 days to notify the CSLB of an Officer leaving the company? What will happen now that we've gone well over the 90 days? Are we subject to automatic suspension?

**A:** As long as your CEO is not also the Qualifier, you should be fine. The CSLB doesn't discipline the license if you do not notify them of an Officer leaving within 90 days (although they have the authority to, they generally don't). You can submit a disassociation notice for the former CEO along with the renewal application. Be sure that both the renewal and the disassociation are signed by a current Officer on the license. If you have a new CEO, you will also eventually want to add him/her to the license.

**Q:** Does the CSLB allow for a Trust to be listed on a license if the Trust is the actual owner of the LLC?

**A:** Yes, that is permissible. If you list a Trust as the "Member" on the license, that also needs to be reflected on the Statement of Information filed with the CA Secretary of State (SOS ) for the LLC. In addition, you will be required to provide documentation showing who the Trustee is and that individual will need to sign the license application paperwork.

**Q:** We have several companies with contractor licenses in California. If one of the entities merges into another one, are we required to update the CSLB with any information?

**A:** With limited information it doesn't sound like you would need to make any updates to the surviving entity's license as long as the Personnel are remaining

the same. As far as the entity merging, you can cancel the license if you want, or it will be automatically cancelled 60 days after the CSLB is made aware or discovers that the company no longer exists.

**Q:** I have a quick and easy question for you that I think I know the answer to but I thought I would ask anyway. Am I allowed to bid on work while I have an application for a new license in the works?

**A:** My quick and easy answer is absolutely not! You cannot bid on or perform any contracting work until you are officially licensed!
