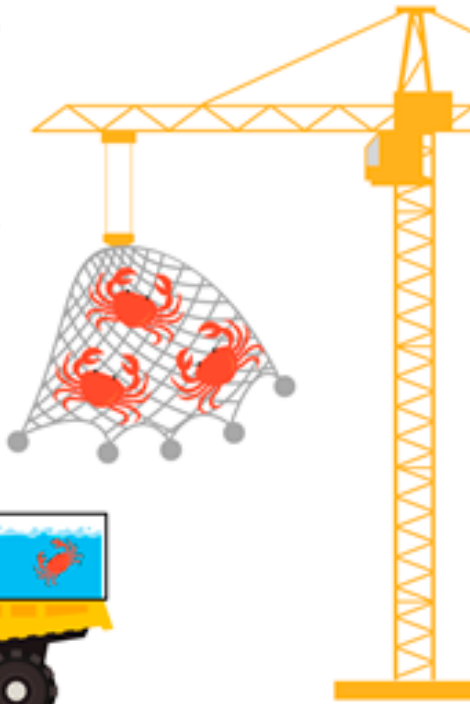

How to Create a Happy Company

A study from Robert Half International highlights, and explains, six factors that influence employee happiness.

Right Fit for the Job and Company

A good fit entails both skills and temperament. Painting an accurate picture of the role and the organizational culture when hiring is a safeguard that can help you avoid skill alignment issues. When you set expectations by clearly communicating to prospective candidates what an open position entails, you greatly reduce the risk that they end up feeling surprised, unchallenged or disappointed once on the job.

“Practicing diligence in each step of the hiring process — from crafting detailed job postings to conducting in-depth interviews, skills testing candidates, thoroughly checking references, and giving them an opportunity to meet different people within the company. This process sets the stage for both employee and employer happiness,” says David Jones, Senior Managing Director at Robert Half Asia Pacific.

A Sense of Empowerment

Empowering your staff to make decisions on their own, or with minimal direction from you, improves employee happiness in multiple ways:

- Empowerment helps staff develop critical skills they can use to advance their careers and make greater, more meaningful contributions to the company.
- Empowerment makes workers feel more invested in the jobs they do because they are the ones making decisions.
- Letting go of the reins also helps team members build confidence as they realize they are able to make the right decisions.
- Empowered employees feel more comfortable questioning the status quo and suggesting new ideas. Large organizational changes or disruptions, like a staff restructuring, are less likely to knock these workers down.

Feeling Appreciated

It doesn't have to break the bank to instill loyalty. Establishing a positive working environment can generally make your employees happier. Simply show your staff that you appreciate their hard work and dedication. Offering a sincere thank you for a job well done has a much greater motivational impact than many people realize.

“Fostering positive emotions through gratitude is easy and powerful,” explains Dr. Christine Carter, author of *The Sweet Spot: How to Find Your Groove at Home and Work*. “The science on this is blazingly clear. There are loads of research studies that show how much higher functioning people are when they feel appreciated by their teams and their manager.”

Interesting and Meaningful Work

“Happy workers understand why their tasks matter and how they connect to the overall objective,” says author Todd Henry, who speaks about productivity, creativity and passion for work and leadership. “When there is a gap in that connection, people tend to drift and have difficulty investing emotionally. Employees who have a strong, through-line, that ties their work together tend to be happy, fulfilled and engaged even when times get tough.”

Gaining a sense of meaningful progress and achievement is particularly important to millennials. According to the survey, Robert Half conducted with Nic Marks, a sense of pride and a sense of accomplishment are among the strongest drivers of happiness for employees under 35.

A Sense of Fairness

Fairness matters deeply to employees.

So deeply, in fact, that a single instance of unfair treatment — whether actual or perceived — is often enough to turn a happy, satisfied employee into one who is cynical and skeptical of the company.

What can managers do to improve fairness in the workplace?

- First, strive to be transparent in your decision-making. Be sure policies around pay, promotions, and projects are clear. Every member of your team should know what they must do to earn a new title or a higher salary.
- Give employees a chance to alert you when they feel a sense of inequality. Often, employees just want to be heard and know that their concerns are being taken into account.

Positive Workplace Relationships

A sense of camaraderie at work improves employee communication, cooperation, and collaboration. Staff cohesion also leads to greater innovation. Employees across the board say they have good team relationships at work. None of the recipients reported significant dissatisfaction in this area. This is good news for employers: those who say they have good relationships with others on their team are 2.7 times more likely to be happy on the job than those who do not get along well with colleagues.

Be deliberate, set goals: Tips for recruiting women

In a recent webinar from CPWR, panelists from across the country offered advice and insight on how to grow the share of women in the industry.

To draw more women workers into the construction industry, contractors must provide an inclusive, welcoming environment with well-established diversity, inclusion and career advancement programs: That was the message from panelists on a webinar this week focused on strategies to recruit and retain women hosted by CPWR, the Center for Construction Research and Training.

Here are some of the top ways that firms can make themselves more attractive to women workers:

Programs are the key to long-term success

Training women and people of color hasn't been enough, the industry needs policies and programs to promote their success, said Mary Vogel, executive director of Building Pathways, a Boston-based nonprofit dedicated to the recruitment of underrepresented workers to the building trades.

The methods to do that, Vogel said, are many. Outreach, applicant assessment, occupational skills training, apprenticeship placement and partnership with industry stakeholders help ensure women don't just set foot on the jobsite, but find their place there, Vogel said.

Still, programs can only do so much — they must give women the tools to succeed.

"We do say we're a GPS, not Uber," Vogel said. "We're not gonna hold their hand to apply to an apprenticeship program, but we'll let them know what that process is and expose them to the various trades."

Childcare support

Multiple speakers touched on the need for affordable quality childcare, something that women deal with more often than men.

TradesFutures, a Washington, D.C.-based nonprofit, has recently established programs in New York City and Milwaukee to provide applicants with vouchers to help them pay for their childcare needs.

Nicole Schwartz, executive director for TradesFutures, outlined the process: In New York City, 10 families will receive \$1,000 a month for support for childcare, while in Milwaukee, vouchers can pay for

up to half of childcare costs for the full year.

The programs are still in their pilot phase.

Deliberate recruiting and culture change

Kathleen Dobson, safety director for St. Louis-based Alberici Constructors, said outreach for the future of the workforce doesn't start early or often enough. Even career days for middle school are often too late, as students have begun to make plans for their high school path, which could steer them away from the trades.

Kids who don't have parents in engineering or construction often don't know about opportunities in these sectors.

But while recruiting needs to start earlier, it isn't sufficient on its own. Dobson said the workplace also needs to be built to feel safe and equitable for women.

Half of construction's job openings vanish

The number of construction job openings in January plummeted by 240,000, a result dubbed "simply shocking," by Associated Builders and Contractors' Chief Economist Anirban Basu.

ABC's monthly analysis of the Bureau of Labor Statistics data indicated there were 248,000 unfilled construction jobs in January, a sharp, 50% drop from the month before and 148,000 jobs below the same time last year.

Basu even questioned the accuracy of the numbers. "While this construction job openings number is likely to be revised or at least eventually viewed as aberrational as new data arrive, there are likely some construction segments that have substantially slowed their pace of hiring," said Basu.

The total number of open jobs in the U.S. hit 10.8 million in January, Basu reported, indicating there were more job openings than unemployed Americans. But as those numbers remained lofty, construction's plummeted — nearly half of all job openings vanished in a month.

"In a nation that is set to rebuild much of its infrastructure and is operating in the megaproject era, including the construction of manufacturing facilities for computer chips, inputs to growing alternative energy industries and electric vehicles, today's numbers seemingly defy credulity," said Basu.

But the head-scratching data isn't without some possible explanations.

Specifically, Basu called attention to the BLS data not differentiating between residential and nonresidential numbers. So, "while many nonresidential contractors continue to report lengthy backlog and numerous open jobs, the single-family homebuilding segment has entered a period of significant retrenchment," he said.

Finally, indications from the Federal Reserve point to further hiking of interest rates and for that elevation to stick around longer than previously thought, which could further dry the well of job openings.

The 8 Habits of a Highly Effective Safety Culture

EHS Today

I believe there are eight habits that will create a safety culture in which it is safe for your employees to fail. We know errors will happen. Moreover, errors are predictable. So, if we build them into the process, then employees can do their jobs in very complex environments and help us create the systems to protect them.

The Eight Habits

The first three habits are:

1) Stop Making Safety a Priority—it should be a value; 2) Make it Safe to Raise Concerns; and 3) Make Safety a Responsibility of Operations. These habits are designed to create a just safety culture that then enables you to truly focus on leading indicators and stop accidents before they happen.

That's where the fourth habit—Focus Left of Zero—comes in. In a just culture, you can track and trend the information you get from the field. When these first four habits are done in conjunction, we can actually see an accident before it happens and implement measures to stop it.

Stop Managing People is habit five. This habit focuses on leadership principles that are essential in creating a culture that is sustainable in every environment. The only constant in life is that things will change. Be prepared to lead your team no matter what comes your way.

Habit six is Stop Trying to Fix the Worker and Fix the Work, and habit seven is Find the STCKY (stuff that can kill you) and Stop the SIF (serious injuries and fatalities). When I originally wrote the eight habits, these two were based on BBS and using Heinrich's Triangle Theory to stop unsafe acts/behaviors, thereby reducing the number of significant injuries and fatalities. While BBS has helped reduce overall incident rates, it has done little to reduce the number of fatalities we have each year on job sites around the country. So, developing these two habits is going to take quite a shift in the way we view and do safety.


The final habit—Stop Trying to Influence Everyone—is one that will help you implement the first seven. When you try to influence everyone, you end up influencing no one.

Human Performance Principles

I want to mention here that all safety programs should be built on the principles of human performance. I use these five principles designed by safety expert and author Todd Conklin:

- Error is normal. Even the best people make mistakes.
- Blame fixes nothing.
- Learning and improving are vital. Learning is deliberate.
- How you respond to failure matters. How leaders act and respond counts.
- Context influences behavior. Systems drive outcomes.

You, however, can select as many or as few principles as you'd like. Choose the ones that fit your organization. In my book, I list a total of 25 principles called "The Incomplete List" because I'm sure there are others; it all depends on your organization and what it is you are trying to accomplish.

What women workers say needs to change in construction

It's no secret that construction has a problem recruiting and retaining women. A new survey from the nonprofit National Center for Construction Education & Research highlights the unique benefits women bring to construction, obstacles they encounter getting into and staying in the industry and advice on what contractors can do about it.

The need for inclusion is dire for construction: Workers are retiring from the industry much faster than new people are being hired, and for every four people who leave, only one enters, according to NCCER researchers. At the same time, the federal government is heavily investing in infrastructure and manufacturing projects through the Infrastructure Investment and Jobs Act and the CHIPS Act, which is further fueling the demand for workers.

Unfortunately, construction companies are not effectively appealing to women in their recruiting and retention efforts — thereby cutting out the largest segment of the population. Women currently make up just 14% of the overall construction workforce — an all-time high — and only about 4% of craft professional positions.

In order to learn more about womens' experiences in construction, NCCER surveyed women in the trades and also met with them in groups. The study finds contractors must change the culture and perception of the construction industry, starting with their own projects.

“Despite the significant benefits offered by tradeswomen, the construction industry has largely neglected to include them,” the NCCER study said. “Rebuilding the U.S. manufacturing, energy and transportation infrastructure is a multi-generational challenge that will require a diverse workforce that leverages all facets of our society to overcome it.”

How to recruit, retain tradeswomen

Those surveyed identified clear ways to support women in the industry. Key challenges to be addressed, in order of most-cited by respondents, are:

Discrimination and sexual harassment: Women surveyed had a worse experience on the jobsite than their male counterparts, saying they felt disrespected and subjected to unprofessional treatment more often.

Nearly half said they had been the target of derogatory comments or jokes at work. An effective place to start making a change is by establishing and publishing a sexual harassment prevention policy that explicitly lays out the firm's position and process for complaints.

Bias in the hiring process: Despite the high demand for workers, gender discrimination in hiring is still alive and well, respondents said. Companies often require a recommendation before they interview for a position — a practice that disproportionately hurts women, who are less likely to already know someone in the field. To address this, employers must ensure consistent hiring practices.

Lack of flexibility for care work: Women are responsible for a disproportionate amount of care work in the U.S., and lack of employer accommodations for family matters is a massive barrier to them entering and staying in construction. The solution is to provide mothers and caregivers support through actions such as clear working hours, scheduling flexibility and consistent PTO policies between office and field positions.

Lack of training opportunities: Respondents identified the need to establish training programs to bring women into the industry, specifically into the trades.

Unequal treatment: Women said they fully expect to be held to the same standard, receive the same training, have the same career advancement opportunities and get the same pay if they do the same work — but they're often not treated as equals.

Few women in site leadership positions: Women want to get into leadership positions, but 57% said they had never had a female supervisor. Without a clear and intentional plan in place to identify and develop potential women leaders, the issue will continue.

Poor jobsite experience: Two problem areas on the jobsite that respondents discussed the most were bathroom facilities and properly fitted workwear and equipment. They noted a lack of access to restrooms stocked with feminine hygiene products as well as no appropriate, discreet way to dispose of them. Most construction protective equipment and clothing are not designed to fit women, even though OSHA has identified improperly fitted PPE as a safety issue.

Unique strengths

Not only can recruiting women into the trades help make up for the quantity gap in the skilled construction workforce, but they also bring unique qualities to the jobsite that contribute to an improved work environment, the NCCER study found. The biggest benefits from hiring women include a greater focus on teamwork, attention to detail, jobsite cleanliness and organization as well as improved safety performance.

Capitol Connection Q&A for Contractors

Get set, get ready, go? A contractor seeks a party of the second part, and I guide a NV applicant over some of the increasingly rocky road on the way to General...

Q: We received the approval for our Qualifier to schedule the exams, which is great, but he isn't ready just yet to take them. You had provided some study materials to him which he hasn't had a chance to spend much time with, so he wants to do that before scheduling. In the meantime, we received his fingerprint request forms. Should he just follow the instructions for the out-of-state applicant to get that out of the way, or does he need to take the tests first?

A: Completing the live scan fingerprints in the State of California is the most efficient way to satisfy the fingerprint requirement. Since he is required to come here to CA to take the exams, he should just bring his live scan with him and complete it when he's here. Two birds, one stone!

Q: I have a question about 7057(b), the second part, which states a general building contractor shall not take a subcontract involving trades other than framing or carpentry, unless the subcontract requires at least two unrelated trades or crafts other than framing or carpentry, or unless the general building contractor holds the appropriate license classification.

The question that I have is, can a 'B' contractor take two unrelated trades, but then subcontract one of the trades to another specialty contractor and then perform the second trade, even though the 'B' contractor does not have the appropriate specialty classification for that second trade?

A: According to the CSLB interpretation of BPC 7057, a "B" contractor may take a prime contract for two or more trade and subcontract or self-perform only one trade. However, a "B" contractor taking a subcontract must self-perform the contracted work (which must include two or more unrelated trades).

Q: We have applied for a "B-2" contractor license in Nevada. We submitted an application over two months ago and our Qualifier has yet to be approved to sit for the exams. The NV Board has rejected his work experience twice now. We are at a loss as to what to do to get the license. He is our most qualified employee and has over 15 years of experience doing construction.

A: You are not alone! It has become increasingly difficult to qualify for the General licenses in Nevada. If your Qualifier does not have at least four years of experience building structures from the ground up, from foundation to finish you may need a different route. Please give my office a call and I would be happy to discuss this with you. You may end up needing to apply for a more specialized class or classifications.

MANAGEMENT: DISCIPLINE IN THE WORKPLACE

The purpose of discipline is to promote the health and safety of all the employees. Without discipline, an employee may be unaware they are doing something wrong or they know they are doing wrong and think they can “get away” with bad behavior. In addition, you as a supervisor can be held accountable for the behavior of the people you supervise, so you want to correct that behavior as soon as you can.

Discipline can be divided up into positive and negative. Positive discipline consists of rewards, such as praise, promotions, or bonuses. Negative discipline consists of punishment such as warnings, demotion, or termination. Negative discipline should be used as a last resort because you don’t want your employees to feel under attack.

Discipline programs differ by company, but the important thing is to have a set program that your employees are aware of. Some examples of a discipline program follow.

WHEN TO DISCIPLINE

When negative discipline is used, it’s usually because immediate action is needed. Some examples are:

- Tardiness/Absenteeism
- Sexual Harassment
- Not following company safety procedures

Discipline should be administered at the beginning while the problem is still relatively easy to fix.

PROGRESSIVE DISCIPLINE

One of the most used methods of discipline is “progressive discipline,” where each level is more strict:

- Oral Notice
 - o Let the employee know that their behavior is incorrect.
 - o Be calm and objective.
- Written Notice
 - o If the employee fails to improve, send them written notice that their behavior is incorrect and that discipline has escalated.
 - o Put the written notice in their employee file.
- Suspension
 - o If the employee continues to disobey, suspend the

employee.

- o The employee does not come to work and is not paid for the time they are suspended.

- Termination

- o The final resort is termination.
- o Use if a major misconduct problem has occurred or if the other disciplinary steps have had no effect.

POSITIVE DISCIPLINE

Positive discipline generally involves more planning than negative discipline, but does create faster learning and longer lasting good behavior.

- Hold meetings or have private conversations with your employees so they know what you expect of them.
- Always give feedback so the employees know they are doing things right.
- Only reward behavior you want repeated.

GENERAL NOTES

- Always document the entire discipline process.
- Discipline in private.
- Be specific.
- Focus on the behavior, not the person.
- Help the employee develop solutions.
- The level of discipline should match the severity of the offense.
- If you give the employee a time frame in which to correct their behavior, do not escalate the level of discipline until the time period is over and they still fail to correct their behavior.

CONCLUSION

Remember, discipline is used to correct behavior, not simply to punish. Positive discipline works best, but sometimes negative discipline is necessary. When you must implement negative discipline, be sure to do so privately and match the level of the behavior with the level of discipline needed.
