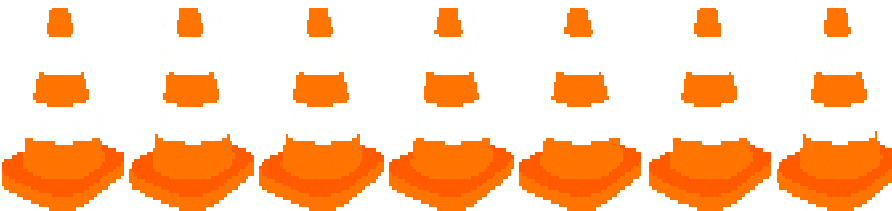

Sacramento, CA – The Contractors State License Board (CSLB) has begun publishing Spanish-language versions of its licensing exam study guides. All study guides can be downloaded for free on the Examination Study Guides page of the CSLB website.

The Spanish study guides for the remaining exams will be released over the next few weeks.

In addition, CSLB is in the process of getting 10 exams translated into Spanish, including the Law and Business, B – General Building, C-8 – Concrete, C-9 – Drywall, C-15 – Flooring and Floor Covering, C-27 – Landscaping, C-33 – Painting and Decorating, C-36 – Plumbing, C-39 – Roofing, and C-54 – Ceramic and Mosaic Tile. This process is expected to be complete later this year. For these exams, Spanish-speaking applicants will take the exam in Spanish rather than using a CSLB-approved translator. Spanish-speaking applicants can still use a translator for the remaining exams that are not being translated.

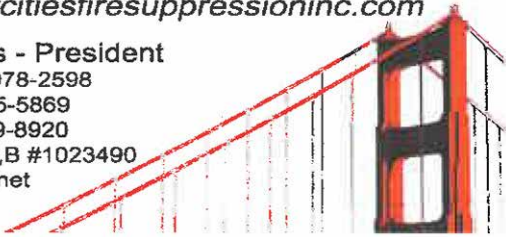

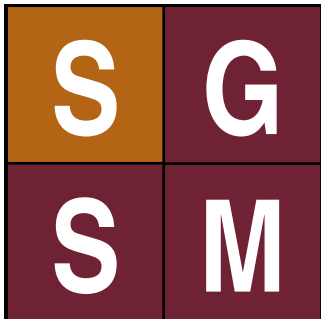

## **Leap Solutions HR Corner: On-Call and Reporting Time Pay**

Under California wage and hour law, on-call pay is due for a variety of reasons and is dependent on the amount of control that you have over an employee's ability to pursue their own personal activities.

On-call duty is separated into two categories, Restricted On-Call With Pay also known as Controlled Standby/Waiting Time and Unrestricted On-Call Without Pay. As the name's imply, the more restriction you place on an employee's ability to control their personal activities, the more likely you will be liable to pay waiting time. The Department of Industrial Relations defines hours worked as, "The time during which an employee is under the control of the employer, including all the time the employee is suffered or permitted to work, whether or not required to do so."

### **Restricted On-Call (With Pay)**

Examples of rules that may put employees in the category of Restricted On-Call With Pay include a restrictive time frame to respond to calls/or to appear on site which could put a geographic limitation on the employee's ability to travel to certain areas; restrictions on the use of alcohol or other personal activities; a restrictive frequency or number of calls; specific hour requirements that the employee has to be available to respond; call-in requirements where an employee must call at a specific time and report, if needed; restrictions on employees being able to trade on-call duty with other employees; and/or corrective action if an employee does not respond when called.

In an article called "Avoid Liability: On-Call Rules to Know" by CalChamber, they site the following scenario where an employer requires workers to call at a certain time to check to see if there will be hours available: "...if an employer requires a worker to call at 8 a.m. to check if they must report to work at 11 a.m. and the worker is asked to report to work, the employer must compensate for the gap hours between 8 a.m. and 11 a.m., in essence paying an employee to wait."

Travel time is also compensable when an employer requires employees to meet at a certain time and place and use employer provided transportation to and from the work site.

### **Unrestricted On-Call (Without Pay)**

On the other hand, Unrestricted On-Call Without Pay, allows employees to spend their time for their benefit. It is a, "we'll call you if we need you," arrangement. "If you are available great, if not, then

we'll reach out another time." It also may be a situation where the worker calls in the day before a shift to see if they will be needed. Remember, the closer your requirement to call in is to the actual shift start time, the more chance that you will be obligated to paying waiting time.

### **Reporting Time Pay**

Reporting Time Pay is required when an employee shows up for their scheduled shift to work, but is not given any work or is given less than half the number of hours that they were scheduled for. When this happens, the employer is required to pay at least half of the hours that the employee was scheduled for (up to a maximum of four hours), but not less than two hours.

Reporting Time Pay also applies when an employee is called into work for a second time in a workday and works less than two hours. This would include being called back in for a meeting after the end of their shift. A minimum of two hours pay is due for going in twice.

Additionally, when an employee is asked to work on a day or attend a meeting on a day that they are not normally scheduled to work (including a termination meeting), the employer is subject to Reporting Time Pay and must pay the employee a minimum of two hours.

### **Exceptions to Reporting Time Pay**

Exceptions occur during situations which are out of the employer's control. They include:

- When operations cannot begin due to threats to you or property or when recommended by civil authority.
- When public utilities fail, such as water, gas, electricity or sewer.
- When work is interrupted by an act of God or other causes not within the employer's control.

Supervisors and payroll administrators should be knowledgeable about On-call and Reporting Time Pay obligations to avoid wage and hour claims and penalties associated with non-payment. Leap can help!

## One size does not fit all: Lack of proper PPE for women is dangerous

When her too-large safety vest caught on a door handle, Amy Roosa was jerked backward into the door. The contact resulted in a bruise.

For women in construction, that's an all-too-common occurrence.

Founder of The Safety Rack, a social media network that reviews PPE for women in the trades, Roosa said it's typical for women in construction to have to don ill-fitting gear. The result can introduce new hazards, as protection equipment like a bright safety vest morphs into an injury risk.

Amanda Guadarrama, project manager for Nashville, Tennessee-based Hardaway Construction, said she had experienced the exact same type of incident — a vest too big for her catching on something and jerking her back unexpectedly.

Sometimes the fit is too bad to even wear and work with.

"If, for example, my gloves are too big on me, I am more likely to remove them to complete my job, thus putting myself at risk for injury that the gloves could have prevented," said Roosa, who works as a risk control specialist senior for Gallagher, a Rolling Meadows, Illinois-based insurance and risk consulting firm.

Jessica Bunting, research practice director for CPWR, or the Center for Construction Research and Training, said an informal survey of 174 tradeswomen found that 77% had been exposed to a hazard unnecessarily because of ill-fitting PPE. The top hazards included falls and inhalation and eye exposure — when eyewear or respiratory gear doesn't fit well, debris or chemicals can more easily get into eyes and airways.

Paige Martonik, Reston, Virginia-based safety manager for DPR Construction, provided the same example as Roosa and Guadarrama: a baggy vest catching on a door. Switching to a more tailored vest that fits her better has made doing her job easier and boosted confidence, Martonik said, adding she'd never go back to a looser fit.

The baggy or loose clothing like Roosa, Guadarrama and Martonik have had to wear can create new, more serious dangers. Beyond catching on a doorknob or hindering mobility, gloves or other

loose clothing can get tangled in heavy, rotating machine parts, putting the worker's body at higher risk.

Even without a specific exposure, poorly fitting fall harnesses, for example, can pinch or ride up, cutting off circulation or creating a choking hazard, Bunting said.

### A worker issue, not a women issue

Bunting said there is a correlation between lack of or improper use of PPE and jobsite injuries.

In response to a separate survey from CPWR about fall incidents across the industry, nearly half of respondents said no protection was in use at the time of a recent fall. In about one in four cases where workers died in falls, they had access to personal fall arrest systems, but did not use them, according to an analysis of the National Institute for Occupational Safety and Health Fatality Assessment and Control Evaluation.

Even wearing poor-fitting PPE can give the impression — outward to others or inward to the worker wearing it — that they are safe and protected when they are not.

“If the PPE is not properly sized, it will not fully protect the worker and will give a false sense of security,” Martonik said.

And it is not just women who need access to the right size and kind of PPE.

“There are many male workers in all different shapes and sizes who don’t fit into PPE created for the average-sized American man,” Bunting said. “Thankfully manufacturers have begun developing more sizes and focus more on women’s workwear.”

In its informal survey, Bunting said, CPWR asked women if they had experienced difficulty obtaining PPE that fits them well at work. Nearly nine in 10 said yes. That said, some respondents indicated they have found and purchased PPE on their own, and thought therefore it wouldn’t be tough for employers to do so on their behalf.

### The right fit

The demand for construction labor is high: the industry needs half a million more workers in 2023. Traditionally, it’s been a male-dominated industry, but that has shifted slightly in recent years: 14% of workers in construction are women, the highest it’s ever been. That includes both office and field employees..

But those underrepresented groups need to feel a sense of belonging to stick around.

“There is a psychological component as well to wearing properly fitted PPE,” Roosa said. “Plenty of women, myself included, are aware we already stand out on a jobsite ... In addition to this, if employers are only supplying male sizes

or unisex sizes, their female workforce may not feel like they are valued or wanted.”

And when wearing ill-fitting gear, it needlessly distracts from the task at hand.

“When women are on a jobsite, they shouldn’t be distracted thinking about the potential safety hazards of something that is supposed to protect them,” Guadarrama said.

Using the oversized glove example, Martonik noted it’s not just a new hazard, it’s frustrating to how it impacts the task at hand.

“When team members don’t feel valued and cared for, their opinion of their job can be impacted,” she said. “Having the proper PPE is one of the ways we can demonstrate everyone’s value to the team ... I want my teams to know that I respect and appreciate them, they too should be proud of their work.”

## Bank failures cause uncertainty for contractors

Pressure on America's banks is fueling uncertainty in financial markets, causing concerns of a spillover to overall construction activity, according to economists.

After the closures of Silicon Valley Bank and Signature Bank last week, questions surfaced about how those collapses could impact the construction industry. For instance, numerous construction executives attending the Associated General Contractors of America's national convention in Las Vegas this week have inquired about potential industry impacts from these bank failures, according to Ken Simonson, AGC's chief economist.

SVB had \$209 billion in assets and \$175.4 billion in deposits as of Dec. 31, according to the Federal Deposit Insurance Corp., while Signature Bank had \$110.4 billion in assets and \$88.6 billion in deposits as of Dec. 31. Neither of those closures had any direct impact on contractors nor their projects, said Simonson.

But contractors can expect tightening and some tension from small and regional banks, said Greg Ross, industry managing partner at Grant Thornton, a Chicago-based accounting firm. These are big players in the construction industry that will likely tighten their credit lines and make it more difficult to close loans.


"[It's] important for construction companies to build cash reserves and maintain a certain level of liquidity," said Ross. "Make sure you have some diversity in your investments where you are able to react quickly."

Nonresidential construction activity this year has remained at high levels despite elevated construction and borrowing costs, according to an Associated Builders and Contractors analysis.



### Impact on interest rates

President Joe Biden has taken steps to restore confidence in the U.S. banking system, and said Sunday that taxpayer dollars would not pay to rescue depositors. Instead, the money will come from a fund banks already pay into — the Deposit Insurance Fund, according to a White House press release. Through that fund, depositors will have access to all of their money, while shareholders and certain unsecured debt holders will not be protected, according to the Department of the Treasury.

"At the moment, I think regulators have acted promptly and appropriately to limit the damage," said Simonson. "The fact that Treasury interest rates have plunged may mean other 'safe' investments will benefit from lower financing costs, such as highly rated state and local borrowers."

Simonson concluded that the impact on the construction industry will be minimal, at least until there has been more time to see if there are other hidden problems among the country's large banks.

These large banks, such as JP Morgan, Citi and Morgan Stanley, all expect a rate hike at the next Federal Reserve meeting, said Anirban Basu, ABC chief economist. Meanwhile, Barclays and Goldman Sachs reportedly await no change to already high rates.

It is conceivable that there will be no further rate increases this year, said Basu. For instance, Japanese financial holding company Nomura expects the Fed to actually cut rates at its next meeting.

However, a more likely outcome is that the Federal Reserve will raise rates perhaps once or twice more during the months ahead. Those rate hikes will take many months to make

themselves apparent in the economy, said Basu.

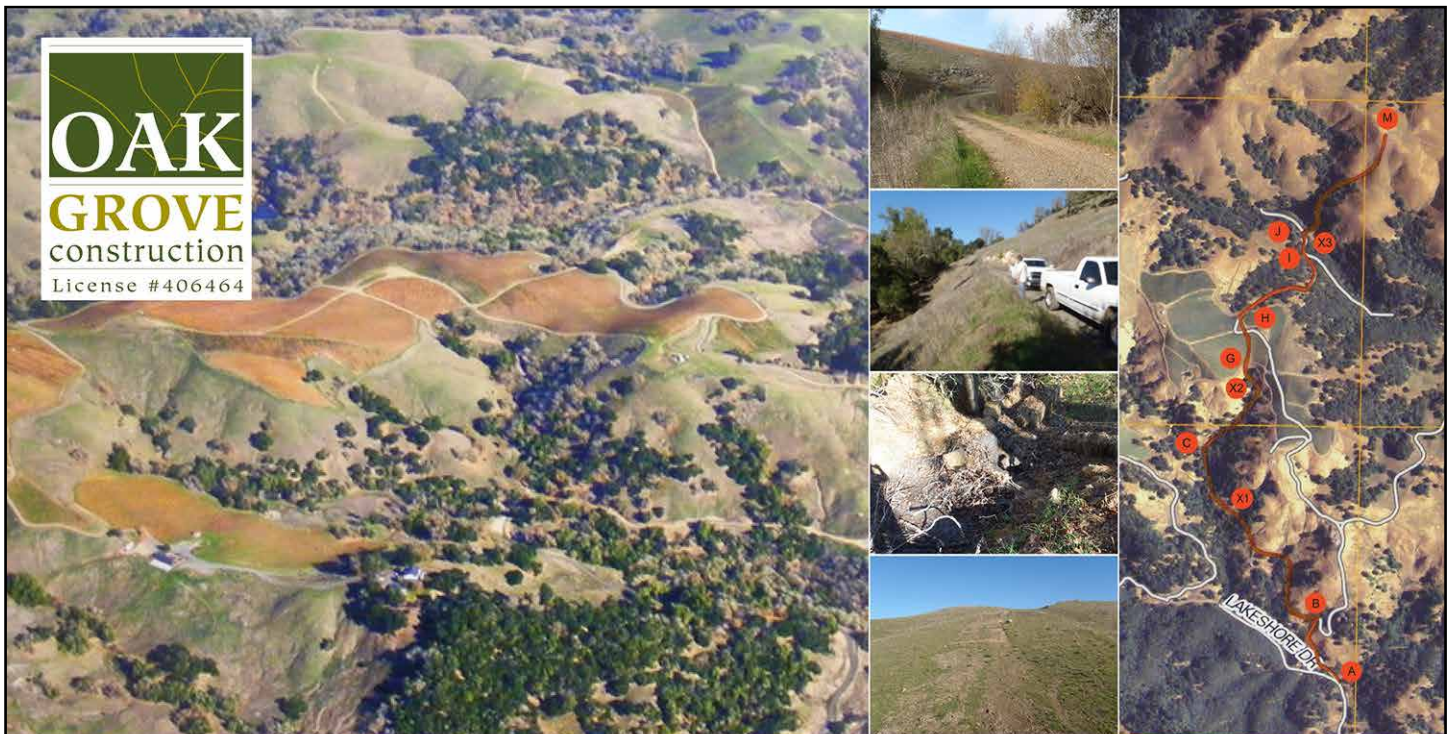
"With the likely tightening of financial conditions given the growing stress on America's banks and ongoing efforts by the Federal Reserve to rein in excess inflation, commercial real estate and construction are likely to weaken further during the year ahead," said Basu. "The current moment is, above all else, defined by uncertainty."

### Looking ahead

Though contractors with work related to infrastructure, industrial facilities and healthcare will remain busy, privately financed projects outside of that scope could see a slowdown, said Basu.

Grant Thornton's Ross also agrees a slowdown could be on the horizon for commercial projects.

"Current strong construction classes like multifamily, warehouse, industrial and storage could see some slowdown due to rising interest rates, investor skepticism and banking tension," said Ross. "Expect to see a fluctuation in consumer confidence that could impact overall demand including high growth areas like single-family, warehouse and multifamily."

## Workplace Violence by Occupation

EHS Today

It's a very grim statistic. From 1992-2019 workplace violence has killed almost 18,000 people.

This number comes from a recent study conducted by NIOSH, the Bureau of Justice Statistics, and the Bureau of Labor Statistics provides a broad view of workplace violence in the United States during the 27 years from 1992 to 2019. They define workplace violence as incidents that occurred outside the workplace but stemmed from work-related issues.


Looking specifically at 2019, the most recent year included in the study, the total of 454 homicides represents a 58% decrease from the high of 1,080 in 1994 but also an 11% increase since 2014. Homicides as a percentage of total fatal occupational injuries fell from 17% in 1993 to 8.5% in 2019.

More than 40% of workplace homicides in this period occurred in public buildings such as convenience stores and office buildings. Most other workplace homicides took place on streets, in private residences, and on industrial premises.

For non-fatal incidents of workplace violence, during 2015–2019 the average annual rate was 8 per 1,000 workers. Law enforcement and security professionals had the highest average annual victimization rate at 77.5 per 1,000 workers, followed by mental health professionals (45.2 per 1,000) and medical professionals (15.1 per 1,000). For workers in corrections professions, a subcategory of law enforcement and security, the victimization rate was 149.1 per 1,000.

During 2015–2019, the occupations with the highest incidence of workplace homicides were sales, protective service (police and firefighters), and transportation.

Available on the website of the Bureau of Justice Statistics, the study "Indicators of Workplace Violence, 2019" draws on five nationally representative data sources, including the Census of Fatal Occupational Injuries, the Survey of Occupational Injuries and Illnesses, the National Crime Victimization Survey, the National Electronic Injury Surveillance System, and the National Vital Statistics System.

## Materials prices inch up slightly

### ConstructionDive

Overall construction and nonresidential input prices both jumped 0.4% in February compared to the previous month, according to an Associated Builders and Contractors analysis.

Sharp declines in energy prices have pushed these overall numbers lower in recent months, but there remains “plentiful evidence of lingering materials price inflation and supply chain challenges,” said Anirban Basu, ABC chief economist, in a press release.

“While the February construction materials price inflation data appear benign, a peek behind the headline numbers indicates that price pressures remain abundant,” said Basu. “With growing pressure on the global banking system and the Federal Reserve still wrestling with excess inflation, risks of recession continue to expand.”

Natural gas prices fell sharply in February, down 41.4%, while the price of unprocessed energy materials such as crude oil and coal tumbled 9.1% for the month, according to the report.

Still, natural gas prices remain up about 68.9% since February 2020, while unprocessed energy materials also remain up 76.3% during the same period.

These massive price drops in energy mask widespread supply chain challenges and persistent materials price inflation, said Basu.

Overall construction input prices remained 2.6% higher than the year before, while nonresidential input prices ticked up 2.8% during that same span, according to the report. Since February 2020, overall construction and nonresidential input prices surged 38.8% and 39.1%, respectively.

That's largely due to increases in commodities such as concrete materials, up 14% in the past year, and switchgear products, up 11.7% in the past year. Meanwhile, on a monthly basis, prices for brick and structural clay tile ticked up 3.4%, copper wire and cable moved up 3.3% and iron and steel prices jumped 2.9% in February, according to the report.

Nevertheless, Ken Simonson, chief economist for Associated General Contractors of America, said earlier this month the U.S. economy should fend off a recession this year. He added that manufacturing and infrastructure projects, boosted by the Infrastructure Investment and Jobs Act and CHIPS Act, remain the bright spot in terms of construction activity.

Still, Basu warns of a possible slowdown for contractors outside that scope of work.

"While contractors performing public construction and working on industrial megaprojects stand to fare well during the years ahead, the fortunes of many other contractors are increasingly threatened by elevated costs of capital, tightening financial conditions and the rising cost of delivering construction services," said Basu. "Eventually, these factors could whittle away at backlog, which is currently elevated... creating greater challenges for contractors in 2024 or 2025."

## Capitol Connection Q&A for Contractors

‘Ch-ch-ch-changes’ to paraphrase David Bowie music! Contractors can’t always anticipate them but help in adapting is available here. I will also share with the CSLB in celebrating the important roles women now play in the construction industry...

**Q:** I have worked for my father’s contracting company for many years, and he passed away recently. I have applied for a new license and I’m requesting that his license number be re-issued to me. The CSLB sent me a letter requesting a contractor’s bond. My Dad just renewed the bond on his license. Can I request that the CSLB also transfer his bond?

**A:** No, unfortunately bonds are not transferrable. So even though you will be keeping your father’s license number you will need to obtain a new contractor’s bond.

**Q:** Our corporation is a licensed contractor in Nevada. We are in the process of changing from a standard ‘S’ Corporation to an Employee Stock Ownership Plan (ESOP). Do we need to do anything to update our Contractor’s License?

**A:** A change in ownership does not require that you update your Nevada Contractors License. However, I am not a tax advisor or attorney so suggest you research changing from an ‘S’ Corporation to an ESOP and if it would warrant a new Federal Identification number. That change may trigger a new application be submitted as your ‘business entity’ is now a different structure.

If your entity changes or if your Officers change, you are required to report it to the Nevada Contractors Board to update your license.

**Q:** You helped me obtain my Sole Proprietor license last year. I’m going to incorporate and transfer my number. I was wondering if your company provides Registered Agent services, or can I be my own Registered Agent?

**A:** We do offer Registered Agent services so please contact me if you’d like to get that set up. You can act

as your own Registered Agent as long as you have a California address.

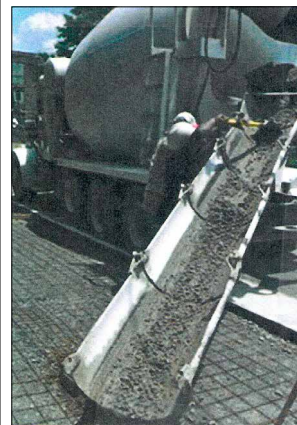
