Empower Makers Global Impact Challenge grant program will award up to \$25 million in grant funding over five years to non-profits that are supporting trade workforce development initiatives.

Stanley Black & Decker has announced the recipients of its inaugural Empower Makers Global Impact Challenge grant program. The program, launched in 2021, awards up to \$25 million in grant funding over five years to non-profits that are supporting trade workforce development initiatives with the goal of skilling and reskilling up to 3 million makers.

With an estimated 650,000 open construction jobs in 2022 and 10 million unfilled manufacturing jobs globally, Stanley Black & Decker has made vocational skills training a priority through its corporate social responsibility (CSR) mission. A major component of the

company's CSR strategy includes a goal to empower 10 million makers by the year 2030.

Fifty-nine organizations have been selected to receive \$3 million to enable vital trade skills training and reskilling programs in the construction and manufacturing sectors. The inaugural recipients include career development schools, community colleges, construction nonprofits and trade schools from around the globe committed to positively impacting trade professions. In addition, the company will be providing nearly \$1 million in

tool donations to another 27 organizations to outfit makerspaces and training facilities.

“Congratulations to this year’s Impact Challenge winners, who are each making a significant impact in helping to address the skills trade gap,” said Stanley Black & Decker’s Vice President of Social Impact, Diane Cantello. *“Our purpose is to support ‘Those Who Make the World,’ and being able to fund educational programs and non-profits that are revitalizing trade careers directly connects to our core mission. By helping provide a pathway for trade professionals, we are also setting our sights on constructing a better future that can uplift the hardworking tradespeople who build our world to meet the ever-changing needs of society.”*

More than 240 total applications were evaluated based on number of people served, outcomes projected,



Capitol Connection Q&A for Contractors

You can't 'ignore' this issue. You can however 'disassociate' from this problem! Another contractor learns what happens when you do ignore doing 'due diligence' when changes affect your company and licensing...

Q: We have an Officer who is retiring, and he has been associated with several of our Corporate licenses over the years, some that are now cancelled. Is it necessary to file Disassociation forms for those cancelled licenses? A few of those entities were merged into other corps as far back as the mid-90's and no longer use the mailing address listed on the CSLB website and the other Officers have long left the Company. I want to be thorough but also don't want to create more work or cause confusion.

A: It's not necessary to file Disassociations if the licenses have been cancelled for good. The only licenses he should worry about removing himself from are the ones where (obviously) he is still associated, or the ones which are more recent. Anything that has been expired or cancelled for more than five years you can ignore.

Q: Our license is currently Suspended for lack of Qualifier. Our Responsible Managing Employee (RME) retired in early 2021, notified the CSLB, and our license was then Suspended after the 90 days. We didn't bother with it because we didn't have any work in CA but now, we are looking at a possible opportunity and need to work to get our license back in good standing. For this potential project, assuming we get our license back to Active status, can a wholly owned subsidiary of our corporation work under our license? Or are they required to have their own Contractor's License?

A: Being that the Subsidiary is a separate entity, it would be required to hold its own Contractor’s License. One entity cannot “use” or work under another entity’s license, regardless of the relation. It’s always a good idea practice ‘due diligence’ with keeping CSLB up to date on adjustments to entities, status or address changes.

Q: When reading the requirements for an individual to Qualify for multiple Company’s licenses, it seems that assuming the individual is an Responsible Managing Officer (RMO), the limit is three. Does that mean three Company licenses in addition to a Sole Proprietor license, or is the Sole Owner license considered one of the three

Company licenses? I’m hoping to be able to Qualify three Company licenses while keeping my Sole Proprietorship active as well.

A: An individual is permitted to be on three Company licenses (assuming he/she meets the requirements outlined in B&P Code Section 7068.1 regarding qualifying multiple licenses) in addition to their Sole Proprietor license. Sound like you are going to be one busy guy!

How to attract and retain subcontractors, trade partners in 2022

Many builders and developers are having a hard time finding qualified talent to fill current subcontracting needs and, as a result, are struggling to keep up with the heightened demand.

Residential construction is booming. However, many builders and developers are having a hard time finding qualified talent to fill current subcontracting needs and, as a result, are struggling to keep up with the heightened demand. In fact, according to the National Association of Home Builders (NAHB), there were 410,000 unfilled construction jobs in October of 2021. That is the highest measurement the NAHB has seen since it started collecting the data in late 2000.

Although there is a talent shortage nationally, builders can take the steps necessary to prevent that shortage from impacting their company by becoming a builder of choice. Builders who make the commitment to invest in building mutually beneficial partnerships, cultivate trust and focus on communication will reap the benefits of having a

committed trade subcontractor base willing to work for them when given a choice of which projects to take on. Here are some ways builders can do just that:

Streamline Operations with Automation

According to ECI's 2021 State of SMB Digital Transformation Report, more than half (65%) of home builders identified contractor management/communication as an invaluable feature included in their enterprise resource planning (ERP) system. With more projects than trades to work on them, there are not enough people to hire to fill the trade gaps that need to be filled. As a result, builders and their trade contractors need to leverage technology, not only to become more efficient, but to

create better internal workflows and improve operational efficiencies.

Subcontractor management tools can help streamline work orders, consolidate scheduling, improve visibility with payments and other documentation. By leveraging automation within subcontractor management tools, builders are able to remove inefficiencies in the process – leaving room for trades to spend their valuable time elsewhere and reduce the time spent on administrative tasks.

Improve Communication and Collaboration

Once under contract, subcontractors are no longer independent. They are responsible for doing their part to build a quality home for the end customer, so treating them as team members and stressing interdependence will be key for builders. Builders should aim to foster a motivational environment that promotes positive work and transparent communication. To achieve this, it's important to, from time-to-time, connect directly with trade subcontractors to discuss what's working and what's not. From there, builders can make adjustments to correct the working environment so that it works for both parties and keeps trades satisfied.

Over the past year or two, builders may have deemphasized this notion of teambuilding. This may be because of COVID restrictions or due to increased demand and tight resources. However, technology can help offer real-time communication and collaboration solutions for subcontractors and builders to touch base on and off the jobsite. This can help with eliminating disparate lines of communications and ensuring all parties are


collaborating effectively. Investing in tools like this will also help attract a younger generation of trade partners who are looking to work with companies that utilize modern technologies.

Prioritize Training



While hiring and finding trades is a big hurdle to overcome, the effort behind building a strong trade base cannot stop there. In a scenario where there is more work to be done than workers to do it—like what we're currently experiencing in the residential construction industry—adaptability is key. One way to build an adaptable workforce is to invest in training. With proper trainings, subcontractors can increase their efficiency and become more versatile which translates to being able to eventually take on more work.

Taking the time to properly train trades on existing technology is also an important step. Once they understand the requirements and how to use your systems, trade partners are often able to streamline their own processes, ultimately saving time and money.

Considering how the scarcity of labor is causing construction delays and, as a result, creating further costs, it's not surprising that we're seeing both housing supply and affordability be negatively impacted. However, builders who lean on technology to improve processes and communication, while putting in the work to train their trades, will be in a much better place to accomplish their projects with fewer resources.

OSHA's National Stand-down to prevent falls in construction

Fatalities caused by falls from elevation continue to be a leading cause of death for construction employees, accounting for 351 of the 1,008 construction fatalities recorded in 2020 (BLS data). Those deaths were preventable. The National Safety Stand-Down raises fall hazard awareness across the country in an effort to stop fall fatalities and injuries.

What is a Safety Stand-Down?

A Safety Stand-Down is a voluntary event for employers to talk directly to employees about safety. Any workplace can hold a stand-down by taking a break to focus on "Fall Hazards" and reinforcing the importance of "Fall Prevention". Employers of companies not exposed to fall hazards, can also use this opportunity to have a conversation with employees about the other job hazards they face, protective methods, and the company's safety policies and goals. It can also be an opportunity for employees to talk to management about fall and other job hazards they see.

Who Can Participate?

Anyone who wants to prevent hazards in the workplace can participate in the Stand-Down. In past years, participants included commercial construction companies of all sizes, residential construction contractors, sub- and independent contractors, highway construction companies, general industry employers, the U.S. Military, other government participants, unions, employer's trade associations, institutes, employee interest organizations, and safety equipment manufacturers.

Partners

OSHA is partnering with key groups to assist with this effort, including the National Institute for Occupational Safety and Health (NIOSH), the National Occupational Research Agenda (NORA), OSHA approved State Plans, State consultation programs, the Center for Construction

Will boycotts of Russia hurt the construction industry?

The construction industry as a whole stands to sustain significant damage from boycotts of Russia over the invasion of Ukraine, according to an analysis by GlobalData. The harm will come in the form of higher energy and materials prices, although individual construction and other firms will suffer only minor direct damage from leaving Russia, GlobalData says.

Incoming ASCE chief emphasizes infrastructure delivery

A focus on programs rather than individual project delivery will help state and local governments avoid supply chain snarls and achieve results using funds coming their way from the bipartisan infrastructure law, says Maria Lehman, president-elect of the American Society of Civil Engineers. Furthermore, entities receiving the funds should work collectively to determine “*how you’re getting the products, how you’re moving it to where it needs to be, how you’re buying it, how you’re implementing it,*” Lehman says.

The economic and risk landscape for construction

The economic earthquakes of the past few years have posed challenges for the construction industry, and it doesn’t appear things are about to change as the Associated General Contractors of America prepares for its annual convention. AGC Chief Economist Ken Simonson and Brian Perlberg, the association’s senior counsel of construction law and contracts, reflect on four key factors for the industry moving ahead: the Russia-Ukraine conflict, construction’s warehouse and manufacturing sector, the distribution of infrastructure funds and the incorporation of pandemic risk in contracts.

February jobless rates down in 31 states; payroll jobs up in 27 states

In February, unemployment rates were lower in 31 states and the District of Columbia and stable in 19 states. Nonfarm payroll employment increased in 27 states and

was essentially unchanged in 23 states and the District.

Rates need to exceed 3% by year-end, says Fed's Bullard

The Federal Reserve needs to raise interest rates above 3% before the end of this year to fight inflation, said James Bullard, president of the Fed's Bank of St Louis and member of the Federal Open Market Committee. *"The committee will have to move quickly to address this situation or risk losing credibility on its inflation target,"* he said.

Gas tax suspension would erode infrastructure funding, road builders say

In an effort to mitigate the effects of high gasoline prices across the country, six Democratic governors requested a pause on the 18.4-cents-per-gallon federal gas tax through the rest of 2022. However, the American Road & Transportation Builders Association said the measure could unravel the revenue structure and transportation funding in the Infrastructure Investment and Jobs Act. That's because the bill would authorize the Treasury Department to use general fund dollars to replace the temporarily lost revenue from the halted gas tax. Since the Highway Trust Fund is flush with an additional \$118 billion from the Infrastructure Investment and Jobs Act (IIJA), its supporters say the

Federal Highway Administration can afford it.

Cities ramp up EV infrastructure as gas prices climb

Towns and cities across the US are installing electric vehicle charging stations, and the trend is not confined to the US. Glasgow, Scotland, will install 164 charging stations this year.

Why modular has not clicked in commercial construction

Visions were grand, forecasts ambitious: Permanent modular construction would change the industry, saving time, money and the environment. But years after its initial adoption in the U.S., it accounted for just 5.5% of new construction last year in North America, according to the Modular Building Institute (MBI). Despite promised cost savings, environmental benefits and quicker return on

investment, contractors are still running into roadblocks using modular construction. Many face a steep learning curve, and there can be snafus with design, manufacturing, transportation and assembly, they say. *“On paper, and if all goes according to plan, modular construction should result in both time and cost savings. But modular techniques have not cracked the code fully on commercial, and other more complicated, construction types,”* said Raja Ghawi, partner at Era Ventures, a proptech-focused venture capital firm, who previously worked as an investment director at Boston-based Suffolk Construction.

US eases tariffs on UK steel and aluminum

The United States reached a deal with the United Kingdom to partially lift tariffs on steel and aluminum exports from the U.K. beginning June 1, the two countries announced Tuesday. The U.K. will be able to export a certain amount of steel and aluminum into the U.S. duty-free before tariffs take effect. In return, the U.K. will lift approximately \$500 million worth of tariffs on U.S. products such as whiskey and blue jeans. The deal eases duties imposed in 2018 by former President Donald Trump. Trump imposed 25% tariffs on steel imports and 10% tariffs on aluminum imports as part of a strategy to prioritize domestic production and address an overcapacity of steel in China.

Could Zoom towns go bust?

COVID-19 shut down offices around the country in 2020, suddenly freeing people to move to smaller, less

expensive cities, also known as Zoom towns. These cities, which increased in popularity among Americans who use videoconferencing to work remotely during the pandemic, are still attracting strong interest from apartment investors. In fact, interest in these metros, like Boise, preceded the pandemic. From 2009 to 2021, investment in these towns jumped more than 2,000%, according to RealPage. Scottsdale, Arizona-based Alliance Residential, the nation’s second-largest apartment developer, has moved into Zoom towns over the last few years. *“We’re in a lot of different markets that we previously weren’t in – the Boises of the world or Colorado Springs or some of the smaller markets,”* said Jay Hiemenz, president and COO of Alliance. As more dollars pour into Zoom towns and new apartments are being built, some people wonder what happens to these areas if workers are called back into the office. Overall, 4.9 million people left cities for rural areas in 2020, according to the U.S. Census Bureau. *“Some of these markets were growing, but they weren’t growing fast,”* said Todd Metcalfe, a senior economist at Moody’s Analytics. *“Now, all of a sudden, they’re outpacing everyone. Long-term growth rates will come back to normal levels.”* Huntsville, Alabama, leads the pack, with apartment stock there slated to grow by 16.5%. Other major Zoom towns such as Boise, Idaho; Charleston, South Carolina; Colorado Springs, Colorado; and Reno, Nevada, will all see inventory growth between 7% and 8% in 2022, according to RealPage. *“If there are pockets of risk, it’s*

where you are seeing people who are putting shovels in the ground to develop units based on what they perceive to be this structural change in migration patterns because of the pandemic,” said Ryan Severino, chief economist for the Chicago-based commercial real estate services firm JLL. “I’m not sure how durable that is.”

Bidding wars break out in NY while San Fran multifamily properties struggle

New York City and San Francisco were the poster children for pandemic urban flight in 2020. As residents moved out of the two pricey coastal markets, landlords grappled with ballooning vacancies and rent decreases. New York saw one-bedroom rents fall 17.6% from March 2020 to January 2021, according to apartment listing service Zumper. In San Francisco, rents in one-bedroom apartments fell 22.6% from November 2019 to November 2020. Now, two years later, San Francisco and New York are rebounding, but they’re not recovering at the same rates. In New York, rents have jumped and occupancies

have tightened so much that there are now bidding wars for rentals in the city. In San Francisco, rents have risen but are still below pre-pandemic levels.


