News Briefs

COVID-19 SPSL requirements for firms with 26+ employees

Last week, the CA Supplemental Paid Sick Leave (SPSL) law took effect for employers with more than 25 employees. Previously, SPSL was only for large employers and those not covered by FFCRA.

The new requirements allow employees to have 80 hours of supplemental paid sick leave for various COVID-19 reasons, including vaccinations.

There is also a posting and wage statement/pay stub requirement effective now. Be aware too that CA SPSL applies retroactively to January 1st, 2021 when requested by an employee.

What to watch out for in expense reimbursements

The California Employers Association, which NCBE belongs to, is urging employers to be very careful when using '*per diem*' or flat reimbursement rates, regardless of what the reimbursements are for.

There is recent case law that found that an employer's reimbursements for things like meals, incidentals, and housing should have been included in the regular rate of pay for purposes of calculating FLSA overtime.

Filing taxes for your small business in 2021: Deductions and credits

Small Business Tax Deductions and Credits

Tax time is approaching fast. Unless your small business is structured as a C corporation, you will likely owe self-employment (SE) tax on your net profits, along with your usual income taxes.

Fortunately, there are several deductions and credits that can reduce the overall tax burden for self-employed individuals, partnerships, and LLCs.

Whether you are planning to hire a professional or do your taxes yourself, you should be aware of a few of the tax benefits available to small businesses.

Standard Deduction

The standard deduction, which lets you deduct a fixed amount from your taxable income, is a simple way to reduce your total tax due.

Because standard deduction amounts have increased significantly in recent years, many taxpayers now choose to claim this deduction rather than itemizing their personal expenses—such as medical and dental costs, state and local taxes, mortgage and home equity interest, and charitable contributions.

On the other hand, you might find that itemizing your Schedule A deduction results in more significant savings for you and your business. In this case, filling out the paperwork may be worth the extra effort—just make sure you have the necessary documents to back up your claims (in case you're audited).

The standard deduction amounts for 2020 are as follows:

\$12,400 for single taxpayers or married couples filing separate tax returns

\$18,650 for individuals filing as head of household

\$24,800 for married couples filing jointly
(or surviving spouses)

Note that certain factors disqualify taxpayers from taking the standard deduction. If you file separately with a spouse who is itemizing their deductions, if your business is a partnership, or if you haven't been a citizen or legal resident of the U.S. for the full tax year, you won't be eligible.

Additionally, if you do qualify for the standard deduction, some factors may limit your deduction amount (such as being claimed as a dependent) or increase it (such as being blind or over the age of 65). This IRS tool can help you quickly determine what your total standard deduction will be.

Qualified Business Income Deduction

Whether you are planning to take the standard deduction or itemize, you will still be eligible to claim the Qualified

Business Income Deduction (also called Section 199A) for your pass-through business entity—provided you meet all the criteria.

Section 199A allows a deduction of up to 20 percent on net income for sole proprietors, partnerships, LLCs and S-Corps—basically any business type that operates as a pass-through entity (where profits and losses “pass through” to the owner's tax return).

However, keep in mind that your taxable income must be at or below a certain threshold to receive the full 20 percent. For those over the threshold, various limitations apply, which reduce this percentage.

This year, limitations on Section 199A will apply to taxpayers with income above \$163,300 for single and head of household returns, \$326,600 for joint filers, and \$163,300 for married filing separate returns.

Note: If your taxable income places you just slightly over the threshold, you might consider asking your tax professional whether tax planning can help you to claim the full 20 percent deduction next year. Contributing to a 401k

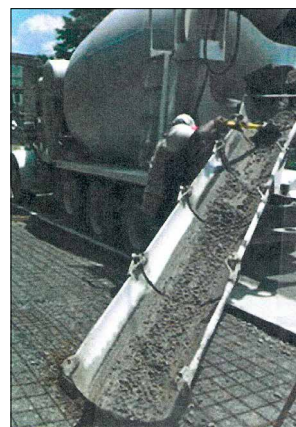

retirement account is one sensible way to reduce your gross income; making tax-deductible contributions to charities is another.

Business Interest Deduction

The interest on your business loans (if you have any) may be deductible—and the CARES Act has potentially made it easier for small business owners to benefit from this allowance.

Until recently, the business interest deduction had to be less than 30 percent of the business owner's adjusted taxable income. With the CARES Act, this limit has increased to 50 percent for the 2019 and 2020 tax years. This increase is applicable to all business types other than partnerships.

If you think your business could benefit from the 50 percent business interest deduction, you (or your tax professional) can apply by attaching Form 8890, Limitation on Business Interest Expense, to your tax return.

Be aware, though, that electing to use the 50 percent business interest deduction rate may be more advantageous to some businesses than others. You will want to discuss the pros and cons with your accountant or tax preparer.

Sick and Family Leave Credit

Eligible self-employed individuals and small business owners may be able to claim Covid-19 sick and family leave tax credits using IRS Form 7202.

If you were unable to work for a period of time in 2020 due to self-quarantine, Covid-19 symptoms, having to care for someone with Covid-19, or lack of childcare due to school or daycare closures, these refundable tax credits could help to reduce your federal income tax bill.

For leave taken in 2020—between April 1 and December 31—you will claim your credits on your 2020 Form 1040. Credits for leave taken in 2021 (between January 1 and March 31) can be claimed when you file your 2021 taxes.

Deductible Operating Expenses

The IRS's list of tax-deductible business expenses is long—these are just a few. You'll want to do your research and consult your tax professional to ensure you are taking advantage of every deduction available to you.

Home Office

Self-employed individuals who work from home (in a workspace that is regularly and exclusively used for business purposes) are eligible to deduct the costs of maintaining this space.

You can either use the simplified option—taking \$5 per square foot up to 300 feet—or you can calculate it as a percentage of your home's total square footage, itemizing all costs associated with the space.

IRS Form 8829 can help you to determine which home office expenses to deduct.

Marketing

A majority of small businesses now have websites, social media campaigns, and SEO (Search Engine Optimization) strategies to increase their visibility online. The good news is these marketing expenditures—and others—are tax-deductible, as long as they are reasonable and directly related to your business.

Sole proprietors and single-member LLCs will need to record their advertising expenses on Schedule C, while partnerships and multiple-member LLCs should use Form 1065: Partnership Income Tax Return.

Business Use of Your Vehicle

If you use your car for business purposes, you can deduct the associated expenses (fuel, car maintenance, insurance) on your tax return. Just make sure to divide your expenses based on mileage if you regularly use your vehicle for both business and personal purposes. The IRS provides a list of standard mileage rates to help you calculate your deductible costs of operating your vehicle for your business.

Deadline Notice-June 30, 2021

Employers with 50+ employees and without a sponsored employee retirement plan will be required to participate in the mandatory State of California Cal Savers plan. Penalties will be assessed for non-compliance.

Employees age 18, paid by W-2, will have to be included after 30 days of employment. These employees will be auto-enrolled at 5% of gross pay into a Roth IRA.

Impacted employers can explore other retirement plan options that will meet the state mandate outside Cal Savers. These solutions can be administratively more manageable and give employers more flexibility and control over the retirement plan they design for their employees.

Infrastructure projects open opportunities for small businesses

Springtime sees an increase in transportation projects, which means more contracting opportunities for small businesses. The US Department of Transportation (USDOT) Infrastructure for Rebuilding America (INFRA) program recently announced new grants for 2021 totaling approximately \$889 million. In addition, the California Road Repair and Accountability Act of 2017 (SB1), Local Partnership Program appropriates over \$200 million annually for transportation improvements.

According to the California Department of Transportation (Caltrans), over \$1 billion is budgeted annually to over 600 cities, counties, joint power authorities, transit agencies, special districts, and other local partner agencies for the purpose of improving transportation infrastructure. With this, Caltrans administers over 1,200 new projects every year. Local partner agencies are a valuable resource in this process since have the primary responsibility for implementing specific projects to improve mobility and access. They are tasked with Advertisement, Award, and Administration (AAA) to help deliver transportation infrastructure projects and programs.

This funding is good news for businesses in transportation and construction industries as it means more contracting opportunities will be available for both prime contractors and subcontractors. Additionally, a percentage of all USDOT funded projects must be performed by [Disadvantaged Business Enterprise \(DBE\)](#) certified firms so there is ample incentive for DBEs to win these contracts.

3 Remodeling industry updates from NAHB

What is new in the industry? The National Association of Home Builders shares updates that remodelers should know.

Lumber Prices Create Uncertainty for Remodelers

Lumber prices have repeatedly reached record highs over the last six months, introducing challenges and uncertainty into a remodeling industry that is otherwise enjoying a prosperous year. In December, the prices that builders and remodelers paid for softwood lumber rose by double digits (up 12.5%) following an almost 25% decline over the previous two months. While softwood lumber prices remain nearly 15% lower than the record high set in September, they are still much higher than normal, and it's likely that forthcoming data will show even further increases in price. When viewed through the lens of material price volatility, the stability of remodeling speaks to enduring strength in the coming years as the nation rebuilds, post-pandemic. Material price fluctuations, namely softwood lumber, are

likely to continue to make it difficult for remodelers to ensure they will be able to complete projects on time and on budget. Anecdotally, some builders and remodelers are providing quotes to clients that are only good for thirty days, due to the unpredictability of the market.

Confidence in Remodeling Market Remains High

In a good sign for the industry, NAHB's Remodeling Market Index (RMI) for the fourth quarter of 2020 posted a reading of 79, an indication that residential remodelers remain confident in the market, based on current conditions and future expectations. NAHB economists, through the RMI survey, ask remodelers to rate five components of the remodeling market as "good," "fair" or "poor." Each

3 Website redesign myths for remodelers

A website redesign could help remodelers generate more leads, but that's not always the case. Here's why.

Spencer Powell, Builder Funnel

Myth #1: My website has worked this long, so it's fine

Just because your website has worked, doesn't mean it can't be improved. I'd also challenge you to think about if your website really has been working or has it just been existing? My guess is that your website doesn't reflect the current quality of your work or even feature the latest projects you've completed or the new way you take clients through the project. If any of these is the case, you have a couple of options.

Path #1: if your website is super outdated and doesn't present your brand in a positive light nor reflects the quality of work you do, it makes sense to explore a redesign before you move on to improving the performance of your website.

Path #2: if your website has high-quality photos and presents your brand well, then you should move directly to working on website performance through SEO and updated content as opposed to website design.

Myth #2: A website redesign will automatically result in more traffic, leads

I talk to hundreds of remodeling companies every single year and probably about a third of them are actively thinking about redesigning their websites. However, the reason they want to redesign their website is not necessarily because they want it

to look better. They want it to perform better. This is a critical distinction.

A good website will present your brand and your company in a good light which means it looks professional and the design is solid with high-quality photography. A high-performance website does that in addition to generating traffic and leads. This means you get legitimate inquiries for your services from prospective customers discovering you via Google. Don't expect a brand new website design to magically bring you new customers. All it will do is change the way your website looks and feels.

Myth #3: SEO changes all the time, so it doesn't matter

Website performance has to do with quality content, SEO, user experience, and lead conversion optimization. When I look at the data from all the remodeling websites we manage across the United States and Canada, the highest quality leads always come from Organic Search (i.e. Google). SEO matters more today than ever before. As the buying demographics for remodels ages, more and more millennials are turning to Google instead of relying on their friends and family for recommendations. Making SEO a priority will ensure your future success online to generate high-quality leads and customers.

Expense reimbursements on shaky ground

Employers should proceed with caution when using “per diem” or flat reimbursement rates—whether it’s for travel expenses, cellphone and internet data usage, or remote worker stipends. If the reimbursements tend to increase or decrease based on time worked, the payments are likely functioning as pay compensation rather than as a reimbursement. If that is the case, the payment should be factored into the regular rate of pay to avoid overtime miscalculations.

New Case Law

In the recent case, *Clark v. AMN Services, LLC*, the Ninth Circuit found that an employer’s per diem expense reimbursements for meals, incidentals, and housing should have been included in the regular rate of pay for purposes of calculating FLSA overtime. While the case turned on fact-specific inquiries (discussed below), it leaves per diem reimbursements on shaky ground.

The court did not go so far as to say that per diem reimbursements must always be included in the regular

rate, but employers must be careful that their per diem reimbursements are tied to business expenses actually incurred, instead of functioning as compensation for hours worked.

Case Specifics

AMN provided per diem payments to travel clinicians who worked more than 50 miles away from their homes. AMN’s policy allowed deductions to the per diem amount when the employee worked fewer hours, regardless of the reason. If the employee worked more shifts than anticipated, they were allowed to “bank” the additional hours for another week if they didn’t work their full shift. Finally, local clinicians who did not travel also received per diem reimbursements, but as part of their “wages” for both tax purposes and the regular rate calculation for overtime.

The combination of these factors led the court to conclude that the per diem reimbursements functioned as compensation for hours worked and, therefore, must be included in the regular rate of pay.

Q: When applying for a California license, does the CSLB set an applicant a test date, or do I have the ability to schedule it myself? I want to obtain my own Contractor's license, but my wife is pregnant, due in about two months, and I don't want to have the application rejected if I'm not able to make the exam date if that is how it works.

A: Congratulations to you both. The CSLB does schedule your exam date for you, however they will work with you on the date if it doesn't line up with your schedule. They always give you the next available date nearest to your location (by zip code).

Q: I am a General "B" Contractor and I currently have a project in process which has been nothing but a headache. The Homeowners are requesting that I hire a "C-10" sub-contractor to do the Electrical work, which I always do myself. Are they permitted to request a "C-10" Contractor to do work that I signed as a General? And if the Electrical Contractor I use cannot start on my project for several weeks, what happens to the "completion date" reflected on the original contract?

A: While there are rules and laws which regulate Contractors, there are no laws which regulate Homeowners, as much as you Contractors may dream of that! Project Owners are "allowed" to require/request anything they want as long as it aligns with the contract you signed. If they want a "C-10" contractor to do the Electrical work, they are perfectly in their realm to

request that. As far as the date of completion, we (Capitol Services) don't get too involved in contracts, but I do know if the Homeowner is requesting additional work or repairs to work already done, a change order can be done, and the completion date can likely be updated, or negotiated to accommodate the change.

Q: If we Disassociate our Qualifier, I understand we have 90 days to replace him. Do we have to stop work for that 90-day period?

A: No, the license will remain Active for the 90 days and you continue business as usual. When the 90 days expires and you haven't replaced your Qualifier, your license will go Suspended. Contact us if you need assistance!
