CSLB to expand testing services for licensed contractor examinations

The Contractors State License Board (CSLB) will transfer the administration of its license examinations to PSI Exams Inc beginning in July 2022. CSLB will continue to develop the license examinations internally.

Moving test administration to PSI will benefit test takers by expanding the number of exam locations throughout the state, increasing testing and customer service hours, and expanding translator services and Saturday and evening availability.

Notifications for scheduling exams will be mailed to applicants with instructions on how to schedule tests at one of the 20 PSI locations.

This change will not increase applicant examination fees.

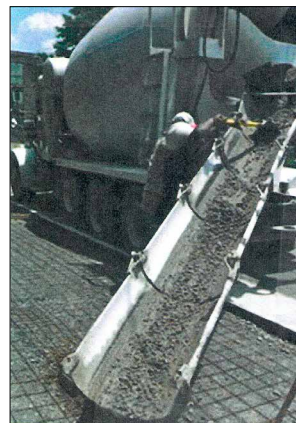

Multichannel TRSPs address different demands. They will be easier to install on vehicles with ABS systems that are already built with multiple sensor and modulator configurations, such as 2S/2M or 4S/2M. In addition, tandem axle trailers are better served by a multichannel option, since each axle is sensed and controlled. Most key components of a multichannel TRSP are efficiently housed in a single, environmentally protected modular unit.

What Drivers Should Know About Trailer Stability

“The first thing any driver should know is what sort of stability system, if any, is on the trailer they’re pulling,” said David Dennis, supervisor – Bendix Tech Team. *“This is pretty easy to spot. You should be able to tell by looking at the information sticker on the trailer if it’s equipped with an ABS or roll stability. And just to be clear – if it’s got stability, it’s built on ABS. You can’t have stability without the ABS controls.”*

Responsibility for the safe operation of the vehicle remains with the driver at all times, which is why it’s

important for the person behind the wheel to be aware of any trailer stability system’s capabilities. Safety technologies like trailer stability complement safe driving practices, Thomas stressed. No commercial vehicle safety technology replaces a skilled, alert driver exercising safe driving techniques and proactive, comprehensive driver training. Responsibility for the safe operation of the vehicle remains with the driver at all times, which is why it’s important for the person behind the wheel to be aware of any system’s capabilities and possible interventions.

Monitoring a trailer stability system from the cab just requires a watchful eye. There’s an amber warning lamp located on the left rear side of a trailer, in view of a driver’s side mirror. If it’s illuminated, there’s an active Diagnostic Trouble Code (DTC) and it needs to be checked out as soon as possible.

In addition, on all tractors built after 2001, the trailer will communicate issues to the tractor through the power line carrier, which enables dashboard warning lights. It’s

important to note that a stability warning lamp does not mean the trailer has no brakes. It just indicates that the ABS/stability system is not functioning; the brakes will operate normally.

Drivers may also catch on to trailer stability issues by listening to the “chuff test” that the system runs at startup. When the tractor is keyed on, the air brake system runs through the process of firing the individual modulators to make sure they’re working, creating a series of clicks and “chuffs.” A system or modulator that has faulted will not produce the chuff sound.

Information Key to Diagnostics

When it comes to diagnosing an issue with a trailer stability system, details matter. If you’re the driver, try to provide as much information about the situation as you can.

Do you notice, for example, that the trailer pulls during long right turns such as on a cloverleaf – or that the warning light comes on when you go over railroad tracks? Anything you can let the techs know about driving situations, road conditions or weather is helpful. Owner-operators can also examine some DTCs themselves, as the trailer sticker will include basic blink code information, providing insight on the severity of the fault.

Wiring-related issues are among the most common causes of trailer stability system faults, since weather and exposure can easily contribute to wire problems. In fact,

many times, the system’s Electronic Control Unit (ECU) isn’t the primary cause, which reinforces the importance of knowing as much information about the circumstances as possible.

Technicians should begin by using a diagnostic tool to identify the ABS or stability system installed on the trailer. From there, deeper dives into the issue may be required, highlighting the importance of using up-to-date diagnostics.

“Safety and uptime depend on getting the right results quickly in the shop, so you need to make sure your diagnostics are equipped to recognize and support the newest ECUs and other connected components,” Dennis said. *“Trailer stability maintenance is a three-step process: Identify the failure, address the failure, and clear the code. Making the right moves along the way is what will get your vehicles back on the road and rolling safely.”*

Officials approve \$312 million for 126 highway projects in California

As part of Gov. Gavin Newsom's landmark \$1.1 billion Clean California initiative, Caltrans is awarding \$312 million for 126 projects along the state highway system.

Designed to foster cultural connections and civic pride, the projects are expected to generate 3,600 jobs as part of the multiyear initiative led by Caltrans to upgrade interstates and beautify community gateways and public areas along highways, streets and roads while creating thousands of jobs for Californians. Ninety-eight percent of the projects will benefit historically underserved or excluded communities.

"Caltrans partnered with communities throughout California to identify and develop projects that meet the specific needs of each individual region while also enhancing and beautifying public spaces," said Caltrans Director Toks Omishakin. "By working together, we are better able to restore public pride in our communities and help change the habits that create litter in the first place."



Developed in close collaboration with tribal and local governments, non-profits and businesses, the 126 state beautification projects include art installations, green space and proposals that improve safety and promote community connections. Construction begins in April 2022.

Some of the larger projects include:

District 3: Eureka

State Route 99 (SR-99) Golden State Highway Beautification Project — Phases 1 & 2 (city of Sacramento/ Sacramento County): These projects will improve and upgrade a 9-mi. stretch of SR-99 between the Broadway undercrossing and the Stockton Boulevard overcrossing. Enhancements will include the painting of existing sound walls and retaining walls and the installation of slope paving, improved lighting and aesthetic fencing on bridges and pedestrian crossings. Murals also will be installed at the 2nd Avenue and 21st Avenue undercrossings.

The total cost of this project is \$13.8 million with an estimated start date of July 2022 for Phase 1 and December 2022 for Phase 2. The expected completion date for both phases is June 2023.

Downtown Sacramento Landmarks Project (city of Sacramento/Sacramento County): This \$5.8 million project will improve and upgrade sections of Interstate

5 (I-5) and State Route 51 (Business 80) including the “Boat Section” of I-5 between Capitol Mall and U Street and the “Marconi Curve” on Business 80 at Marconi Avenue. Enhancements will include the installation of materials with aesthetic designs, public art and fencing. The estimated start date is October 2022 with an expected completion date of September 2023.

State Route 70 (SR-70) Oroville Beautification and Safety Project (city of Oroville/Butte County): This \$3.2 million project provides safety improvements for two interchanges along SR-70 at Montgomery Avenue and State Route 162. Improvements include creating dry creek beds and rock outcroppings, adding non-irrigated plants and installing transportation art and sculptures. The estimated start date is May 2022 with an expected completion date of June 2023.

District 7: Los Angeles

U.S. Route 101 Lankershim to Beaudry: The project will beautify the landscape areas of the on/off-ramps,

and slopes along U.S. Route 101 in Los Angeles County from Lankershim Boulevard to N. Beaudry Avenue. A decorative sculpture and rock design, California native plants and new decorative colored concrete will be installed. Overhead signs will be enhanced by removal of barbed wire and installation of dimpled sleeves on columns; and irrigation will be upgraded for water conservation and theft prevention. Estimated cost is \$3.151 million and is expected to be complete by April 2023.

State Route 118 Simi Valley: The project will enhance six interchanges in Simi Valley by replacing dying groundcover with aesthetically pleasing rock cobble. Native, drought tolerant plants to control erosion and provide pollinator habitat will be planted in selected areas at local streets to enhance the visual experience for the local community. As the community requested, each interchange will receive a different plant palette and hardscape or aesthetic motif to provide a unique place-making aesthetic to each location. Estimated cost: \$3.924 million. Estimated completion date is June 2023.

District 11: San Diego

Imperial County Community Improvements Project: This \$3.8 million project will improve locations by installing bus stop shelters in Holtville, Brawley and Calipatria; and enhancing roadway medians and pedestrian safety improvements in El Centro along State Routes 86.

Bridge Safety Enhancements: \$8.5 million to install safety elements and slope paving, hardscaping, fencing and vegetation management at 30 locations along Interstate 5, Interstate 8 and State Route 94.

San Ysidro International Gateway: \$2.5 million to replace the existing “*Bienvenidos a California*” monument built in the early 1970s; and add energy-efficient accent lighting, drought tolerant landscaping and artistic elements on Interstate 5 and Interstate 805 near the U.S./Mexico border.

Workplace safety more important than ever for employed Americans

Only half (55%) of working Americans feel their employer has made more of an effort to ensure their safety than in previous years.

Not surprisingly, 90% of American workers believe their organization has a duty of care—a legal and moral obligation—to protect employees from unnecessary risk of harm when working or traveling on their behalf.

This is according to a new study, State of Employee Safety Report, from AlertMedia details employees' current perceptions of safety in the workplace. The study also found that 82% of employees stated employers' obligation to keep employees safe extends to those working remotely

But employees are concerned with how well their companies are adhering to those expectations. Only half (55%) of working Americans feel their employer has made more of an effort to ensure their safety than in previous years.

"It's clear that workplace safety has a powerful influence over organizations' ability to attract and retain talent, and we hope employers use this data to inform their emergency preparedness plans, training efforts, and employee communication to demonstrate their commitment to safer working conditions for all," said Alex Vaccaro, Chief

Marketing Officer for AlertMedia, in a statement. *"While health and safety have been top-of-mind for nearly every person, business, and community for the past two years, this research offers new evidence about what employees expect from their employers when working as well as how their perception of safety impacts numerous aspects of their lives."*

What Worries Employees?

The study found that while the majority of employed Americans remain concerned about navigating public health crises (78%) at work, nearly as many are worried about other emergencies and disruptive events, including cyberattacks (64%), severe weather (65%), crime (61%), significant outages (59%), and workplace violence (54%). Additionally, 83% of U.S. workers say they have encountered at least one emergency situation while working across their careers.

Workplace safety more important than ever for employed Americans

The report offers new perspective and insights on the following:

Workplace Safety Perceptions: The vast majority (89%) of working Americans say workplace safety is more important than ever before; however, only half (54%) believe their safety is extremely important to their employer. And while 81% agree that executive leadership personally cares about employees' safety, 64% believe their employer's approach to emergency communication needs work.

Safety Awareness & Training: While most (82%) of working Americans report that their employer offers safety training, only half (56%) report participating in training more than once per year. What's more, employees who are not offered safety training are more than twice as likely to say they would not know what to do in the event of an emergency at work.

Employee Retention & Loyalty: Nearly all (97%) working Americans said feeling safe is an important factor in determining where to work. In fact, when asked how they would respond if their employer failed to communicate effectively about an emergency or other potentially dangerous event, 44% said they would feel unsafe and 58% said they would reconsider their employment or start looking for other job opportunities.

Is there personal liability for OSHA penalties?

Normally, OSHA citations are issued only against the corporations which employ workers, not the individuals who own or control them. Thus, corporate entities are generally liable for penalties under the Occupational Safety and Health Act (“Act”) as opposed to supervisors, officers, or directors. Moreover, there is no statutory authority to extend liability under the Act to supervisors, officers or directors individually. However, under the traditional common law doctrine of “*piercing the corporate veil*,” a court may put aside limited liability and hold officers or directors personally liable for the corporation’s actions or debts. Although the standard may differ from court to court, it typically requires somewhat egregious conduct to justify piercing the corporate veil.

In *Secretary of Labor v. Juan G. Quevedo-Garcia*, OSHRC Docket Nos., 20-1029, 20-1030, 20-1031, 20-1032 & 20-1042, an administrative law judge granted

summary judgment for the Secretary of Labor finding an individual who owned the majority interest of a limited liability company and served as its only officer abused the corporate form and was thus, personally liable for approximately \$2 million in workplace safety penalties. The underlying OSHA citations involved eight willful, ten repeat, and 12 serious violations for hazards, including failure to use fall, head, or eye protection; unsafe use of stepladders; scaffolding, housekeeping, and fire safety deficiencies; and lack of stair rails or forklift training.

In *Quevedo-Garcia*, the court recognized that the Occupational Safety and Health Review Commission (“OSHRC”) has the authority to “*pierce the corporate veil*” to hold an individual (or a different business organization) responsible for the corporate employer’s violations and responsibility for resulting penalties.

Although the court rejected the Secretary's argument that the individual was the statutory employer, it found him to be liable under an alter ego theory which permits assigning statutory employer status under the Act to both a corporate employer and an individual for whom the corporate employer is an alter ego. In reaching its conclusion, the court examined several factors concerning the existence of a separate corporate personality: gross undercapitalization; failure to observe corporate formalities; non-functioning of other officers and directors; non-payment of dividends; siphoning of funds; corporate form a mere façade for operations of the individual; and circumvention of the Act.

The decision is a good reminder, particularly for smaller businesses where these factors may be more likely to exist,

that it is important for OSHA and virtually every other area of the law to respect corporate formalities.

Finally, it is worth noting that local district attorneys or other prosecuting offices may also bring potential criminal charges against individuals for workplace injuries depending on the circumstances. Some of these cases involve construction sites where the prosecuting body determines that certain individuals ignored safety warnings and/or intentionally failed to implement certain safety measures to maximize profits which subsequently led to worker fatalities.

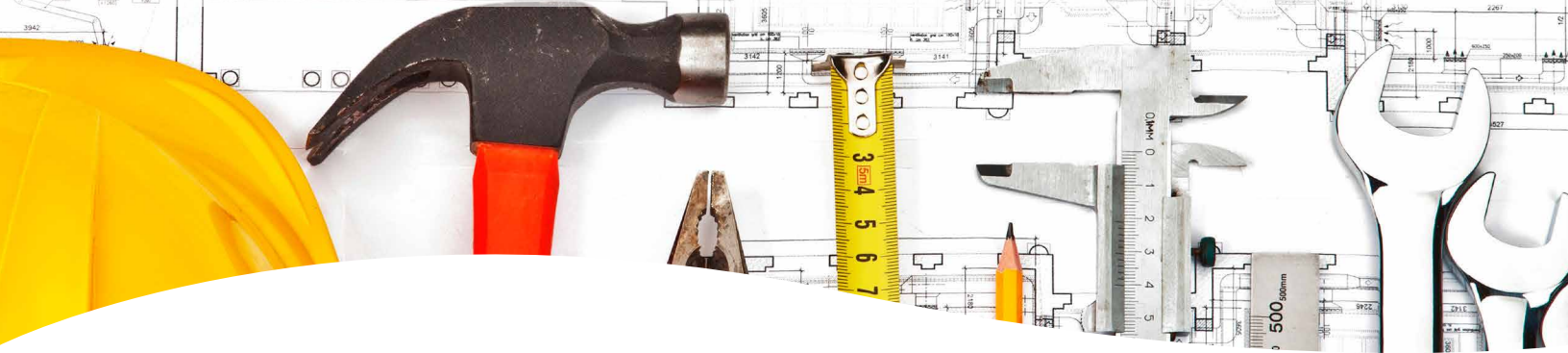

Capitol Connection Q&A for Contractors

Take notice that ‘what’s old is new again’ in CA license testing! An aspiring contractor asks for a quick ‘tutoring’ session while I touch on another take for ‘fingerprinting’...

Q: I am going to be applying for a Contractor’s license and I’m just curious to know what is the process if my application is not acceptable?

A: If you are worried about that you can always give me a call to assist with any potential rejection issues. But, in the normal processing of an application, the CSLB will send you a notification with any items that are need of correction or if more information is required. You will then have the opportunity to make the necessary additions or corrections, or in the case that you cannot meet their requirements, you can choose to withdraw your application.

Q: We are in the process of transitioning from a Corporation to an LLC and have applied for a new Contractor’s license. One of our officers has never been on a License before and is therefore required to be fingerprinted. She lives in Ohio and will not be available to fly to CA until the middle of May, which still makes more sense (timing wise) than having her complete the hard copy fingerprint cards locally. Do you agree? Regardless, our current Contractor’s License expires at the end of this month, on April 30th. In the past, I know it takes several weeks for the CSLB to process a renewal, so I’m wondering if we even have time to get that done? We absolutely do not want to go any period without a license.

A: Yes, I would agree that if your Officer is going to be in CA next month and will get fingerprinted via live scan, that will still be quicker than the time it takes to process the hard copy fingerprint cards done outside of CA.

And good news - assuming your Corporation is still in good standing with the CA Secretary of State and hasn’t been converted or cancelled yet, it no longer takes weeks to

process most renewals. Many licenses can now be renewed online and the license is updated immediately!

Testing Update for CA License Applicants! Coming in July 2022 ...

According to the Board the CSLB will continue to develop the license exams internally, however the exams will soon be administered by PSI Exams Inc. PSI Exams currently administers exams for several State Contractor Boards including Nevada and Arizona.

The change to PSI will expand the number of testing locations throughout the State and will likely allow for a more flexible test dates for applicants.

The CSLB will no longer be scheduling a specific date for applicants and instead will be notifying when they have been approved to take the exams along with the instructions to schedule with PSI.

Good to share that the Board says, *"This change will not increase applicant examination fees."* Yeah!

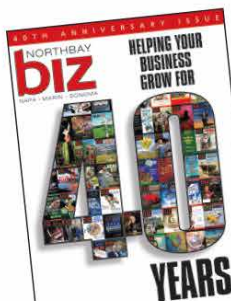
