## North Bay Construction Corps students will be ready for two-week paid internships in June

Looking for an entry-level employee at your company? Interested in being part of the solution to the construction workforce shortage? Then read further.

This year's class of North Bay Construction Corps students is looking to secure two-week paid internships in June with local construction companies in the North Bay to experience "real-life" construction work.

These students have spent the past 10 weeks (*with four to go*) learning about the building process, construction math, framing, concrete construction, solar and battery installation, the electrical trade, plumbing, welding, and more. At every meeting we discuss what comprises a solid work ethic and address important work-ready skills. They have practiced measuring with a tape measure and have been introduced to basic safety requirements on a job site. By June, they will have their First Aid/CPR certificates as well.

NBCC has close to 40 students who are 18-years-old and will have just graduated high school in June. They are expected to have their own transportation and will come to work properly dressed and ready to go with safety glasses and a hard hat. We ask that if there are any specific tools or PPE you require, you provide them. Upon request, NBCC will contribute \$750 per student to offset any employment costs.

This is a win-win. Your firm can learn about a potential employee while the student is given the opportunity to experience the realities of construction and give your particular trade a try. We are surveying students now to learn from them the top three areas of construction they are most interested in and we will match students up with companies in the field they have shown an interest in.

### 3 Reasons construction companies need to digitally transform now

**As the pandemic continues to change the way businesses run, construction companies have begun to realize the importance of going digital.**

Digital transformation has been a key area of investment for businesses over the past decade and is expected to only continue. Even with the pandemic wreaking havoc on business spending worldwide, overall digital transformation spending was still forecasted to increase by 10% in 2020.

The construction industry has lagged behind other industries in this respect, being notoriously reliant on outdated technology and operating in deeply entrenched business silos. Despite this, there is still progress. The pandemic forced companies to innovate, and construction businesses that introduced safety and communication technologies are highly likely to keep them once the pandemic is over. It's clear technology will continue to play a major role in transforming safety, communications and operations.

#### **How the Pandemic Increased the Need for Efficiency**

Prior to COVID-19, construction companies were experiencing high demand and increasing revenues, despite their slow adoption of new technologies and a lack of digital maturity. Once the pandemic hit, this changed rapidly. The construction industry lost a total of \$60.9 billion in GDP in the U.S. alone, with an estimated reduction to 6.5 million jobs, down from 7.64 million since February 2020.

Furthermore, inefficient on-site workflows that relied on paper trails and outdated communication methods became even more difficult to work with once social distancing measures were implemented. As a result, businesses have been forced to look for digital solutions that can unlock new

operational efficiencies and enable service delivery with reduced manpower.

### Why are Construction Companies Struggling to Innovate?

The need for digitization in construction has been made clear by the pandemic and by other industries that have successfully overcome their operational challenges through the introduction of digital products and services. Construction companies, however, often work on projects with extremely different requirements. The processes and systems that are in place for one project have to be coordinated with a variety of contractors, subcontractors, suppliers, and business divisions. These projects are often one-offs and are rarely replicated. Consequently, business leaders who might be enthusiastic about digital transformation might be unsure how to go about achieving it.

### 3 Reasons Construction Companies Need to Digitally Transform Now

#### The gap between field and office workers is growing

Construction operations have always been broken down into individually operating business divisions, and slower

collaboration between divisions has caused a significant increase in lead time. The enforced necessity of remote work has only made communication between teams a greater challenge.

Between offices, remote workers, contractors and suppliers, any on-site observations made regarding material quality, for instance, have to go through several communication channels before new materials can be procured. This communication chain can cause great confusion, delay delivery time and create animosity between contractors and employees.

The introduction of a unified communication channel allows construction teams to increase collaboration, aligning the different stakeholders on the requirements and schedules of each project. A digital solution also allows communication to occur in real time. Many on-site employees still use physical paper forms to take notes while inspecting the site and communicating the information on the form can take time. An integrated communications platform keeps everyone up to date and reduces the time it takes for key information to cross business divisions.

#### Productivity and effectiveness are key to delivering results

Construction businesses tend to be entrenched in outdated processes that limit productivity. McKinsey reported that productivity growth in the construction industry has increased a mere 1% a year over the last 20 years. This lags behind counterparts in other industries, who are increasing productivity at almost three times the rate. This inefficiency is estimated to cost the global economy \$1.6 trillion a year.

With the demand for construction services increasing rapidly and the construction workforce aging to a large extent, efficiency and improved productivity can be the difference between an overwhelmed workforce and a satisfied clientele. McKinsey found that firms that introduced digital systems for procurement, supply-chain management, better on-site operations and increased automation had improved productivity 50% over firms that relied on analog solutions.

Through the use of technologies such as AI, IoT and VR, construction businesses can modernize each stage of their operations from planning to execution. This reduces the amount of time spent revising designs, seeking approvals and calculating the resources needed for any changes in the project.

#### There is an increased focus on health and safety

The pandemic has caused many people to pay more attention to health and safety standards in all types of workplaces. For construction businesses, this focus on safety and health is not new. Despite its efforts, according to the U.S. Bureau of Labor Statistics, the construction industry has one of the highest fatality rates, with 9.5 fatalities per 100,000 full-time equivalent workers. Construction companies are under pressure to minimize construction accidents by improving on-site safety and protection guidelines, and provide improved support to workers who need it.

The introduction of technologies such as exoskeletons, AR glasses and wearable monitoring devices has made

## Is your future talent hidden in plain sight?

There are 28 million hidden workers according to the Harvard Business Project on managing the future of work.

If you are like me, you struggle with understanding how so many jobs are going unfilled, and yet there are so many people out of work.

Joseph Fuller, who is a co-chair of the Project on Managing the Future of Work at Harvard Business School, points out in an article in the Harvard Business Review published in June of 2019, that employers posted 7.3 million job openings, while almost 12 million working-age Americans were unemployed or underemployed.

Companies, it turns out, are not looking at talent sources that are right in the front of their eyes. Many of those who are unemployed, or underemployed are “hidden workers” says Fuller and his co-authors. *“They are a talent pool in plain sight with the potential to be hired, but for one reason or another are unable to make the transition into the workforce.”*

While there are a number of barriers to people finding employment, one of the overriding reasons seems to be that this population doesn’t fit the profile of what he calls a “perfect candidate”. So, they don’t even get to the interview stage and often get frustrated and abandon the search for work entirely. To get an understanding of the size of this hidden market, Fuller’s research showed that 28 million fit this category in 2019.

It’s not as difficult as it might seem. *“What is required is a shift in attitude,”* says Fuller. *“Instead of filtering out those who do not fit, companies need to focus on who has the skills they urgently need.”* Fuller offers some examples of different types of long-term unemployed and discouraged workers:

He asks companies to consider hiring several different types of long-term unemployed and discouraged workers in these economies:

Veterans, who have many of the skills that are in high demand — from underwater welding to emergency nursing care — but who are not hired in civilian jobs because they lack the necessary licenses.

Caregivers — most of them women, but also men — are forced to drop out of full-time and part-time work because they are needed at home to provide childcare, eldercare, or both.

The formerly incarcerated or recovered substance abusers who do not even get past the application stage.

Those with health issues — physical or mental — are often pre-judged and not considered for positions.

Older workers bring experience and skills but are considered an expensive burden.

Immigrants and refugees who have credentials from their home countries but struggle to get hired because they lack language skills.

Maybe the first step toward a solution is to understand the unique situations and work toward finding ways to adjust to a variety of circumstances. It’s my fervent hope that in the very near future, as a society we are able to harness the abundance of talent out there and put it toward creating a stronger and more inclusive economy.

# Workplace harassment: Is Cuomo the exception or status quo?

Just three years after the #MeToo Movement, Governor Cuomo is under fire as multiple accusers have come forward with complaints of sexual harassment. Cuomo has denied all allegations and apologized for making “people feel uncomfortable.” This begs the question: after the #MeToo Movement, is workplace harassment the “exception” or “status quo?” And, as HR professionals, how should we respond?

The U.S. Equal Employment Opportunity Commission (EEOC) recently released its 2020 data regarding claims filed with the agency. The EEOC secured a whopping \$439.2 million for victims of discrimination through voluntary resolutions and litigation. The numbers show the following categories account for the greatest percentage of claims:

**Retaliation: 37,632 (55.8% of all charges filed)**

**Disability: 24,324 (36.1%)**

**Race: 22,064 (32.7%)**

**Sex: 21,398 (31.7%)**

**Age: 14,183 (21%)**

Retaliation claims took the lion’s share, accounting for over half of all EEOC claims last year, however, one-third of all claims filed were based on sex. This suggests that sexual harassment may still be the “status quo” in some work environments. Even if a company isn’t sued for sexual harassment itself, it may be sued for any retaliation that follows.

## How to Address Employee Complaints

California employers who receive any employee complaint about harassment, discrimination, or retaliation, must promptly, thoroughly, and impartially investigate whether any company policies have been violated. Employers may choose to conduct the investigation internally or hire a third party who is a licensed attorney or private investigator.

As a leader in your organization, do you know how to respond to these situations? Have you decided in advance who will be responsible in your company for conducting the investigation? How will you decide when to bring in a third-party investigator? What will be the process for making temporary personnel changes as needed during the pendency of the investigation?

While you can and should show empathy to an employee, you must not “take sides” or comment on what you think happened, as this may be construed as an admission on behalf of the company. And, no matter how much the employee begs, you cannot promise complete confidentiality.

## Avoiding Retaliation

Given that retaliation claims made up a majority of EEOC claims last year, we recommend that you closely monitor your employees following a complaint. If a subordinate makes a claim against a supervisor, consider an alternative supervisor for the employee to report to during the pendency of the investigation. Make sure the supervisor also understands that they should not confront the employee about the allegations.

## What about Public Figures?

There are additional considerations if the accused is a high-level executive or public figure, such as Governor Cuomo. The company will need to decide what message to communicate to the public, if any. Anytime the accused is an executive or in upper management, it is imperative to hire a third party to investigate the allegations to ensure neutrality.

## Capitol Connection Q&A for Contractors

Sometimes ‘jumping into the pool’ isn’t a straight shot! Another contractor is tired of being a ‘zombie’ working with an ‘expired’ license, and I will be helping aspiring contractors answer questions about getting a license as a panelist in an upcoming webinar ...

**Q:** I previously had a “C-33” (Painting) Contractor’s license which expired in 2009. I let it go because for the past 20 years I have been doing outdoor living spaces. I install the outdoor kitchen area, the BBQ/Smoker area, the deck/flooring, and then I pay tilers/masons to do the countertops and any

stonework involved, etc. With summer coming up, I’ve decided I need to get my General Contractor’s (“B”) license to do all the work myself and more importantly, to not get “dinged” for working without a license since almost every job I do and have done is over \$500.00. What are the requirements for a General License, and

since I was previously licensed, will I be able to waive the exams?

**A:** In order to qualify for a General Building license, you would be required to show at least four years of fulltime experience doing Building work, specifically framing, and at least two unrelated trades. You would not be able to Waive the exams based on your previous license or experience gained from what you described.

Also, the work you described falls more under a “C-27” (Landscaping) license rather than a General license. The “C-2” also requires a Trade exam, and because your previous license has been expired for over five years, you will also need to take the Law exam again.

**Q:** I am looking into purchasing a Pool business. What are my options for obtaining a “C-53” (Pool Contractor) license if I don’t have any experience? I am looking to run the business, keeping all the existing employees on board to run the work.

**A:** You would need to either hire someone who is currently a “C-53” license holder to Qualify your



# Workers' Compensation Insurance and the future for contractors

As we have reported over the years, the rules regarding workers' compensation insurance have been strengthened by the Legislature and the Contractors' State License Board. Moreover, the Courts have further penalized contractors who seek to cheat the system, either by declaring themselves to be exempt when in fact they have employees that they classify as "*independent contractors*," or, those who have a workers' compensation insurance policy but do not declare any employees or very few of their employees in their Workers' Compensation reports.

Business and Professions Code section 7125.2 requires every contractor who has employees to have workers' compensation insurance. The Legislature and the Contractors' Board have cracked down on contractors who have filed Certificates of Exemption while having employees. Many years ago, it was not uncommon to find contractors who skirted the system by having persons work for them while providing them with a 1099 and calling them an independent contractor. The Labor Code defines a person as an employee if the work they are doing would otherwise have required a license. With respect to contractors, if the worker was performing any task that would have required a license for that person to do the task, they must be a bona fide employee for wages.

The Supreme Court of California held a couple of years back that to be an independent contractor, in addition to the usual independence one would think of, the worker had to perform work that is outside the usual course of the hiring entity's business. That meant that if you needed that type of work to operate your business, they could not be independent contractors. Thus, in the construction realm, any arguments that salespersons could be independent contractors was squashed.

Even with these Legislative and Court decisions, people in the industry still try to find ways around having worker's compensation insurance. Arguably if all have it, not only are workers protected by contractors will compete on a level playing field. Various groups have lobbied over the years to require workers' compensation insurance for all contractors. Indeed, several years ago, the Roofing Contractors

Association lobbied the Legislature and was successful in causing the Legislature to pass legislation that requires a C-39 roofing contractor to have workers' compensation insurance even if they really have no employees. It was argued to the Board that there was no such thing as a one-man roofing operation.

Now, there is pending legislation that would require certain contractors, including concrete and HVAC contractors to immediately having workers' compensation for all employees, and for all contractors of every classification to have workers' compensation insurance by 2025. to be specific, after that time there will be no "paper contractors" or contractors who can claim they are Workers' Compensation exempt.

Even with these rules, contractors should be aware of the potential civil losses possible if they consider obtaining these policies but find ways around declaring all of their workers. In 2007, a contractor set the stage for contractors in contract disputes to have to prove their

proper compliance with these laws. A billing dispute made its way all the way to the Court of Appeal in a case called Wright v. Issak. In that case, it was shown that there is a practical difference between having workers compensation insurance and properly maintaining it. In Wright v. Issak a contractor had over \$80,000 of payroll that had been billed to an owner over a period of time but during that period of time it reported \$312 to its workers' compensation insurance carrier. It was held by the Court of Appeal that by fraudulently providing payroll reports to the workers' compensation insurance carrier, the contractor did not maintain insurance, and therefore their contractor's license was deemed suspended automatically as a matter of law. What that meant was the contractor could not collect for their work but also had to repay every penny that they had received.

Some argue that the pending Legislation, if passed, will increase the costs of construction to those who cheat the system, and potentially decrease the costs to those who fully comply as more premiums will be collected by the carriers to cover the bigger pool of employees. Thus, the effect will not be as substantial as simply requiring coverage at today's rates. Obviously that effect is yet to be seen. But, you should prepare yourself and your business if you are not currently in compliance.

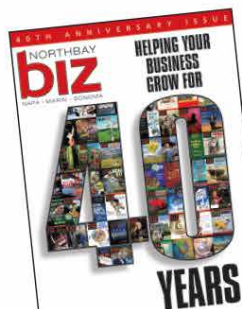
