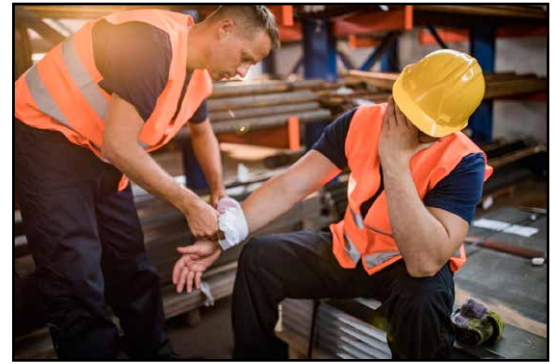

Beginning March 15, 2021, healthcare providers may use their clinical judgment to vaccinate individuals age 16-64 who are deemed to be at high risk from COVID-19 as the direct result of certain conditions and settings, as specified in the [California Department of Public Health's Provider Bulletin](#):

- Individuals with one or more severe health conditions
- Individuals with developmental or other severe disabilities or illness
- Individuals who live or work in a high risk congregate residential setting
- Public transit workers

Plan Your Work, Work Your Plan: What I've Learned About JHA's

Very early on in my career as a Safety Manager, I attended a Safety Forum that would shape my view of what really works in preventing accidents. I'll never forget listening to a peer tell his story about two employees losing their lives on different jobs in the span of a year. While that fact should strike fear in the heart of any safety person, what he said afterward has rung in my ears since that day. He related that what really turned things around for his company was the development of an effective Job Hazard Analysis (JHA) program. As he explained how it had been such a success in improving the employees' safety record, a light went on in my head. This is what I had been looking for!



An effective Job Hazard Analysis (JHA) is not rocket science, but it must be appropriate to the tasks that your employees will be performing. While my previous experience in safety management was in construction, I currently work with union millwrights who work with steel, not wood or other building materials. To develop an effective JHA that these employees could relate to, I needed to take the time to observe the tasks that they perform. After all, the JHA starts with what the job or task is. It was only after several months of intense observation that I could begin to develop an appropriate Job Hazard Analysis for this work environment.

Depending on who you work for, your JHA may have other names, such as a Pre-Task Plan, Job Safety Analysis or Activity Hazard Analysis. How you label it doesn't matter as much as how you execute it. As everyone responsible for safety knows, documentation can certainly save us after an incident or if OSHA drops by our jobsite, something we emphasize constantly to frontline supervision who are tasked with completing the paperwork. However, when it comes to a JHA, we need to stress to our team leaders that if they are running a crew, it is imperative that all members of the crew should be involved in the process.

The basic concept of an effective Job Hazard Analysis establishes and answers 3 questions: (1) What is the task that I will be performing? (2) What could hurt or injure me while performing that work? (3) What will I do to prevent or mitigate that hazard so that I don't get injured? The more people involved in this process and giving their input, the more awareness there will be throughout the workday. JHA's work best when they are a completed via a team discussion.

There is so much to say about this subject, but here are a couple reminders that I have learned over the years about an effective JHA. If the workers can occasionally see the JHA throughout the day, it becomes more set in their minds while performing their tasks. Some construction companies encourage the use of a whiteboard JHA. That visual reminder of the hazards and controls on the whiteboard posted near their gang box or other location increases greater awareness throughout the day. Finally, sometimes the hazard is not so obvious, or tangible. When you get to the root cause of an accident and if the injured employee is honest, you may discover that the real cause is that they momentarily lost their focus, let their mind drift onto a personal problem, were unnecessarily rushing or being reckless, experiencing fatigue, taking a short cut or any number of other reasons related to human error. So, talk about those types of hazards when discussing the JHA, not just the physical hazards.

A well-executed Job Hazard Analysis can help reduce incidents and accidents. It's not a guarantee that you will never have another incident, but it increases awareness throughout the workday. It makes your workers feel safer, which in turn promotes greater production. So, plan your work and work your plan! Make a great JHA work for you!



How to help maintain a high credit score

The following tips can help you maintain or potentially improve your credit score throughout the holidays and beyond.

Know how your credit score is calculated. The most common credit score is expressed as a three-digit number ranging from 300 to 850. (*Some lenders may calculate it differently, but this should be a good guideline.*) The score is derived from a formula using five weighted factors: payment history (35%), amounts owed (30%), length of credit history (15%), new credit (10%), and types of credit in use (10%).¹ Keeping these components in mind can help you stay on track with your credit.

Make payments on time. Set up alerts for every credit card you have so you don't miss notifications of charges, statements, or due dates. To help avoid missed payments, set up automatic payments. If you do miss a payment, contact the lender and bring the account up-to-date as soon as possible.

Keep credit-card balances low. If you carry a balance, consider paying down the cards with the highest balance-to-credit limit ratio first while keeping up minimum (or higher) payments on others. Don't "max out" your available credit.

Be careful about opening and closing accounts. Some retailers may offer discounts on purchases if you sign up for

a store credit card, but store cards often have high interest rates and low credit limits. Unless you plan on shopping regularly at that store and the card offers useful bonuses or discounts, avoid applying for new credit cards solely to save money on purchases. Likewise, try not to close multiple accounts within a short period of time — this could actually hurt your credit score.

Research before using credit boosting services. You might be tempted to sign up for a free service that promises to instantly boost your credit score, but they're usually only worth considering if you have a thin credit file and/or a low credit score. These services can't fix any late payments you've made or reduce the impact of an excessive level of debt.

Monitor your credit report regularly. You can order a free credit report annually* from each of the three major consumer reporting agencies at annualcreditreport.com. If you find incorrect information on your credit report, contact the reporting agency in writing, provide copies of any corroborating documents, and ask for an investigation.

A tale as old as time: Conflict in the workplace

CEA HR Advisors often receive calls about a “problem” employee that goes something like this:

“One of our employees, Natalie, has created many issues for the Company in the last few months. She is often tardy, gossips about her coworkers, and snaps back at her supervisor, Elizabeth.

Earlier this week, Natalie cursed at her supervisor, Elizabeth in front of customers. Elizabeth decided that she was going to terminate Natalie and spoke with HR. Neither Elizabeth nor HR documented the conversation.

Today, before we had a chance to terminate Natalie, she informed us that she has a serious health issue and needs to take family and medical leave. She satisfies the eligibility requirements. By the way, all of her prior performance reviews are positive. What do we do now?”

Our Advice

Whenever an employee’s past performance issues go undocumented, there is concern that the company may

appear retaliatory if they terminate someone immediately after they request a protected leave. How should this situation be handled?

While each situation is different, reasonable options may include:

Allow some time to elapse. While there is no “safe” amount of time to wait before taking disciplinary action, document performance issues going forward, in accordance with your policies. There’s a likely chance that poor behaviors will resurface and then you can handle the situation as you would with any other employee who violates a company policy.

Consider executing a severance agreement and release of legal claims. One alternative to “waiting it out” is to execute a severance agreement, in which you offer the employee severance pay in exchange for a release of

legal claims against the company. This will help insulate you from liability if you let this person go and they agree. Specific release language is required.

It is important to consult legal counsel about the risks involved before taking adverse action against the employee. If you need a severance agreement, consult a law firm.

Capitol Connection Q&A for Contractors

I begin with a ‘credit’ check for one aspiring contractor, while another license applicant is concerned with a completely different ‘experience’ in the past. Sometimes having the desire to get a license, and working without one, requires a certain ‘conviction’ ...

Q: I want to get my Contractor’s License and some of my experience is from a long time ago and I know they will only consider experience within the last ten years. I only have two years of construction experience within the last ten years. Will the CSLB give me any credit for an AA degree from a Community College?

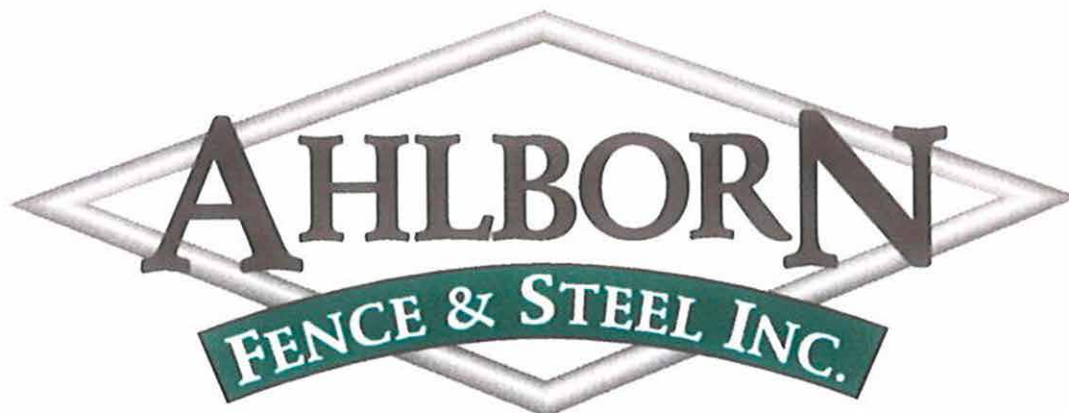
A: If your Associate Arts (AA) degree is in Building or Construction Management, the CSLB will give you up to one and a half years of experience credit. You will need to submit your sealed transcripts along with your license application and the CSLB will determine

the months of experience credit based on the courses you completed. They typically give credit for the fields of construction, accounting, business, etc. You didn’t mention it, but if you have military experience that may also be considered.

Q: What does the CSLB consider “advertising” for contractors?

A: The CSLB requires a license number in a wide range of promotional vehicles and stresses that advertisements are not limited to newspapers, radio, and TV commercials. They include; business cards, social media pages such as Facebook, Twitter, and Instagram. Other forms of advertisements: referral websites (Angie’s List, Contractor Connection, etc.), any contract proposal, lettering on trucks and other vehicles, sign or billboards identifying a person or company as a contractor, electronic transmissions such as company’s website content, any soliciting brochure, pamphlet, circular, or internet posted or distributed, and clothing or giveaway items that include the company name or logo, and any

directory or listing that states or implies an individual is requesting or looking for the kind of work that requires a contractor's license.

Q: I have worked for a licensed contractor for several years, however I haven't been working for him for four years yet so I know I don't qualify for my own license yet. I have been doing work on the side, and when I advertise online I always specify that I'm not licensed and cannot do work over \$500. Just out of curiosity, if a project does happen to go over \$500 and I somehow get caught, what is the possible penalty?

A: First-time conviction penalties for unlicensed contracting include up to six months in jail may cost up to \$5,000 in fines. Penalties are more severe with each successive violation. A second conviction carries a

mandatory sentence of 90 days in jail. That being said you'll want to make sure you don't take on a project that potentially may go over \$500 (labor and materials combined).

FEMA COVID-19 Funeral Assistance now available

The Federal Emergency Management Agency (FEMA) is now accepting applications for funeral assistance and reimbursement through its COVID-19 Funeral Assistance Helpline. Under the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 and the American Rescue Plan Act of 2021, FEMA will provide financial assistance for COVID-19-related funeral expenses incurred after January 20, 2020.

Expenses for funeral services and interment or cremation typically include, but are not limited to:

- Transportation for up to two individuals to identify the deceased individual
- Transfer of remains
- Casket or urn
- Burial plot or cremation niche
- Marker or headstone
- Clergy or officiant services
- Arrangement of the funeral ceremony
- Use of funeral home equipment or staff
- Cremation or interment costs
- Costs associated with producing and certifying multiple death certificates
- Additional expenses mandated by any applicable local or state government laws or ordinances

Assistance is limited to a maximum of \$9,000 per funeral and a maximum of \$35,500 per application per state.

Apply for Assistance:

To begin the application process, individuals can call FEMA's COVID-19 Funeral Assistance

Helpline at 844-684-6333 | TTY: 800-462-7585. The helpline is available Monday through Friday from 6 a.m. to 6 p.m. PST.

Find a checklist of documentation needed prior to your call by [clicking here](#).

Eligibility:

To be eligible for funeral assistance, you must meet the following conditions:

- The death must have occurred in the United States, including the U.S. territories, and the District of Columbia.
- The death certificate must indicate the death was attributed to COVID-19.
- The applicant must be a U.S. citizen, non-citizen national, or qualified alien who incurred funeral expenses after January 20, 2020.
- There is no requirement for the deceased person to have been a U.S. citizen, non-citizen national, or qualified alien.
- A minor child cannot apply for COVID-19 Funeral Assistance on

behalf of an adult who is not a U.S. citizen, non-citizen national, or qualified alien.

Gather Documentation:

Once an applicant has applied for COVID-19 Funeral Assistance and is provided an application number, they may provide supporting documentation to FEMA a few ways:

- Mail documents: P.O. BOX 10001, Hyattsville, MD 20782

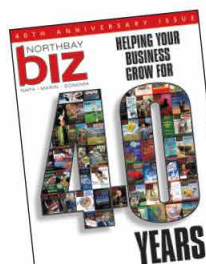

The number of Californians filing initial unemployment claims dropped to its lowest level in nearly three months, with around 69,000 claims filed for the week ending April 10, according to U.S. Department of Labor data released Thursday. That's a decrease of nearly 76,000 from the week before, signaling that the Golden State's economy is on the mend as businesses reopen. But problems persist at the state's unemployment department, which announced earlier this week that "an issue" was preventing about 178,000 Californians from reapplying for benefits. "We apologize for the inconvenience and will have this fixed by Friday," the Employment Development Department said on Twitter.

Meanwhile, the number of unresolved unemployment claims remained above 1 million for the 10th straight week. Around 122,000 have been pending EDD action for more than 21 days, while another 912,000 are reportedly awaiting claimant certification. But many claimants say they've provided information to the department to no avail, a statistic apparently backed up by EDD's own data: As of April 2, more than 226,000 claims for which EDD had received certification were still pending department resolution.

NEARLY HALFWAY THERE

No counties are left in the state's most restrictive reopening tier. California has the lowest coronavirus positivity rate in the country. And 49% of eligible residents are at least partially vaccinated — a number sure to have crossed the 50% threshold Thursday, when the state threw open eligibility to everyone 16 and older. "It's not tax day, it's vax day," Gov. Gavin Newsom said at a vaccine clinic in Alameda County. Despite an initially rocky rollout and prolonged bickering over transitioning to a new vaccine system helmed by Blue Shield, the Golden State managed to make vaccines available to all adults several days ahead of President Joe Biden's April 19 deadline. But numerous challenges remain: The state's vaccine supply is set to shrink over the next few weeks, a decline exacerbated by a temporary pause of the Johnson & Johnson vaccine. Counties and community groups are still struggling to provide doses to hard-to-reach populations, such as homebound Californians. And vaccine hesitancy appears pervasive in some areas, such as Kern County.

TRANSFORMATION OF EMPLOYERS COVID-19 SAFETY DUTIES

Workplace safety remains a top priority as CA plans to reopen. COVID-19 restrictions may soon be lifted, but guidelines for outstanding items such as leave and accommodation, vaccination protocols, hero pay and work return procedures have not been definitively established. Employers are left to grapple with the creation of safety procedures. [Read more.](#)

CLIMATE ACTION PLAN FOR TRANSPORTATION INFRASTRUCTURE

POLITICIANS UNPUNISHED FOR UNPAID FINES

California politicians, judges, lobbyists and campaign donors owe the state more than \$2 million for late campaign reports, according to the secretary of state's office. But the office has allowed some of the largest fines to go unpaid for more than a decade without any consequences for those who owe the money — raising questions as to whether California is effectively enforcing its campaign finance law meant to promote transparency and prevent corruption. The lax enforcement contrasts sharply with the punishment ordinary Californians face for neglecting to pay a traffic ticket, ranging from increasingly higher fines to misdemeanor charges.

Legislators write laws and judges enforce them, so they have an especially high duty to abide by them. But 26 state lawmakers and 21 superior court judges have unpaid fines — some in the tens of thousands of dollars. [Read more here.](#)

CALCHAMBER'S 2021 JOB KILLER LIST

For more than 20 years, [CalChamber's Job Killer list](#) has identified legislation in the works that could potentially be detrimental to CA's business climate (with an amazing 90% success rate of stalling bills that make it on the list). SRBX actively works with CalChamber to target bills on this list that would discourage employers to locate in CA; restrict workforce growth; eliminate jobs; or significantly increase costs on employers, which simultaneously limits their ability to expand employee wages, benefits, and jobs.

NEW REPORT TRACKS THE RISING COSTS OF HOUSING

PPIC released a new report to shed some light onto the housing boom during the pandemic. While soaring prices are good news for current homeowners, would-be buyers could be locked out. Even in areas where housing had been less expensive in the past, prices are rising beyond the reach of many Californians. In Sacramento, 42% of homes sold in 2019 were affordable versus 32% in 2020. As the state moves into recovery, the affordable housing crisis will be a key area where policymakers can target the concerns of everyday Californians.

SHARE INPUT ON STATWIDE HOUSING PLAN

The Department of Housing and Community Development (HCD) is seeking feedback on its efforts to refresh the Statewide Housing Plan, intended to address CA's housing crisis. [Respond to this survey](#) by April 23 to ask the state for CEQA reform, improvements to new VMT mitigation standards, and removal of other barriers that limit the ability and increase costs to build badly needed housing in CA.
