Did you know... FALLS ARE THE LEADING CAUSE OF DEATH IN CONSTRUCTION.

In 2020, there were 351 fatal falls to a lower level out of 1,008 construction fatalities (BLS data). These deaths are preventable.

Since 2012, OSHA has partnered with the National Institute for Occupational Safety and Health and National Occupational Research Agenda (NORA) - Construction Sector on the Fall Prevention Campaign to raise awareness among workers and employers about common fall hazards in construction, and how falls from ladders, scaffolds and roofs can be prevented.



PLAN ahead to get the job done safely

When working from heights, employers must plan projects to ensure that the job is done safely. Begin by deciding how the job will be done, what tasks will be involved, and what safety equipment may be needed to complete each task.

When estimating the cost of a job, employers should include safety equipment, and plan to have all the necessary equipment and tools available at the construction site. For example, in a roofing job, think about all of the different fall hazards, such as holes or skylights and leading edges, then plan and select fall protection suitable to that work, such as personal fall arrest systems (PFAS).

Workers who are six feet or more above lower levels are at risk for serious injury or death if they should fall. To protect these workers, employers must provide fall protection and the right equipment for the job, including the right kinds of ladders, scaffolds, and safety gear.

Use the right ladder or scaffold to get the job done safely. For roof work, if workers use personal fall arrest systems (PFAS), provide a harness for each worker who needs to tie off to the anchor. Make sure the PFAS fits, and regularly inspect it for safe use.

TRAIN everyone to use the equipment safely

Every worker should be trained on proper set-up and safe use of equipment they use on the job. Employers must train workers in recognizing hazards on the job.

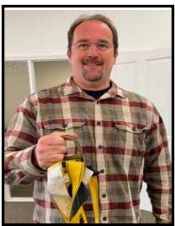

The Direct and Indirect Costs of Construction Injuries

The construction industry is one of the most hazardous in the US. According to the National Safety Council (NSC), the construction industry experienced the largest number of preventable fatal injuries in 2020. There were 957 fatalities and 250,000 medically consulted injuries in the construction industry in 2020. Investing in safety can prevent accidents and fatalities and save companies money in the long run.

Think of safety incidents like an iceberg. There's the costs you see and the costs you don't. Accidents have a significant impact on construction projects, and can result in expenses that can quickly add up to thousands of dollars.

The tip of the iceberg, or direct costs of a construction incident can include things like:

Medical bills,

Damage to materials, equipment, or property,

Litigation, and

Regulatory fines

But, looking below the surface, construction accidents can also lead to indirect costs, like

Hiring replacement workers,

Penalties for missed deadlines, and

Costs from implementing corrective measures.

In high-risk industries like construction, indirect costs can be much higher, sometimes several times higher than direct costs.

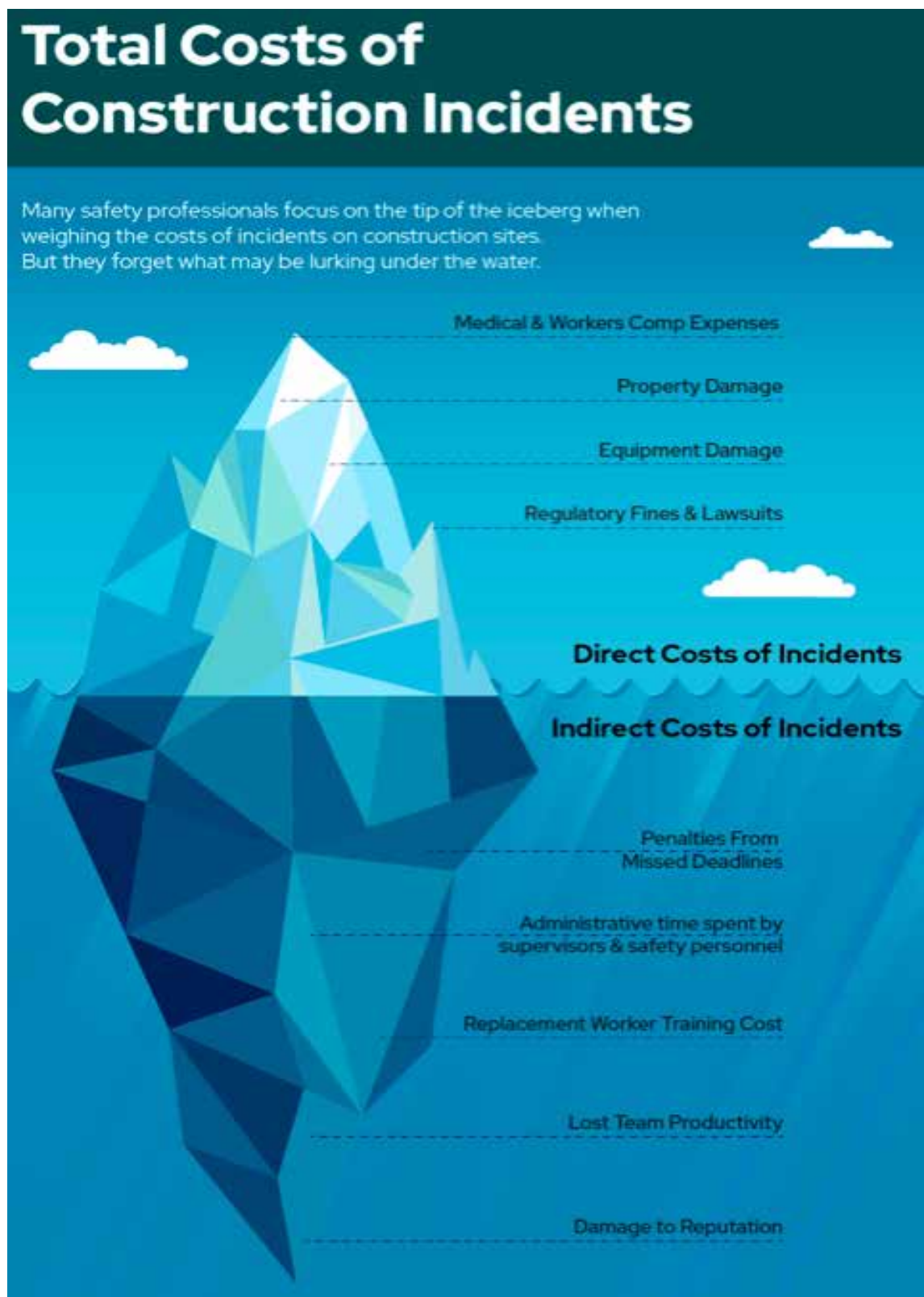

Calculating the Costs of Construction Injuries

For construction companies, the average cost of one lost-time injury on a job site is \$35,000, though many injuries cost much more due to litigation, medical expenses and compensation, according to the Workplace Safety and Insurance Board. Further, 6-9% of construction project costs are workplace injury related, leading to long-term increases in insurance costs and shrunk profit margins. A severe or deadly accident can mean the end of a project or company.

According to the Occupational Safety and Health Administration (OSHA), US companies pay over \$1 billion per week in workers' compensation for disabling and non-fatal injuries. Preventing these accidents means protecting the lives of workers, while offering major savings for their employers. It is estimated that the full impact of workplace injuries and fatalities cost companies approximately \$151 billion per year.

The human impact of accidents is even more significant and important than financial losses. In 2020, the US Bureau of Labor Statistics (BLS) reported 2.7 million work injuries and illnesses,

and 4,764 workplace fatalities. One fifth of those fatalities occurred in the construction industry.

Investing in Construction Safety

On many construction projects, safety is often viewed as a necessary expense, something that must be included in the project but is often a waste of money and time.

Studies have shown that the cost of doing nothing is much higher than the cost of prevention. **According to one study, when companies invest just 2.5% of project costs into safety training and procedures, accident rates decrease and profits increase by 4-7% per project.**

When comparing accident and injury prevention costs with accident costs, doing nothing is far more expensive. A NSC survey showed that every dollar invested in prevention saves \$2 in accident consequences. The NSC also estimates that each prevented injury or illness saves the employer \$37,000,

and each prevented fatality saves \$1,390,000. And multiple studies have come to the same conclusion: doing nothing about construction accidents is 200% to 300% more expensive than investing in prevention measures.

When an accident does happen, the consequences can be far more expensive than the money and time spent to prevent them.

5 Keys to a Solid Construction Safety Program

1. Develop a written safety program.

To make it stick, talk frequently with employees about the importance of safety. Hold employees accountable for breaking the rules through progressive disciplinary steps, and reward them for following procedures. Make managers responsible for their teams' group safety records.

2. Complete a hazard analysis for every job activity.

Preplanning will save you lots of headaches. Analyze each specific activity for each job. What are the hazards, how can you mitigate them and which equipment will you need? Create an equipment list for that activity. Train everyone who will be on that jobsite.

3. Use toolbox talks as safety training opportunities.

It's a best practice to use toolbox talks as a platform to complement your existing safety training program. Use the job

hazard analysis as the basis for your content, and you'll achieve three objectives at once: reinforce previous training, meet the requirements of CFR § 1926.21(b)(2)—Safety training and education and reduce injuries on the jobsite.

4. Train new hires before day one on the job.

Make it specific to their type of contracting work. Electricians should have different training for scaffolding work than a plumber, for example. Construction firms have specific challenges when it comes to new-hire training. Your company might have to address double the number of subjects as an auto dealer, for example. Even the most minimal orientation training can take half a day or longer. But since most construction worker injuries occur in the first year of employment, the investment in more comprehensive onboarding training is a no-brainer.

5. Provide proper training for your "competent persons."

OSHA requires a competent person to be on-site, which is someone who: Is capable of identifying existing and predictable hazards in the surroundings; or working conditions that are unsanitary, hazardous or dangerous to employees; and is authorized to take prompt corrective measures to eliminate them.

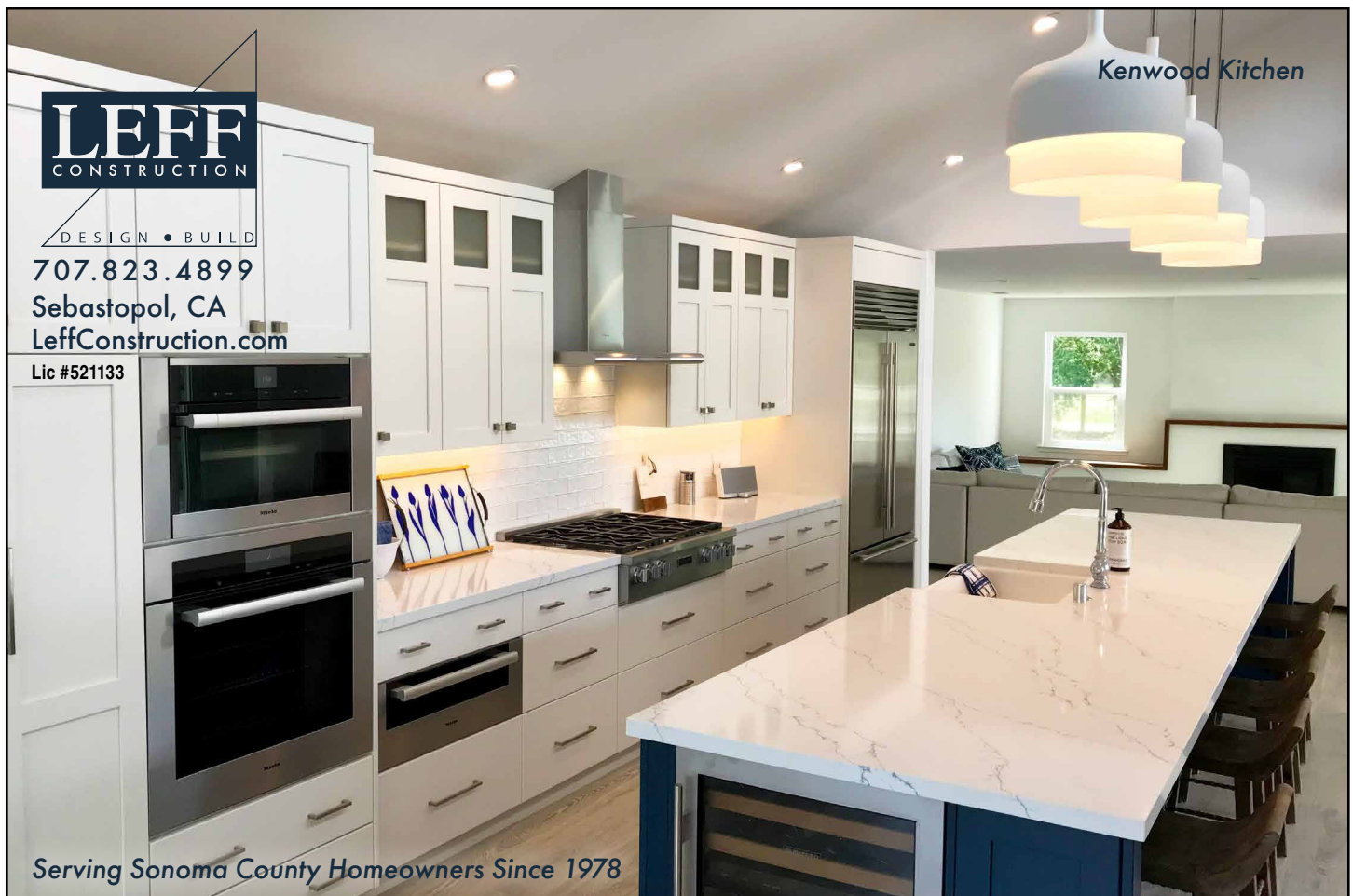

Cal/OSHA Proposes Changes to Third COVID-19 ETS; Standards Board to Consider Adoption on April 21

Seyfarth Synopsis: The Cal/OSHA Standards Board (“Board”) has published proposed language for the third adoption of the Cal/OSHA COVID-19 emergency temporary standard (“ETS”), which will be voted on during the upcoming April 21, 2022 Board meeting. The ETS, assuming it is readopted, will expire on December 31, 2022.

Background

The first iteration of the Cal/OSHA ETS took effect on November 30, 2020. It was initially readopted and revised on June 17, 2021, and then again (called the “second readoption”) on December 16, 2021. The second readoption is set to expire on May 6, 2022, after being extended by Executive Order. Normally, an emergency regulation can only be readopted twice, but the Governor issued an Executive Order in December 2021 permitting a third readoption of the ETS, so long as it does not extend beyond December 31, 2022.

The Board will hold a meeting on April 21, 2022, to vote on the new proposed language. In the meantime, the Board is accepting comments on the proposal, but because this is an emergency regulation, changes prior to the vote are unlikely. As with past meetings, it is expected that the Board will vote to approve and adopt the proposed third iteration of the ETS.

What’s New?

Much of the current ETS (which was blogged about here) will remain intact. But, the proposed changes are significant for businesses and employees, and will include removal of some requirements. **Highlights include:**

Removing the definition of “fully-vaccinated” from the ETS. This is significant because it means the ETS will no longer distinguish between fully-vaccinated and not-fully-vaccinated employees. In other words, most requirements of the ETS will apply in the same manner regardless of vaccination status, including:

Testing Requirements: Employers will have to offer testing to all symptomatic employees, and all employees with a workplace close contact, regardless of vaccination status. Testing must be provided at no cost to the employee, and during paid working time. The only exception will be based on whether an exposed

employees has recently had and recovered from COVID-19 (see below).

Provision of Respirators: Employers must offer respirators (e.g., N95s) to employees upon request. Now, all employees regardless of vaccination status are entitled to a respirator for voluntary use, free of charge, if they ask for one.

A new term, “returned cases,” has been added, referring to employees with naturally-conferred immunity, i.e. employees who have recovered from COVID-19 in the past 90 days and remain symptom free.

If such employees have had a workplace close contact, employers are not required to offer them testing. Nor are employers required to offer such employees testing if they are part of an outbreak’s “exposed group.”

Face coverings are no longer required for employees who are not fully vaccinated. This has been the case since February 28, 2022, when Governor Newsom issued an Executive Order overriding the ETS. The third readoption codifies that Executive Order.

Face coverings will still be required:

If the CDPH issues orders requiring them; For employees who have tested positive and are returning to work before 10 days have passed since their symptoms began, or 10 days since they tested positive if they never developed symptoms; or for all employees indoors in an exposed group during a workplace outbreak or major outbreak, or those outdoors who cannot maintain 6 feet of distance from others.

In situations where face coverings are required but employees are exempted from wearing them, those employees will no longer need to be kept at least six feet apart from others in the workplace, however they will still need to be tested at least weekly.

The definition of face covering will be updated to remove the requirement that they “not let light pass through when held up to a light source.”

Removing static requirements for employees who had a close contact, and instead requiring employers to follow current CDPH guidance on close contacts (note these change frequently).

Changing the term “high risk exposure period” to “infectious period.” Substantively, the change has no impact; it simply aligns the language of the ETS with the language used by public health authorities. Cleaning and disinfection requirements are removed.

During a major outbreak, partitions will no longer be required for exposed groups working together for an extended period but who can’t maintain distance, such as at cash registers, desks, and

production line stations.

The definition of testing will be updated to allow for self-administered and self-read tests for purposes of return-to-work, but only if another means of independent verification of the results can be provided (e.g., a time-stamped photograph of the results).

Inclusion of an explicit requirement that unredacted personal identifying information about COVID-19 cases has to be shared with the local health department, CDPH, and NIOSH immediately upon request.

Note that many employers have been uncomfortable sharing the breadth of information being requested by some of these entities based on employee privacy concerns, and have been wanting to redact or leave blank. The ETS now says clearly that the information must be turned over.

When Will This End?

The ETS, assuming it is readopted this third time, will expire on December 31, 2022. So while much of the rest of the country moves on from burdensome COVID-19 requirements, California employers will still be under the weight of the Cal/OSHA ETS for the remainder of this year. That includes (but is not limited to) requirements to continue notifying employees any time a COVID-19 case has been onsite during the infectious period, and to continue “exclusion pay” for eligible employees with workplace exposure.

And after December 31, 2022 COVID-19 regulation in California is unlikely to disappear. Word on the street is that Cal/OSHA may seek to make the third readoption a permanent standard until it ultimately replaces it with a more general airborne infectious disease prevention standard. So don’t plan on throwing your notification templates or written COVID-19 Prevention Plan in the trash just yet.

Capitol Connection Q&A for Contractors

The Contractor's Board has a new 'test' for applicants that should make it easier. I 'power' up to answer a question for a company who is cleaning up and share when a while back is too long ago to be counted today...

Q: I'm considering starting an exterior power washing business. I've heard it said that since it's cleaning and not installing I don't need a contractor's license. If that's the case, what is the C61/D38 license for?

A: The "C-61"/"D-38" is for just that - sand and water blasting. Many owners will not hire power washing companies who are not licensed, and that's the reason behind a license. While whether or not a license is absolutely required, power washing is somewhat of a gray area. If the jobs you are doing are going to be over \$500, I would error

on the side of caution and go with obtaining a Contractor's License.

Q: A while back I worked for a Construction company and I'm considering purchasing an existing business which has a contractor's license. Will my past experience allow me to Qualify the license and become the RMO (Responsible Managing Officer)?

A: It depends on what you mean by "A while back." The CSB will only consider work experience gained within the last ten years. As you probably know, a total of four years of full-time work experience is required. If you meet the requirement and would like our assistance with this process, please contact the office.

Q: I've had my "C-39" (Roofing) license for over 30 years. About 10 years ago I obtained my "B" (General Building) license. I slowly over time stopped using my "C-39" classification. Is there a way to inactivate my "C-39" classification while keeping my General Building license active?

A: There is no way to “inactivate” the “C-39”, however there is an application to remove a classification from a license.

Testing Update for CA License Applicants! Coming in July 2022...

According to the Board the CSLB will continue to develop the license exams internally, however the exams will soon be administered by PSI Exams Inc. PSI Exams currently administers exams for several State Contractor Boards including Nevada and Arizona. The change to PSI will expand the number of testing locations throughout CA and will likely allow for more flexible test dates for applicants.

The CSLB will no longer be scheduling a specific date for applicants and instead will be notifying when they have been approved to take the exams along with the instructions to schedule with PSI. This change will not increase applicant examination fees.

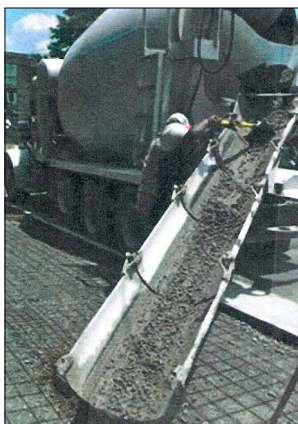

Developing an Emergency Action Plan

Workplace emergencies can happen on any jobsite and have the potential to cause severe injury to workers and extreme property damage. Emergency Action Plans (EAP), or Emergency Response Plans (ERP), provide site-specific procedures so workers understand what is expected and how to respond in the event of an emergency

The goal with any EAP / ERP is to:

- Prevent fatalities and injuries
- Reduce damage to buildings, stock, and equipment
- Protect the environment and community
- Accelerate the resumption of normal operations

OSHA Construction Standard 1926.35(a) specifies that EAP / ERP needs to be in writing and cover designated actions to ensure employee safety. In the event of an emergency, all personnel must know:

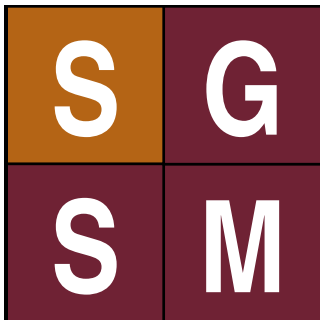
- Basic first aid and CPR
- How to report an emergency
- The procedure for emergency evacuation, including the type of evacuation, exit route assignments, and muster points
- What the alarm system looks or sounds like to alert

workers of emergencies – phone call, text message, air horn, siren, etc.

- How to account for all employees after evacuation
- Procedures for employees performing rescue or medical duties
- Contact for HSE department and other EAP / ERP information

Examples of potential workplace emergencies include:

- Fires and explosions
- Severe weather – rain / flood, tornado, hurricane, etc.
- Heavy equipment failures
- Confined space rescues
- Hazardous material incidents
- Cave-in rescues
- Fall arrest rescues
- Worker injuries
- Struck-by / caught-in incidents
- Medical emergencies
- Motor vehicle accident
- Chemical / hazardous material spill
- Active shooter

Site-specific EAP / ERP must be in place for every jobsite, should be easy-to-read, and posted in multiple locations across the jobsite so every worker can review it.

The basic EAP should include:

- Address and description of the site location
- Meeting and / or muster points for evacuation

- Emergency response numbers for 911, fire department, police, emergency responders
- Name and address of nearest medical facilities
- Map to nearest medical facilities
- Name and contact information of utility providers
- Access points for emergency personnel

The first instinct in any emergency is to call 911, but before any project starts and as the EAP / ERP is being developed, it is critical to verify 911 is in effect in the area and to understand the emergency resources and facilities available for the specific jobsite. Questions to consider include:

- What is the emergency response time for the job site?
- Is a high-angle rescue team available?
- Is a confined space rescue team available?
- How close is the nearest medical facility?
- What on-site emergency resources are available – first aid kits, AED, fire extinguishers, spill containment equipment, PPE?

To be effective, all workers need to be trained on the EAP / ERP and sufficiently understand their role during an emergency. Workers need to be trained on the EAP / ERP:

- Initially upon hire
- At the start of any project on a new site
- If the plan changes or if site conditions / location changes
- If designated persons' duties change

- Annually thereafter review:
- With any new subcontractors
- With suppliers for delivery and storage hazards
- Take time to review your project specific EAP / ERP

Planning ahead of time, creating a site specific EAP/ERP, and communicating it to everyone involved on a project is critical to its successful execution in the event of an emergency situation.
