Jobber

Job tracking and customer management software for home service businesses. Jobber's 160K+ home service professionals have served over 12 million households in more than 47 countries and invoiced for over \$15 billion in services.

This affordable but powerful software suite addresses the entire quote-to-cash lifecycle starting with customer relationship management (CRM) including online service booking, marketing automation, quoting, scheduling, reporting, job checklists and invoicing. Jobber is growing quickly, doubling in size over the last year. Its customers include sole practitioners to companies with 20 or so employees—which gives them an addressable market of somewhere between five and six million across Canada and the United States.

This addition of third-party services and offerings

embedded in SaaS software products—a business equivalent of in-app purchases in consumer apps—is interesting for a few reasons. First, it can put valuable services like gap financing for contractors or project financing for customers, in the hands of contractors in the most convenient way.

But the heart of Jobber from a functional standpoint is job scheduling, where they compete most often with Quickbooks Time, formerly Tsheets, which Intuit acquired in 2017 and is not as deep or robust as Jobber.

This level of sophistication extends all the way up to drip scheduling, which they offer on a client-by-client basis. While a big landscaping or concrete contractor will be on the same job for a number of days, other types of contractors like lawn care or emergency response HVACR contractors may benefit from a

Hippo.Build

Hippo.Build helps small and medium-sized (SME) construction companies connect existing siloed software solutions into one single cloud space with the competitive advantage of Enterprise Resource Planning (ERP).

Most ERP applications work by consolidating business data in a single, centralized application. What makes Hippo.Build different is that it works more by connecting data and processes from the handful of technologies a contractor already uses, reducing complexity.

The product should be understood in terms of what the product does in its current state and where it will be functionally in a short space of time. Right now, the software is pulling inventory or stock information from the job site through chatbots back into a dashboard. Hippo.Build integrates with project management software to send reminders to on-site staff of tasks that need to be completed and then pulling back into the system a report of the results or productivity. Hippo.Build also handles punch in/punch out of the on-site staff to support payroll.

Task management functionality in Hippo.Build is focused on delegating tasks to workers on a job site with information on what the task entails. At the end of the day, the worker can confirm they have completed the task and upload a photo of their work. The software can accommodate 3D scans, Lidar and other visual evidence and documents, but most users are now just uploading standard JPG photos. Analytics then call out tasks that are on track versus delays, enabling management by exception.

Dibbs

Dibbs is a digital marketplace for bidding, buying, and selling products and services targeted at home repair services. The tool delivers a verticalized construction market of homeowners, contractors, suppliers and retailers and also gives a contractor a central place to manage the entire quote-to-cash process, including online payments.

“Quotes, contracts, payments and supplies, all in one place,” a YouTube video touting Dibbs proclaims. This

ability to facilitate the quote-to cash lifecycle is what makes Dibbs more than a marketplace, yet more affordable from a fees and percentages standpoint than Angi, formerly Angie’s List. This tool, which is currently rolling out nationwide, may give the small home contractor a system of record that formalizes business processes better than ad hoc approaches they currently may be using.

What sets Dibbs apart from standard online service directories is its inclusion of materials, so construction materials vendors can bid for their portion of the job and coordinate availability of materials on site according to the plan. Co-founder Case Olszewski brought a background in technology and digital customer experiences, augmenting Fleury’s street cred as a residential contractor. A third co-founder, Rob DeSantis, brought board and tech startup experience and helped architect the company. A number of the company’s founders and advisors were founders of Ariba, a procurement software solution now owned by software giant SAP. This focus on digital procurement workflows comes through in the Dibbs functional stack and approach.

By virtue of the way it facilitates transactions, Dibbs will also serve as a contract management solution, and contractors can lay out in the tool payment terms, including up-front and milestone payments and final payment after inspection.

The company aimed first to achieve critical mass in its home state of Rhode Island, hitting enough contractors in different disciplines, then Massachusetts, New York and the rest of New England. This will be followed by a multi-phase launch across the United States.

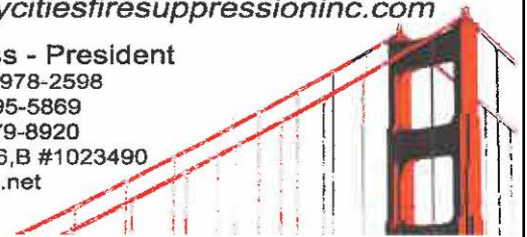

Capitol Connection Q&A for Contractors

I will help a contractor who has let his license expire and will need to jump thru the same hoop before any renewal. Finally, this time I will 'rerun' a question on home theater...

Q: Our license is up for renewal soon and upon receiving the renewal application, we realized that we needed to update our Officers. Against our better judgement, my office decided to handle the update process as a "try this at home" project and we now have a situation on our hands that I hope you can help with! We submitted applications to add our current President/CEO and our CFO and we also submitted Disassociation Notices for the previous President and CFO. The Disassociations were processed before the Additional Personnel Applications, leaving

us with no Officers associated with the license. Then came the rejection notices for the Additional Personnel applications because they weren't signed by a current Officer on the license. What do we do now? We are willing to re-associate one of the disassociated Officers who is still an affiliate if that is what it takes. We need this corrected before our license can be renewed, right?

A: Yes, you will need at least one officer associated with the license before you can renew your license. What you will need to do is update the President/CEO and the CFO with the CA Secretary of State. Once that's done, you can have the new President/CEO sign the applications you need processed and the CSLB will cross reference the SOS records and accept his/her signature.

Q: I had a Contractor's License about six months ago which I let expire. I am trying to apply as the RMO

(Responsible Managing Officer) for another company and the CSLB is requesting I go get fingerprinted again. Does that seem accurate?

A: Yes. The CSLB has been purging fingerprints once you let your license Expire, or once you Disassociate from a license, etc. So yes, you do need to be fingerprinted again unfortunately.

Q: My license was revoked due to some citations I received last year. How long do I have to wait before I can re-apply for a Contractor's License?

A: There is no specific time limit. You will need to provide documentation demonstrating that all losses that

resulted in the revocation have been fully satisfied and you have complied with all terms and conditions imposed by the revocation before you can apply for a new license.

Q: What type of license is required to install Home Theatre systems?

A: The "C-7" Low Voltage classification would be the most appropriate license for that type of work. To quote a famous TV character, 'That's all folks!'

Regulatory Update: OSHA Proposes Injury Reporting Changes

The Occupational Safety and Health Administration (OSHA) has proposed changes in injury and illness reporting that would require employers to file their reports electronically, which could end up in making it easier for the public to access these reports online—including tort lawyers and union organizers.

The same sort of change was proposed during the Obama administration but withered after Donald Trump became President. Critics say posting these reports for everyone to see will make companies targets for organized labor and turn attorneys hunting for liability lawsuit clients into high-tech ambulance chasers.

OSHA's explanation of its motivation behind the proposal appears to bear this out: "The expanded public access to establishment-specific, case-specific injury and illness data would allow employers, employees, potential

employees, employee representatives, customers, potential customers, researchers and the general public to make informed decisions about the workplace safety and health at a given establishment, and this accessibility will ultimately result in the reduction of occupational injuries and illnesses."

Andrew C. Brought, an attorney with the law firm of Spencer Fane, points out, "While this data is already subject to FOIA [Freedom of Information Act], OSHA's intent to make the data available in a searchable online database presents a significant transformation in how the general public, competitors and employees can access the data."

Attorneys for the law firm of Seyfarth Shaw also note, "Many in the regulated community have criticized the new rule on the basis of potential public disclosures

of employee health information.” To address concerns regarding employee privacy, OSHA has announced that it will use artificial intelligence software to identify and redact employee names but leave all references to employee health information.

Under the proposed rule, employers in high hazard industries who have 250 or more employees will not be required to file their 300A reports electronically because they already must routinely keep OSHA injury and illness records in this manner. However, the new rule will increase the burden on other employers with more than 100 employees in the same designated high-hazard industries.

The agency claims that the proposed rule also will improve its ability to use its enforcement and compliance assistance resources to identify workplaces where workers are at high risk, the Seyfarth Shaw attorneys explain. By doing so, OSHA stressed that the change will advance its mission to empower workers by increasing transparency in the workforce.

Specifically, the proposed rule would:

- Require establishments with 100 or more employees in certain high-hazard industries to electronically submit information from their OSHA Forms 300, 301 and 300A to OSHA once a year.
- Update the classification system used to determine the list of industries covered by the electronic submission requirement.


- Remove the current requirement for establishments with 250 or more employees not in a designated industry to electronically submit information from their Form 300A to OSHA annually.

- Require establishments to include their company name when making electronic submissions to OSHA.

In addition, establishments that have 20 or more employees that are in the designated high-hazard industries would continue to be required to electronically submit information from their OSHA Form 300A annual summary to OSHA.

However, the recently released guidance memo shows another way the agency will make use of the data it gathers for enforcement purposes when it comes to tracking down those employers who have failed to submit their annual Form 300A reports and targeting them for enforcement action.


Under the agency’s plan, each week the OSHA headquarters office responsible for statistical analysis will look through inspections opened during the previous week and not yet closed. It will match the open inspections list against a list of establishments that may have failed to submit their 2021 Form 300A data and then create a list of potential non-responders by area office, and forward a weekly report of the results to those area offices.

Let Them know Failure is OK

“The key to nurturing 20-something talent is to communicate a clear goal and let each employee determine the best way to accomplish it,” says Panagakos.

In an article in Harvard Business Review, they go even further identifying a leader as a “failure tolerant leader. Authors Richard Farson and Raphy Keyes, cite the example of Robert Shapiro, a well-known attorney who worked at Monsanto.

During his years leading Monsanto, Robert Shapiro was struck by how terrified his employees were of failing. They had been trained to see an unsuccessful product or project as a personal rebuke. Shapiro tried hard to change that perception, knowing that it hindered the kind of creative thinking that fueled his business. He explained to his employees that every product and project was an experiment and that its backers failed only if their experiment was

a halfhearted, careless effort with poor results. But a deliberate, well-thought-out effort that didn't succeed was not only excusable but also desirable.

Understand What Work Means to This Generation

In an article by Daniel Goleman, author of the bestseller “Emotional Intelligence,” he cites a survey that found 63% of millennials—essentially workers under 35—said the primary purpose of businesses should be “improving society” instead of “generating profit.” Given the fact that the millennial generation, which is comprised of 75 million in the U.S. and makes up the largest generation in the American workforce, their values have to be considered he says. “If millennials want a purpose-driven workplace, then organizations would be remiss not to deliver. If the largest generation in the workforce wants more volunteer time, then any organization concerned with talent retention would do well to make it happen.”

“When it comes to preventing heat illness and exposure to harmful wildfire smoke, employers with outdoor workers should not wait to review their procedures and they should ensure their training is effective as soon as possible,” said Cal/OSHA Chief Jeff Killip.

Heat Illness Prevention Requirements

Cal/OSHA investigates heat-related incidents and complaints of hazards at outdoor worksites in industries such as agriculture, landscaping and construction. These investigations ensure compliance with the heat illness prevention standard and the injury and illness prevention standard, which require employers with outdoor workers to take these precautions:

Plan – Develop and implement an effective written heat illness prevention plan that includes emergency response procedures.

Training – Train all employees and supervisors on heat illness prevention.

Cal/OSHA Reminds Employers to Protect Outdoor Workers from Heat Illness, Wildfire Smoke

Water – Provide drinking water that is fresh, pure, suitably cool and free of charge so each worker can drink at least 1 quart per hour, and encourage workers to do so.

Rest – Encourage workers to take a cool-down rest in the shade for at least five minutes when they feel the need to do so to protect themselves from overheating. Workers should not wait until they feel sick to cool down.

Shade – Provide proper shade when temperatures exceed 80 degrees. Workers have the right to request and be provided shade to cool off at any time.

Observe – Closely observe all employees during a heat wave and any employee newly assigned to a high heat area.

Lighter work, frequent breaks or shorter hours will help employees who have not been working in high temperatures adapt to the new conditions.

Additional information about heat illness prevention, including details on upcoming training sessions throughout the state are posted on Cal/OSHA's Heat Illness Prevention page. Cal/OSHA also has extensive multilingual materials for employers, workers and trainers on its Water. Rest. Shade. public awareness campaign website.

Wildfire Smoke Requirements

California's protection from wildfire smoke standard requires employers to monitor the air quality index for fine particulate matter (PM2.5) before and periodically throughout the work shift when wildfire smoke might affect the worksite. Employers can easily track the air quality index using U.S. EPA's AirNow, local air quality management district websites, or use their own instruments to measure PM2.5 at a worksite under Cal/OSHA's requirements.

Workers should be trained on the health effects of wildfire smoke. Smoke from wildfires contains chemicals, gases and fine particles that can harm health. The greatest hazard comes from breathing fine particles in the air (PM2.5),

Cal/OSHA Reminds Employers to Protect Outdoor Workers from Heat Illness, Wildfire Smoke

which can reduce lung function, worsen asthma or other existing heart and lung conditions, and cause coughing, wheezing and difficulty breathing.

If the AQI for PM2.5 is 151 or greater, employers must take these steps to protect employees:

Communication – Inform employees of the AQI for PM2.5 and the protective measures available to them.

Training and Instruction – Provide effective training and instruction to all employees on the information in section 5141.1 Appendix B.

Modifications – Implement modifications to the workplace, if feasible, to reduce exposure. Examples include providing enclosed structures or vehicles for employees to work in, where the air is filtered.

Changes – Implement practicable changes to work procedures or schedules. Examples include halting operations or changing the location where employees work or reducing the time they work outdoors or are exposed to unfiltered outdoor air.

Respiratory protection – Provide proper respiratory protection equipment, such as N95 disposable respirators, and encourage their use.

If the AQI for PM2.5 exceeds 500 due to wildfire smoke, respirator use is required. Employers must ensure employees use respirators and implement a respiratory protection program as required in California's respiratory standard.
