- Election Day is June 7
- All registered voters will receive a mail ballot. The county will begin sending out ballots May 9.
- The last day to register to vote is May 23. After that, same-day registration will be available, allowing use of a provisional ballot.
- The county's switch to voting centers will offer those wishing to vote in-person more days to do so, without limiting them to use of assigned, precinct-based polling places. A total of 31 voting centers will be open by June 4.

Construction Companies Take Note: Here's Where OSHA's Focusing in 2022

It's no secret that the construction industry is full of risks. There were almost 1,000 fatalities and 250,000 medically consulted injuries in the construction industry in the US in 2020. So it's easy to see why construction companies are always on the Occupational Safety and Health Administration's (OSHA) radar and why construction inspections make up 60% of OSHA's inspections.

Two-thirds of construction fatalities occur in four main areas. This is what OSHA calls "the Focus Four Hazards"—or the "Fatal Four." Falls lead the group, followed by being struck by an object; and the last two are electrocutions and caught in between.

If you work in the construction industry, you're probably familiar with the Focus Four and have put a plan into place to protect your workers from these common types of injuries. You also likely know your company could incur costly OSHA fines if you don't address those Focus Four hazards. But there are some other important programs that OSHA is focusing on in 2022, and you should too in order to keep workers safe and OSHA at bay.

2021/2022 OSHA Construction Programs and Standards

With any administration change, employers can expect to see a change or update to OSHA's focus on accident and fatality prevention. Under the Biden Administration, US workers, including construction workers, can expect the administration to enforce some existing and new regulations vigorously, guidelines, and national and regional (or local) emphasis programs.

National Emphasis Programs (NEPs) are temporary programs that focus OSHA's resources on particular hazards and high-hazard industries. Some construction-related NEPs that OSHA has adopted since 2008 have dealt with combustible dust, hazardous machinery, hexavalent chromium, lead, crystalline silica, and trenching and excavation.

Construction Companies Take Note: Here's Where OSHA's Focusing in 2022

Here are some areas you can expect enhanced OSHA construction company enforcement.

Heat Stress - In September of 2021, President Biden launched a coordinated, interagency effort to respond to the extreme heat that threatens the lives and livelihoods of Americans, especially workers, children, and seniors. So it's no surprise that OSHA's Acting Director, James Frederick, has made heat safety a priority.

Almost 400 workers died from job-related heat stress in the past ten years. So last September, OSHA initiated measures to protect workers from heat-related injuries in an effort to reduce heat exposure. The agency plans to develop a national emphasis program, similar to an emphasis program created in 2018 by OSHA's Region VI (Texas and surrounding states), to prioritize inspections of exposure to heat-related hazards.

In short, the Region VI program implemented a regional emphasis program (REP) to conduct heat illness inspections of outdoor work activities on days when the National Weather Service issued a "Heat Advisory." The Advisory goes hand in hand with OSHA's "Campaign to Prevent Heat Illness in Outdoor Workers".

OSHA also began the rulemaking process to develop workplace heat standards, using Region VI's program as guidance. They also formed a National Advisory Committee on Heat Injury and Illness Prevention to help identify the challenges impacting worker safety.

OSHA has tasked its Area Directors to institute the following: prioritize inspections of heat-related complaints, referrals, and employee-reported illnesses and initiate an onsite investigation where possible; instruct compliance safety and health officers to conduct interventions (i.e., providing heat posters, wallet cards, trainings) or opening inspections when they observe employees performing strenuous activities in hot conditions; and expand the scope of other inspections to address heat-related hazards where worksite conditions or other evidence indicates present hazards.

OSHA moved towards adopting a federal heat standard in October 2021 by issuing an Advance Notice of Proposed Rulemaking on heat injury and illness prevention in indoor and outdoor work settings.

Other OSHA National Emphasis Programs affecting the construction work include:

The 2021 OSHA Fatality Inspection Procedures to Victim's Family Program

This program outlines OSHA's commitment to communicating with a victim's family, or a designated representative, throughout a fatality inspection process. This initiative aims to keep the victim's family informed of the status of the inspection, preliminary findings, any issued citations, proposed penalties, settlement, and closure of the case.

OSHA's Combustible Dust National Emphasis Program (CPL 03-00-008)

This Program was re-issued in 2012. It is a long-standing program focused on abating combustible dust hazards. It contains policies and procedures for inspecting workplaces that create or handle combustible dusts. These dusts may cause a deflagration, other fires, or an explosion in some circumstances. These dusts include, but are not limited to:

- Metal dust such as aluminum and magnesium.
- Wood dust
- Coal and other carbon dusts.
- Plastic dust and additives
- Biosolids
- Other organic dust like sugar, flour, paper, soap, and dried blood.
- Certain textile materials

OSHA's Lead Exposure National Emphasis Program (CPL 03-00-009)

A long-standing OSHA program that's purpose is to reduce occupational lead exposures by effective targeting, enforcement, and outreach for lead hazards.

OSHA's Trenching and Excavation National Emphasis Program (CPL 02-00-161) emphasizes reducing or eliminating workplace hazards with trenching and excavation operations.

OSHA's Regional Emphasis Programs affecting the construction industry

Along with OSHA's national emphasis programs, OSHA's ten regions each have their own specific emphasis programs. Some of these regional emphasis programs that affect the construction industry include:

- Noise hazards

There are noise hazard REPs in seven of OSHA's ten regions.

- Fall hazards

Fall hazards are getting special attention in all but 2 of OSHA's regions.

- Cranes

Cranes in construction are getting special attention in the New England, Pacific Northwest, and Texas (and surrounding states) regions (I, VI, and X).

- Demolition

There are demolition REPs in the regions stretching from New York south to Virginia and west to Minnesota (II, III, and V).

- Residential construction

Nebraska and Kansas have emphasis programs on commercial and residential construction following severe weather events.

- Asbestos

There is an asbestos abatement REP in the Rocky Mountain region VIII.

- Highway & bridge construction

New York, New Jersey, Puerto Rico, and the Virgin Islands all have heavy highway and bridge construction REPs in place.

OSHA's REPs and NEPs help inform construction companies of how accidents occur and where OSHA focuses its efforts. But ultimately, every company should ensure they comply with all of OSHA's regulations, preventing accidents and providing their employees with a safe work area.

Use Toolbox Talks to Improve Worker Safety During the Labor Shortage

Since President Joe Biden signed the \$1 trillion Infrastructure Investment and Jobs Act in November 2021, construction demand has increased. The labor force, however, has not: 92% of contractors reported moderate to high levels of difficulty recruiting skilled labor in Q3 2021, up from 88% in Q2.

When paired with high construction demand, the skilled labor shortage has increased workplace pressures on remaining industry veterans. And with fewer skilled workers, construction companies have had to rely on a less-skilled workforce—a fact that should concern safety-minded contractors. According to the Bureau of Labor Statistics, nearly one-third of nonfatal construction-related injuries occur among workers with under a year's experience.

Given this reality, contractors need to focus on providing

robust workplace safety education. One effective method can be regular safety briefs called “toolbox talks.”

THE CONSTRUCTION LABOR SHORTAGE THREATENS WORKPLACE SAFETY

The construction industry's labor shortage has been a persistent problem since the Great Recession. But in Q3 2021, the U.S. Chamber of Commerce's Commercial Construction Index (CCI) painted a particularly grim picture. Of the contractors struggling to recruit skilled workers:

- Seventy-three percent find it difficult to meet project schedule requirements.
- Seventy-one percent are demanding more of their

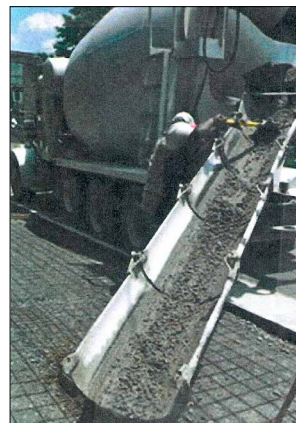

skilled workers.

- Ninety-three percent expect the labor shortage to persist or worsen over the next six months.

These numbers describe a perfect storm for more frequent on-site injuries. When overworked and understaffed crews feel pressured to stay on schedule, they might cut corners. Those decisions can seriously impact their safety.

Fortunately, contractors recognize this problem—workplace safety is their second-highest concern, according to last quarter's CCI. Even so, concern isn't enough. In order to find an actionable solution, contractors need efficient and effective ways to implement workplace safety training.

USE TOOLBOX TALKS TO KEEP SAFETY TOP OF MIND

For contractors struggling to find time for safety training within a busy project schedule, toolbox talks can help make workplace safety a priority. Usually led by shift

supervisors or safety representatives, these talks:

- Are informal.
- Last up to 10 minutes.
- Can happen daily or weekly before shifts.

In an example toolbox talk, your crews might discuss matters like scaffold safety, eye protection, or fall protection anchor systems. Because these discussions are so brief, regular toolbox talks can keep safety top of mind without taking much time away from daily tasks.

Toolbox talks can benefit your workers in a few ways. They enable your crews to:

- Refresh their workplace safety knowledge.
- Perform safety checks.
- Receive advice from experienced crewmates, supervisors or safety professionals.

With consistent usage, toolbox talks can help you build a safer workplace. However, it's important to note that toolbox talks are intended to supplement—not replace—formal safety training. Your crews should engage in regular longer-format training sessions to

ensure a deeper understanding of workplace safety and comply with relevant regulations (OSHA, EPA, etc.).

TIPS FOR AN EFFECTIVE TOOLBOX TALK

For maximum effectiveness, your toolbox talks should follow a few key guidelines. When you hold a toolbox talk, remember to:

- Hold your talk in a distraction-free environment.
- Focus on a single relevant topic, such as a project-specific hazard or observed concern.
- Use props where applicable, such as a ladder if your topic is ladder safety.
- Make space for questions.

In case you're audited, record talk details to demonstrate your attention to safety. At a minimum, write down the talk's date, topic, trainer and attendees.

Taking these steps can help you demonstrate the value of toolbox talks to your crews. Toolbox talks can keep critical safety information top of mind and encourage better communication. And with proper attention, these quick safety chats can mitigate incident risks and build trust between workers and your company.

A CULTURE OF SAFETY CAN HELP YOU WEATHER THE LABOR SHORTAGE

Construction can be dangerous work—in 2019, 20% of all workplace fatalities happened on construction sites. Safety concerns can make it difficult to attract workers, apart from the current labor shortage. But a culture of safety can change that.

Alongside toolbox talks and formal workplace safety training, you should post clearly defined safety protocols for each project. Encourage your workers to call out unsafe practices within their crews. And make sure they feel comfortable speaking up to supervisors if safety appears to be on the back burner.

With safety as a priority, your company can better mitigate risk to retain your existing labor. And going forward, you make it easier to recruit and train new workers.

No four-day work weeks yet. California bill mandating overtime stalls in the Legislature

Don't count on that four-day work week just yet.

A California bill that would mandate employers to pay overtime for workers working more than 32 hours a week will not be advancing in the Legislature this session.

Assembly Bill 2932, authored by Assembly members Evan Low, D-Campbell, and Cristina Garcia, D-Bell Gardens, had been referred to the Assembly Labor and Employment Committee, but missed the April 29 deadline for legislative policy committees to send it along for consideration by fiscal committees.

"I am disappointed that AB 2932 is not moving forward this year, but we must continue to elevate the conversation about the 4 day work week and in general ensuring our workforce has a better work life balance. There have been so many societal advances in the last 100 years. It doesn't make sense that we are still holding onto a work schedule that served the industrial revolution. It's long overdue that this progress is shared with our workforce which deserves an improved quality of life. This has been true for a while,

but the pandemic and the Great Resignation have made it crystal clear the time is now to figure out how we return to better and not what we had before the pandemic," Garcia said in a statement Monday.

The bill had been mocked by comedian and talk show host Jimmy Kimmel, and was dubbed by the California Chamber of Commerce as a "job killer."

The bill "significantly increases labor costs by imposing an overtime pay requirement after 32 hours and other requirements that are impossible to comply with, exposing employers to litigation under the Private Attorneys General Act," according to a CalChamber statement announcing that the bill had stalled.

"As the fifth largest economy in the world, California can lead the nation and further reiterate what we're already seeing from companies who have made the shift — there has been no correlation between working more hours and better productivity. Some employers have even found their employees were more productive working a four-day work week," Garcia said.

California High-Speed Rail Connection to Silicon Valley Approved

A critical 90-mile section of California's high-speed rail extending the system from the Central Valley into the San Francisco Bay Area has been unanimously approved by the High-Speed Rail (HSR) Authority Board of Directors.

The Final Environmental Impact Report/Environmental Impact Statement (EIR/EIS) for the San Jose to Merced project section in Northern California was approved by the board on April 28. The action completes the environmental clearance for nearly 400 miles of its entire 500-mile Phase 1 alignment from San Francisco to Los Angeles/Anaheim. With the environmental process complete, the High Speed Rail Authority—the entity responsible for planning, designing, building and operating the nation's first high-speed rail system—now has a plan moving forward, says HSR spokesman Anthony Lopez. "We know what the alignment will be and where we will be building, and generally the approach we are going to take with that alignment," he says.

The next step is the design-build and preconstruction phase, which can begin as soon as funding is secured, says Lopez. In the meantime, he says the main focus of work is in the Central Valley, where there are 35 active job sites

spanning 119 miles.

"The 119 miles will serve as a test and certification track (for the HSR project), as there is currently no place planned or under construction anywhere in the country where we could achieve our voter mandated speeds of 200-plus miles per hour," says Lopez.



The planned San Jose to Merced project section will connect the existing construction in the Central Valley to San Jose's Diridon Station, the city's central passenger rail depot and a major intermodal transit center for Santa Clara County and Silicon Valley.

Officials say the high-speed rail system will make the trip from Fresno to San Jose in one hour, compared to three hours by car today.

Productivity, or nonfarm business employee output per hour, decreased at a 7.5% annual rate from the previous three months, according to Labor Department figures Thursday." Bloomberg says "that compared to a 6.3% gain in the fourth quarter and the 5.3% projected decline in a Bloomberg survey of economists."

CNBC reports on its website, "At the same time, unit labor costs soared 11.6%, bringing the increase over the past four quarters to 7.2%, the biggest gain since the third quarter of 1982." According to CNBC, "The metric calculates how much employers pay workers in salary and benefits per unit of output."

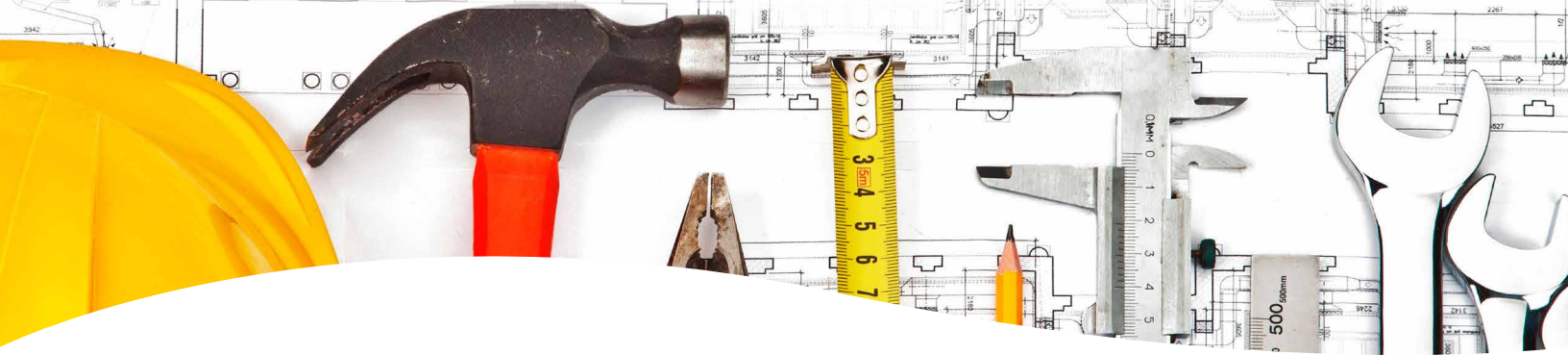

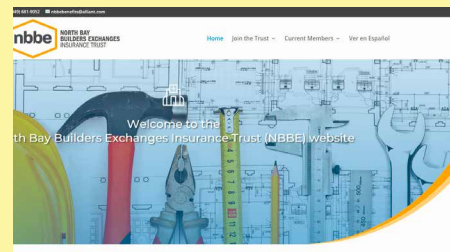

Capitol Connection Q&A for Contractors

I will investigate an unfortunate ‘family’ affair for one corporate contractor, make the ‘call’ on a General question before going ‘online’ to assist a troubled renewal...

Q: I have an “A” (General Engineering) license which I obtained last year. I am trying to start a new company separate from my existing company which strictly does Telecommunications work which my “A” license is sufficient for (sometimes I will need to sub some work to a C10 but that is beside the point). Can I use my license for both Companies?

A: You cannot use the same license number for both Companies. As long as you own at least 20% of each Company, you can qualify both licenses, but each license will have its own number.

Q: My license expires on June 30, 2022. I’m trying to be way ahead of the game this time around because twice now there have been issues with processing my renewal or me not receiving it in enough time to get it in well before the expiration date, which causes it to be expired for a period of time. Do you know when I should start looking for it?

A: The CSLB sends out your renewal notification about 60 days prior to the expiration so you should start right about now! BUT, I have great news for you. The CSLB now allows you to renew licenses in real time online! The implementation of this new feature will certainly save many contractors who have experienced the same dilemma as you. Check it out! <https://cslb.ca.gov/Renewals.aspx>

Q: I just recently came to work for my dad’s company, it’s a corporation. He is the sole owner and has run the business his entire adult life. He is getting on in years and in the event that something was to happen to him unexpectedly, I’ve read there is a way to get a continuance on the license so we can continue employing people and doing work while we update the corporation. Can you give me more information on how

A: Continuances are specific to Sole Proprietorships, Partnerships, and Joint Ventures. These three types of entities are directly affected by one of the parties to the license passing away or otherwise becoming not associated with the license. Corporation and LLC licenses are not affected as if one (or more) of the parties is disassociated from the Company, the license remains in place and will remain Active for a period in order for you to update the license and make changes, all while you continue operating, employing people, etc.
