Internship Hosts Needed for 2022 North Bay Construction Corps

Be a part of shaping future construction industry professionals - host an intern (or two!)

The 2022 North Bay Construction Corps kicked off on April 2nd and sessions run through May 21st. NBCC students will then participate in a week-long intensive career exploration and construction skills building lessons. Over eight weeks, NBCC students will be exposed to a number of construction skills and topics such as heavy equipment operation, electrical trades, plumbing trades, methods to form, mix, and pour concrete, power and hand tool safety, personal protective equipment, construction math, introduction to plan reading & comprehension, and much more. **Our ultimate goal is to create a pipeline of workers for our local community – and we need your help!**

The final portion of the program consists of either a two-week paid internship (for students 18 and older) or a two-week boot camp project (for students under 18). We are currently looking for companies to host interns from June 13th through June 23rd. These internships are an integral piece of the process to ensure our students graduate from the North Bay Construction Corps ready for our industry to hire.

If you are unable to host an intern this year, but still want to be involved, we are looking for industry partners to help out during Boot Camp as well. Boot Camp volunteers will serve as mentors to the students as they complete their Boot Camp project. The NBCC is proud to have placed over 50 students in internships in the past 2 years, and our members have been incredibly happy with the students, often hiring them on full time.

Cal/OSHA Releases Fact Sheets and FAQs on Updated COVID-19 Emergency Temporary Standards

Oakland— Cal/OSHA today posted fact sheets and updated its **FAQs on COVID-19 Prevention Emergency Temporary Standards (ETS)** to reflect revisions adopted by the Occupational Safety and Health Standards Board on April 21, 2022.

The ETS revisions incorporate updated guidance from the California Department of Public Health (CDPH) and make the ETS more flexible if changes are made to CDPH guidance in the future. The updated ETS standards are in effect now through December 31, 2022. They apply to most workers in California not covered by the Aerosol Transmissible Diseases Standard.

OSHA ANNOUNCES NATIONAL EMPHASIS PROGRAM TO PROTECT WORKERS FROM HEAT

Those of you who work in the construction industry are probably well aware that the risk of workers suffering heat-related illnesses and injuries is greater than ever before. Eighteen of the last nineteen summers were the hottest on record, and all indications are that this trend will not only continue but likely get worse. OSHA's recent findings indicate that construction had thirteen times the risk of heat-related deaths than the average annual heat-related fatality rate in all other industries and the highest number of workers hospitalized for heat-related issues.

In an effort to help protect millions of workers from heat-related illnesses and injuries, OSHA has recently launched a National Emphasis Program (NEP) that creates a nationwide enforcement mechanism to proactively inspect workplaces for heat-related hazards in a wide range of industries, including construction.

Reducing heat-related illnesses and injuries is one of OSHA's top priorities, and this NEP is designed to immediately improve enforcement and compliance efforts, while continuing long-term work to establish a heat illness prevention rule.

Key elements of OSHA's National Emphasis Program include:

- Encouraging employers through both enforcement and outreach/compliance assistance to protect workers from heat hazards by providing access to water, rest, shade and adequate training, and implementing acclimatization procedures for new or returning workers.

- Establishing heat priority days when the heat index is expected to be 80°F or higher during which OSHA will initiate compliance assistance in targeted high-risk industries. OSHA will also continue to inspect any alleged heat-related fatality/catastrophe, complaint or referral regardless of whether the worksite falls within a targeted industry.
- Conducting programmed (pre-planned) inspections in targeted high-risk industries on any day that the National Weather Service has announced a heat warning or advisory for the local area.
- Engaging in proactive outreach and technical/compliance assistance on heat priority days to help keep workers safe on the job and to help employers develop and implement heat illness prevention plans.

Areas of construction that have been targeted by OSHA as high-risk for heat-related hazards include, Residential and Nonresidential Building Construction; Utility System Construction; Land Subdivision; Highway, Street and Bridge Construction; Other Heavy and Civil Engineering Construction; Foundation, Structure and Building Exterior Contractors; Building Equipment Contractors; Building Finishing Contractors; and Other Specialty Trade Contractors.

Applications for Curbside Chipper Program open to unincorporated residents

Santa Rosa, CA | May 02, 2022

Sonoma County announced that Permit Sonoma has begun accepting residential applications for the Curbside Chipper Program. The service supports residents of unincorporated Sonoma County in creating defensible space around their homes, neighboring roadsides, and reduces vegetation along access routes.

The Curbside Chipper Program operates from May through November (dependent on weather) and is provided on a first-come, first-served basis. After submitting a complete application, Permit Sonoma will provide up to two hours of complimentary chipping which, on average, is enough time to process a pile of vegetation that is approximately 50 feet long, 3 feet tall and 8 feet wide. In 2021, Permit Sonoma completed a total of 465 jobs assisting property owners as they reinforced defensible space around their homes.

“Permit Sonoma’s free Curbside Chipper Program is a great way for residents to reduce their costs as

they clear defensible space around their property,” said Fire Marshal Steve Mosiurchak. “The chipper program is one of Permit Sonoma’s most popular programs, so we are encouraging residents to apply as soon as possible.”

In the event of a wildfire, having 100 feet or more of defensible space can help save homes. Likewise, thinning vegetation on access roads can make travel and access safer for residents and first responders.

Eligible California Employers with 5 or More Employees Must Comply with CalSavers Retirement Savings Trust Act by June 30, 2022

California law requires that employers doing business in California that do not offer a 401(k) plan must register under the CalSavers Retirement Program (the “CalSavers Program” or “Program”) and provide employee census information in order for CalSavers to automatically enroll eligible employees in a retirement savings program. By June 30, 2022, all employers with five or more employees must comply.

CalSavers gives employees the opportunity to have the employer direct contributions into an IRA account maintained by California. The employer will be directed to automatically deduct these contributions from the employee’s earnings and remit them to the CalSavers Program. Contributions are made on an after-tax basis to a Roth IRA, which is administered by the State of California.

Who Must Comply with the Act?

An eligible employer for purposes of the CalSavers Program is any person or entity (other than the federal government, the State of California or any county, municipal corporation or any units or instrumentalities of the state), whether for profit or not, (1) who is engaged in “a business, industry, profession, trade or other enterprise” in California, and (2) who employs at least five California employees, with at least one of the five employees being an eligible employee. This would include various sole proprietors and self-employed individuals. Generally, an “eligible employee” is an employee who is at least 18 years in age, has the status of an employee under the California Unemployment Insurance Code, and receives a Form W-2 with California wages from an eligible employer.

Employers that contract employment services through multi-party employment relationships (for example, temporary services or leasing agencies and professional employer organizations (“PEOs”)) should also consider those service providers when determining how many employees it has. If your company engages a PEO to provide human resource or payroll withholding services or engages leased or temporary employees from a third-party agency, we recommend you contact the PEO and/or agency to determine who is responsible for complying with the CalSavers Program.

When Must Eligible Employers Register under the Act?

Eligible employers must be in compliance with the Act by the following registration deadlines:

- Deadline for employers with more than 100 employees: September 30, 2020
- Deadline for employers with more than 50 employees: June 30, 2021
- Deadline for employers with five or more employees: June 30, 2022

The California legislature is further considering an amendment to lower this threshold for the mandate to any employer with one eligible employee.

If you are an employer with more than 50 employees, your registration deadline has already passed and you may be liable for penalties for noncompliance, as discussed below.

Can an Eligible Employer Become Exempt from Registration under the Act?

If an employer later adopts a 401(k) plan or drops below the required number of employees in the prior year such that it would be exempt from the requirements of the CalSavers Program in a current year, it must provide the appropriate notice to the CalSavers Program administrator within 30 days of its change in status.

Eligible California Employers with 5 or More Employees Must Comply with CalSavers Retirement Savings Trust Act by June 30, 2022

An eligible employer becomes exempt from CalSavers if it adopts or offers an employer-sponsored retirement plan for its employees. Under the Act, plans meeting this requirement include the following:

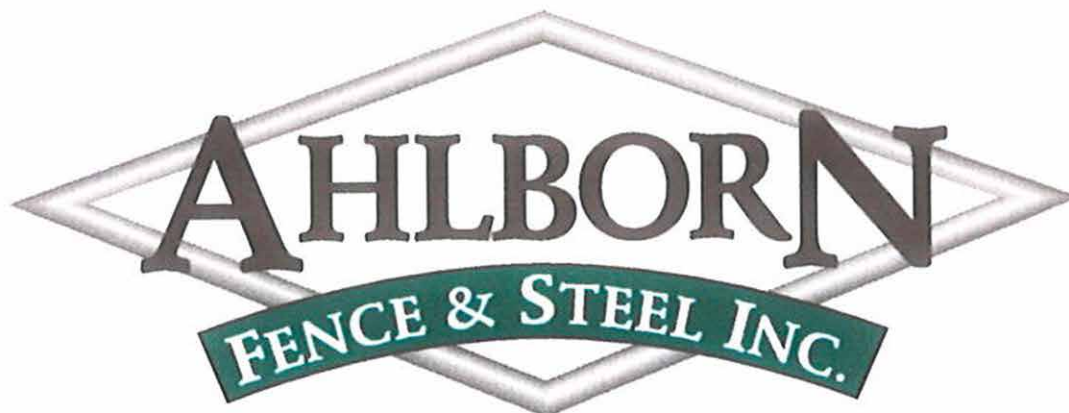
- 401(k) plan (including a multiple employer plan (e.g., PEO sponsored) or a pooled employer plan (“PEP”))
- 401(a) qualified plan (including profit sharing and defined benefit plans)
- 408(k) Simplified Employee Pension (SEP)
- 408(p) Savings Incentive Match Plan for Employees of Small Employers (SIMPLE IRA)
- 403(a) Qualified Annuity Plan
- 403(b) Tax-Sheltered Annuity
- An automatic enrollment payroll deduction IRA

If an employer adopts, or makes available, one of the above retirement plans, it must provide the appropriate notice to the CalSavers Program administrator within 30 days of its change in status.

Are Penalties Assessed on Eligible Employers That Do Not Register under the Act?

Eligible, non-exempt employers that, without good cause, fail to enroll their employees in the CalSavers Program upon receiving notice of noncompliance may be subject to a penalty of \$250 per eligible employee if noncompliance extends 90 days or more after service of the notice. If noncompliance continues for 180 days or more after the notice, an additional \$500 per eligible employee penalty applies (for a total per eligible employee penalty of \$750).

Eligible California Employers with 5 or More Employees Must Comply with CalSavers Retirement Savings Trust Act by June 30, 2022

Employers with more than 100 employees that did not register by June 30, 2020, and employers with more than 50 employees that did not register by June 30, 2021, should be aware that the CalSavers Program has begun notifying employers of delinquencies and will soon begin enforcement actions.

What Responsibilities Do Eligible Employers Have under the CalSavers Program?

Each eligible employer must register its business with the CalSavers Program by the applicable registration deadline. Upon registration, an employer will have 30 days to provide employee census and account information to the CalSavers Program. And once registered, an employer must maintain up-to-date employee census information and register new employees within 30 days of their respective hire dates. The CalSavers Program will use this information to contact enrolled employees to provide them with information on how the Program works, how to set up their account and how to opt out if they wish.

The CalSavers Program will send each registered employer an informational flyer that includes background information on the Program and appropriate disclosures. Employers may choose whether to disseminate these flyers to their employees. However, if the employer communicates any information regarding CalSavers to its employees the employer must remain neutral regarding the Program.

Eligible employers that elect to enroll in the CalSavers Program will act as Program facilitators, essentially as a conduit for remitting Roth IRA contributions, and are not responsible as sponsors of the Program. Employers are responsible for remitting employee contributions for each payroll period within seven days of the deduction from the employee's paycheck. Employers will not have any liability for the investment decisions of employees whose assets are deposited in the Program. The Roth IRAs utilized by the CalSavers Program are not ERISA-covered plans; therefore, other than complying with the requirements of the CalSavers Program, employers have no ERISA reporting and disclosure or fiduciary responsibilities.

Additionally, employers are not required or permitted to contribute to employee accounts, nor are they responsible for answering questions about the Program, managing investment options, processing distributions or giving investment or tax advice.

Any fees collected for participation in, or the administration of, the CalSavers Program are assessed against the employees' account balances and are not the financial liability of the employer.

Can Employees Opt Out of the CalSavers Program?

Employees that are enrolled in the CalSavers Program may elect to opt out (and opt back in) by notifying the CalSavers Program via written notice, the CalSavers website or telephone. Employers do not have any liability for an employee's decision to participate in or opt out of the CalSavers Program.

How Are Employees Enrolled in the CalSavers Program?

Any eligible employee who does not opt out of the CalSavers Program within 30 days of the employer's registration will be automatically enrolled in the Program.

Unless otherwise specified by the employee, 5% of each enrolled employee's annual wage or salary will be contributed to the CalSavers Program, with an automatic increase of 1% each year up to a maximum of 8% of annual compensation. Automatic contributions will begin in the first payroll period following 30 days from the employer's registration. Employees may log into their CalSavers account and change contribution amounts and investment options at any time. The process by which employers are notified of participant deferral election changes is not explicitly addressed, but informal discussions with CalSavers indicates there will be a notification and/or alert in the employer portal.

Are There Any Fees to the Employers Associated with Participation in the CalSavers Program?

There are no costs or administrative expenses to employers for joining CalSavers; all expenses are borne by the employees.

What Type of Retirement Investments Are Offered under the CalSavers Program?

The CalSavers Program offers employees a Roth IRA, which is an after-tax contribution retirement vehicle in which earnings grow tax-free. Distributions from a Roth IRA are also tax-free, provided certain holding periods are met prior to distribution.

Capitol Connection Q&A for Contractors

I take ‘responsibility’ and make one question into four answers! While it might be a ‘family’ business, some license transfers ‘test’ the limits of law, and a CSLB reminder to those who are called to assist in fire prone communities...

Q: I was reviewing our license recently, and we are an Limited Liability Company (LLC). I noticed that our Qualifier is shown as an “RMO”. I didn’t think that LLCs could have “RMO’s”. I thought LLC only had “Members” or “Managers”. Is this a CSLB mistake or am I about to learn something new?

A: You are about to learn something new! The Qualifying Individual on an LLC license can be a (1) RMM (Member), an (2)RMG (Manager), an (3) RMO (Officer), or an (4) RME (Employee). LLCs are required to have at least one Member or Manager listed and their Member/Managers listed must match the CA Secretary of State records. LLC’s can also internally “elect” to have Officers. In CA, Officers of an LLC are not required to be listed with the SOS but can still be listed on the Contractor’s License.

Q: My wife and I have a Partnership license and we are ready to retire. One of our Sons who has worked for us for years is wanting to take over the business. Being that he’s worked for the Company for well over five years, can he do that without testing?

A: No, he will not be granted a Waiver of the exams based on working for the Partnership for over five years. This is yet another reason why I'm not a big fan of "General Partnerships" with respect to licensing. B&P Code section 7065.1, which is the Code Section authorizing Waivers under certain conditions, is in relation to Sole Owner, Corporation, and LLC licenses. For Partnerships, the only Waiver which would be permitted is where a General Partner replaces the Qualifying Partner after five years, with no other changes to the Partnership structure.

With fire season beginning in California, the Contractor's State License Board wants to remind all "C-16" Fire Protection Contractors about the requirement for Certification through CAL FIRE. This is required for all installers, licensees, and their employees, of water-based fire protection systems for commercial or multi-family dwellings. Please note this does not apply to "C-16" Contractors and employees who work on one and two-family homes.
