

## THE DROUGHT EMERGENCY: How bad is it and what effect will it have on the local construction industry?

As NCBE members are likely aware, last month Governor Gavin Newsom proclaimed a local drought emergency in both Sonoma and Mendocino Counties. So exactly how bad is it and what will it mean to the building industry.

NCBE staff took part in an excellent special Zoom forum on water issues and the drought emergency held by the North Bay Leadership Council. The featured speaker, Grant Davis, General Manager of the Sonoma County Water Agency, painted a gloomy picture unless there are significant increases in rainfall which doesn't look likely in the near future.

Davis said the drought emergency is a direct result of a severe lack of rain, with record lows in both water storage and rainfall in both counties. This multi-county emergency has prompted local officials to consider new measures in an attempt to manage local water supplies.

In an attempt to aid in the conservation of current water supplies, the Sonoma County Water Agency is requesting that customers reduce the amount of water they are using by 20%. The 20% reduction can be achieved by implementing some quick water saving tips, such as the ones listed below

- Reducing outdoor irrigation
- Finding and fixing leaks
- Eliminating unnecessary watering
- Reducing shower time

Davis also announced that on Saturday, June 12<sup>th</sup> the Sonoma County Water Agency will be hosting a “Drought Drop-by” (previously called a Drought Drive-up) in various communities around Marin, Mendocino, and Sonoma Counties. For four hours on that day, local residents will be given water efficiency items and can get information on where rebates will be offered. These measures will mark an important step in the right direction, said Davis.

Davis was careful to explain that his agency doesn't have any land use authority. As an organization, SCWA is only responsible for providing water. He doesn't believe that water supply will be a limiting factor when it comes to building and development locally. But as development continues to occur, those in construction may be asked to find a way to help offset the supply needed.

Davis recommended that any new projects seriously consider putting reclaimed water in purple pipes throughout the development. Utilizing this water conservation measure is not likely to be heavily over-regulated and will actually be encouraged. He urged those in the construction industry to look for creative solutions that could provide long-term solutions for the serious issues being faced today.

With the drought emergency having been declared only recently, it is unclear to what extent builders will be impacted, but things are hopefully not as bleak as they may appear. As the Builders Exchange learns more, we will continue to provide updates on the Drought Emergency.



One message rang through throughout Davis' hour-long presentation and question-and-answer period last Thursday morning: As a community, we all need to take action to prevent the emergency from escalating. He highlighted not only the severity of the situation, but also the need for immediate conservation methods to maintain feasible water levels in both counties.

## Lumber futures extend record rally to top \$1,500 for first time


U.S. lumber futures extended their steep rally to fresh record highs, shooting above \$1,500 in early trading Wednesday.

The extended rally comes as voracious home construction demand sends builders scrambling to secure the wood they need, while sawmills struggle to bulk up their inventories and labor shortages from truckers to construction workers exacerbate the situation.

Prices have quadrupled in the past year, vaulting higher on an unexpected surge in home building and renovations that caught sawmills off guard amid the pandemic. Weyerhaeuser Co. reported a record quarterly profit last week, having sold out of some products for the next five to six weeks, while Resolute Forest Products Inc. said its order book exceeds its inventory.

The rally, which some expect could continue even higher, is hitting pocketbooks and potentially pushing first-time home buyers out of the market, as North America heads into its peak building season. It has lifted the price of an average new single-family home by \$35,872 over the past 12 months, according to the national Association of Home Builders.

July lumber futures on Chicago Mercantile Exchange rallied as much as 4% to \$1,541 per 1,000 board feet, the highest-ever for a most-active contract. The May contract, which will expire May 14, rose \$1.10 to \$1,610.10.

# Construction Safety Emergency Action Plans

Workplace emergencies can happen on any jobsite and have the potential to cause severe injury to workers and extreme property damage. Emergency Action Plans (EAP), or Emergency Response Plans (ERP), provide site-specific procedures so workers understand what is expected and how to respond in the event of an emergency.

**The goal with any EAP / ERP is to:**

- Prevent fatalities and injuries
- Reduce damage to buildings, stock, and equipment
- Protect the environment and community
- Accelerate the resumption of normal operations

OSHA Construction Standard 1926.35(a) specifies that EAP / ERP needs to be in writing and cover designated actions to ensure employee safety. In the event of an

emergency, all personnel must know:

- Basic first aid and CPR
- How to report an emergency
- The procedure for emergency evacuation, including the type of evacuation, exit route assignments, and muster points
- What the alarm system looks or sounds like to alert workers of emergencies – phone call, text message, air horn, siren, etc.
- How to account for all employees after evacuation
- Procedures for employees performing rescue or medical duties
- Contact for HSE department and other EAP / ERP information

**Examples of potential workplace emergencies include:**

- Fires and explosions
- Severe weather – rain / flood, tornado, hurricane, etc ...
- Heavy equipment failures
- Confined space rescues
- Hazardous material incidents
- Cave-in rescues
- Fall arrest rescues
- Worker injuries
- Struck-by / caught-in incidents
- Medical emergencies
- Motor vehicle accident
- Chemical / hazardous material spill
- Active shooter



Site-specific EAP / ERP must be in place for every jobsite, should be easy-to-read, and posted in multiple locations across the jobsite so every worker can review it.

**The basic EAP should include:**

- Address and description of the site location
- Meeting and / or muster points for evacuation
- Emergency response numbers for 911, fire department, police, emergency responders

- Name and address of nearest medical facilities
- Map to nearest medical facilities
- Name and contact information of utility providers
- Access points for emergency personnel

The first instinct in any emergency is to call 911, but before any project starts and as the EAP / ERP is being developed, it is critical to verify 911 is in effect in the area and to understand the emergency resources and facilities available for the specific jobsite. Questions to consider include:

- What is the emergency response time for the job site?
- Is a high-angle rescue team available?
- Is a confined space rescue team available?
- How close is the nearest medical facility?
- What on-site emergency resources are available – first aid kits, AED, fire extinguishers, spill containment equipment, PPE?

To be effective, all workers need to be trained on the EAP / ERP and sufficiently understand their role during an emergency. Workers need to be trained on the EAP / ERP:

- Initially upon hire
- At the start of any project on a new site
- If the plan changes or if site conditions / location changes
- If designated persons' duties change
- Annually thereafter review:
- With any new subcontractors
- With suppliers for delivery and storage hazards
- Take time to review your project specific EAP / ERP

Planning ahead of time, creating a site specific EAP / ERP, and communicating it to everyone involved on a project is critical to its successful execution in the event of an emergency situation.



# Never a dull moment! Recent updates in the HR world

In honor of the recent passing of DMX, our world continues to “*blow our minds, up in here*” with some confusing and contradictory requirements. Never fear! Your CEA team is on the case and tracking these issues. The following is an update on several recent and contradictory employment policies. Be sure to follow our blog and sign up for our newsletter as there will be more to the story on each of these issues.

## CDPH aligns with the CDC

The California Department of Public Health (CDPH) updated the state’s face covering guidance to align with the federal Centers for Disease Control (CDC) guidance regarding face coverings for people who are vaccinated.

This guidance says that if fully vaccinated workers are exposed to COVID-19 at work, they do not need to quarantine so long as they are asymptomatic. The new guidance also indicates that masks may not be required

if all parties are fully vaccinated. However, employers subject to the Cal/OSHA COVID-19 Prevention Emergency Temporary Standards (ETS) must ensure that employees are following the current ETS face covering and testing requirements, regardless of whether your staff is fully vaccinated. Even with recent Cal/OSHA updates protocol such as masks and physical distancing are still required. Nonetheless, we still have a contradiction here.

What does this mean for employers? The ETS provides stricter requirements, so until the Governor issues an order or Cal/OSHA updates the ETS, nothing changes! Cal/OSHA’s updates state that employers do not have to exclude fully vaccinated employees from the workplace following exposure (so long as they are asymptomatic). However, testing requirements, masks, physical



distancing and cleaning protocol remain in place. More COVID-19 compliance information is available on our website under COVID-19 Resources.

### AB 5 and Trucking

Not long ago, the California Trucking Association (CTA) received a favorable verdict that AB 5, the independent contractor law, did not apply to their members and therefore interstate truckers could remain as independent contractors. Late last month, an appeals court disagreed. CTA will appeal this decision, as CTA believes AB 5 disadvantages the trucking industry.

What does this mean for you? If you're in the trucking industry, reach out to CTA or your legal counsel. For the rest of employers, this is a reminder that AB 5 challenges are a steep hill to climb, so enter independent contractor matters with mindfulness and a good legal team.

### Eviction Moratorium Unenforceable

Last fall, the Centers for Disease Control (CDC) issued a nationwide moratorium on evicting residents who could not pay their rent due to COVID-19. The moratorium was set to expire on June 30, 2021. However, a federal court judge found that the CDC exceeded its authority when issuing the moratorium. The CDC has said it will appeal this decision and hopes to succeed in getting an emergency stay so the moratorium stays in effect during the appeal.

What does this mean for you? As our state begins to open up (indeed there remain some state rules restricting evictions), many employers hope to bring employees back to work. Employees who have insecure housing

have different stressors and may need additional support or communication during this time. If employees cannot return to work or are not able to "work from home" be sure to discuss the reasons around that so you are making informed decisions about individual's employment status.

### Posters: Can't We Just Email Them?

Alas, no. We have written about posters over the years in our blog – and while we were hoping the state and federal agencies would provide the option of virtual posters due to COVID-19, that has yet to come to fruition. Some more recent posters, such as the SPSL posting (*good news the Spanish version is finally available*) can be emailed, but the posters in CEA's all-in-one poster (*except California's Pregnancy Leave posting*) must still be posted in a conspicuous location where employees will see it.

What does this mean for you? If your folks will remain completely remote and not come into your office this year, those employees should have their own poster sent to their home.

## North Bay Construction Corps students will be ready for two-week paid internships in June

**Looking for an entry-level employee at your company?

This year's class of North Bay Construction Corps students is looking to secure two-week paid internships in June with local construction companies in the North Bay to experience "real-life" construction work.

NBCC has close to 40 students who are 18-years-old and will have just graduated high school in June. They are expected to have their own transportation and will come to work properly dressed and ready to go with safety glasses and a hard hat. We ask that if there are any specific tools or PPE you require, you provide them. Upon request, NBCC will contribute \$750 per student to offset any employment costs.

This is a win-win. Your firm can learn about a potential employee while the student is given the opportunity to experience the realities of construction and give your particular trade a try. We are surveying students now to learn from them the top three areas of construction they are most interested and we will match students up with companies in the field they have shown an interest in.

## Capitol Connection Q&A for Contractors

The source of experience credit will get ‘tested’ in applying and must pass examination! I knuckle-down on another compelling question that will help resolve any ‘asbestos’ issues you may have, and be a knock on ‘opportunity’s’ door ...

**Q:** I had spoken with you a couple of weeks ago regarding purchasing a Plumbing business. You informed me in order for me to qualify the license, I would be required to document at least four years of experience. With my college education hopefully allowing for two years of credit towards that, we concluded I would likely only need to show another two years of experience. I wasn’t positive I would be able to support my experience (*although I do have plenty of plumbing experience*) and you mentioned how sometimes in these buy/sell

agreements, the seller agrees to stay on the license until I gain enough experience to replace him. I proposed this to the bank, but one of their stipulations in order to qualify for the business loan is I, myself, hold the license.

I just spoke with the contractor I worked with for several years in the past and he has agreed to fill out the forms and support my experience in any way necessary to fulfill the requirements for me to sit for the exams. He had a CA General Building license during the time I gained industry experience (*on and off from 2014-2017*), however he moved to Florida and let his CA license expire. Is he still okay to sign for me, or will the fact that his license is not current as of today raise a red flag? And given what I’ve told you today, do you believe I will qualify for the exams?

**A:** First, the person who signs off on your experience does not need to be currently actively licensed in California.

As to whether or not you will qualify, in my opinion you still have several “red flags” that will likely come up. The one which concerns me the most is even though you worked with the General Contractor, you weren’t an actual employee of his, so your work would be considered self-employed. Self-employed experience is the most difficult form of experience to get the CSLB to recognize, as it’s difficult to verify. You will likely have to provide additional documentation such as permits you pulled for the plumbing work, contracts, etc. We’ve seen the CSLB give an applicant 1/3 credit of the time they are claiming, and we’ve seen them give applicants no credit if they cannot produce additional documentation.

**Q:** I have a question about the “C-22” (Asbestos Abatement) classification. Is it required that you hold

a certain classification first before you can obtain the “C-22”? I’ve heard you have to have the “A” (General Engineering) first, and I’ve also heard that you must have the “B” (General Building) classification before you can apply to add the “C-22”.

**A:** Neither of those is correct. While you do need to hold certain classifications first before you obtain the Asbestos certification, you do not need to even have a Contractor’s license in place in order to obtain the “C-22”. The “C-22” is its own classification. There are other requirements to qualify for the “C-22”, so if you, or anyone else, want more information please feel free to contact our office.



# Why asbestos still threatens construction workers' health

**Asbestos exposure remains a significant risk for today's construction workers  
— and will pose an even greater risk for decades to come.**

Asbestos continues to represent a considerable threat to the health of construction workers and the population at large. Though some applications for asbestos have been banned in the United States, the naturally occurring silicate mineral itself is not.

The first use of asbestos is believed to date back to the Stone Age, approximately 750,000 years ago, as archeologists found asbestos fibers that were used for wicks in lamps and candles. Furthermore, the embalmed bodies of Egyptian pharaohs were wrapped in asbestos cloth to protect the bodies from deterioration between 2000-3000 B.C. In Finland, clay pots dating back to 2500 B.C. contained asbestos fibers, which are believed to

have been added to strengthen the pots and make them resistant to fire.

Knowing the modern history of asbestos is important to understanding the current challenges in the construction sector. In the 20th century, industrialization gave way to unparalleled development and growth throughout the nation. Asbestos was then the raw material of choice for an almost infinite range of applications. It was hailed as a magical material and praised for its:

**Unique strength and durability qualities;**

**Fire, heat, chemical and electricity resistance; and**

**Low cost of mining and production.**

The physical and chemical qualities of asbestos made it ideal for solving the many technical challenges arising from industrialization. For example, companies used asbestos extensively as a fortification measure in nearly everything, such as tile, flooring, insulation, electrical applications, heating systems, cooling systems, windows and roofing.

In the early 20th century, the medical community quickly realized the adverse health effects of this deadly mineral. That's when cases of asbestos-related mortality were first diagnosed and documented. However, despite this newfound knowledge, the use of asbestos continued. Asbestos

reached its heyday after World War II when the number of applications and products grew in the construction industry.

The mineral has since fallen from grace after more and more pertinent medical studies supported the connection between asbestos exposure and lung disease in the 1980s, but it can still be found in U.S. commercial, industrial and residential buildings erected before the mid-1980s. Awareness of the adverse health effects of asbestos grew, leading to a shift in public opinion.

Many Americans assume that asbestos is banned. It is not. The U.S. Environmental Protection Agency (EPA) tried to ban asbestos in 1989. However, most of its regulations were overturned in 1991 through an appeals court ruling. The EPA has banned new uses of asbestos and its use in flooring felt, rollboard, commercial paper, corrugated paper, specialty paper and spray-applied asbestos. However, the mineral is still being imported and used in existing consumer and industrial products, mostly in roofing materials, fireproof clothing and automotive components such as gaskets and brakes.

Asbestos continues to pose a significant health threat, particularly for workers in the construction sector and for inhabitants of asbestos-infested buildings and workplaces.

## Asbestos Exposure in the Construction Industry

Many occupational groups are at risk of asbestos exposure. However, the construction sector tops the list of dangerous professions, according to recent findings from Advisor Smith. In this industry, occupational hazards are accepted risks, and the threat of respiratory illness caused by asbestos exposure remains a legitimate concern.

Due to how extensively asbestos was used, construction workers will come across asbestos on a regular basis in almost every type of construction. All too often, these products remain hidden in virtually every part of a building or structure. This puts workers conducting maintenance, renovation or demolition at risk of exposure to asbestos fibers, yet they are often unaware of the dangers, especially when they lack the awareness training and knowledge about safety precautions.

Most likely, a construction worker will know that asbestos is a hazardous substance they will often encounter and that there are fines and penalties for improper handling and disposal as well as:

**Where it can be found;**

**What the mineral looks like; and**

**Where it was used.**

There are extensive publications about the hazards of asbestos, such as the Occupational Safety and Health Administration standards for proper asbestos protocol and EPA's Asbestos Hazard Emergency Response Act. Nevertheless, the average construction worker does not know enough about the aforementioned protocol and dangers associated with asbestos exposure.

Employers often fail to inform their workers about the health consequences of asbestos exposure and may even fail to provide them with adequate personal protective equipment (PPE) or respiratory protective equipment (RPE) to wear when working with the mineral.

Identifying asbestos-containing products can be difficult given their prevalence and pervasiveness in construction. Furthermore, asbestos-containing materials become susceptible to fragmentation as they age. This can release deadly asbestos fibers into the air. Once released, asbestos fibers cannot be detected without technical equipment. Unfortunately, this is not done consistently.

Once inhaled, the mineral fragments can become lodged in the body. Even when the amounts of inhaled fibers might be small, there are no safe exposure limits. Together with the accumulated exposure over a worker's career, there is an increased risk of falling ill with asbestos-related diseases such as mesothelioma or asbestosis.

A lack of awareness and asbestos removal planning means that dealing with it is postponed to a later time. For example, painters, electricians and floor tilers conducting renovation on parts of a building may expose themselves to asbestos and potentially leave behind asbestos products that will continue to pose a risk for the next generation of workers.

The best way to ensure worker safety is for them to know the threat asbestos poses to their health. When education is paramount, the effects will manifest and safeguard the health of workers and provide an environment where the job can be completed efficiently. Thus, they will be more apt to follow proper protocols and compliance policies.

Building owners and employees must assess workplaces according to the standards to determine if asbestos is present and if the planned work will generate airborne fibers. This is done by a specific method under each

standard before commencing major works. A thorough and complete risk assessment should include full details of the work to be carried out and an estimate of how long the work is going to take. It should also include the following:

- details of the type and quantity of the asbestos;**
- details of the expected level of exposure;**
- details of the controls to be used to reduce exposure, e.g., use of local exhaust ventilation, controlled wetting, adequate PPE / RPE use of enclosures;**
- decontamination procedures for tools, equipment and PPE;**
- details on how asbestos waste will be managed; and**
- emergency procedures.**

Awareness training is highly important, as it is the only way for workers to identify potential sources of asbestos to protect themselves. Asbestos-related diseases can have latency periods of up to 30 or 40 years. The danger is that employers and workers alike often perceive asbestos as an abstract threat without immediate consequences. Thus, many pay too little attention to potential dangers until it is too late.

## Health Effects of Exposure to Asbestos

Throughout the 20th century, sturdy men with a lifetime of construction experience began exhibiting signs of alarming illness. These men spent their entire working lives in the industry, only to receive a diagnosis of mesothelioma. This rare disease was first recognized in the 1960s.

### Their symptoms included:

- Chest pain,**
- Chronic cough and**
- Fluid buildup in the lungs.**

As it stands today, the only known cause of mesothelioma is asbestos exposure. Mesothelioma is often misdiagnosed because of the rarity of mesothelioma and the commonality of the symptoms that can be attributed to several illnesses.

Most cases of malignant mesothelioma are diagnosed in the late stages. Once specialists diagnose mesothelioma, patients face an imposing prognosis. The average patient lives 12-21 months after diagnosis.

Treatment options vary based on the progression of cancer, but patients can expect a regimen of chemotherapy, radiation and sometimes surgical removal of affected

# Why asbestos still threatens construction workers' health

tissues. Currently, mesothelioma has no cure.

Although asbestos helped forge America's cities, it did so at the cost of the lives of many workers and their loved ones. With an estimated 39,275 annual asbestos-related deaths, the mineral is believed to still cause:

- 34,270 lung cancer deaths,**
- 3,161 mesothelioma deaths,**
- 787 ovarian cancer deaths,**
- 443 larynx cancer deaths and**
- 613 chronic asbestosis deaths.**

Considering the rate of asbestos removal today, asbestos will continue to claim a significant number of lives for decades to come.

As older workers retire and a new generation with little experience of the dangers of the mineral take their place, public awareness and knowledge about the dangers of asbestos is fading away, posing an even greater risk for future generations of workers.

Given these dangers, the construction sector will have to face the challenge of protecting today's workers from

asbestos hazards during their careers. Companies need to take appropriate actions to protect their workers from asbestos—now. Thousands of companies have already been held accountable even after the typically long latency periods of asbestos-related diseases, and that already established legal precedent will likely be applied in the future, too.
