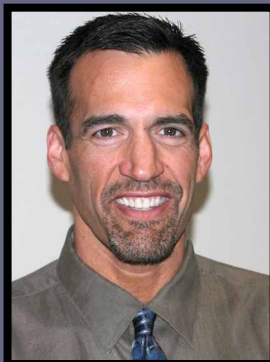

Unprecedented Budget Surplus Is Focus of May Revision

Governor Gavin Newsom announced another upward revision in the state's general revenues—a \$55 billion bump since January. To the surprise of many, this means that discretionary surpluses for three consecutive fiscal years will top \$100 billion. Nobody had this number on their bingo card as the state tumbled into the pandemic recession just two years ago.

This unprecedented and unexpected streak of budget surpluses has been amassed in large part from the strong economic performance by key California economic sectors and entrepreneurs. This creativity and adaptability by employers, along with the commitment of millions of California workers, has seen the state through the tragedy of COVID-19, with extra revenues to bolster the social safety net.

Experience with the California budget teaches that what goes up must come back down, so the Governor prudently sets aside \$37 billion into various reserve funds, and

calculates that 94% of all spending from surplus funds is dedicated to one-time purposes.

Since the state budget is pushing against the so-called Gann Limit, which caps annual expenditures from the state budget, the Governor targeted several of his initiatives toward spending exempt from the limit, in particular, infrastructure and tax relief.

Noting the toll that inflation has recently taken on individual family budgets (not to mention the already high cost of living endemic to California), the May Revision calls for more than \$18 billion in various tax relief or rebate programs, including:

- A \$400 rebate to households based on registered motor vehicles.
- A temporary reduction to the diesel sales tax.

Unprecedented Budget Surplus Is Focus of May Revision

- Funding for rental assistance and payments for outstanding utility arrearages built up during the pandemic.
- Covering all family fees for subsidized child care programs as well as continued health care subsidies for the middle class if federal subsidies expire
- Retention bonus payments to approximately 600,000 workers in hospitals and nursing homes.

The Governor is also proposing some targeted tax benefits for businesses, including:

- Extending the CalCompetes tax credit program for five years at \$180 million per year, and extending the CalCompetes grant program for another year at \$120 million.
- Fully conforming California law to the extended federal Paycheck Protection Program (PPP), which prevents these federal grants from being subject to state taxation.
- Another \$500 million for a grant program administered by the Small Business Advocate to provide additional relief to small businesses most affected by the pandemic, focusing on the top ten industries hardest hit by the pandemic.

California will receive \$13.9 billion in new federal funds from the Infrastructure Investment and Jobs Act that will support transportation, broadband and other projects over the next five years. On top of that, the May Revision will target another \$17 billion (on top of \$20 billion from the January budget proposal) for electric vehicle infrastructure and clean energy innovation, transportation projects, broadband build-out, and reducing wildfire risk and supporting drought resiliency.

Schools automatically receive a portion of every new general tax dollar, courtesy of a 1988 ballot measure, Proposition 98. The May Revision includes total funding of \$128.3 billion for all K-12 education programs—more than \$20,000 per student. This is \$20 billion more than the Governor proposed in January, and a stunning \$35 billion higher than the current year budget. Some \$8 billion of

this amount is a one-time allocation that schools can use to address the continuing effects of the pandemic by supporting students' mental health and learning challenges and to take actions to preserve staffing levels.

The Governor made good on his pledge to give annual budget increases of 5% to the University of California and California State University systems over the next five years. In exchange, the systems will be expected to make progress and report annually on goals including improved graduation rates, growing enrollment, making college more affordable and preparing more students for high-demand careers.

Governor Newsom increased his spending commitment for programs related to climate change and drought mitigation, adding \$9.5 billion to a \$23.5 billion multi-year commitment made in January. The spending will cover drought relief and water projects, investments in clean energy, and subsidies for electric vehicle purchases and charging infrastructure.

The Governor made no changes to his January proposal to transfer \$3 billion to the Unemployment Insurance Fund to offset future employer tax liabilities.

The COVID-19 Regulation's Final Re-Adoption – What Does it Mean Going Forward?

It has been almost a month since the third (and final) re-adoption of the COVID-19 Workplace Emergency Temporary Standard (ETS) was adopted at Cal/OSHA's April meeting. Now that the third re-adoption is done, there are three big picture things to keep in mind as we look to the future of COVID-19 workplace safety.

(1) We won't be seeing more amendments every few months to the ETS. Since its passage in November of 2020 (around 18 months ago), the ETS has been amended with each re-adoption – meaning it was changed substantively about every six months. Now, with the ETS statutorily out of extensions (and finished with one final emergency-related extension via executive order), the ETS text will not be updated again until it is (potentially) turned into a permanent regulation by Cal/OSHA at the December 2022 Standards Board meeting.

(2) What would a permanent regulation mean for the COVID-19 ETS? Cal/OSHA is definitely preparing for the

potential to consider the ETS as permanent at its December meeting. In the most recent indication of the coming December vote, the Department of Finance posted its Standardized Regulatory Impact Assessment (SRIA) of the potential permanent COVID-19 regulation on April 29, 2022. (The SRIA analysis is a requirement prior to any major regulation in California, so Cal/OSHA could not have voted on making the ETS permanent without it.) Cal/OSHA staff has suggested that any version considered by the Board would be very close to the present text (and would have to stay close for the SRIA analysis to be legally sufficient), so we can expect a vote on basically the third re-adoption's text at the December meeting.

Assuming Cal/OSHA approves the COVID-19 ETS as a permanent regulation, we can expect the pace of changes to be much slower than with the ETS. Permanent regulations may go years (or even decades) without major updates.

The COVID-19 Regulation's Final Re-Adoption – What Does it Mean Going Forward?

This is a particular concern for employers, as the ETS continues to contain provisions that many would consider “emergency level” precautions and locking them in place for years when COVID-19 has become endemic is a huge concern.

In contrast, Standards Board members have also expressed support for potentially an over-arching infectious disease regulation, in lieu of the COVID-19 regulation being extended. This would take months (or years) to draft with stakeholder input, so it will not be voted upon in December – but is the other potential successor to the ETS.

(3) Watch the FAQ's and Orders! Just because the regulation's text itself is not changing doesn't mean that the compliance obligations on businesses may not shift over the next six months. New FAQs were issued on May 7th (available here: COVID-19 FAQs Updated May 6, 2022 (ca.gov)), and we can expect more changes between now and December 31st of this year. And don't forget – the regulation cites to CDPH orders and guidance, so any changes by CDPH may also change ETS obligations.

So, though the pace of change in California's COVID-19 ETS is slowing, California employers should not stop watching for changes just yet!

Six Months In: How Has the Infrastructure Bill Progressed?

May 16th 2022 marked the six-month anniversary of President Joe Biden's signing of bipartisan infrastructure legislation called the Infrastructure Investment & Jobs Act.

White House Infrastructure Implementation Coordinator Mitch Landrieu told that his team is "hitting the ground running on the projects that are shovel-ready."

Landrieu said the administration has "pushed \$110 billion out of the doors to the states" and made another \$100 billion available in opportunities to fund infrastructure projects. The \$110 billion includes funding for over 4,300 specific projects. From rural communities to urban areas, the Biden administration said over 3,000 communities are beginning to benefit. The projects include things such as tunnel and bridge reconstruction, brand new buses for cities and airport improvements.

The infrastructure bill includes \$110 billion for roads, bridges and major projects; \$65 billion to expand broadband access and affordability; \$66 billion for rail; \$55 billion for water infrastructure; \$25 billion for airports; \$39.2 billion in new transit spending; and \$5 billion for electric vehicle charging stations.

Here is a list of results so far from the legislation :

- Roads: The U.S. Department of Transportation (USDOT) and Federal Highway Administration (FHWA) announced \$52.5 billion in Federal Highway Apportionment for

fiscal year 2022 the largest in decades for all 50 states and D.C. The law invests \$350 billion in highway programs over the next 5 years.

- Rural Highways: USDOT announced \$1.2 billion for highways in rural Appalachia for the Appalachian Development Highway System (ADHS) toward the timely completion of designated corridors in 11 states in the Appalachian region. The total amount that will be available to the states in Fiscal Year 2022 is \$246 million.
- Bridges: USDOT and FHWA announced over \$27 billion in funding to replace, repair, and rehabilitate bridges across the country to all 50 states, D.C., Puerto Rico, and Tribal governments over the next five years.
- Major Local Infrastructure Projects: USDOT opened applications for \$2.9 billion for major transportation projects through a combined notice of funding opportunity (NOFO) for MEGA, INFRA, and Rural programs. Putting these three programs under a single NOFO makes it easier for communities to apply to one, two, or three major discretionary grant programs with a single application and common set of criteria.

Special Projects Receive Special Funding

The Transportation Department also opened for applications \$1 billion in 2022 grant funding for communities to help address mounting U.S. traffic deaths.

The National Highway Traffic Safety Administration (NHTSA) said in February U.S. traffic deaths rose 12% in the first nine months of 2021 to 31,720 - the highest number killed on American roads in that period since 2006.

Communities can apply to use these "Safe Streets" funds to add roadway safety features like "centerline and shoulder rumble strips" or "traffic calming road design changes ... and making strategic use of speed safety cameras," the Transportation Department said in a briefing document.

These projects present opportunities for contractors and your main question should be "Where is the funding going?" and "How can I identify opportunities emerging from this bill?"

The first place to start is by looking over the agencies and programs in play in order to identify where their offerings may align with your services.

- **Get To Know the Players:** There are more than 20 agencies funded in the IIJA. Contractors need to assess their footprint in those organizations and if none exists, develop a customer intelligence strategy for building up agency knowledge.
- **Get to Know the Programs:** The IIJA focuses heavily on funding specific infrastructure programs, including the establishment of new ones. Contractors can identify programs within agencies of interest to them and start to inform themselves of program missions, history, leadership.
- **Get to Know the Specific Teams:** Many government departments receiving significant IIJA funds have set up dedicated infrastructure pages to provide implementation updates, to varying degrees of depth and granularity. Check regularly for insight into the mechanisms being used to distribute the money. Contracting and acquisition support firms also have dedicated research teams that will be monitoring for updates.

Economy Hindering Optimism

While getting the law passed with bipartisan support was a major win for President Biden, recent polling indicates that Americans are more concerned about other issues, especially inflation. Infrastructure efforts are now wrestling with high inflation, labor shortages that cut across industries and supply chain stumbling blocks that will slow projects and make them more significantly expensive. That will impact state and local budgets when the economy already posted negative GDP growth (-1.4%) in the first quarter.

The complications confront contractors facing labor shortages and their own sets of higher costs. What that means? There may be an even longer delay before we begin to feel the real impacts of the IIHA due to these project delays and increased spending.

"Over the past two years, we have seen overall construction cost increases of 15% to 20% per year. This increase includes the cost of labor and materials. We have seen a particularly large spike in cost on petroleum-based projects such as asphalt and plastic pipe," said Tom Points, senior director of public works for the city of Nampa, ID.

And inflation is not helping. The U.S. Bureau of Labor Statistics

reported an inflation rate of 8.3% for April compared to a year ago. That includes a 43.6% rise in gasoline prices, a 13.2% increase in new cars and trucks, a 33.3% hike in air fares and an 80.5% jump in fuel oil prices. Inflation rates are at their highest levels since 1981, including record highs for gasoline nationally and in states such as Oregon, Maryland, Florida and Ohio.

As the next six months unfold, federal agencies across the administration will continue to shift into high gear with new programs taking shape and existing programs sending out significant funding increases to states. Let's hope the economy cooperates so we can all reap the benefits of this legislation.

Capitol Connection Q&A for Contractors

A smooth ride to reciprocity means keeping the cart behind the horse! I also answer an 'SOS' from another contractor with a paperwork 'jam', and share a 'graceful' ending...

Q: I need to associate my "A" (General Engineering) license with another company. After ten years with my current company, I will be acquiring another entity and moving my license to that company. I submitted my Disassociation Notice for the current Company today, knowing it will take the CSLB a few weeks to process it. I would like your assistance with obtaining the license under the new company, and at the same time obtaining a Nevada license with Reciprocity. Please let me know what I need to do.

A: As always, I'm happy to help. Give me a call so we can go over all that is needed/required. Regarding Nevada and Reciprocity, if you already filed a disassociation from the current company, you are not going to qualify for Reciprocity unfortunately. Nevada's reciprocal agreement requires that you be Actively licensed in one of the reciprocal States for the previous four years straight, with no gaps. Filing the Disassociation is going to create a gap. Again, happy to help though so please contact me to discuss further.

Q: We have a CA Corporate Contractor's License and we just recently converted to an LLC. I called the CSLB and was informed that because the registration number at the Secretary of State (SOS) is going to change, we are required to obtain a new license. However, the registration number actually didn't change. I checked with the SOS and they told me they recently updated their system so that now when a Company converts, they keep their registration number. Does that mean we can file a simple name change with the CSLB?

A: Unfortunately, no. Even though the registration number

stays the same, it is still a new entity and therefore requires that you apply for a new license. You can transfer the number though under certain circumstances. Feel free to contact my office so we can go over whether you would meet the transfer requirements.

Q: Is there a grace period to continue operating as a Corporation with a Contractor's License when the entity has converted to an LLC?

A: I wouldn't necessarily refer to it as a "grace period", but the license does not automatically cancel. The law requires the CSLB to cancel the license 60 days after the Contractors Board discovers your corporation is no longer valid with the Secretary of State. My recommendation is always to notify the CSLB as soon as possible when planning a merger, conversion, or change in entity type!

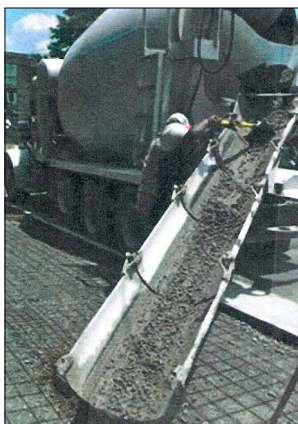

Developing an Emergency Action Plan

Workplace emergencies can happen on any jobsite and have the potential to cause severe injury to workers and extreme property damage. Emergency Action Plans (EAP), or Emergency Response Plans (ERP), provide site-specific procedures so workers understand what is expected and how to respond in the event of an emergency

The goal with any EAP / ERP is to:

- Prevent fatalities and injuries
- Reduce damage to buildings, stock, and equipment
- Protect the environment and community
- Accelerate the resumption of normal operations

OSHA Construction Standard 1926.35(a) specifies that EAP / ERP needs to be in writing and cover designated actions to ensure employee safety. In the event of an emergency, all personnel must know:

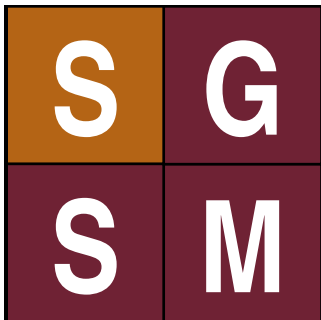
- Basic first aid and CPR
- How to report an emergency
- The procedure for emergency evacuation, including the type of evacuation, exit route assignments, and muster points
- What the alarm system looks or sounds like to alert

workers of emergencies – phone call, text message, air horn, siren, etc.

- How to account for all employees after evacuation
- Procedures for employees performing rescue or medical duties
- Contact for HSE department and other EAP / ERP information

Examples of potential workplace emergencies include:

- Fires and explosions
- Severe weather – rain / flood, tornado, hurricane, etc.
- Heavy equipment failures
- Confined space rescues
- Hazardous material incidents
- Cave-in rescues
- Fall arrest rescues
- Worker injuries
- Struck-by / caught-in incidents
- Medical emergencies
- Motor vehicle accident
- Chemical / hazardous material spill
- Active shooter

Site-specific EAP / ERP must be in place for every jobsite, should be easy-to-read, and posted in multiple locations across the jobsite so every worker can review it.

The basic EAP should include:

- Address and description of the site location
- Meeting and / or muster points for evacuation

- Emergency response numbers for 911, fire department, police, emergency responders
- Name and address of nearest medical facilities
- Map to nearest medical facilities
- Name and contact information of utility providers
- Access points for emergency personnel

The first instinct in any emergency is to call 911, but before any project starts and as the EAP / ERP is being developed, it is critical to verify 911 is in effect in the area and to understand the emergency resources and facilities available for the specific jobsite. Questions to consider include:

- What is the emergency response time for the job site?
- Is a high-angle rescue team available?
- Is a confined space rescue team available?
- How close is the nearest medical facility?
- What on-site emergency resources are available – first aid kits, AED, fire extinguishers, spill containment equipment, PPE?

To be effective, all workers need to be trained on the EAP / ERP and sufficiently understand their role during an emergency. Workers need to be trained on the EAP / ERP:

- Initially upon hire
- At the start of any project on a new site
- If the plan changes or if site conditions / location changes
- If designated persons' duties change

- Annually thereafter review:
- With any new subcontractors
- With suppliers for delivery and storage hazards
- Take time to review your project specific EAP / ERP

Planning ahead of time, creating a site specific EAP/ ERP, and communicating it to everyone involved on a project is critical to its successful execution in the event of an emergency situation.
