Five Good Things Happening in Construction Right Now

It might seem like there is no end in sight to the struggles we are facing in the construction industry, but there are still many things worth celebrating - and the future for the industry looks bright.

It's tough out there. The cost of doing business is increasing around every turn and construction business owners are grappling with labor shortages, extended timelines, supply chain disruptions and so much more. Still, there is work to be done and reasons to remain positive about the future of our industry. Here are five of them.

1. Increasing Industry Interest

Over the past few years, there has been a growing shortage of skilled trades workers. The Associated General Contractors of America found that 89% of contractors were having a difficult time finding workers who were trained for the job. That affects project timelines — 61% of contractors reported project delays because of these workforce shortages. The American Welding Society predicts a need for 400,000 more welders by 2024. In HVAC and electric, job openings are expected to grow by 14 percent through 2024. And the struggles continue on for every other industry segment needing workers.

While a shortage of workers is pushing wages higher in the skilled trades, the financial return from a bachelor's degree is softening, even as the price — and the average debt into which it plunges students — keeps going up. The astounding \$1.747 trillion dollars of student debt is growing six times faster than our nation's economy, and the average public school student borrows \$30,000 for a bachelor's degree.

In response, the proportion of high-schoolers who are considering a four-year education has plummeted from 71% to 48% since the start of coronavirus pandemic, according to a survey by the ECMC Group, a nonprofit student loan guaranty agency that also operates career schools.

What is increasing? Enrollment in trade schools.

Community college enrollment in agriculture-related programs increased 38% during the pandemic. Construction trade program enrollment is up 5% and transportation and material moving program enrollment was up 1%. With a growing number of people without a bachelor's degree starting to out-earn their four-year college peers, these numbers are only going to increase.

2. Long-Term Funding

The passage of the Infrastructure Investment & Jobs Act (IIJA) represents a historic investment in our nation's core infrastructure priorities— including roads and bridges, rail, transit, ports, airports, the electric grid, water systems, broadband and more. There will be \$550 billion in new spending over a five-year period, representing a huge opportunity for construction contractors to take advantage of new work.

The bill also contains the Surface Transportation Reauthorization Act which provides a five-year reauthorization of crucial programs (through FY26). This includes funding for competitive grants, formula grants, set-asides and more for federal surface transportation programs.

Sustainable funding should increase contractor confidence to bid for big projects as they are able to better plan out what the next five years look like.

3. Technology Adoption

Nestled in that \$1.2 trillion IIJA, among the hundreds of billions dedicated to road improvements, dam repairs, clean energy credits and more, is a relatively small sum of money — \$100 million — dedicated to construction technology.

The money will be disbursed over the course of five years, in \$20 million-per-year increments. Construction technology has been advancing at breakneck pace and some contractors have jumped on board and started to adopt new ways of getting their work done.

slow, outdated machinery that's constantly breaking down. Getting more work done doesn't mean anything if your crew is not safe. Older equipment has fewer fail-safe mechanisms, monitoring instruments and industry-specific upgrades, all of which can lead to malfunctions and jobsite accidents. Upgrading your equipment today allows you to keep your workers safe and prepare for the demands of even bigger projects tomorrow.

5. Infrastructure is Changing the World

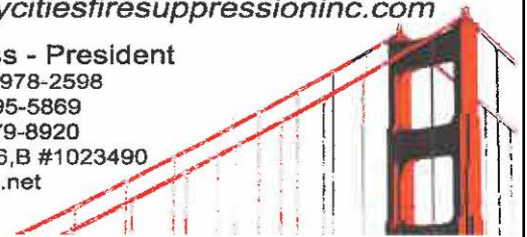

Capitol Connection Q&A for Contractors

In all the years assisting contractors no one has ever asked us to get it done slowly! I always offer a 'speedy' answer because time is still money. A second contractor question begins in the far north, while the last highlights a situation that could end in potential disaster without immediate action...

Q: I need to obtain a CA license fairly quickly for a job I'm being requested to do. Is that something that you can help me with? I see exams will be required. If I do not pass on the first attempt, what is the process from there?

A: We can definitely assist you with the entire process and do our best to speed up the normal processing time. We offer you study materials to prepare for the exams, so

you should be just fine with passing the first time around. BUT, if for some reason you do not, you are required to wait three weeks to re-test. The CSLB allows you to take the exams as many times as you need to within 18 months.

Q: We are a large Solar Company out of Canada and we have work coming up in California. We don't self-perform any work but understand we still need to be licensed which requires a "Qualified" individual. We are unsure about who to designate to fulfill this role. We have plenty of what we consider qualified members, but they aren't physically out in the field doing the work. One of our owners who is willing to sit for the exams did work out in the field for his Father but it was in the 90's. What are your thoughts on that individual acting as our Responsible Managing Officer (RMO)?

A: The CSLB will only accept experience gained within

the last ten years. The requirement is four years of fulltime work experience, with at least one of those years being hands-on “in the field” experience. If you don’t currently have anyone on board, you may need to hire an employee who has the requisite experience as your RMO.

Q: I’m an attorney representing a client who has a Sole Proprietorship Contractor’s License in California. He incorporated in 2021 and has been operating as such since incorporation. My question is does he need to apply and obtain a new Contractor’s license? Or, is it enough that he, as the sole Officer of the Corporation, is actively licensed with his own personal license?

A: Your client needs to apply for a new license if that’s how he is doing business now. Whenever there is a change in business entity, a new license is required and doing business under an entity without its own license faces all the legal risks of an unlicensed contractor, even if one (or

more) of the Officers is individually licensed.

A Letter on PLAs from Eric Christen, Executive Director of the Coalition for Fair Employment in Construction

On election day 2000 I found myself sitting in Santa Rosa's City Hall debating something that had nothing to do with the Presidential Election but everything to do with elections, elections at the local level. There had been a proposal to bring before the City Council a "Project Labor Agreement" or "PLA" that would cover the work on the planned hotel and convention center in downtown Santa Rosa. After hearing from dozens of speakers the City Council wisely decided that a PLA was not in the best interests of the city or broader community. We left a happy group and things settled down in the North Bay.

For a while.

Since that great victory, a victory that was achieved through hard work and involved contractors, the PLA menace in the North Bay has increased greatly. Since that November day so long ago we have had PLAs put into

place at the County of Sonoma, College of Marin and Santa Rosa Junior College. A PLA was approved at the Sonoma Valley Unified School District two years ago but removed by a new board of trustees who saw it as having been approved illegally (it was) and as not being in the best interests of the community (it's not). PLAs are now being considered at the Santa Rosa City Schools, City of Santa Rosa, City of Napa and Napa County while the County of Sonoma is looking to reduce the threshold the PLA kicks in from the current \$10 million to \$1 million. Why? Well County staff detests PLAs and is doing all they can to get projects out that fall under the \$10 million threshold, something they have been quite successful in doing as not one County project has had a PLA placed on it to date.

This is work, and potential work, that quality, tax paying contractors are unable to bid and work on because of the PLA. With the Bureau of Labor Statistics showing that more than 80% of the regional construction workforce is union-free that's a large number of bidders being left out of the game which means higher costs for taxpayers.

"But PLAs don't keep you from bidding!" PLA proponents tell us. This is true but only in a technical sense. What they won't mention is that in order to work under a PLA a union-free contractor must:

1. Be limited to only a few of their core employees. All the rest must come from a union hiring hall which means that this contractor is now expected to build something using people he has no relationship. It's like asking the Golden State Warriors to switch half their team just before tip off against the Boston Celtics and be expected to compete.
2. Those core workers must pay union dues. This not insignificant sum is taken out of their first paycheck. This worker has now paid for something they didn't want and been forced to join a group they didn't wish to join.
3. Those same core workers are forced to pay into union health, welfare and pension plans they will not vest in thereby guaranteeing that money is lost to them. This is wage theft.
4. State approved union-free apprentices are not allowed to work at all. So young men and women who are looking to start a new career and who have all the qualifications of their union peers are now explicitly excluded from being able to work on projects paid for with

their tax dollars.

These key provisions, found in every PLA, are meant to keep union-free contractors from bidding work. After all, what kind of contractor would force their workers to lose money on a job? This is the reality of PLAs.

At CFEC we have been fighting this discrimination for 23 years and we have been doing it effectively. We have witnessed more than 700 PLAs being attempted across California during this time and we have helped to keep more than half from being implemented. How? Simple: We use a non-linear strategy that seeks to employ tactics that depend on the situation. We will never have the resources unions have as they can reach into workers paychecks and take out dues without their permission while we must ask for each dollar we have contributed to us. Knowing this we have to make every dollar count and be as innovative and efficient as possible. In one fight it may be simply showing up and speaking out that kills the PLA. In another instance it may require us to engage in a full-on public relations effort that employs mailers, radio ads, social media ads, press conferences and any number of other tools. Flexibility is the key.

CFEC has always been appreciative of the support that it has received from the North Coast Builders Exchange and its members. Without it we would not have had the success we have had in the North Bay all these years.

In 2022 we are asking for your help again.

Moreover, the Occupational Health and Safety Administration expects you to conduct safety meetings on a regular basis.

To put it another way, if you're not engaging in safety meetings or running them effectively, you're putting your employees and your bottom line at risk.

Here's what you need to know about running safety meetings, from topics to discuss to the best format for meetings, to OSHA requirements for safety meetings, and how often you should hold them.

Why Are Safety Meetings Important?

Safety meetings serve multiple purposes for your company, your safety program, and your workforce.

1. **Safety meetings shape your overall environment, health, and safety program.** A well-functioning EHS program doesn't just come into existence on its own. It takes strategic planning and development—the creation of policies and controls, as well as the assignment of projects, roles, responsibilities, and follow-through. These conversations can happen during safety meetings.
2. **Safety meetings drive awareness of key safety topics.**

Safety Meetings: Everything You Need to Know to Run them Well

You can't rely on annual safety training alone to keep your people safe, healthy, and productive at work. You might run a safety meeting to address a timely concern, for instance, or prevent a negative trend (such as increasing workforce injury rates) from continuing further.

3. Safety meetings help you control your workplace safety budget and resources. Too many industrial safety programs flounder because organizations fail to allocate their limited resources effectively or keep things optimized. The program is frequently a patchwork of disparate, disorganized processes and outdated systems. Maybe there are siloes or bottlenecks that impede program function or adoption. A safety meeting is the perfect venue to uncover and address problems like these.

4. Safety meetings ensure everyone has a voice in your safety program. The best way to get every member of your organization on board with safety is to ask them for their input. Safety meetings give you the opportunity to hear directly from your workforce about their issues, challenges, and ideas.

Examples of Safety Meeting Conversations

To get a little more specific, here are a few tangible

examples of the kinds of discussions that take place at safety meetings:

- “We had 11 falls last quarter. Let’s take a close look at our fall protection procedures and make sure everyone is doing their job safely.”
- “With wildfire season right around the corner, it’s time to have a discussion about wildfire safety and smoke exposure. We’re going to watch a short video, go over what you need to know, break into groups for an activity, and then open the floor for questions.
- “As many of you know, we’re looking to recruit more forklift drivers. I wanted to use this opportunity to make sure our forklift training is top of mind, introduce you to some new procedures, and answer any questions you might have.”

Safety Meetings: Everything You Need to Know to Run them Well

Safety Meetings: What, When, and How Many

How often should you conduct safety meetings? The answer comes down to the needs and realities of your workforce.

Some companies conduct safety meetings once every three months; others conduct them every month or even multiple times per month. If you're seeing increased accident rates and your safety program isn't performing well, you likely need to increase the frequency of your safety meetings.

But keep in mind that too many meetings can disrupt your operations and cause workers to tune out. Safety meetings likely can't turn things around by themselves. It's important to optimize other pieces of your safety program, such as training and reporting, in tandem.

In general, the content, duration, and frequency of safety meetings are largely up to you. While OSHA strongly encourages you to hold safety meetings, the federal agency doesn't have specific requirements for most employers about the format of those meetings.

That said, many state OSHA programs do have specific rules in place. And regardless of where you operate, an inspector would likely consider a lack of safety meetings a red flag.

Common Safety Meeting Topics

As for what the safety meetings should cover, it depends on the issues and risk your workers face. In any case, it's a good idea to start with the most frequently violated OSHA standards: Hello, OSHA Top 10:

- Fall Protection
- Hazard Communication

- Scaffolding
- Lockout/Tagout
- Respiratory Protection
- Ladder Safety
- Forklifts
- Machine Guarding
- PPE - Eye and Face Protection

Best Practices for Running Safety Meetings

Focus on one issue at a time. The most effective safety meetings are the most simple and direct.

Not too long, not too short. An ideal length of time for a safety meeting is 20–45 minutes. Any longer than that and you'll start to lose the audience's attention. Any shorter and you may not be able to discuss the issue in sufficient depth.

Involve your employees. Your workers aren't just the audience for your safety meetings—they should also take part in making the meetings happen. Ask employees for topic suggestions. Collect questions before the meeting. Have a member of your team give a demonstration, tell a story, or lead a discussion.

Make it interesting. Safety meetings can and should be fun. Try out a variety of media and approaches. Humor goes a long way as well, but be sure it's appropriate to the topic.


Document everything. Make sure to record the relevant details of every safety meeting: when it happened, what it was about, who led it, which employees attended, and what activities attendees engaged in. This will help you track the results so you can improve future safety meetings and other elements of your safety program, such as training. It also gives you material to present to an OSHA inspector or other regulatory authority interested in your safety program.
