Supreme Court limits California labor law that allows private suits against employers

In a victory for California employers, the Supreme Court on Wednesday placed limits on a state labor law that authorizes private lawsuits on behalf of groups of workers, even if they had agreed to resolve their disputes through individual arbitration.

The majority ruled the Federal Arbitration Act preempts or overrides the state law.

California is the only state to authorize such private suits as a means of enforcing its labor laws, the justices said. But by doing so, the state allows employees to escape the binding arbitration agreements they signed when they were hired, the court said.

The outcome appears to limit private suits but not block them entirely.

The conservative high court has repeatedly overruled judges in California who refused to uphold arbitration clauses.

Over nearly two decades, the justices have steadily closed the door to courts and lawsuits and instead upheld private arbitration as the means to resolve costly disputes, whether involving banks, credit cards, retail purchases or the workplace.

In 2004, the California Legislature adopted a different approach to protect the rights of workers. The Private Attorneys General Act said lawyers may file claims against an employer seeking penalties on behalf of a group of employees and for multiple violations of the labor code. Three-fourths of the money recovered is paid to the state.

Lawmakers said the state's labor laws were going unenforced, even when workers were cheated out of their wages or not paid extra for overtime work. They said

Supreme Court limits California labor law that allows private suits against employers

In defense of the law, the state's attorneys and state judges argued the lawsuits spoke for the state, not the employees who were cited as plaintiffs.

The ruling should not affect unions that often arbitrate disputes on behalf of groups of workers. In that instance, both the employer and employees have chosen arbitration.

The case before the court was Viking River Cruises vs. Moriana. It arose when Angie Moriana quit her job in 2017 as a sales agent in Los Angeles for Viking River Cruises and alleged she did not receive her last paycheck on time. She then became the lead plaintiff in a private suit alleging multiple violations on behalf of a large group of Viking employees.

Viking objected and said she and the other employees had agreed to arbitrate "any dispute arising out of or relating to your employment." Moreover they had waived any right to any "class, collective or private attorney general action."

But a Los Angeles County Superior Court judge and the state appeals court refused to block the lawsuit. They said that under California law, the "state is the real party" bringing the suit over violations of the labor code.

Viking appealed to the Supreme Court, arguing that California and its state courts refused to honor binding arbitration agreements.

Regulatory Update: OSHA Pushes COVID Standard and Other Rulemakings

Agency is working towards preventing future infectious disease outbreaks and pandemics.

Douglas L. Parker, assistant secretary in charge of the U.S. Department of Labor's Occupational Safety and Health Administration (OSHA), recently sought to minimize the damage done by the Supreme Court's decision blocking the agency's attempt to fulfill President Biden's order requiring all employers in the United States have their employees vaccinated against COVID-19.

"COVID-19 has been the occupational health issue of our time," he noted in recent testimony before the House of Representatives Committee on Education and Labor's Workforce Protections Subcommittee. He added that his agency is "working to finalize a permanent COVID-19 standard to ensure healthcare workers are protected as long as COVID-19 is a threat."

Sworn in as the new head of OSHA last November, Parker previously served as the chief of the California Division of Occupational Safety and Health (Cal/OSHA) and as deputy

assistant secretary for policy for Mine Safety and Health Administration (MSHA) during the Obama administration.

At the hearing, he described the development of an infectious disease standard to apply to high-risk workplaces as a top priority for the agency. Had one been in place prior to the pandemic, he argued, "OSHA would have been in a better position to address COVID."

However, he did not provide a target date for when the new standard would be issued. Unlike the Emergency Temporary Standard (ETS) on COVID that was met with such fierce opposition and was struck down by the Supreme Court, this time the agency will follow all of the notice and public comment procedures normally required for the development of a federal regulation.

This delay does not mean OSHA is waiting for the new rule to take action on COVID, he pointed out to the legislators.

Regulatory Update: OSHA Pushes COVID Standard and Other Rulemakings

Since early 2021, agency staff have conducted 1,826 COVID-19 related inspections in healthcare facilities, with an additional 701 inspections conducted by state plans. The agency also has responded to complaints filed by workers in other industries.

In addition, Parker observed that in March OSHA launched a COVID-19 enforcement initiative to focus on evaluating and ensuring the readiness of hospitals and skilled nursing care facilities to protect workers in the event of surges in COVID-19 patients.

"While COVID-19 remains a priority, we are also looking ahead to ensure workers in the highest risk workplaces are protected against future infectious disease outbreaks and pandemics," Parker said. "Those efforts include developing an infectious disease standard to ensure healthcare workers are protected in future pandemics and developing infectious disease preparedness training so all workplaces can be more prepared."

Attorneys for the Seyfarth Shaw law firm commented that "employers may be happy to hear that OSHA is not planning to propose a permanent COVID-19 vaccinate-or-test regulation similar to the ETS stayed by the U.S. Supreme Court on Jan. 13, 2022."

Parker also took his testimony as an opportunity to inform the representatives about some of OSHA's other top priorities for the near future. These include a new indoor and outdoor heat standard, addressing workplace violence in healthcare, and bolstering recordkeeping regulations.

He also thanked the members of the Education and Labor Committee for providing more than \$100 million in supplemental funding through the American Rescue Plan legislation that he said will help support and strengthen OSHA's enforcement and regulatory efforts, which he said lacked needed resources during the Trump administration.

Parker informed the committee that his agency also is working to expand and diversify its staff through recruitment and workforce development and is preparing to pilot an apprenticeship program to develop safety technicians into future inspectors. He also said OSHA has launched new intensive leadership training to ensure that it has a pipeline of future senior managers "equipped to make OSHA a more resilient, innovative and effective agency."

Here's how OSHA is protecting workers from heat this summer

As temperatures rise this summer, employers across the nation are on notice: For the first time ever, federal inspectors could stop by unannounced to ensure workers are safe from heat exposure.

That's thanks to the Occupational Safety and Health Administration's "National Emphasis Program" for heat. Under the program, OSHA inspectors will target workplaces in more than 70 industries at "high risk" for heat exposure — such as agriculture, warehouses and construction — whenever the National Weather Service announces heat warnings or advisories for the area where the business is located.

Such emphasis programs are an important enforcement tool for OSHA because they allow inspectors who are otherwise limited to only visiting workplaces after they have received complaints or after workers are killed or injured to visit workplaces and inspect for hazards before anyone gets hurt.

"We want to be proactively addressing heat hazards," OSHA Deputy Assistant Secretary Jim Frederick said in an interview. "Without an emphasis program, we can see a hazard and address it if we are already in a workplace, but this gives us the ability to proactively go to these workplaces and see what heat protections they have in place."

The program also means that when inspectors visit job sites for complaints about other hazards, they will also be directed to assess whether workers there are being protected and safe from high heat, as well.


While everyone is at risk from heat illnesses when temperatures rise, laborers are particularly vulnerable because the exertional nature of their work makes it more difficult for their bodies to cool down.

That means having a national emphasis program for heat could save lives, said Jordan Barab, who was OSHA's deputy assistant secretary of Labor for occupational safety and health during the Obama administration.

"It shows we are watching, we are looking, and we may be visiting a workplace near you, so do what you can before OSHA gets there to protect your workers from high heat exposure," he said.

The emphasis program is part of the Biden administration's broader efforts to address the effects of climate change using a "whole of government" approach. The administration announced its intention to create an emphasis program last September, and Vice President Kamala Harris headlined an April event

officially kicking off the program at the Sheet Metal Workers Local 19 union in Philadelphia.

"Let's be clear: Heat is a workplace safety issue," she said to applause. "And employers are responsible for protecting their workers in the workplace from the dangers of heat, including in farm fields, in delivery vans, and in nursing homes — everywhere that has workers."

The emphasis program won't start out as an enforcement tool right away. Rather, for the first few months, OSHA compliance officers will merely consult with employers, visiting work sites and explaining what needs to be done to make it safe. Formal inspections that could result in citations for violations will begin later.

Labor advocates agree that the program is a step up for OSHA.

Juley Fulcher, a worker health and safety advocate at Public Citizen, said the program could be "a very good thing," especially because OSHA often does not investigate all heat-related complaints it receives, often only visiting worksites where workers have died or become seriously ill.

But she also suggested that there is a limit to how big of an impact the emphasis program can have without specific standards telling employers exactly what they need to do to protect workers from heat.

Indeed, OSHA has no heat regulations. Though the agency is currently working on writing such a standard, an actual proposed

rule is years away. In the meantime, OSHA must rely on its "general duty clause," which broadly requires employers to ensure workplaces are safe from "recognized hazards."

Both Strater and Fulcher lamented that it could be years before OSHA finalizes a heat regulation, noting that the agency, on average, takes more than seven years to finalize new rules. They think OSHA could be moving faster given that a number of states have recently written their own rules to protect workers from heat and that, over multiple decades, the CDC has made three recommendations to OSHA that it create a regulation.

Not everyone is eager for OSHA to establish new rules quickly. U.S. Chamber of Commerce Vice President for Workplace Policy Marc Freedman said he is not sure OSHA should issue any standard at all.

"We can all agree that heat is a hazard, but trying to say, 'This is the point at which you are in trouble or where employers have to take action,' is difficult to nail down," he said.

Frederick said the agency is working as fast as it can on the rulemaking, but that progress is hampered by budget constraints. He also said the agency is trying to write a rule that would withstand potential lawsuits, given how often OSHA rules end up in court.

"We can't just issue a rule and hope nobody has any concerns about it," he said. "We need to make sure it can match and exceed anyone's challenges."

Capitol Connection Q&A for Contractors

You must keep your 'eyes on' the work, but where you go home isn't an issue. A corporate contractor learns you really can't 'go back to the future' and the expert answer on the sometimes surprising 'gray' areas in contractor regulations...

Q: Does our Qualifying Party need to reside in California? I'm just wondering how strict the state law is about the Responsible Managing Employee (RME)/Responsible Managing Officer (RMO) being on-site. I'm assuming he will need to initially come to CA in-order-to obtain the license, correct?

A: No, your qualifying party does not need to reside in California. The RME/RMO needs to be actively involved in overseeing the work being performed, but the CSLB does

not have particular guidelines for what exactly that entails.

Your RMO/RME will need to come to California to take the exams, and now that the exams are being administered by PSI, your Qualifier will be able to schedule their own exam, choose a location, etc. The only negative aspect to the change to PSI that we've noticed so far is now the Trade exam and the Law exam must be taken on separate days. You can no longer do them on the same day, one right after the other.

Q: We have a corporate contractor's license in CA but we haven't done any business there for quite some time. I don't want to let the license go completely, in-case we start working there again in the future, but I would like to avoid paying State taxes while we aren't doing any business there. The CA Secretary of State told me I would need to cancel the Corporation in order to not be charged corporate taxes. Can I dissolve the Corporation and then keep the contractor's license on an Inactive status to be able to activate it in the future?

A: Once you cancel or dissolve your corporation at the

Secretary of State level, your contractor's license will be cancelled eventually as well because the corporation no longer exists. You would be required to re-apply for a new license in the future when you are ready to start working here again.

Q: I am going to be applying for a new Contractor's License for my Corporation. I have a "B" (General Building) license. I am contemplating bringing on a Business Partner who holds a "C-10" (Electrical) and an "A" (General Engineering) license for his own corporation which he still needs to maintain. With regards to the 20% ownership requirement for him to be able to maintain both licenses, what form of "proof" does the CSLB require? Is there a code section which describes exactly what the 20% ownership means? For example, 20% of the Company's profits, or 20% of the Qualifying Party's electrical/engineering work, etc.?

A: The "proof" required by the CSLB is strictly a question

on the license which asks what percentage of the business the Qualifier owns. In order to hold more than one Active license at the same time, the Qualifying party must fill in an amount of at least twenty percent. That is then signed under penalty of perjury. There is no code section which addresses exactly how the CSLB interprets "20% ownership of the business".

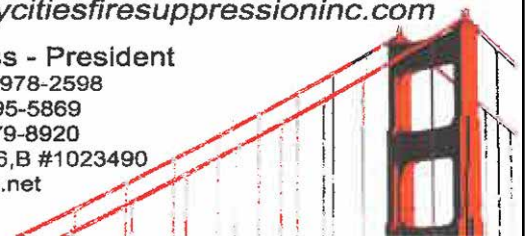
