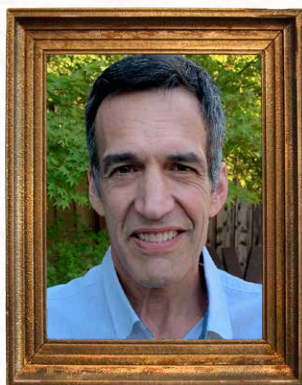

## Contractors Face 142 Legal Actions After Series of Statewide Stings and Sweeps

**Contractors State License Board enforcement operation part of national effort to warn consumers about dangers of hiring unlicensed or uninsured contractors**

A series of statewide stings and sweeps conducted by the Contractors State License Board (CSLB) identified unlicensed activity in the California construction industry, putting consumers at risk. During the undercover sting and sweep operations 142 legal actions were taken, primarily for unlicensed and uninsured practice.

One of the many ways unlicensed contractors can hurt homeowners is because they have not met minimum competency requirements, do not have a license bond, or carry workers' compensation insurance, putting consumers at risk.

"Unlicensed individuals can be dangerous for consumers," said David Fogt, CSLB Registrar. "Unlicensed contractors have not met licensing requirements, undergone background checks and don't carry the proper insurance," Fogt said.

From June 6 to 24, 2022, CSLB partnered with local law enforcement to conduct three undercover sting operations in South Lake Tahoe, El Dorado County; Salinas, Monterey County; and in Redding, Shasta County. Undercover stings target unlicensed contractors, with investigators contacting the suspects through their advertisements.

The suspected unlicensed operators came to the sting locations to place bids on projects including ceramic and mosaic tile, concrete, deck work, fencing, flooring, landscaping, painting, plumbing, tree services, and sheet metal. As a result, a total of 40 legal actions were filed and 32 people are subject to misdemeanor criminal charges for contracting without a license. Unlicensed contractors can face penalties of up to six months in jail and/or a fine of up to \$15,000 if they bid or contract for work valued at more than \$500.

Fifty-three sweep operations of construction sites were also conducted in Contra Costa, El Dorado, Fresno, Kern, Los Angeles, Marin, Monterey, Napa, Orange, Placer, Sacramento, San Benito, San Bernardino, San Luis Obispo, San Mateo, Santa Barbara, Santa Clara, Santa Cruz, and Ventura counties that resulted in 102 legal actions against licensed and unlicensed contractors. Twenty-six of the legal actions were for unlicensed contracting and 38 Stop Orders were issued which halted all employee labor at active job sites where contractors did not have workers' compensation insurance for their employees.

The enforcement actions were part of a nationwide effort coordinated by the National Association of State Contractors Licensing Agencies designed to make consumers aware of the importance of hiring licensed contractors and the risks of using unlicensed operators.

"Nationwide enforcement operations are key to educating consumers about the risks of not checking a contractor's license," Fogt said. "It takes only seconds to find a contractor's license information on the CSLB's website to confirm they are licensed."

During the stings and sweeps, six individuals were also cited for requesting an excessive down payment. In California, a home improvement project down payment can't exceed 10-percent of the contract total or \$1,000, whichever is less, and subsequent payments may not exceed the value of working being paid for. This misdemeanor charge carries a maximum penalty of six months in jail and/or a fine of up to \$5,000.

During operations, unlicensed individuals were given information on getting licensed and were invited to attend one of CSLB's Licensed to Build workshops. CSLB also created a new B-2 licensing classification for home remodeling with the goal of promoting the growth of small businesses and increasing consumer protection.

For their protection, CSLB recommends that consumers get at least three bids and check references before hiring someone for a construction job. Consumers can quickly check if a contractor is licensed on CSLB's online Instant License Check.

From the License Check, consumers can also view the contractor's individual license page, which indicates if the contractor is carrying workers' compensation insurance for employees. Contractors without workers' compensation insurance should not have workers on the jobsite. Consumers can find a list of licensed contractors in their area by using CSLB's Find My Licensed Contractor.

# Shop Class Resurgence: Can It Help Resolve the Skilled Labor Shortage?

**Vocational programs play an integral role in workforce development, especially as more high school students consider careers in the skilled trades**

Targeted by budget cuts and a shift toward core academic courses, the age-old shop class began to disappear from many junior high and high schools in the 1990s. By the next decade, shop classes that taught the basics of carpentry, electrical and welding, among other skills, had disappeared in many states to enable educators to teach to standardized testing requirements that prepared students for success in college and the white-collar careers that followed.

These testing standards, along with college acceptance rates, have become a dominant method of assessing school performance. The top-ranked schools across the country have a large number of students who score above

expectations in math and reading assessments, pass an array of college-level exams and graduate in four years. Some are even ranked on the number of students they send to the top-rated colleges.

What schools are not ranked on is how many students gain the skills necessary to make basic home repairs, or how many were exposed to the trades that are crucial to keep our communities humming; skills like masonry, carpentry, plumbing and electrical work. And they are not judged by how many students go off to college but never graduate, or don't acquire the skills they need for a successful career.

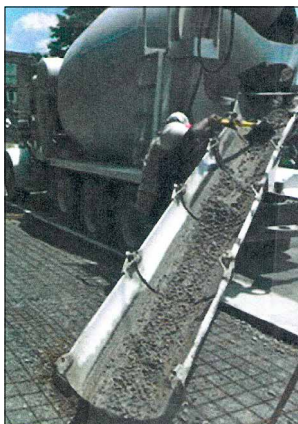
As schools eliminated vocational programs over recent decades, America's potential plumbers, electricians, carpenters and roofers were left without any early exposure to the trades and occupations in the construction industry. Teachers and counselors instead steered students into business and computer programming classes with the promise of a rewarding white-collar career, without consideration of potential student loan debt taken on by pursuing higher education.

But a shift has happened in recent years. Counselors, teachers and — what Weissman and others say is the key factor, parents — began to realize that college is not the best option for every student. The increasing cost and debt associated with college, and the high number of people who accumulate significant debt but never receive a degree, are leading to growing doubt about the value of the four-year college track. As a result, many are taking a new look at careers in the skilled trades.

The housing market remains underbuilt and requires additional labor as the sector continues to expand. In fact, economists at the National Association of Home Builders (NAHB) note 2.2 million new workers are needed in

residential construction over the next three years to keep up with the booming demand for homes. The labor shortage is also a serious threat to housing affordability as businesses scrambling to find workers are forced to add time and costs to projects.

Many of the schools that tend to value skilled trades training are in more rural areas of the country. It's also an area seeing a higher percentage of home building, according to NAHB, as the ability to telework becomes more prominent in the wake of COVID-19 and builders and developers are looking further afield to find more buildable lots.

Educators agreed that the push for every student to obtain a four-year college degree is not the right path, especially with many graduating in debt and still no idea what they want to do for a living.

"My job isn't to push a student in a specific direction. It's to teach skills and provide new experiences so they may make the decision to move toward a career they desire," Kregel said.

"I believe had I been pushed to follow the dreams of someone else, I wouldn't be as involved and passionate about my career as I am," she said.

While some students may graduate high school and immediately begin working in the skilled trades, others in these updated shop classes are taking advantage of agreements with area colleges and universities to continue their studies using the hands-on training — and even some early college credit — obtained in their classes. Some are even building homes.

# Five key employment law deadlines and developments for California employers for July 2022

The last two weeks have been busy on the California employment law front, and California employers must remain vigilant about new employment law developments still going forward this summer. As we enter the second half of 2022, here are five issues California employers need to pay attention to:

## 1. IRS mileage rate increases July 1, 2022 to 62.5 cents per mile.

On June 9, 2022, the IRS announced that it will be raising the mileage rate effective July 1, 2022. The IRS mileage rate will increase from 58.5 cents per mile to 62.5 cents per mile from July 1, 2022 to December 31, 2022.

As gas prices continue to rise to historic highs, employers with employees driving for work purposes, need to ensure their mileage reimbursement policies are current.

## 2. Deadline for small employers to register for CalSavers is June 30, 2022.

California employers are required to register for the CalSavers retirement savings program. Employers 5 or more employees must register for the program by June 30, 2022. Employers with over 100 employees were required to register by September 30, 2020, employers with more than 50 employees were required to register by June 30, 2021. The state has begun to issue citations, which

start at \$250 per employee, and can increase to \$500 per employee.

### 3. Many local minimum wage increases effective July 1, 2022.

As we have previously written about here, many local cities and counties throughout California are raising their minimum wages on July 1, 2022. Employers need to review their jurisdictions to ensure compliance with the applicable minimum wage.

In addition, the City of West Hollywood is also increasing the amount of paid leave required to be paid to employees. The City's website explains, "Beginning July 1, 2022, full time employees for all businesses are to be provided at least 96 compensated hours and 80 uncompensated hours per year for sick leave, vacation, or personal necessity. Part-time employees are to be provided compensated and uncompensated hours in increments proportional to that accrued by someone who works 40 hours in a week." More information about West Hollywood's minimum wage and paid leave is provided on the City's website here.

### 4. Responsible Beverage Service (RBS) training required for alcohol servers starting July 1, 2022.

The RBS "training teaches servers to responsibly serve alcoholic beverages for on-premises consumption and mitigate alcohol-related harm in California communities". The Alcoholic Beverage Control requires that beginning July 1, 2022, any ABC licensee who has an "ABC On-Premises License" will be required to ensure specific staff (alcohol servers and managers of alcohol servers) have

received training from an ABC approved RBS Training Provider within 60 days of employment. This includes staff employed prior to July 1, 2022. More information can be found at the ABC's website here.

### 5. Bill proposed to create council to regulate California "fast food restaurants" continues in California Legislature.

AB 257, termed the Fast Food Accountability and Standards Recovery Act or FAST Recovery Act, proposes to establish a Fast Food Sector Council within the Department of Industrial Relations is making it way through the California Legislature. If passed, the bill would create a council composed of 11 members appointed by the Governor. The council would define which fast food restaurants it would regulate, and would set standards for minimum wages, working hours, "and other working conditions related to the health, safety, and welfare of" fast food establishments. In addition, the bill also creates joint liability for franchisors and provides a private right of action for employees to sue for discrimination or retaliation.

Moreover, as drafted, the bill defines "fast food chain" as "a set of restaurants consisting of 30 or more establishments nationally that share a common brand, or that are characterized by standardized options for decor, marketing, packaging, products, and services." The bill would add another layer of complexity for these restaurants in addition to the existing Labor Code and is a proposed law restaurant operators of all types should closely monitor this summer.

## Governor Rolls Back California COVID-19 Executive Orders & Cal/OSHA Releases Draft Permanent COVID-19 Standard

On June 17, 2022, Governor Newsom issued an executive order terminating certain provisions of prior executive orders related to Cal/OSHA's COVID-19 Emergency Temporary Standards (ETS). Some of the terminated orders were no longer necessary due to changes in the ETS. For example, previously the Governor had issued an executive order stating exclusion periods could not be longer than California Department of Public Health (CDPH) guidelines or local ordinances. However, since the ETS now defers to CDPH guidance on isolation and quarantine, the Governor has rescinded his prior executive order on this issue. Moreover, Cal/OSHA has issued guidance for employers on COVID-19 Isolation and Quarantine that aligns with CDPH requirements.

The current version of the ETS remains in effect until the end of 2022. However, Cal/OSHA won't be done with COVID-19 regulations in 2023. The agency is currently working on a permanent COVID-19 Standard. Recently, the draft of the proposed regulation was released.

The draft regulation carries over many of the employer obligations from the current ETS. The following are some of the proposed requirements:

- COVID-19 procedures, either included in their Injury and Illness Prevention Program (IIPP) or a separate document.
- Exclusion and prevention requirements for positive employees and close contacts.
- Employers would continue to be required to provide testing to employees who have a close contact in the workplace.
- Employers would continue to have notice requirements for COVID-19 exposure.

- Employers would continue to have to provide face coverings to employees.
- Employers would continue to have reporting and recordkeeping requirements for COVID-19 cases and outbreaks in the workplace.

Currently, no public hearing has been set for the proposed permanent COVID-19 Standard, so it is uncertain how soon the regulations may be implemented.

# **Rising labor costs eat away at construction firms' profits**

*By Joe Bousquin, Construction Dive*

The clamor over construction's labor crisis reached a fever pitch this week, with new evidence suggesting historic wage increases for low-skilled site workers are eating into contractors' profits.

Average hourly earnings for production and nonsupervisory employees in construction rose to \$32.19 in May, according to the Bureau of Labor Statistics, a 6.3% increase from a year ago and the highest gain in 40 years.

But increasingly, those higher wages are coming on the bottom rung of the construction employment ladder, with unskilled laborers seeing the greatest wage gains, economists told Construction Dive. That means construction companies pay more for hard-to-find workers, without necessarily reaping the benefits of increased productivity, or profits.

Construction's shrinking premium

The average construction wage of \$32.19 in May was 17.8% higher than the average hourly earnings of \$27.33 in the

private sector as a whole, where wages rose 6.4% year over year, illustrating the premium construction companies pay their workers compared to other fields.

The industry has emphasized that higher pay rate to recruit more workers into what they often perceive as a more dangerous job, without the perks of remote work, climate-controlled offices or more flexible hours.

As other industries have ramp up their pay rates in the face of worker shortages and skyrocketing inflation, construction is losing its lead in the wage race, according to Ken Simonson, chief economist for the Associated General Contractors of America.

"Construction still has a considerable premium, as I call it, in what it pays the average worker, compared to other industries," Simonson said. "But that premium has shrunk."

For example, before the onset of the COVID-19 pandemic in February 2020, construction wages were 20% to 23% higher than the private sector as a whole, Simonson said, compared to today's roughly 18% rate.

"So the average hourly wage in the rest of the private sector has come up, and that is squeezing what contractors are offering as a premium to go out and work in 100 degree heat," Simonson said.

More workers, lower profits

At the same time, construction employers get fewer skilled workers for the higher wages they pay, said Anirban Basu, chief economist for the Associated Builders and Contractors.

"The 'unskilled laborer' is among the fastest growing occupational categories within construction," said Basu. That means companies are getting less value for their labor dollars. "Contractors are still hiring aggressively, but they're often just throwing bodies at jobs, without those bodies being more productive."

As a result, even as contractors anticipate hiring more workers in the months ahead, they don't anticipate profits

going up, as they normally would while adding more employees to take on more jobs.

That's the latest reading in ABC's Construction Confidence Index report, which tracks contractors' expectations for sales, profit margins and staffing over the next six months, with any score of 50 or above indicating growth.

While May's CCI came in with a score of 62.8 for staffing outlooks, meaning contractors expected to add more jobs, profit margin forecasts were at just 50, or barely clinging to growth expectations.

"While you see many contractors still staffing up, the expectations regarding profit margins are flipping," Basu said. "They're becoming more pessimistic."

Just half the workers needed

On the labor front, contractors hired 455,000 people in April. But that was less than the 494,000 jobs that were still open, a jump of 40% from a year ago, according to Simonson.

"We're in maybe the tightest market ever in the number of job openings for construction," Simonson said.

"The implication is that construction firms, including homebuilders, would have brought on twice as many workers as they did, if they could have found enough qualified workers."

Indeed, a recent article in the Wall Street Journal pointed to labor shortages stymieing construction activity and company profits even as work from the \$1.2 trillion Infrastructure Investment and Jobs Act kicks in.

Jim Schneiderman, mid-Atlantic vice president for Broomfield, Colorado-based Flatiron Construction, told the paper that higher employee costs were starting to eat into the firm's profits.

"We learned our lesson and will be building in those higher labor costs accordingly for future work," he said. "Everyone I talk to in the industry has had this same realization."
