## So how bad is the COVID-19 pandemic in California?

Late last week, the California Department of Public Health (CDPH) released the most recent statistics on COVID-19 and updates on the state's pandemic response. Here is the latest data as of July 30<sup>th</sup>:

- California has 3,840,364 confirmed cases to date. Numbers may not represent true day-over-day change as reporting of test results can be delayed,
- There were 10,356 newly-reported cases in one day on Thursday, July 29<sup>th</sup>
- Cases are increasing statewide, largely among un-vaccinated people. The average case rate among un-vaccinated Californians is 20.7 per 100,000 per day and the average case rate among vaccinated Californians is 3.5 per 100,000 per day.
- There have been 73,566,888 tests conducted in California.
- There have been 63,935 COVID-19 deaths since the start of the pandemic.

There are reports that have estimated that more than 974,000 adults have asthma that was caused or aggravated by substances they use or are exposed to at work, a number that represents about 40% of all asthma sufferers in California.

## AIHA Issues latest science-based COVID-19 back to work safely guidelines

***“Employers are increasingly concerned about how to keep their employees safe and how to address potential liability issues as they return to work,”*** said Lawrence D. Sloan, AIHA’s CEO.

The American Industrial Hygiene Association (AIHA) has announced its revisions to its complete library of its Back to Work Safely (BTWS) guidelines. The new edition includes multiple updates, including reference to: current scientific evidence indicating that SARS-CoV-2, the virus that causes COVID-19, is spread primarily by fine particle airborne transmission; the hierarchy of health and safety controls; and alignment with the CDC’s new recommendations regarding vaccinated individuals.

*“There’s been a seismic shift in the level of understanding of how the virus propagates since the first cases of COVID-19 were identified, not to mention the massive (ongoing) deployment of vaccines worldwide. Employers are increasingly concerned about how to keep their employees safe and how to address potential liability issues as they return to work,”* said Lawrence D. Sloan, AIHA’s CEO. *“We have continued to update the AIHA Back to Work Safely guidance documents to*

*address the latest science as employers re-open their workplaces and navigate evolving employee work arrangements.”*

AIHA’s Back to Work Safely Guidelines, 2nd Edition, is now available for small to mid-size businesses in 27 sectors. The free guidance documents, available only in English now (and in Spanish this fall), provide clear and actionable steps towards the safe operations of a variety of workplaces through prevention, early detection, and control of COVID-19. The new edition offers practical guidance for employers to implement multiple layers of risk mitigation strategies in order of most effective to least effective – through the elimination of a hazard, substitution of a hazard, use of engineering controls (e.g., increased ventilation and air filtration), administrative controls (e.g., staggered shifts), and personal protective equipment (e.g., respirators and gloves).

*“We also included an expanded discussion of how COVID-19 is primarily transmitted, and how important it is for employers to perform a job hazard analysis prior to re-opening and periodically after re-opening (as needed), so that the implemented measures continue being health protective,”* said Melanie D. Nembhard MSPH, CIH, lead contributor to the BTWS 2nd edition guidance documents. *“We urge employers to implement a multi-layered risk management approach so that if one layer is weakened or fails (e.g., masks or physical distancing), the other protective measures such as ventilation or disinfection are there and can be strengthened to provide adequate protection for workers.”*

As some restrictions have lifted and continue to be lifted, many uncertainties still remain. The latest guidelines address difficult questions that employers face as they re-open, resume normal operations, or continue normal operations, such as:

**What communication is needed to keep everyone informed of the preventive steps being taken?**

**What steps can we take to minimize the risk of disease transmission?**

**What training is needed for our employees?**

**What health and safety measures do we need to take regarding new virus variants?**

**What do we do if an employee or customer has tested positive for, or is suspected to have, COVID-19?**

**What do we do if an employee or customer is sick or not following guidelines?**

**How do we handle crowd management (high traffic) throughout the workplace, including during peak times?**

**How do we deal with cleaning and disinfecting high-contact surfaces such as check-in desks, computer keyboards and door handles regularly during the day?**

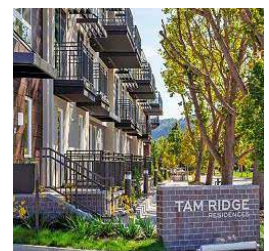

## 5 Strategies for today's (and tomorrow's) labor shortage

The US Department of Labor reports a record 9.3 million job openings. Heres what construction can learn from what's happening today

Help wanted signs are popping up everywhere, many offering \$1,000 or more in signing bonuses. Restaurants and stores are limiting hours and posting signs about long wait times. Earlier this spring, the U.S. Labor Department reported 9.3 million job openings, an all-time record.

The worker shortage is affecting the service industry more than most other sectors right now, but construction companies are no strangers to the challenges presented by a tight job market. What can we learn from what's happening today? Here are five suggestions for dealing with a labor shortage.

**Expand your criteria.** Your ideal operator may be a seasoned pro with 15 years of experience across a variety of machine types, but is that really realistic right now?

Be open to candidates with less experience who show a willingness to learn on the job. (Here are five skills to consider that aren't time behind the controls.) The investment you make in training them now could pay off later.

**Look in-house.** Before you post a job externally, consider your own internal candidate pool. Have any of your employees expressed interest in learning a new skill? Do some workers exhibit potential in areas beyond their current responsibilities? It may be easier to promote from within for a more skilled job, then advertise externally for an entry-level position.

**Get flexible.** Take a lesson from the service industry and consider perks or benefits you haven't offered before. Would a signing bonus set you apart in crowded job market? You can always make it contingent on a specific length of time worked. What about a more flexible work schedule — say four shifts of 10 hours versus five shifts of eight — or additional vacation time? A work-from-home option, even if it's just one or two days a week, might appeal to back-office employees.

**Recruit where others aren't.** When everyone's targeting the same pool of workers, it makes sense to look elsewhere. Older workers often are overlooked in job searches, but they can bring experience and leadership skills to your organization. Women aren't always top of mind for typical construction jobs, but they've proven

they can do the work as well as or better than their male counterparts. (Check out this all-female crew in the paving industry.) You may also want to consider tapping into the temp/freelance market or enlisting a staffing agency to help you find workers.


**Do a culture check.** In a workers' market, there's little reason for employees to stay in jobs where they're treated poorly. If your employees are leaving, maybe it's time to ask why. Are you paying fairly compared to the rest of the market? Are your benefits up to snuff? Is your commitment to worker safety clear? Do you listen to employee feedback and take action on their concerns? Find out where you need to improve to make your company an *"employer of choice."*

Given the challenges of finding skilled employees — especially equipment operators — in the construction industry, these aren't just short-term tips to help you get through today's labor shortage. They're long-term strategies you can use to give your organization a permanent head start in the recruiting race.

## DIR Awarded \$10 million Federal Grant to fund innovation in registered apprenticeship programs

Oakland —The U.S. Department of Labor has awarded a \$10 million State Apprenticeship Expansion, Equity and Innovation grant to the Department of Industrial Relations (DIR) to support the development and expansion of new and existing registered apprenticeship programs. DIR is one of five applicants that received the maximum \$10 million in funds.

*“DAS continues to be a leader in using new strategies to engage with employers and attract a diverse workforce,”* said Division of Apprenticeship Standards Chief, Eric Rood. *“This award recognizes our dedication to apprenticeship and funds our ability to provide more career opportunities to all Californians.”*

The grant will help support DIR and its Division of Apprenticeship Standards’ (DAS) efforts to expand equity in

apprenticeships to non-traditional industries by creating new ways to engage with employers, academic institutions and workforce development organizations.

### This grant supports the following goals:

Expand the development, modernization and diversification of registered apprenticeship programs.

Increase the number of active enrolled apprentices.

Develop innovative programs and recruitment strategies.

The funds awarded will be used to foster regional collaborations in specific industries, such as the Inland Empire Cybersecurity Apprenticeship Consortium pilot program that launched this past May. The initiative

addresses the 56% vacancy rate for cybersecurity jobs in the Inland Empire to fill the 70,000 cybersecurity vacancies throughout the state. ## Capitol Connection Q&A for Contractors

To protect yourself you need the right answers, and a warning to beware like you will find here today. You can share a great bond with your family, but your license bond is yours alone. Buying business assets will include the company name, but will it include the contractor's license? It seems the theme here is change, and sometimes that includes sudden unexpected loss that means the end of the partnership ...

**Q:** I have worked for my father's contracting company for many years and he passed away recently. I have applied for a new license and I'm requesting that his license number be re-issued to me. The CSLB sent me a letter requesting a contractor's bond. My Dad just renewed the bond on his license. Can I request that the CSLB also transfer his bond?

**A:** No, unfortunately bonds are not transferrable. So even though you will be keeping your father's license number you will need to obtain a new contractor's bond.

**Q:** My client currently has a California license (for the purpose of this conversation we'll call it ABC Inc). If ABC Inc. purchases the assets of another existing licensee and wants to continue operating the existing licensee's business, but under ABC Inc., could the license be amended to identify more than one dba name, or would they be required to obtain a separate license?

**A:** In an asset sale you cannot continue to operate under the same license number that the company currently has. When purchasing the assets of a licensed business, your client as the buyer will be transferring the assets to ABC Inc. and from that point can either obtain a new license for ABC Inc. with a dba name attached (which may be the current business name reflected on the seller's license), or they can form a new entity, purchase the assets, and continue operating the business.



**Q:** My Partner recently passed away. I have read that a Partnership license is cancelled upon the death or Disassociation of one of the General Partners. I plan to apply for a new license but I know that takes some time. We have quite a bit of work in progress. Is it possible to request that the CSLB hold off on cancelling the license until we finish the work in progress?

**A:** First of all, I'm sorry for your loss. B&P Code Section 7076 allows for the remaining General Partner or Partners to request a continuance of the license to complete projects in progress and undertake new work for a reasonable amount of time, which will be determined by the CSLB. This request must be made in writing within 90 days of his death.

**FRAUD ALERT:** The CSLB released a bulletin warning Contractors of a phone scam targeting licensees. In the scheme, an individual falsely identifying themselves as an employee of the CSLB demands a license "activation" fee of up to \$500 be paid immediately over the phone or the license will be cancelled. The CSLB never calls licensees asking for credit cards or other confidential information. If you receive any such call, take down the caller's information and contact the CSLB.

## Making the case for coming back to the office

### Connection

Humans are social creatures, which means we rely on positive relationships with others for encouragement, development, and support. Onsite work offers an environment for interpersonal interaction, hallway chats, and in person meetings; none of which can be found in a zoom meeting. There's even a business case for encouraging your employees to spend more time socializing. Gallup research shows that people who have a best friend at work, are seven times as likely to be engaged in their jobs, are better at engaging customers and produce higher-quality work.

Create an environment that encourages connection and recharges your teams' batteries. Eating lunch together, coffee runs or donut days when people are in the office, allow for fun interactions. Encourage your staff to take a walk together to mull over a concern or have more conversational one-on-one meetings. The more connections there are between co-workers the better.

### Collaboration

Four, five, or even six heads are always better than one. Collaborating at work allows teams to capitalize on the strengths and contributions of each person. Returning to the office improves teamwork and efficiency in situations that require interdependent and/or complex interactions. Working together also fosters and sustains trust. Visibility around each person's performance and contribution will sustain your team's confidence in one another, even when the team is not together.

### Creativity

We've all heard that creativity and innovation drive continual improvement in the workplace, but creativity at work can arise from both spontaneous discoveries or from planned collaboration. Remote work and social distancing have made spontaneous creativity, often found in impromptu conversations or over lunch, difficult, if not obsolete. Onsite meetings make it easier to brainstorm ideas onto whiteboards and organize them into something new and useful. Returning

to the office fuels spontaneous creative moments and intentional creative collaboration.

### Culture

An organization's culture is a reflection of *"how we do things around here."* Culture creates a shared experience for employees that is reflected in their collective values and behaviors. Bringing people back into the office, even in a hybrid solution, allows employees to experience the environment, touchpoints, messaging, and values that signal who you are as an organization. If you hired new employees during the pandemic and everyone was working remote, they haven't yet had time to be fully immersed in your culture.

If your organization wants people back onsite, explain these four key advantages and ask your managers to engage in meaningful conversations about the transition. Your end goal in creating a workplace value proposition is to create an environment that employees can't get anywhere else!

## When it pays to be picky: Jobs not worth taking

**But some projects actually end up costing you more than they're worth and keep you from spending time on profitable work. How do you determine if a job's not worth taking?**

### Any job is better than no job – or is it?

When you run a business and find yourself responsible for paying bills, meeting payroll and funding your own retirement, it can be tempting to take anything that comes your way. But some projects actually end up costing you more than they're worth and keep you from spending time on profitable work. How do you determine if a job's not worth taking?

### Run the numbers first

Before bidding on any job, you need to be realistic about what it will cost you to finish the work on time and to the required specs. Ask yourself:

What are my employee costs to complete this job — wages, benefits, workers' compensation, payroll tax and any insurance needs?

How much will it cost to travel to and from the project site? What about the costs of transporting equipment and keeping it secure while on site?

Are any rental machines, attachments or tools required? If so, how long will I need them and how much will it cost to rent them?

What are my expenses for fuel and routine maintenance over the course of the project? How much contingency should I include for unexpected breakdowns or downtime?

What are the costs for bonding and insurance?

How much time will I (or other company leaders) personally spend managing and overseeing this project? Will that come at the expense of other potential work? How much is my time worth?

Only you can determine how much profit you want to make on each job. But the only way to bid the work so that you earn that money is to estimate your costs accurately first. And if the numbers show that you can't be profitable, believe them — it's time to take a pass on the project.

### Weigh your financial situation

Saying no to some jobs is easy — you don't have the right equipment, the right skills or the right team, and acquiring them in time to complete the work isn't possible. But other projects fall into a gray area. Perhaps you don't have the exact equipment you need, but you could get it. Maybe you don't have enough operators on staff, but you know some good people looking for work.

In these situations, the decision may come down to your comfort with financial risk. Are you in a position to rent, buy or finance the required equipment or take on the costs of increased payroll, benefits and training? If the answer is yes, and you've run the numbers above to determine you can make a profit, then bidding on the project may be worth it. But if these added costs will drain your working capital, then it's likely a job not worth taking.

On the surface, some projects look like can't-miss opportunities, but when you dig deeper, you discover they're a better fit for someone else. The reverse is true as well. Less flashy projects can turn out to be your most profitable. The only way to know is to do your homework – and don't be afraid to pass on the jobs that simply won't pay off.


