# FIRST AID KIT: WHERE AND WHAT (CAL/OSHA)



#### INTRODUCTION

Due to the chances of there being an injury that needs either minor or major attention, companies should have a wellstocked first aid kit readily accessible to all employees. The contents of the first aid kit can vary depending on the work location and work tasks involved. In this lesson we will cover the requirements for first aid kits in the workplace, first aid personnel, where first aid kits may be found, and what a first aid kit may contain.

#### **REQUIREMENTS FOR FIRST AID KITS IN THE WORKPLACE**

Cal/OSHA requires businesses to have a first aid kit readily available for employee use in the event of a medical emergency or injury.

#### Inspection and Replenishing of First Aid Kits

For non-construction worksites, first aid kits should be frequently inspected and replenished as necessary.

On a construction site, first aid kits should be in weatherproof containers with individual sealed packages for each type of item and should be checked before going out to the jobsite and on a regular basis to make sure it remains well-stocked and expired items are replaced.

#### **FIRST AID PERSONNEL**

In addition to first aid kits, depending on your industry and travel distance (i.e., how long it will take for emergency medical services to reach your jobsite or for employees to be transported to medical services), your company may also have personnel who have been trained and certified to render first aid and CPR.

#### Construction

There should be a suitable number of appropriately trained persons to render first aid on a construction site. If the site will have more than one company working on the site, the companies may choose to pool the employees who have been trained and certified together.

#### **General Industry**

If the work location is not in close proximity to an infirmary, clinic, or hospital, there should be a person or persons who are adequately trained to render first aid. Just as with construction, this person or persons should be trained and certified through a program that is equal to either the American Red Cross or the Mine Safety and Health Administration.

#### LOCATIONS OF FIRST AID KITS

Cal/OSHA requires that first aid kits be kept in readily accessible areas. Common areas where first aid kits may be found include, but may not be limited to:

- Break rooms
- Locker rooms



# FIRST AID KIT: WHERE AND WHAT (CAL/OSHA)

- Production areas
- Designated office areas
- Work vehicles

All employees should become familiar with all locations where a first aid kit, and, if available, an automated external defibrillator (AEDs) may be located.

Additionally, first aid kits may be placed near posted Emergency Action Plan items such as emergency phone numbers and evacuation maps. For more information on the Emergency Action Plan, please refer to our "EAP (Emergency Action Plan)" lesson.

#### WHAT A FIRST AID KIT MAY CONTAIN

While Cal/OSHA does not specify the exact contents for a first aid kit, as contents will differ depending on the job location and work tasks, involved, they do provide an example that employers can use when looking at or creating their own first aid kit.

In addition to first aid kits, your company may have designated personnel that have been trained and certified in first aid and CPR. All employees should become familiar with the location of all provided first aid kits, and, if provided, AEDs. If you have questions about your company's first aid kit and where one might be located, please speak with your supervisor.

## **CyberSecurity - Protect Your Company Information**

Today many business communications and other tasks take place using the internet and connected devices. The ease and convenience of these methods of communication and ways of completing work have turned criminals to cybercrime to collect information and cause damage to a business. This lesson will cover what cybersecurity is, the types of cyberattacks used, the potential consequences, and ways to protect information.

#### WHAT IS CYBERSECURITY

Cybersecurity, also referred to as information technology security, is the protection of computers, internetconnected devices, and information from attack, theft, or damage. This is achieved through a variety of methods, including: • Anti-virus and anti-malware software • Technology security services • Virtual Private Networks (VPNs) • Strong passwords • Firewalls • Company technology policies and procedures • Website security

#### TYPES OF CYBER ATTACKS

There are many ways for cyberattacks to be made. Attacks can include: Malware Malicious software that is used by cybercriminals to break into a network. Typical malware includes the use of: • Spyware • Ransomware • Trojans • Viruses • Worms Once the malware has broken into a network, it can do the following: • Install additional software that could harm the network or device. • Block access to critical components of the network. This is commonly completed with ransomware. • Quietly and covertly obtain information from the hard drive through data transmission. This type of activity is typically achieved through spyware. • Render a system inoperable by disrupting specific components of the infected device or network.

Social Engineering Social engineering is the psychological manipulation of individuals to trick them into giving away sensitive information or making a security mistake that will allow the attacker to gain information.

#### CONSEQUENCES OF CYBER ATTACKS

When a business finds itself the victim of a cyberattack, it could experience one or more consequences because of the damage: • Reputational damage • Theft of data • Financial losses in the form of money that has to be spent on recovery efforts • Fines for failure to comply with local, state, or federal regulations • Loss of productivity • Legal liability

#### WAYS TO PROTECT INFORMATION

Many of the cyberattacks covered can be prevented. You can do your part to protect your company's information by utilizing the following:

Passwords: Create strong passwords.

**Email:** Some of the most common attacks are through email. Before you open an email, click on any links, or open attachments, look for the following:

• The email is from the stated sender. Many criminals will try to pose as a legit person or company To see the actual email address, hover your mouse over the name, and the address will appear. If the email does not match the sender, do NOT open. The same trick can apply to links.

- Check the spelling and grammar of the email.
- Do NOT open attachments if they come from an unknown sender.
- If the email does not seem typical for the sender, contact the stated sender to confirm if they sent the email or not.

**Wi-Fi connections**: If your company has policies for public Wi-Fi use, make sure to follow them.

**Security Updates:** You should also make sure that all security updates for your computer and other devices have been performed.

The ease of accessibility to the web and its interactions with computers and other devices have made it an easy target for cybercriminals. These criminals use a variety of tactics to get information and do further damage. You, as an employee, play an essential role in your company's cybersecurity system.

#### **FIRST AID: CONCUSSIONS**

Whether you are at work or enjoying a fun activity, there may have been a time where you or another person has struck their head in one way or another. These bumps on the head may result in an invisible injury known as a concussion. In this lesson we will cover what a concussion is, signs and symptoms associated with concussions, how to minimize the chances of a concussion occurring, and what to do if someone displays symptoms of a concussion. Please note that nothing in this lesson is meant to be used to diagnose an individual with a concussion. Diagnoses should only be done by a licensed medical professional. If someone displays signs or symptoms that may indicate a concussion after a hit to the head or jolt to the body, that individual should be advised to seek medical attention.

#### WHAT A CONCUSSION IS

A concussion is a type of traumatic brain injury (TBI) that may occur after someone experiences a bump, blow, or jolt to the head or by a hit to the body that causes the head to move rapidly back and forth. The sudden movement can cause the brain to bounce around or twist in the skull. This can result in either temporary or permeant changes in how the brain functions due to the following: • Depolarization of neurons (i.e., nerve cells) know as ionic flux • Changes in how glucose is metabolized • Stretching and damage to nerve cells • Impairment of the transmission of brain chemicals (i.e., how the signals in the brain communicate with each other) • Changes in certain enzymes and proteins

#### COMMON CAUSES OF CONCUSSIONS

Concussions can be caused by a variety of things, including, but not limited to: • Participating in sports where body contact frequently occurs (i.e., football, soccer, hockey, boxing, etc.) • Being in a car, bike, or motorcycle accident • Slipping, tripping, or falling • Domestic violence • Being struck by falling objects • Military combat • Previous concussions Please note that the bump, blow, or jolt to either the head or the body does not have to be hard for a person to experience a concussion.

#### SIGNS AND SYMPTOMS ASSOCIATED WITH CONCUSSIONS

While a concussion is an invisible injury, there are some common signs and symptoms that a person may feel or display that could be an indicator that they are experiencing a concussion after a hit to the head or body. These symptoms can include both physical and cognitive symptoms.

#### **FIRST AID: CONCUSSIONS**

Physical symptoms that a victim may experience include:

- Blacking out/ losing consciousness, even if briefly
- Seeing "stars" or lights in front of the eyes
- Blurred or double vision
- Nausea or vomiting
- Seizures
- Headaches
- Light sensitivity .
- Lack of motor coordination or having difficulty balancing
- Tinnitus (i.e., ringing in the ears)
- Uneven pupil sizes
- Bleeding at the scalp
- Bleeding under the scalp, which may create a large lump under the skin

Cognitive symptoms can include:

- Feeling or appearing dazed
- Memory problems
- Disorientation and confusion
- Trouble focusing
- Post-traumatic amnesia
- Slurred or incoherent speech
- Mood changes
- Lethargy .
- Irritability

#### WHAT TO DO IF SOMEONE DISPLAYS SYPMTOMS OF A CONCUSSION

If someone took a hit or jolt to the body, you should do the



following: • Assess the situation to make sure that it is safe to approach the victim. • Call or have someone contact your supervisor. o If the victim is displaying signs such as loss of consciousness, seizures, vomiting, unequal pupils, weakness on one side of the body, dizziness, confusion, severe drowsiness, neck pain, or slurred speech, either call or have someone else call 9-1-1. • If the person is lying on the ground, check for loss of consciousness. o If the person is unconscious, you should check the victim per the ABCs or CABs procedures. o For more information on these procedures, please refer to our "First Aid: Basics" and "Cardiopulmonary Resuscitation (CPR)" lessons. Keep the victim still until assistance arrives. o If 9-1-1 was called, follow any instructions that are given by the dispatcher. If applicable, stop any bleeding.
 Check the victims' cognitive functions by asking simple questions such as "What is your name? Where are you? How are you feeling? etc." Anyone who is not seen by emergency medical services, should seek medical attention if they develop symptoms or if symptoms worsen.

To conclude, concussions are invisible injuries that can occur when someone hits their head or takes a hit to the body where the head moves back and forth. When this occurs, victims should be monitored for signs and symptoms of a concussion and should seek professional medical attention if symptoms develop or get worse after hitting the head or getting hit in the body. #### Here's how OSHA is protecting workers from heat this summer

As temperatures rise this summer, employers across the nation are on notice: For the first time ever, federal inspectors could stop by unannounced to ensure workers are safe from heat exposure.

That's thanks to the Occupational Safety and Health Administration's "National Emphasis Program" for heat. Under the program, OSHA inspectors will target workplaces in more than 70 industries at "high risk" for heat exposure — such as agriculture, warehouses and construction — whenever the National Weather Service announces heat warnings or advisories for the area where the business is located.

Such emphasis programs are an important enforcement tool for OSHA because they allow inspectors who are otherwise limited to only visiting workplaces after they have received complaints or after workers are killed or injured to visit workplaces and inspect for hazards before anyone gets hurt.

"We want to be proactively addressing heat hazards," OSHA Deputy Assistant Secretary Jim Frederick said in an interview. "Without an emphasis program, we can see a hazard and address it if we are already in a workplace, but this gives us the ability to proactively go to these workplaces and see what heat protections they have in place." The program also means that when inspectors visit job sites for complaints about other hazards, they will also be directed to assess whether workers there are being protected and safe from high heat, as well.

While everyone is at risk from heat illnesses when temperatures rise, laborers are particularly vulnerable because the exertional nature of their work makes it more difficult for their bodies to cool down.

That means having a national emphasis program for heat could save lives, said Jordan Barab, who was OSHA's deputy assistant secretary of Labor for occupational safety and health during the Obama administration.

"It shows we are watching, we are looking, and we may be visiting a workplace near you, so do what you can before OSHA gets there to protect your workers from high heat exposure," he said.

The emphasis program is part of the Biden administration's broader efforts to address the effects of climate change using a "whole of government" approach. The administration announced its intention to create an emphasis program last September, and Vice President Kamala Harris headlined an April event

officially kicking off the program at the Sheet Metal Workers Local 19 union in Philadelphia.

"Let's be clear: Heat is a workplace safety issue," she said to applause. "And employers are responsible for protecting their workers in the workplace from the dangers of heat, including in farm fields, in delivery vans, and in nursing homes — everywhere that has workers."

The emphasis program won't start out as an enforcement tool right away. Rather, for the first few months, OSHA compliance officers will merely consult with employers, visiting work sites and explaining what needs to be done to make it safe. Formal inspections that could result in citations for violations will begin later.

Labor advocates agree that the program is a step up for OSHA.

Juley Fulcher, a worker health and safety advocate at Public Citizen, said the program could be "a very good thing," especially because OSHA often does not investigate all heat-related complaints it receives, often only visiting worksites where workers have died or become seriously ill.

But she also suggested that there is a limit to how big of an impact the emphasis program can have without specific standards telling employers exactly what they need to do to protect workers from heat.

Indeed, OSHA has no heat regulations. Though the agency is currently working on writing such a standard, an actual proposed



rule is years away. In the meantime, OSHA must rely on its "general duty clause," which broadly requires employers to ensure workplaces are safe from "recognized hazards."

Both Strater and Fulcher lamented that it could be years before OSHA finalizes a heat regulation, noting that the agency, on average, takes more than seven years to finalize new rules. They think OSHA could be moving faster given that a number of states have recently written their own rules to protect workers from heat and that, over multiple decades, the CDC has made three recommendations to OSHA that it create a regulation.

Not everyone is eager for OSHA to establish new rules quickly. U.S. Chamber of Commerce Vice President for Workplace Policy Marc Freedman said he is not sure OSHA should issue any standard at all.

"We can all agree that heat is a hazard, but trying to say, 'This is the point at which you are in trouble or where employers have to take action,' is difficult to nail down," he said.

Frederick said the agency is working as fast as it can on the rulemaking, but that progress is hampered by budget constraints. He also said the agency is trying to write a rule that would withstand potential lawsuits, given how often OSHA rules end up in court.

"We can't just issue a rule and hope nobody has any concerns about it," he said. "We need to make sure it can match and exceed anyone's challenges."






