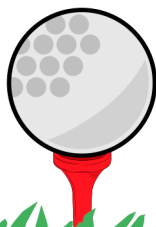

# Cal/OSHA Announces Public Hearing on Proposed COVID-19 Permanent Standard

On September 15, 2022, the California Occupational Safety and Health Standards Board (“Board”) will hold a public hearing to address its draft proposed COVID-19 Permanent Standard (“Permanent Standard”).[1] At the hearing, the Board will hear comments from the public in favor of adopting, amending, or repealing the Permanent Standard. The good news for employers who are tired of revising their COVID-19 policies is that the Permanent Standard largely tracks with the protocols already required under the current COVID-19 Emergency Temporary Standards (“ETS”). Additionally, the Permanent Standard eliminates or reduces some of the costly requirements under the current ETS. The bad news, however, is that it appears COVID-19 protocols are here to stay for the near future and California employers will need to continue to remain in compliance with the state’s COVID-19 regulations and enforce them in the workplace.

## Background

To date, the California Division of Occupational Safety

and Health (“Cal/OSHA”) has adopted four iterations of the ETS, which is codified in California Code of Regulations, Title 8, Section 3205 et seq. The original ETS was adopted November 19, 2020, and became effective on November 30, 2020. The current ETS is the fourth iteration, which became effective on May 5, 2022, and remains in effect until December 31, 2022. On June 18, 2022, Cal/OSHA published its proposed language for the Permanent Standard, which appears to be a slightly less stringent version of the current ETS. If adopted, the so-called “Permanent” Standard will become effective January 1, 2023, and remain in effect until December 31, 2024.

## Differences Between the ETS and the Permanent Standard

Unlike the ETS, the Permanent Standard does not state that employers must maintain a written COVID-19 Prevention Program (“CPP”).

However, the Permanent Standard does state that an employer's COVID-19 procedures must either be addressed in the employer's written Injury and Illness Prevention Program ("IIPP") or maintained in a separate document. Thus, it appears that employers should either maintain their CPP or incorporate it into their IIPP.

Although the requirements under the Permanent Standard are largely similar to the current ETS, there are a few important changes that will likely be the primary discussion points at the hearing.

Addressed below are six changes that will likely receive the bulk of the attention due to their impact on employers and employees alike.

## Reduced Requirements for Employers:

### 1. Elimination of Exclusion Pay:

Employers are no longer required to provide exclusion

pay to employees excluded from the workplace due to COVID-19. This change will hopefully reduce some of the financial burden that COVID-19 and the ETS have placed on employers. However, due to the financial impact of this change to both employers and employees, this will likely be a hotly contested topic at the September 15, 2022, hearing.

### 2. Employer-Provided Testing:

The Permanent Standard eliminates the requirement that employers make COVID-19 testing available to employees who are a close contact outside of the workplace and/or who experience symptoms. Under the Permanent Standard, employers would no longer be required to provide COVID-19 testing to all symptomatic employees. Instead, employers will only be required to provide testing, still at no cost and during paid time, to employees who are a close contact within the workplace.

### 3. “Relaxed” Notice Requirement:

While the prior iterations of the ETS call for notice of potential exposure to be given to employees and independent contractors within one day, the Draft Standard now calls for notice to be given “as soon as possible.” In theory, this might give employers slightly more breathing room to respond to information regarding a positive COVID-19 case. In practice, this change has little effect, if any. Labor Code section 6409.6 still requires that notice be given within one business day and although this section of the Labor Code is set to expire at the end of this year, pending legislation would extend its enforcement until January 1, 2025.

### Added Requirements for Employers:

#### 1. New Definition of “Close Contact”:

The Permanent Standard’s definition of “close contact” mirrors that of the California Department of Public Health (“CDPH”) and states close contact means “sharing the same indoor space as a COVID-19 case for a cumulative total of 15 minutes or more over a 24-hour period during the COVID-19 case’s infectious period.” Not only is this

broader and more ambiguous than the previous six-foot/15-minute rule, but it substantially increases the number of potential close contacts. Areas where employees may be more than six feet apart but in the same indoor space includes areas such as conference rooms, waiting rooms, break rooms, restrooms, and office floors with cubicles, just to name a few. Employers will now have to use their discretion to determine which areas fall under this new definition and more closely monitor those areas.

#### 2. Reporting of Cases and Close Contacts:

Employers are still required to keep records of COVID-19 cases and outbreaks. However, under the Permanent Standard, employers also will be required to keep records of close contacts. These records must be provided to the local health department, CDPH, Cal/OSHA, or the National Institute for Occupational Safety and Health upon request.

As a reminder, for COVID-19 cases, these records should contain the employee’s name, contact information, occupation, location(s) where the employee worked, the date the employee last worked, and date of last positive COVID-19 test. For close contacts, the records should contain the employee’s name, contact information, and the date the close contact was provided notice. These records should be kept confidential and be retained for two years.

### 3. Respiratory Protection for Aerosol Producers:

The Permanent Standard will require certain employers to evaluate the need for respiratory protection for employees who are exposed to procedures that may aerosolize potentially infectious materials, such as saliva or respiratory tract fluid carrying COVID-19. This requirement will apply to employees in work settings that are not covered by the Aerosol Transmissible Diseases (“ATD”) standard (California Code of Regulations, title 8, section 5199), which contains specific requirements for protecting employees from diseases and pathogens transmitted by aerosols. Examples of work settings that this requirement may affect include certain dental procedures and certain outpatient medical specialties.

### Conclusion

Although the Board still can modify the proposed language in the Permanent Standard, it seems unlikely that any of the proposed requirements will change. Employers who wish to submit written comments may do so until 5:00 p.m. on the day of the hearing on September 15,

2022. Sheppard Mullin will continue to closely monitor any important employment developments related to COVID-19, including the upcoming hearing and any changes to the Permanent Standard. Employers with any questions or concerns about the Permanent Standard or the current ETS should consult with experienced employment counsel to ensure they are compliant with the evolving regulations and guidance.

The legal landscape continues to evolve quickly and there is a lack of clear-cut authority or bright line rules on implementation. This article is not intended to be an unequivocal, one-size fits all guidance, but instead represents our interpretation of where applicable law currently and generally stands. This article does not address the potential impacts of the numerous other local, state and federal orders that have been issued in response to the COVID-19 pandemic, including, without limitation, potential liability should an employee become ill, requirements regarding family leave, sick pay and other issues.

## Regulatory Update: Big Jump in OSHA Fines Not Coming

It's not often these days that employers have something to cheer about when it comes to the regulatory front, but that seems to be the case now that Democrats in the Senate apparently have decided not to proceed with a proposal that would have quadrupled financial penalties imposed by the Occupational Safety and Health Administration (OSHA).

At present, the maximum fine OSHA can assess against an employer per alleged repeat, willful or failure-to-abate violations is \$145,027. Last year, the House of Representatives passed a bill that would have boosted the maximum penalty for willful or repeat violations of OSHA workplace safety rules from that amount to \$700,000 per violation, including imposition of a \$50,000 minimum.

Under last year's House proposal, the serious failure-to-abate fine limit also would have increased from \$13,653 to \$70,000.

However, the most recent update to the reconciliation spending bill still being debated by the U.S. Senate does not mention or incorporate any provisions for raising the cap on

civil money penalties regarding citations issued by OSHA, notes Raymond Perez II, an attorney with the law firm of Jackson Lewis.

"Labor and safety groups along with many Democrats have long advocated for higher OSHA fines which they argue will deter safety violations and encourage better employer compliance by reducing or eliminating workplace hazards that could lead to serious injury or death," Perez observes.

Despite the stated good intentions, he points out that OSHA regulatory compliance can be extremely complicated and expensive even for large employers to comply with, and increasing penalties to such a high amount will not necessarily result in better outcomes.

In fact, massive fines would most certainly lead to employers being more likely to contest citations in drawn-out litigation, Perez argues. "This would take away time and resources from actual compliance and would not serve the underlying purposes of the Occupational Safety and Health

(OSH) Act.”

Another good reason for employers to dislike the currently high rate of inflation is that since the enactment of legislation in 2015, OSHA fines and civil penalties are adjusted upward each January to match the previous year's rise in the Consumer Price Index (CPI).

On the funding front for the agency, Democrats serving on the U.S. Senate Appropriations Committee have proposed a \$68 million dollar increase to OSHA's fiscal budget for 2023. In total, Senate Democrats are intending to fund OSHA in 2023 with approximately \$679.8 million dollars.

While certainly a significant increase from 2022 funding levels, this is considerably less than the \$702 million requested by the White House or the \$712 million OSHA budget that was already passed by the House this year, Perez points out.

According to the wording of the Senate Appropriations Committee legislative report, the additional funding is intended to increase OSHA's critical enforcement

activities to inspect the nation's workplaces to prevent employee injuries and deaths. Under this proposal, all line-items for OSHA's budget would be increased from 2022 levels. This includes \$272 million dedicated to enforcement, while whistleblower protections would be funded at \$27.5 million, and standards development at \$27.5 million.

Perez believes that it also is likely that any budget increase for enforcement would be directed to hiring more Compliance Safety and Health Officers (CSHOs) in order to conduct an additional number of workplace investigations related to hazards that already have been prioritized by the agency, such as heat stress, workplace violence and ergonomics.

“While employers will need to be prepared for an expected rise in OSHA enforcement activity next year, at least for now it does not appear that it will come along with significantly higher penalties,” he says

## Capitol Connection Q&A for Contractors

We all lost something during the Pandemic shutdown, but recovery might be taxing! I 'venture' an expert answer that might surprise you, wish a retiring contractor well in retirement and outline the rule on 'oversight' for an RME...

**Q:** I let my license expire at some point during the pandemic. It's a corporation and when I look it up it on the CSLB's website it says the Corporation status at the Secretary of State needs to be returned to Active to renew the license. The Corporation status with the SOS says "FTB suspended". Do you know what I need to do?

**A:** "FTB suspended" means the Franchise Tax Board has suspended the entity either due to failure to pay taxes or failure to file taxes (or both). If you file/pay all taxes due and file a revivor with the SOS, you will then be able to renew

the Contractor's license.

**Q:** We are going to be starting a new JV in California and I wanted to check if by chance you know the bidding requirements. Both entities are licensed in CA and are submitting an application as the JV. Can we submit the bid in CA without the Active license? My understanding was we just cannot start any labor until it is processed and approved?

**A:** Yes you can submit a bid without the active license in hand, but you are correct, you cannot start any work under the JV until it is officially licensed.

**Q:** We are a part of the Union. We are licensed with the "C-36" and "C-34" classifications. My husband is the Qualifier, and he is ready to retire and take advantage of some the Union's benefits. We need to have him off the license completely by the end of this month. Our son has worked for the business for the past twelve years. He had completed his Journeyman training and Apprenticeship program and we have plenty of other documentation showing he has many years of experience doing plumbing work. In your experience, is testing always required or is there a

chance he can waive the exams based on his experience?

**A:** It sounds like he will be able to request a Waiver of the exams based on B&P Code section 7065.1 which allows for it if the individual has worked as a Supervisory Employee for the five out of the last seven years. We can file to remove your husband from the license simultaneously.

**Q:** We are an out-of-state company with a CA Contractor's License. Our Responsible Managing Employee (RME) just informed us he is leaving to go work for another business. We contacted our attorney to help us with an agreement for the replacement RME we are hiring, and he suggested we contact you to find out specifically what the CSLB requires with regards to duties for an RME. Do they need to be showing up on site to a certain percentage of our jobs?

**A:** There is no rule in place to specify a certain amount of projects which an RME is required to be on site. The first main requirement of RME's is they must work at least 32

hours per week or 80% of the Company's operating time. Beyond that, in general the CSLB requires that RME's are overseeing projects and providing direct supervision and control for the work being performed. While space is limited here you can always call for more information.

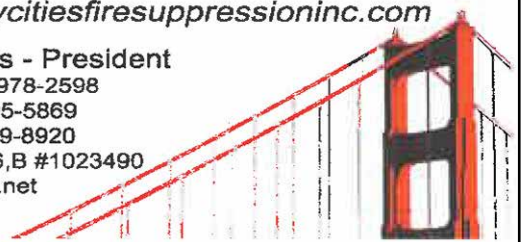

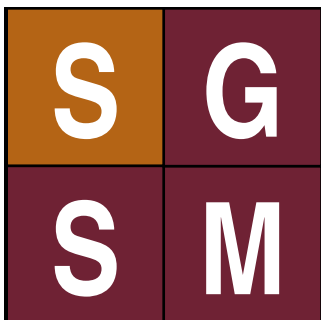
