### Alta Madrone

General contractor [Midstate Construction Corporation](#) and developer Satellite Affordable Housing Associates (SAHA) recently completed Alta Madrone, a new 48 unit multi-family affordable housing community in Sonoma, CA.

Designed by Pyatok Architects, this project includes ground up construction of an eight building two-story, 41,778 square foot affordable housing community featuring 48 one, two and three bedroom units for low, and very low income residents. The community building includes lobby/lounge area, computer lab, full kitchen, laundry facilities, activity and meeting rooms. The 1.95 acre site includes 75 parking spaces, 24 secured bicycle parking spaces, two courtyards, community garden, playground, ample pathways and established existing valley oak trees. Sustainable features include photovoltaic panels, pervious pavers and bioswales.



Alta Madrone targets tenancy for those with the greatest need. 11 rental units are set aside for formerly homeless families and filled in coordination with the Sonoma County Housing Authority; another 10 rental units are filled in coordination with the housing authority for Veterans Affairs Supportive Housing (VASH) units.

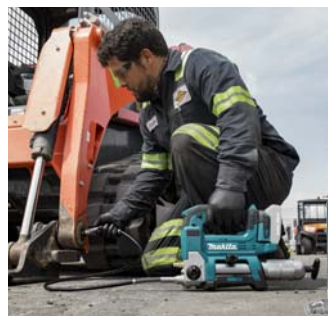

## Trends for wood flooring in 2022

Learn what's popular and emerging when it comes to width, length, color, finish, and type of wood

Of all the available floor coverings, wood is the most consistent choice that adds value, says Brett Miller, VP of education and certification for the National Wood Flooring Association in St. Louis.

Others agree. *"If a house has wall-to-wall carpeting, it becomes a huge marketing challenge. People expect hardwood at least in the main public areas of a house or condominium. Some buyers also have allergies to carpet,"* says Chicago broker Jennifer Ames, with the Ames Team at Engel & Volkers.

Due to better technology and new trends, no single wood flooring dominates. For that reason, remodelers should understand the options.

### What are the latest trends?

**Width and length.** Going wider and longer are both popular now with boards as wide as 18" to 20" and as long

as 12' or more, Miller says. *"That way you have a less choppy look."*

**Color.** Colors have gone from the grays of recent years to lighter whites or white undertones with a natural look. Chicago designer Tom Segal of Kaufman Segal Design likens it to a beachy or Scandinavian vibe. While darker colors remain in vogue, their popularity has decreased, Miller says. But because trends keep shifting, he sees darker colors on the not-too-distant horizon, influenced by paint and fashion color trends. Within the darker choices there are favorites, with a walnut tone more popular than mahogany, and both surpassing cherry, Ames says. One color family that should be avoided is red. Segal also advises steering clear of an oak color that veers toward yellow. He and Ames stress the importance of going with

one color family throughout a home or on the same level for visual continuity.

**Finish.** Here, the trend is for low or no sheen with natural penetrating or hard-wax oils rather than a plastic film. *“The choice should depend on how much traffic there is,”* Miller says.

## What are the best reasons to go with a hardwood or solid wood floor, engineered, or reclaimed wood floor?

While Miller says it’s personal preference, he recommends solid hardwood because it lasts a long time and offers an authentic, natural look. However, it may not be the best solution for below grade locations like basements due to the possibility of moisture causing the wood to bow or buckle.

Engineered wood, which is constructed of plywood layers with a real wood veneer, is better at withstanding moisture than hardwood since its multiple layers beneath make it more stable. It’s also prefinished in a factory, can

be constructed in longer lengths and widths, and saves installation time.

Bamboo is another sustainable, durable choice that has gained in popularity.


## What are other ways to be sustainable?

Miller’s organization recommends choosing domestic woods such as oak, walnut, hickory, and cherry since they are grown and harvested in North America. Want something more exotic and imported? There are systems to monitor imported tropicals to be sure they’ve been responsibly harvested, he says, such as the Forest Stewardship Council (FSC) certification program.

## When it comes to maintenance, is it better to sand an existing wood floor or clean and polish it?

When color variations and disrepair are highly visible, it may be time to sand, stain, and finish. But if a homeowner



is considering selling, they may want the next owner to have the choice—since some wood floors may be down to their final sanding. When worn and dull looking, a good cleaning and polishing may be all that's needed.

### When is it better, if ever, to go with a faux wood?

Segal prefers not to use these options because he likes the look and feel on the feet of real wood. But others think there are times when they make sense.

Vinyls have been improved thanks to technology and some closely resemble wood, even copying grains. Ames says they make sense in a lower-level room where moisture might pose a problem for real wood. A quality vinyl is also a great solution when price is a factor, says Mary Cook, a Chicago-based commercial interior designer. They also represent low VOCs and are easy to clean, says Mallios who installed them in her former garage, now her she-shed/cave.

Porcelains appeal for similar reasons but also may work well for a kitchen or bathroom floor or countertop, Ames

says. But she cautions that they can feel cold and for this reason sometimes prefers a quality vinyl.

Laminates appeal less to Ames who finds they don't feel like wood when walked on. Cook agrees and adds that they can be noisy when walking.

### Have there been supply chain disruptions during the coronavirus pandemic?

As with other materials needed for remodeling, wood shortages have developed and prices have escalated at points. Ordering too far ahead has been problematic for storage but if not ordered ahead supplies may not arrive on time due to shipping challenges, Segal says.

## Burbank Housing opens 82 affordable dwellings in Napa, Santa Rosa; \$221,000 in donations to local causes

Burbank Housing, based in Santa Rosa, has opened Napa and Santa Rosa communities with 82 homes altogether.

Redwood Grove is a 34-unit duet-style home ownership project at 2033 Redwood Road in Napa.

The nonprofit home builder stated The Redwood Grove project puts “homeownership in reach of local first-time homebuyers who otherwise would likely not be able to afford current market rate home prices.” The development provides homes for over 250 people, with every household either living or working in Napa County.

The agency stated the homes are valued \$550,000, which it describes as substantially lower than current average home prices in Napa County. Buyers get heavily subsidized mortgages so that income-qualified homebuyers paid between \$250,000-\$400,000. Subsidies come in the form of financial support from city, county and state down-payment assistance programs.

Lantana Homes is a new 48 home single-family affordable home ownership project located at 2979 Dutton Meadow in Santa Rosa. The project provides homes for over 200 people, with home buyers either having lived or worked in Sonoma County.

Each home in the community is valued at about \$494,100, lower than current average home prices in Sonoma County.

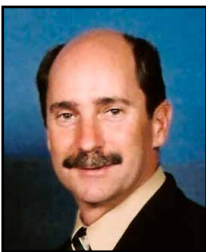

## Capitol Connection Q&A for Contractors

Who's on first? As an expert I can tell you it depends on which states your working in. Another contractor's business is also 'moving' on. An 'explosive' inquiry, and for another contractor 'time' is of the essence. No matter where or when I can help ...

**Q:** We need to apply for a General Contractor's License in CA and AZ. Is it better to apply for one before the other, or at the same time, or what would you recommend?

**A:** I would recommend obtaining the CA license first and then apply for the AZ license second. Arizona allows the Qualifying Individual to Waive the trade portion of the exam if he/she has passed the equivalent exam in a "reciprocal" State and that individual has been actively licensed for just one day. You can certainly get the

paperwork going for both at the same time, and just have the AZ documents on the back burner ready for submittal as soon as the CA license is issued. Let me know if you would like our assistance!

**Q:** Our LLC is currently a CA Limited Liability Company. We are considering changing domicile from CA to another State – rather than a CA LLC, it'll be a Delaware LLC or some other State. Obviously, it will still be registered to do business with the California's Secretary of State's office. Does changing domicile of our entity require any paperwork to be filed with the CSLB?

**A:** No. New paperwork would only be required if the change/conversion results in a new LLC Registration number with the Secretary of State, which it shouldn't.

**Q:** We will be changing our business name in our Home State, and therefore need to file an Amended Registration with the CA Secretary of State and also change the business name on our license. I know the Secretary of State filing

must occur first, so I'm wondering how long a name-change application takes to be processed by the CSLB? We have a target date of 1-1-22 for the official new business name in each State we operate in.

**A:** The CSLB takes about three weeks to process name changes.

**Q:** Our company does highly specialized work and we are being asked to come into California and do the work for a large telecommunications company. I need to know what type of license we need as we are not familiar with the Contractor Licensing requirements in California. We drill large "holes" in the sides of mountains to run cables and

such. Sometimes we use explosives. Would that be an "A" General Engineering Contractor's License?

**A:** The most appropriate license classification for the installation of electrical conduit would either by a "C-7" Low Voltage or a "C-10" Electrical license depending on the type of cabling or wire you are installing in the conduit. The method you use, such as explosives, would be considered incidental to the overall project. Let me know if you would like our assistance with the process.

## OSHA initiates rulemaking process, other steps to combat risks of extreme heat exposure

### OSHA issues an Advance Notice of Proposed Rulemaking for Heat Injury and Illness Prevention in Outdoor and Indoor Work Settings.

With heat-related illnesses become an ever-increasing health risk for many workers, the U.S. Department of Labor, through the department's Occupational Safety and Health Administration (OSHA), issued an Advance Notice of Proposed Rulemaking for Heat Injury and Illness Prevention in Outdoor and Indoor Work Settings on Oct. 27, 2021. Currently, OSHA does not have a specific standard for hazardous heat conditions and this action begins the process to consider a heat-specific workplace rule.

The Advance Notice of Proposed Rulemaking will initiate a comment period to gather diverse perspectives and expertise on topics such as heat-stress thresholds, heat-acclimatization planning and exposure monitoring. It likely marks the initial step toward a formal standard.

*"While heat illness is largely preventable and commonly underreported, thousands of workers are sickened each year by workplace heat exposure, and in some cases, heat exposure can be fatal,"* said Acting Assistant Secretary of Labor for Occupational Safety and Health Jim Frederick. *"The Advance Notice of Proposed Rulemaking for Heat Injury and Illness Prevention in*

*Outdoor and Indoor Work Settings is an important part of our multi-pronged initiative to protect indoor and outdoor workers from hazardous heat."*

*"As we continue to see temperatures rise and records broken, our changing climate affects millions of America's workers who are exposed to tough and potentially dangerous heat,"* said U.S. Department of Labor Secretary Marty Walsh. *"We know a disproportionate number of people of color perform this critical work and they, like all workers, deserve protections. We must act now to address the impacts of extreme heat and to prevent workers from suffering the agony of heat illness or death."*

The announcement closely follows OSHA's announcement that it would implement enhanced and expanded efforts to address hazards associated with extreme heat exposure, both indoors and in concert with the Biden-Harris administration's interagency effort and commitment to workplace safety, climate resilience, and environmental justice.

### A Preventable Risk

Heat illness is largely preventable and commonly under-reported, OSHA notes, with thousands of workers sickened each year by workplace heat exposure. Forty-three workers died from heat illness in 2019, and at least 2,410 others suffered serious injuries and illnesses, though the actual figures may be significantly higher.

*“Every year dozens of workers die and thousands more become ill while working in extreme heat or humid conditions,”* noted Cari Elofson, Assistant Director of the OSHA Training Institute Education Center at Chabot-Las Positas Community College District. *“More than 40% of heat-related worker deaths occur on construction jobsites. Most heat-related illnesses and deaths are totally preventable.”*

### 3 Essentials Define Effective Heat Illness Prevention Plan

The potential costs of heat illness are also substantial to both workers and employers in the form of lost work hours and productivity. According to *“The Cost of Heat Stress and Heat Related Injuries”* by Portacool, just a single case

of *“heat prostration”* can have a direct cost of more than \$23,000 with indirect costs doubling that amount. It adds that productivity declines roughly 14% during workdays exceeding 86° F.

The Atlantic Council’s Adrienne Arsht-Rockefeller Foundation Resilience Center estimates the overall economic loss from heat to be at least \$100 billion annually – a number that could double by 2030 and quintuple by 2050 under a higher emissions scenario, the Department of Labor points out.

*“As we continue to see temperatures rise and records broken, our changing climate affects millions of America’s workers who are exposed to tough and potentially dangerous heat,”* said U.S. Department of Labor Secretary Marty Walsh. *“We know a disproportionate number of people of color perform this critical work and they, like all workers, deserve protections. We must act now to address the impacts of extreme heat and to prevent workers from suffering the agony of heat illness or death.”*

To combat the risks, OSHA initiated enhanced measures to better protect workers in hot environments and reduce the dangers of exposure to ambient heat. They include:

- implementing an enforcement initiative on heat-related hazards,
- developing a National Emphasis Program on heat inspections,
- launching a rulemaking process to develop a workplace heat standard,
- and forming a National Advisory Committee on Occupational Safety and Health Heat Injury and Illness Prevention Work Group to provide better understanding of challenges and to identify and share best practices to protect workers.

*“Throughout the nation, millions of workers face serious hazards from high temperatures both outdoors and indoors. Amid changing climate, the growing frequency and intensity of extreme heat events is increasing the dangers workers face, especially for workers of color who disproportionately work in essential jobs in tough conditions,” said Marty Walsh, U.S. Department of Labor Secretary, in a statement issued*

*today. “As Secretary of Labor, my priority is to make sure we are taking appropriate action to keep workers healthy and safe on the job.”*

### Intervention and Enforcement

As part of this effort, OSHA implemented a nationwide intervention and enforcement initiative that prioritizes heat-related interventions and inspections of work activities on days when the heat index exceeds 80° F. The initiative applies to indoor and outdoor worksites in general industry, construction, agriculture and maritime where potential heat-related hazards exist.

*“While agricultural and construction workers often come to mind first when thinking about workers most exposed to heat hazards, without proper safety actions, sun protection and climate-control, intense heat can be harmful to a wide variety of workers indoors or outdoors and during any season,” said Jim Frederick, Acting Assistant Secretary for Occupational Safety and Health.*

OSHA plans to increase enforcement efforts on days when a recognized heat temperature can result in increased risks of heat-related illnesses. The agency also encourages employers to proactively implement intervention methods on heat priority days, including:

- Regular breaks for water, rest and shade
- Training workers on how to identify common symptoms and what to do when a worker suspects a heat-related illness is occurring
- Taking periodic measurements to determine workers' heat exposure

In addition, OSHA Area Directors across the U.S. will institute the following:

- Prioritize inspections of heat-related complaints, referrals and employer-reported illnesses and initiate an on-site investigation where possible.
- Instruct compliance safety and health officers, during their travels to jobsites, to conduct an intervention

(providing the agency's heat poster/wallet card, discuss the importance of easy access to cool water, cooling areas and acclimatization) or opening an inspection when they observe employees performing strenuous work in hot conditions.

- Expand the scope of other inspections to address heat-related hazards where worksite conditions or other evidence indicates these hazards may be present.

A National Emphasis Program on heat hazard cases is also being established that will target high-risk industries and focus agency resources and staff time on heat inspections. The program will build on the existing Regional Emphasis Program for Heat Illnesses in OSHA's Region VI, which covers Arkansas, Louisiana, New Mexico, Oklahoma and Texas.

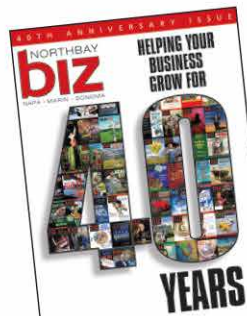
