3 Ways Safety Professionals Can Benefit from Better Communication

Effective communication is critical to establishing and maintaing a safety culture.

Safety professionals are responsible for ensuring their companies follow a wide range of workplace rules. Whether it's emergency exits, fire safety training, industry-specific guidelines, or OSHA's new national emphasis program on heat exposure, regulatory compliance is an increasingly complex field.

However, nearly every specific rule extends from OSHA's General Duty Clause, which essentially states that employers have an obligation to promote a safe work environment.

Effective communication is one of the most critical aspects of workplace safety. Employers must clearly identify workplace hazards and explain how to mitigate and avoid them. And workers need a way to report changing conditions and seek help in the event of an emergency.

Unfortunately, most common OSHA violations involve a failure to adequately communicate safety risks to employees. From failing to provide twoway monitoring for divers and alarm devices for psychiatric ward employees, or improper training on emergency scenarios such as active shooters or severe weather, failed communication directly contributes to workplace violence, injuries and even fatalities.

Here are three benefits of building effective communication into organizational preparedness plans.

1. Increase Employee Engagement

In the event of an emergency, workers are counting on their employers for information and guidance. The 2022 Edelman Trust Barometer found that 77% of respondents trust their employers, while just half trust the government or media.

Trust is the cornerstone of a safe workplace. Employers can check every box for required training and communication. But if employees aren't listening, engaged and believing what they hear, will they actually use the information to build a safer environment?

To earn employee buy-in, a company needs a strong and positive safety culture. Organizations

should build it into every aspect of operations, from onboarding to training to day-to-day activities. Focusing on proactive prevention, rather than reactive discipline such as a quick-turn training after an emergency occurs, encourages employees to be mindful of safety practices in a routine-like manner. Once employees are used to implementing daily safety tactics, getting involved in larger safety plans—such as joining a fire safety or operational safety team—becomes a more welcomed concept across the organization.

Another key aspect of maintaining a healthy safety culture is ensuring employee feedback loops are in place. Employees often experience workplace safety through a different lens than those responsible for writing policies and procedures. They face hazards every day, see safety plans in action, and are well-positioned to keep them in motion and provide insight into improvements.

Yet according to research from UKG, 86% of workers feel that colleagues are not heard fairly or equally at their companies. Listening to employees not only refines safety plans, it helps build trust in the employer's commitment to safety.

2. Optimize Emergency Response

Every second counts in a crisis, and communication can be the difference between life and death. The September 11, 2001, terrorist attacks are a painful but powerful reminder of this. While many companies in the World Trade Center towers were in disarray, Morgan Stanley deployed swift disaster response and evacuated all but 13 of its 3,800 employees to safety within 45 minutes.

Many people think of emergency preparedness as a discrete set of plans. In reality, it's a constantly evolving continuum, from planning to practice to refinement. And in rare but critical cases, execution.

When a company needs to put its disaster plans into action, a robust two-way communications tool is critical. Centralized software allows a dedicated safety officer to push alerts out to the entire company instantly, delivering the message via voice, SMS, email and any other necessary channels.

Content can also be dynamically tailored to different segments of the audience to provide the most relevant information, such as conditions pertaining to a specific building or location.

The importance of the two-way aspect is not to be overlooked here. With read receipts, delivery notifications and employee responses, safety teams can get a clear picture of whether employees have received information, changes in site conditions, and where to deploy help.

This two-way flow of information provides enhanced direction in the midst of a crisis and facilitates a rapid, effective emergency response to maximize employee safety.

3. Improve Business Resiliency

The past few years have been an immense test of resilience for companies across all industries. Millions of businesses shuttered—some temporarily, others permanently—and revealed how fragile many organizations were. In the wake of the pandemic, an Accenture survey found that 74% of C-suite executives feel they need to completely rethink their companies' operating models to be more resilient.


COVID-19 was beyond the scope of any reasonable emergency scenario, but companies face smaller and more foreseeable crises every year. While ensuring employee safety is the top priority, companies need to maintain business continuity as well. One of the keys to achieving both the goals of safety and resilience is maintaining a constant state of readiness.

Severe weather storms are an excellent example of how to focus on preparation to build resilience. Before the storm arrives, companies should keep their teams abreast of forecasts, provide reminders on preparedness plans, and actively field incoming questions. Once the storm approaches, an organization can leverage its twoway communication system to keep employees updated on conditions, announce location closures, and allow employees to request assistance if it's needed. After the event, employees can document any damage or injuries, and company-wide alerts keep everyone informed throughout the reopening process. Proactive measures before an emergency scenario will always lead to better outcomes than a hurried and improvised reaction.

Promote a Safety Culture with Effective Communication

Strong safety culture is critical to successfully protecting employees in the workplace. A company can develop complex plans and perform regular drills, but if employees don't buy in and believe in the process, they're not truly prepared for an emergency.

Effective communication is critical to building that trust. Whether it's safety training, regular updates, or emergency alerts, employees are counting on accurate and reliable information. With a robust plan and a twoway communication platform in place, organizations can position themselves to protect their employees and ensure business resilience when disaster strikes.



Top 10 Causes of Construction Claims

The majority of claims and disputes are not only intertwined, they also tend to share common roots, according to the report. For example, project owners, seeking to minimize their outlay on upfront design, allow construction work to proceed. That almost invariably leads to changes in scope, according to the report.

On public projects, federal funds are conditional on being spent by a fixed deadline. For this reason, work may proceed before full due diligence, or before all necessary rights of way or licenses are in place.

"Many of the dominant causes of claims and disputes — notably change in scope, unforeseen physical conditions and deficiencies in design or workmanship — arise from short-sighted attempts to save time and money up front," said Toby Hunt, partner at HKA, a U.K.-based business consulting and services firm, in the release.

Here are the top 10 causes of claims or disputes in the Americas region, according to the report:


- 1. Change in scope.
- 2. Physical conditions were unforeseen.
- 3. Design was incorrect.
- 4. Workmanship deficiencies.
- 5. Design was incomplete.
- 6. Poor management of subcontractors, suppliers or their interfaces.
- 7. Design information was issued late.
- 8. Contract management or administration failure.
- 9. Contract interpretation issues.
- 10. Access to the site was restricted or late.

Tech can help

Without a fundamental change of approach, complex projects delivered in a fast-track environment will continue to encounter these causes of claims and disputes, the report authors said. For this reason, the report said construction firms need to move toward digitalization, including digital twinning. At minimum, parties involved in the construction stages should streamline the paper processes commonly used for change order management, project correspondence and design approvals.

To reap the full potential of design and project management tools, the entire planning and delivery team needs to keep up to date with the latest technology. Access to digital platforms also needs to be shared, ensuring a common data environment, according to the report.

Financial Health is Concern in New Employee Health Survey

The 2022 Workplace Wellness Survey, from EBRI, found that 66% of employees believe their employer is responsible to ensure they are financially secure.

The Workplace Wellness Survey, recently released by EBRI, (the Employee Benefits Research Institute) covers a wide range of employee issues.

"This is the third year of the Workplace Wellness Survey and probably the most meaningful survey report where workplace flexibility, work-life balance, paid time off and leave benefits have become major critical factors for employees," said Paul Fronstin, director, Health Benefits Research, EBRI, in a statement.

For this year's survey, a total of 1,518 American full-time and part-time workers ages 21-64 were interviewed through 20-minute online interviews conducted from July 13-29, 2022. Data was weighted by race, age, gender, income and LGBTQ status to reflect employed Americans ages 21-64.

"In recent years, key metrics like job satisfaction, benefits satisfaction and ratings of work/life balance have remained fairly consistent. It's important to note the declines measured this year in overall benefits satisfaction and in ratings of work-life balance, which contrast with stable job satisfaction, and the belief that remote work has improved well-being and underscores the need for employers to ramp up well-being efforts," said Lisa Greenwald, CEO, Greenwald Research, in a statement.

Key highlights from the 2022 Workplace Wellness Survey report include:

Financial Well-Being/Health Benefits

Most employees are concerned about their household's financial well-being and the overwhelming majority describe their level of debt as a problem. Six in ten employees (60%) are at least moderately concerned about their household's financial well-being, which has increased by 11 points since 2021 (49%). About half of employees are concerned about their emotional (50%) and physical (48%) well-being.

- Employees agree that their employers have a responsibility to ensure they are physically, emotionally and financially well, but fewer than half rate their employer's efforts highly in these areas. Three in four employees agree that their employers have a responsibility to make sure employees are mentally healthy and emotionally well (77%) and healthy and physically well (74%). Two-thirds (66%) feel the same about their employer's responsibility to ensure employees are financially secure and well.
- Health insurance and retirement savings plans are the most common employee benefits and are the top benefits for employee retention/recruitment and their financial security. Four in ten employees (44%) are extremely or very satisfied with their benefits package, which has decreased by 7 points since 2021 (51%).
- Most employees have a high level of understanding about their health benefits and half rate their employer's communications about health benefits highly. Half of employees (52%) rate their employer's communications about health insurance and health care as excellent or very good. Less than half (47%) rate communications about online resources about benefits at the same level.
- Half of employees are satisfied with their current retirement benefits and most are satisfied with the contributions received from their employer. Seven in ten employees (70%) say they are currently offered a retirement savings plan. Half of employees (51%) are extremely or very satisfied with their current retirement benefits and nearly six in ten (58%) understand their retirement benefits extremely or very well.
- Fewer than half of employees say they are offered a financial wellness program at work. When offered, six in ten employees have participated. Over four in ten employees (45%) say their employer offers the opportunity to participate in a financial wellness program.

Work/Life Balance

Workplace flexibility, work-life balance, paid time off and leave benefits are important to employees. Most feel teleworking has positively impacted their well-being. Four in ten employees (39%) describe the work-life balance at their company as excellent or very good, which has decreased significantly since 2021. Another 36% rate it as good and 25% rate it as fair or poor.

Most employees agree that balancing work and caregiving is challenging, but few employees report access to caregiving benefits. A quarter of employees (24%) report their employer offers subsidized/complimentary child or daycare. Among those with access, 65% of employees have used it. Among those without access, 44% are interested in having the benefit available.

Most employees feel mental health wellness programs have become more important in the past year and most are interested in mental health resources and expanded benefits.

Four in ten employees (45%) rate their employer's communications about mental health and work-life balance as excellent or very good over the past year.

Most employees remain satisfied with their current job despite decreases in satisfaction with their benefits package and work-life balance. Six in ten employees (59%) are extremely or very satisfied with their current job, which is consistent with the 2021 findings (60%).

4 Major California Employment Law Changes for 2023

Construction Dive

Major themes include compensation and leave, but employers also will need to note legislation that adds new retaliation protections, attorneys said.

California employers will see a number of changes affecting human resources in the new year.

Major themes include compensation and leave, but employers also will need to note legislation that adds new retaliation protections for workers, attorneys told HR Dive.

Pay transparency

SB 1162 takes effect the first of the year and requires employers with 15 or more employees to provide pay ranges when they announce, post, publish or otherwise make known an available job.

Ben Ebbink, partner at Fisher & Phillips LLC, said this is the bill he's hearing most about. "I'm fielding 15 to 20 questions a day from clients on that," he said, because the statute is "not super extensive, and doesn't have guidance or FAQs."

For employers with structured pay systems, "it's going to be easier to get into compliance," he added. But for companies that don't have "a real set structure of steps that folks in different positions earn, there's going to be a lot of work just figuring out where things are right now."

Mariko Yoshihara, legislative counsel and policy director of the California Employment Lawyers Association, said human resources professionals should be careful if they post jobs on aggregate sites, "making sure the pay scale is listed there" as well, she said.

She also said many employers were nervous when Colora do's pay transparency law went into effect Jan. 1, 2021, but job candidates sought out Colorado after. Recruitonomics found the labor force participate rate went up by 1.5% in Colorado compared to Utah from 2020 to 2021.

Pay data reporting

That same law also will require that employers with 100 or more employees report to the state pay data including the total number of workers broken down by race, ethnicity and sex who fall within each pay band used by the U.S. Bureau of Labor Statistics. Within each job category, employers must include median hourly rate for each combination of race, ethnicity and sex.

"It helped create a framework for [companies] auditing their own pay practices," said Yoshihara. "So if for instance the hourly rate for White men is two to three times higher than Black women, they should be re-evaluating looking at their pay and promotion disparities."

Leave

California employers will see two changes to leave requirements. AB 1949 requires that employers with five or more employees give workers up to five unpaid days of bereavement leave, available to employees who have worked at a company for at least 30 days.

AB 1041 changes the California Family Rights Act, which grants workers the right to take up to 12 weeks of leave to take care of a family member. The bill extends the definition of who is considered a family member, which "breaks out of this very outdated heteronormative definition of family," said Yoshihara. "Oftentimes your closest people in your care network are not necessarily your mom or dad. Maybe you don't have children, so it reflects the reality of our care networks now."

An employer is allowed to limit an employee to

one des ignated person per year. There isn't any guidance on how to determine if the designation is appropriate, and Ebbink counsels clients not to. "I don't think you as an HR person or employer have much ability to dispute who they've designated," he said. "How you define that individual is on a case-by-case basis."


Retaliation in emergency conditions

SB 1044 prevents employers from retaliating against workers who refuse to report to or leave a workplace or worksite because an employee has a "reasonable belief" that their jobsite is unsafe, or who are under an order to evacuate a workplace, worksite, worker's home or the school of a worker's child.

It covers natural disasters and something like an active shooter situation, said Ebbink, but not a health pandemic, so employees can't use the law to say they're not coming to work because they feel a company's COVID-19 protocols are unsafe.

The law also makes it unlawful for an employer to stop employees from using their cellphones to seek emergency help or communicate with someone to make sure they're OK in an emergency situation. This may drive employers to revisit any "no cellphone" policies they might have or are thinking of implementing.

Capitol Connection Q&A for Contractors

By Shauna Krause <u>Capitol Services, Inc</u>

One contractor is 'betting' on a qualifier to work in Nevada, while another needs to cover his 'base' on short notice. I offer expert help to them and look forward to hearing what rule, regulation or change you need assistance on. First, let's throw a lifesaver for an 'SOS'...

Q: Our qualifier is retiring soon. How quickly can we sub someone in assuming he/she has all the experience qualifications but still needs to take a test and file paperwork? And how does that timing compare with substituting in an already licensed individual?

A: For the individual who needs to sit for the exams, the timing depends on when they take the test. It will take about four weeks, possibly sooner, for the CSLB to review the application, and from there, it is up to the applicant to schedule the exams. They are given 18 months, so you can see the timing greatly depends on whether they get in for the test right away or take months. For an already licensed individual, the replacement process usually takes about four weeks or less right now.

Q: My Son and I are going into business for ourselves. We are going to be a S-corporation and will have a Responsible Managing Officer (RMO) be our license holder. The business ownership structure will be split 40-40-20. My understanding is the qualifier is required to be at least 20% owner in order to keep his separate license. The qualifier has an "A" General and Hazardous Substance Removal certification. I was wondering if both can be used for our business? Also was wondering if I can also use the License in Nevada?

A: You can definitely use both of the RMO's qualifications for your new business. You cannot automatically use your CA license in NV, however there is a reciprocal agreement between the two States which your RMO would possibly qualify for. If he has actively been licensed in CA for the previous four years and he took the trade exam when he originally obtained his license, he would not be required to provide references or take the trade exam to obtain the NV license. You still need to go through Nevada's application process though.

Q: We have a current license under a Partnership. We received a complaint which we are in the process of closing out with the CSLB, however the CSLB mentioned something about our business name as shown on the CA Secretary of State's records needs to match what is on our license. We are looking for some help updating the business name on the Secretary of State and making sure our license is in regulatory compliance.

A: We would be happy to help you out with that. Your Partnership is actually not registered with the Secretary of State. I see what the problem is here. Based on the contract you provided me for review, you are operating as a corporation but your license is a Partnership license. Because Partnership licenses are not transferrable, you are required to apply for a new license in the corporation business name as reflected with the Secretary of State. We will assist you with the process of getting everything updated so that you are in compliance!



Distracted Working in Construction Gotsafety.com

By their very nature, construction sites are busy and inherently dangerous workplaces. Not only are you working around heavy equipment, a variety of tools, chemicals, heights, and more, but you and coworkers may be surrounded by external and internal distractions. In this type of environment distractions could lead to injury or death. In this lesson we will cover hazards normally associated with construction sites, and common workplace distractions.

HAZARDS

When working on a construction site, you may potentially be exposed to one or more of the following hazards:

- Slipping, tripping, or falling;
- Eye injuries or damage from chemicals, tools, and equipment;
- Being run over by heavy equipment, crushed extremities from tools or equipment, cuts or lacerations from working with sharp tools;
- Burns from open flames, fires from combustible materials or chemicals being ignited, and xposure to chemicals

WORKPLACE DISTRACTIONS

Distractions on the worksite can make the hazards dangerous. The best way to minimize or eliminate distractions on the worksite is to become aware of them. When out on the jobsite you may find one or more of the following distractions.

Unfamiliarity with equipment or tools

While you may think that you can learn to operate a piece of equipment or tool on your own, it could actually be a distraction because you are not paying attention to your surroundings or your work because you are busily trying out knobs, levers, and so on.

This type of distraction can lead to personal injury, crashes, or damage to materials. In some cases, personal injuries can result in death depending on how fast medical treatment can be received.

Smart Phones and Tablets

Whether it is checking work emails, calling someone, or checking social media, we rely on phones for a variety of communications. While these can be great tools on the jobsite, they become a dangerous distraction when they are used for non-work purposes. This includes distracted driving; trying to text, answering an email, or calling someone while behind the wheel of a dump truck, backhoe, and so on that could result in an accident.

Noisy Co-workers

Being social is just part of our nature. However, there is a time and place for certain conversations because friendly interactions, gossip, and other discussions can pull our mental focus away from our work.

Problems at home

Whether it is a sick family member, a pet, the car, bills, etc., when our thoughts turn to these matters our focus shifts away from our work. This could result in us not being aware of our surroundings, not paying attention to a task, or experiencing a misstep, resulting in either injury to ourselves or others.

Health Issues

Whether physical or mental, your health can be a distraction in the workplace. Be it a cold, fatigue, or a mental condition such as depression or anxiety, these things can affect how you pay attention to your surroundings and tasks.

Poor Housekeeping

Poor housekeeping can be very distracting on a construction site. Not only can it make items harder to find but unkept floors, wires, and so on create hazards.

Music and Loud Noises

While music can help make a task or day go by faster, it can pull your attention away from what you are doing. Additionally, loud music when added to noises that are produced by power tools and equipment can make it harder to hear alarms, sirens, etc.

Complacency

The more we repeat a task, the more comfortable we get. This can help boost our confidence; however, complacency can be a distraction. You may feel so confident that you know what you are doing that you allow your mind to wander which may take your focus away from the task which could result in an injury to you or others.

Shortcuts

In today's world, we all seem to be racing against time. On construction sites, this pressure is sometimes more present due to deadlines. However, trying to rush and taking shortcuts can be a distraction because you may be doing things too quickly and not paying attention to the actual steps of a task or place a tool in the wrong spot which could result in an injury.

SMARTER WORK PRACTICES

• Speak with your supervisor about additional training for tools, machinery, or tasks that you are unsure about. Only operate tools and machines that you have been trained on.

• Take all scheduled breaks or ask for a break if you are feeling overwhelmed.

• Be sure to put all mobile devices away if they are not being used for work purposes. If you find that mobile devices are becoming a distraction speak with your supervisor about using two-way radios or other means of communication.

• Take care of both your physical and mental health. If you are feeling sick or are dealing with a mental condition, please speak with a professional.

• Get plenty of sleep before coming into work. If you are feeling fatigued speak with your supervisor and do NOT attempt to drive any piece of machinery.

• Be aware of your surroundings. If you notice something hazardous, please notify your supervisor.

• Do NOT get complacent. Remember it only takes a moment of inattention for something to go wrong.

• Do NOT multitask or take shortcuts.

• Practice good housekeeping.

• And wear all provided PPE.

To conclude, we are bombarded with both internal and external distractions every day. On construction sites distractions can be deadly. Remember that you have a personal responsibility for health and safety on the jobsite, so do your best do minimize distractions.



On September 16, 2015, the Town Council of the Town of Windsor adopted Resolution No. 3231-15, and the Board of the Windsor Water District adopted Resolution No. 1858-15 WWD electing to be subject to the California Uniform Public Construction Cost Accounting Act (Act) as described in Section 22030 of the California Public Contract Code. In accordance with the California Public Contract Code 22032(b), public works projects valued at \$200,000 or less may be let to informal bidding when the public agency, by resolution, elects to be subject to the procedures of the Act.

When a project is to be awarded via the informal bidding process, contractors that are registered on the Town's Qualified Bidders Contractor List for the category of work being bid will be notified with a general project description, location of where to obtain more detailed information, and the time and place of bid submission at least 10 days in advance of the submission deadline and bid opening as described in California Public Contract Code 22034.

The Town invites all interested licensed contractors to submit their company information for inclusion on the Town's Qualified Informal Bidders Contractor List for the 2023 Calendar year.

To be placed on the initial Town's Qualified Bidders Contractor List, contractors should complete and submit the attached Pre-Qualification Questionnaire form.
