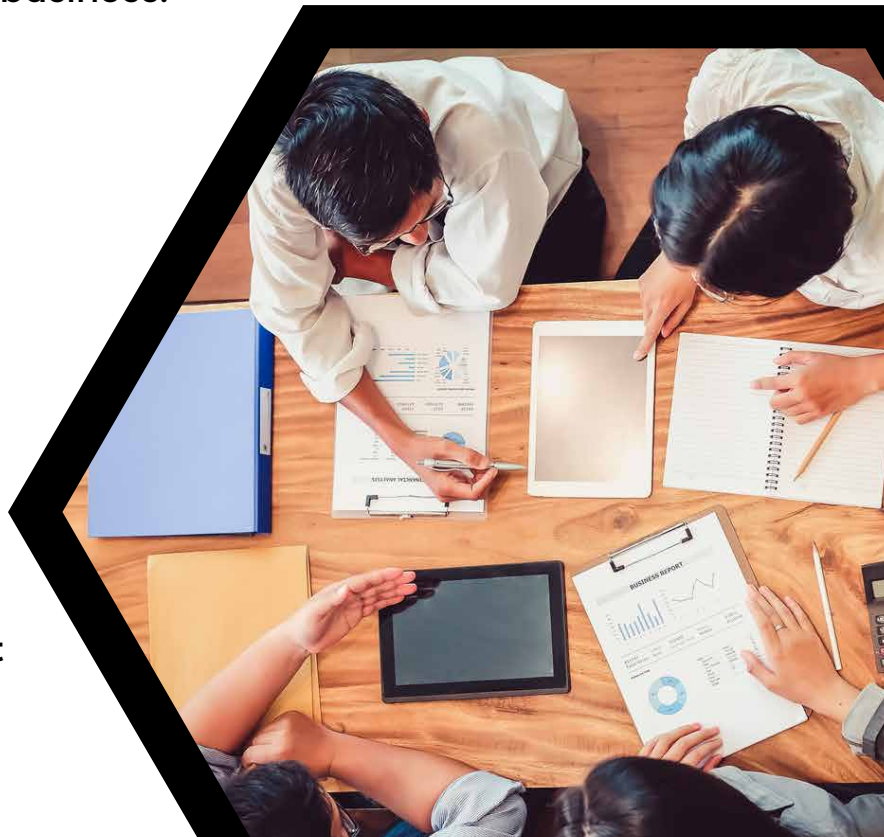

Regulatory Update: California Employers Face COVID Rules Uncertainty

Due to a new state law and looming regulatory changes to existing rules, starting on Jan. 1, 2023, California's employers must adhere to a new version of the state's COVID-19 standards dictating how they handle coronavirus outbreaks among their workers.

To make matters confusing, a new state law was enacted last October that extends the general exposure notification requirement imposed on employers until Jan. 1, 2024. The earlier requirement had been slated to expire at the end of this year.

In a separate development, the state Division of Occupational Safety and Health (Cal/OSHA) earlier this year proposed a two-year "permanent" or "non-emergency" COVID standard that is intended to replace the Emergency Temporary Standards (ETS), an exhaustive list of requirements adopted by the state earlier in the pandemic.

The ETS has been revised several times since originally adopted, including earlier this year, and extended by the governor's executive order, but is still scheduled to expire on Dec. 31. Cal/OSHA is expected to formally approve the permanent standards at a meeting scheduled for Dec. 15. However, much of what will be adopted is already known.

"Given the months-long planning process, we hoped we would see an orderly and seamless transition between expiration of the ETS (on Dec. 31, 2022) and the effective date of the non-emergency standard (Jan. 1, 2023). It now seems that may not be the case," say attorneys Benjamin Ebbink and Abby Harrington Puztulu of the Fisher Phillips law firm.

Controversy has arisen over proposed removal of the ETS requirement that employers provide "exclusion pay" for employees who are absent from the workplace due to COVID infection or exposure (although other paid leave requirements may be available).

Currently, employers must continue employees' earnings, seniority, rights and benefits when excluded from the workplace due to COVID exposure or illness contracted at work. Employers have to provide exclusion pay under the ETS before requiring employees to exhaust other forms of leave, like Supplemental Paid Sick Leave.

The new standard eliminates this provision. Instead, employers must only provide information to confirmed cases and close contacts about benefits they may be entitled to under local and federal law. Organized labor has steadfastly opposed the elimination of the exclusion pay standard.

At the last meeting of the Cal/OSHA Standards Board in October, four of the seven board members echoed the concerns of labor and essentially "demanded" that exclusion pay be added to the standard, Ebbink and Puztulu note. "It remains to be seen whether Cal/OSHA will respond by revising the language, but one way or the other, this continued debate and delay means that the board will not vote to adopt the non-emergency standard until their Dec. 15 meeting."

After being approved by the Cal/OSHA board, the new standard still needs to be reviewed by the state's Office of Administrative Law (OAL) and filed with the Secretary of State before it takes effect. Because of this, the ETS may remain in effect for employers beyond the end of the year.

There Is Good News

In all of this is some good news for employers, too, according to attorneys for the Seyfarth Shaw law firm. The new law significantly reduces the burden on employers by allowing an option for the notice of potential exposure to be posted at the worksite, or on an employee portal if other workplace notices are posted on the portal.

Just like the notice required under the current standards, it must be posted within one business day from when the employer learns of the COVID-19 case, and remain posted for at least 15 calendar days. Records of the written notices provided and a log of the dates when the notices were posted must be maintained for three years.

Employers still have the option of providing written notice to covered workers, and the employers of subcontracted workers, if they prefer. But employers will still be required to supply a written notice to the exclusive representative (union), if any, of the COVID-19 cases and any employees who had close contact.

The new version of the notice has been “streamlined,” according to the Seyfarth Shaw attorneys, but will still include the following:

- The dates on which an employee or employee of a subcontracted employer with a confirmed case of COVID-19 was on the worksite within the infectious period.
- The location of the exposures, including the department, floor, building or other area, but the location does not need to be so specific that it would allow individual workers to be identified.

Instead of detailed information, employers now only need to provide contact information for where employees can receive information regarding COVID-19-related benefits they are entitled to under federal, state or local laws, as well as antiretaliation and antidiscrimination protections of the employee. These benefits may include categories such as workers’ compensation, COVID-19-related local or emergency leave, company sick leave, state-mandated leave, recently extended COVID supplemental sick leave, or negotiated leave provisions.

As a best practice, the Seyfarth Shaw lawyers say companies should ensure human resources, safety or designated management personnel are prepared to provide this information on request and are familiar with local options for paid and unpaid leave.

Likewise, employers now only need to provide contact information about where employees may receive the cleaning and disinfection plan that the employer implements per the guidelines of the Centers for Disease Control and Prevention (CDC) and the Cal/OSHA standards.

Workplace cleaning and disinfection plans are not currently part of CDC guidelines or Cal/OSHA requirements, so many employers will likely refer to their normal cleaning and disinfection protocols that could be independent of COVID-19 mitigation measures.

Making ETS Permanent

Much of the ETS has carried over into the new proposed standard, but there are also some major changes that employers should be aware of, say the Seyfarth Shaw attorneys.

Instead of a single definition for close contact, the proposed standard distinguishes between two scenarios based on workplace size. (This new definition already applies because it was adopted by Cal/OSHA on Oct. 13, 2022.)

In indoor spaces of 400,000 cubic feet or less, a close contact results from sharing the same indoor space for 15 or more cumulative minutes within 24 hours during the infectious period. Six feet of distance does not matter. In indoor spaces of greater than 400,000 cubic feet, a close contact results from being within six feet of a COVID case for a cumulative total of 15 minutes or more within 24 hours.

“Importantly, each room with floor-to-ceiling walls makes up a distinct indoor space for purposes of this rule,” the lawyers point out. In these locations, workers who are wearing respirators during this time are not considered to be in close contact with those who are infected.

In fact, places where individuals momentarily pass through without congregating—whether or not they wear face coverings—are not considered to be exposed, which was not true under an earlier version of the new standards.

For symptomatic cases, the infectious period may end five days (down from 10 days) after the arrival of symptoms if the individual tests negative on that day and has not had a fever for over 24 hours without medication. For asymptomatic cases, the infectious period may also end five days after a positive test if a negative test is produced on the fifth day.

Regulatory Update: California Employers Face COVID Rules Uncertainty

The ETS notice requirements also have been streamlined. Currently, employers must provide written notice to all employees present at a worksite during the infectious period of a COVID-19 case within one business day of when they learn of the case. The permanent standard includes similar notice requirements, but changes the time frame for notice to “as soon as possible.”

Reporting and recordkeeping requirements have changed to reflect increasing priorities on cases and large outbreaks, rather than exposures or isolated cases, the Seyfarth Shaw attorneys explain. Employers no longer must report information about workplace COVID-19 cases and outbreaks to their local health department. Also, while employers must keep a record of COVID cases for two years, they no longer have to keep records of close contacts.

“There’s still a lot that is up in the air for California employers,” say Ebbink and Puztulu. “Employers are waiting with bated breath to see if Cal/OSHA buckles to the pressure from labor groups and adds exclusion pay back into the mix.”

As a result, they recommend that employers keep their COVID protocols in place until the non-emergency regulation goes into effect. “Employers should continue to identify, evaluate and correct COVID-19 hazards in the workplace. This means that contract tracing, reporting outbreaks, individual notice requirements, and exclusion pay from the ETS may be here to stay a little bit longer than we anticipated.”

The ETS will likely remain in effect into 2023 if only for procedural reasons, according to Ebbink and Puztulu. They advise, “California employers will need to be prepared to continue to comply with the ETS beyond the end of the year and be prepared to pivot to comply with the non-emergency regulation thereafter.”

Percentage of women in construction higher than ever

Dive Brief:

- The share of construction workers who are women is at an all-time high and has steadily increased since 2016, according to data from the Bureau of Labor Statistics.
- As of August, 14% of all construction workers were women, an analysis from The Washington Post found. The previous high point for women workers' share in construction was in October 2009, when they made up 13.5% of workers.
- Hispanic women have largely contributed to that growth. The number of Hispanic women in the industry grew 117% over the last six years, the Post found, and in 2020, the share of Hispanic women overtook the share of White women in construction. The rates include women in office roles.

Washington, D.C., had the highest share of women in construction as of August, with 17.6%. Arizona and Florida nabbed second and third place, with 15.6% and 14.5%, respectively. Delaware had the lowest nationwide, with 6.8%.

The growth of women in construction is due in part to the industry's continued high demand for workers. The unemployment rate in 2016 for people who had most recently held a construction job was the lowest since at least 2000, according to BLS data. That meant recruiters had to look elsewhere from the usual pools to find new employees, which led to the continued increase.

The difference between the early aughts and the last few years can also be attributed to labor groups and employers removing or lowering hurdles to help broaden the pool of workers in the trades, as the industry grows more desperate for new talent. Though the industry has tried to lower the barrier to entry, it is still there. Women are harder to recruit, experts noted to the Post, because they often have less experience and often require more flexible hours than men for childcare considerations.

To continue this trend, experts say employers should set goals for diversity hiring and focus on inclusion and safety. Often, women may not see construction trades as a career option, so inclusive language on job postings and employee materials is critical to communicate that women already have a place on the jobsite.

Last month, U.S. Secretary of Commerce Gina Raimondo announced the Million Women in Construction Initiative. While speaking at the North American Building Trades Union's Tradeswomen Build Nations Conference,

Raimondo highlighted the goal of doubling the number of women in construction — from 1 million to 2 million — over the next 10 years.

Though she revealed no details as to how that goal will be met, Raimondo and the Biden administration hope that the Infrastructure Investment and Jobs Act along with the CHIPS and Science Act will open more doors for women and minorities. The IJA establishes a Minority Business Development Agency within the Department of Commerce, which could help minority- and women-owned businesses win contracts and grants.

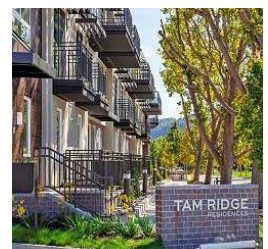

FLU SEASON TIPS FOR STAYING HEALTHY

Flu season is the portion of the year where the flu is most prevalent. In the United States, flu season can start as early as October and last all the way through May with the peak being January and February. Getting the flu causes a host of terrible symptoms, and all employees should actively avoid catching it.

WHAT IS THE FLU?

Flu is short for influenza, a contagious viral infection that affects the respiratory system. Symptoms may include the following:

- A fever of 100 degrees Fahrenheit or more
- A cough or sore throat
- A runny nose
- Headache or body aches
- Chills
- Fatigue
- Nausea, vomiting, or diarrhea

PREVENTION

It may be impossible to guarantee that you won't get the flu during flu season, but there are some things you can do to reduce your risk. Employees should avoid the flu by practicing the following:

- The number one doctor-recommended way to avoid the flu is to get the flu shot.
- Wash your hands often! Everything and everyone you touch during flu season could potentially transfer the flu virus. Alcohol-based sanitizer is also a satisfactory substitute for hand washing.
- Reduce skin to skin contact, such as shaking hands, even with healthy-looking individuals.
- Sanitize your work station frequently with disinfectant wipes or spray, if available.
- Never touch your face. Unbroken skin will block the flu virus, but broken skin and mucous membranes such as your nose, eyes, and mouth will not!
- Instead of coughing or sneezing into your hands, aim into the crook of your elbow. This will reduce the spread of germs.
- If you are feeling ill you should call in sick from work. •

Employees should get advice from their doctor if they are at risk for complications from flu or if symptoms become significantly worse after the first three days of illness, because the flu may leave the body more vulnerable to other more dangerous infections.

BOOST IMMUNE FUNCTION

The following lifestyle changes will actually boost immune function and make you less likely to come down with the flu:

- Make sure to get a full night's sleep at night.
- If you are physically capable, regular exercise can boost immune function.
- Stay hydrated by drinking at least 8 glasses of water a day.
- Make sure your diet has the recommended daily amount of vitamins C and D.
- Avoid smoking, as this decreases immune function.

The flu can be a formidable infection, but there are many things you can do both at work and on your own time to significantly decrease your chances of catching it. By following the above stated safety procedures, you will have a better chance at staying healthy.

Strong Link Between Driver Behavior and Crashes

Truck driver behavior is a key predictor of whether any driver will be involved in a road accident in the future, according to the American Transportation Research Institute (ATRI), the nonprofit research arm of American Trucking Associations (ATA).

“Having a science-based model for predicting crashes is one of the most important tools the trucking industry can have,” declared Dan Horvath, ATA’s vice president of safety policy. “ATRI’s Crash Predictor research allows carriers to target and monitor those truck driver behaviors that matter most. With truck crashes increasing, there is no better time to have this data in our hands.”

The new report provides an update to the organization’s Predicting Truck Crash Involvement research, which was first aired in 2005 with updates published in 2011 and 2018 as well as this year.

“Four years have passed since the release of the last Crash Predictor report,” ATRI noted. “Since then, [there have been] substantial changes in the regulatory environment, technology adoption, safety performance and working conditions.”

However, the report’s authors made the point that the time periods covering when the study was conducted generally preceded the impacts stemming from the COVID pandemic. “The industry’s efforts have generally shown promise: from 2005-2010, fatal truck-involved crashes decreased significantly by 24.8%,” they said. “Unfortunately, recent upticks in truck crashes may negate the long-term progress.”

ATRI’s analysis identified more than 25 different violations and convictions that increased the likelihood of future crashes, five of which increased future crash likelihood by over 100%. Simply having a previous crash increased a truck driver’s probability of having a future crash by 113%, which is 28.4% higher than previous ATRI Crash Predictor reports.

According to the institute, its research has succeeded in designing and testing a predictive model that is capable of identifying statistically significant relationships between truck driver safety behaviors and future crash probability. The new 2022 report uses the same statistical methods and is based on looking into more than 580,000 individual truck driver records.

A number of behaviors have consistently been strong indicators of future crash involvement across three or more reports, ATRI pointed out. In the 2022 report, these were found to be:

- A reckless driving violation increased crash likelihood by 104%, showing an 8.8% decrease from 2018 to 2022.
- On the other hand, a failure to use/improper signal conviction increased crash likelihood by 116%, a 41.5% hike from 2018 to 2022. Prior crash involvement showed a 113% increased likelihood of a driver being involved in a future crash, 28.4% higher than previous reports.
- A failure to yield right-of-way violation increased crash likelihood by 141%, a 39.6% increase from 2018 to 2022.
- Improper or erratic lane changes conviction predictability remains at 79%, unchanged from previous reports, ATRI said.

Age and Gender Measures

The 2022 Crash Predictor update includes several new analyses, including a safety comparison between 18- to 20-year-old truck drivers and those who were older than 24 years. What ATRI found was that drivers younger than 21 years old have statistically fewer crashes than those older than 24.

Due to the small sample size of drivers under the age of 21, however, further research on young driver safety is necessary, the researchers admitted. Also, because they are currently excluded from obtaining a commercial driver’s license for operating in interstate operations except in highly supervised pilot research projects, most of their truck driving occurs in local service.

When it comes to gender, the analysis also documents a surprising differential between the percentage of female truck drivers overall (6.7%) and their much smaller representation among truck driver inspections (2.7%). Several explanations are being tested to better understand the basis for the difference, according to the researchers.

“While ATRI research corroborates that female truck drivers are safer, there is no clear basis for female truck drivers being inspected less frequently than male truck drivers—as is shown in this latest Crash Predictor data,” the researchers said.

They examined the inspection anomaly further by testing several hypotheses through research and interviews with female drivers. Most of these theories failed to pass muster (e.g., that they tend to drive for well-known, safer fleets), but one that appears to be accurate is that females are more conscientious about driving clean and well-maintained trucks.

Strong Link Between Driver Behavior and Crashes

Based on the inspector interviews and site visits, inspectors generally look for damage, cleanliness and odd driving behaviors. In addition, the researchers said a number of female drivers mentioned in their survey responses that they tend to be more inclined to pursue jobs where they can be home at the end of the day. This may motivate them toward Class B and Class C licenses, shorter trip lengths, and straight truck configurations, ATRI said.

Leaving inspections behind, when it comes to breaking the law, ATRI found that males continue to be more likely than females to have violations, convictions and crash involvement for all statistically significant events. From 2018 to 2022, males continued to be significantly more likely than females to commit 11 behaviors that are considered predictive of future crash involvement, the researched explained.

Of these behaviors, three experienced an increased likelihood compared to 2018. These three behaviors include a medical certificate violation (up 49.2% from 2018); failure to obey traffic sign conviction (up 50% from 2018); and failure to obey traffic control device violation (up 26.1% from 2018).

The remaining eight behaviors, while still more likely among males than females, had a lower increased likelihood in 2022 than in 2018. These eight behaviors include: a seat belt violation (down 2.6% from 2018); hours-of-service violation (down 30.0% from 2018); and a failure to obey traffic signal or light conviction (down 46.6% from 2018).

Also, violations by males were more likely to presage another incident, an out-of-service (OOS) violation (down 24.4% from 2018); false/no log book violation (down 28.3% from 2018); any conviction (down 42.5% from 2018); speeding more than 15 miles over speed limit conviction (down 55.8% from 2018); and a past crash (down 30.0% from 2018).

A female driver explained to the researchers, "Women have more to prove than men in this industry, and we have an image to uphold, so we have to make sure our record is clear."

Finally, the report includes an updated list of the 10 Top Tier States for truck safety, as ranked by the relationship between traffic enforcement inspections and crashes. The top-ranked states (in order) were Washington, Indiana, New Mexico, Arizona, Massachusetts, Georgia, Pennsylvania, Illinois, California and Michigan.

Over the course of the ATRI studies conducted over the years, it said a correlation has been found between the number of state law enforcement inspections and the number of truck crash incidents. That is, the more inspections conducted by a state, the lower the number of accidents.

Capitol Connection Q&A for Contractors

Before you are 'lost' I will share how to find a contractor with 'zip' and clarify NV financial limitations for another. We all benefit from understanding how to keep the 'horse' in front of the license 'cart' which is important if you want to move forward ...

Q: You recently helped us with replacing the Qualifier on our license when we were under the gun on our 90-day time limit. While not a problem yet, it may be again in the future, and we want to make sure we are not breaking any laws. How do we find people that are willing to allow us to use their license within a certain area? For example, we wouldn't want to use an individual in Northern California and incur the cost of having him/her travel to Southern CA frequently. While, on the subject of future hiring, I was told a license holder must work a minimum of 32 hours per week, is that true?

A: The CSLB has a 'tool' on their website which allows for you to search licensed contractors by zip code/area, although that would require 'cold calling' of some sort I would imagine. From what I hear, finding an RME/RMO is the same as any other recruitment search, so however you typically do your hiring.

An RME (Responsible Managing Employee) is required to work at least 32 hours per week or 80% of the Company's operating time, yes.

Q: Can a licensee retain his Sole Proprietor license a **Q:** We are licensed in Nevada with a bid limit of \$4.5 million. If our contract is \$12 million, we have to have our limit that high, correct? Even if we plan to sub out \$7.5 million?

A: Yes, your limit would be required to be \$12 million in order to sign a \$12 million contract.



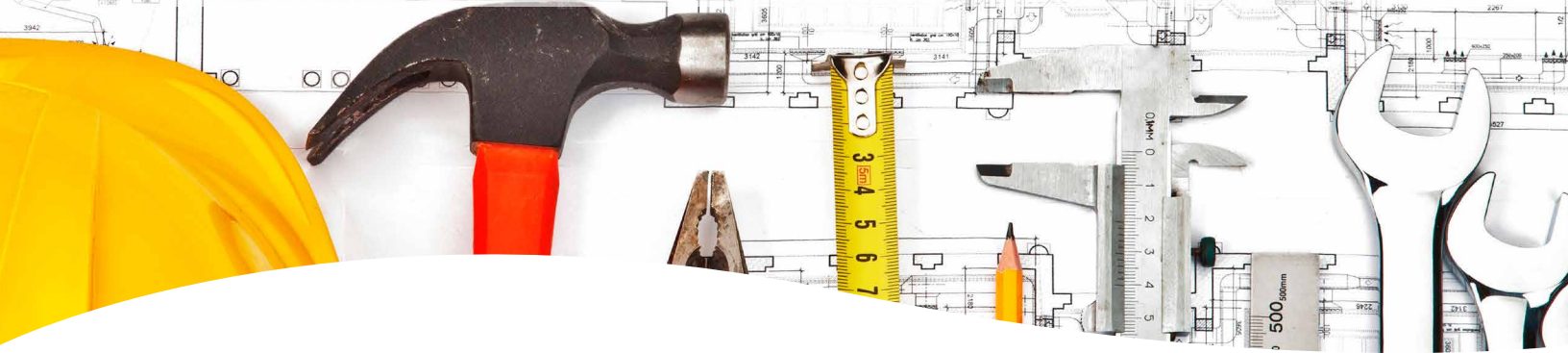
